Gov't eyes P2-B fund for cancer patients in 2024

MANILA - The Marcos administration is seeking an allocation of PHP2 billion in the 2024 National Expenditure Program (NEP) for the prevention, treatment and control of non-communicable diseases such as cancer, the Department of Budget and Management (DBM) said Tuesday.

In a statement, DBM Secretary Amenah Pangandaman said about 18,695 cancer patients would benefit from the allotment of some PHP1.024 billion under the Prevention and Control of Non-Communicable Diseases included in the 2024 NEP.

A total of PHP1.7 billion would be allocated for the prevention and control of non-communicable diseases.

Pangandaman said the PHP1.024 billion of the proposed PHP1.7-billion budget would cover the procurement of 61 (Turn to p. 2)

"We in CHED are thankful for the trust and confidence of the Filipino people as we become the top-rated government agency as shown in the survey," he said. The commission particularly showed a strong performance in Visayas with 91 percent satisfied, 9 percent undecided, and zero percent dissatisfied.

It registered 86 percent satisfaction in the National Capital Region and Mindanao, while it got 71 percent in the balanced Luzon.

The survey released on Monday was conducted among 1,200 respondents nationwide from July 22 to 26. (PNA)

different cancer commodities such as Trastuzumab 600 mg/5mL, Docetaxel 40 mg/mL and Paclitaxel 6 mg/mL.

She added that an additional PHP1 billion would be appropriated to the Cancer Assistance Fund (CAF) that will be used to cover the medical expenses of 6,666 cancer patients registered across 31 cancer control access sites nationwide.

The CAF aims to fill the financial gap in cancer diagnostics and laboratories not covered by PhilHealth, the DBM said.

The DBM noted that on average, Filipino families spend approximately PHP150,000 per patient for cancer treatments.

The CAF will partially finance outpatient

and inpatient cancer control services.

The services include therapeutic procedures and other cancer medicines needed for the treatment and management of cancer and its care-related components.

The DBM said the remaining PHP682.71 million of the PHP1.7 billion under the Prevention and Control of Non-Communicable Diseases initiative would benefit around 124,246 mental health patients.

"The amount will fund mental health medications including Sodium Valproate 250 mg, Paliperidone Palmitate 100 mg, and Haloperidol 5 mg/mL for patients on 362 mental health access sites nationwide," the DBM said. (PNA)

High oil prices seen to persist until end of 2023

MANILA – A Department of Energy (DOE) official on Tuesday said oil price hikes are expected to continue until the end of the year.

During the Laging Handa public briefing, Oil Industry Management Bureau Director Rino Abad said tighter supply has boosted global oil prices, with the output cuts from Saudi Arabia and Russia.

Abad said the global market has oil shortage of around one million barrels a day since June.

"So, the projection of S&P Global Platts (is that) high oil prices will continue from July until December," he said in Filipino. "The only chance that prices will go down is when demand slows down. Unfortunately, during 'ber' months, these are the months when demand increases."

Abad said since local players hiked oil prices in nearly two months, the common pump price for gasoline is currently at PHP73 per liter, PHP67 per liter for diesel, and around PHP79 to PHP80 per liter for kerosene.

He said the agency is reviewing the joint memorandum circular to implement the Pantawid Pasada Program, wherein Congress allotted PHP3 billion for this year.

DSWD, PNVSCA promote volunteerism in social services

MANILA - Department of Social Welfare and Development (DSWD) Secretary Rex Gatchalian and Philippine National Volunteer Service Coordinating Agency (PNVSCA) Executive Director Donald James Gawe on Tuesday signed a memorandum of understanding (MOU) to encourage and promote volunteerism in the delivery of social protection programs and services

to the people.
"We all know that the most precious commodity is time. I have always come to realize that people always find it easy to do social responsibility programs by donating, but when we ask them for time, that is something that give," they cannot Gatchalian said during the ceremonial signing of the MOU at the DSWD Central Office in Batasan Hills, Quezon City.

He emphasized the importance of time offered by organized citizens in mainstreaming volunteerism across

the social welfare and development land-

"The Department is looking forward to this partnership because we know that not only we will be able to harness the most expensive commodity out there, which is time, but we will also be able to use them efficiently in the right direction," Gatchalian said.

He thanked the PNVSCA for leading the promotion and coordination of volunteer programs and services on social protection delivery.

"And we know that there are so many good doers out there, it's such that walang nagcha-channel nung energy nila (no one is channeling their energy) to the right direction," Gatchalian said.

The MOU primarily aims to establish a mechanism where volunteer organizations and individuals can be involved in the implementation of social protection programs and services.

"Today is indeed a significant milestone in our effort to promote volunteerism as a tool for nation-building," Gawe said.

The DSWD is among the first government agencies that adopted the PNVSCA's Bayanihan Bayan Program, the government's volunteer program that encourages volunteerism among Filipinos and enjoins government employees to volunteer service in social, economic, and humanitarian development undertakings in the community.

"It is timely that the DSWD has renewed and revised this initiative given our whole-of-society approach to addressing socio-economic concerns," Gawe said.

The Department is working with volunteer groups and individuals during disaster response, particularly in repacking food packs and in loading and unloading of relief goods, among others. (PNA)

DFA confirms death of another Filipino in Hawaii wildfire

MANILA – The Department of Foreign Affairs (DFA) confirmed Tuesday the death of a Filipino citizen from the deadly wildfires that razed the coastal town of Lahaina in Maui, Hawaii.

The victim was one of the five fatalities recently identified by local authorities, the rest of whom are all US citizens.

The DFA earlier confirmed that 79-yearold Alfredo Galinato, a US citizen of Filipino descent, also perished from the blaze.

DFA Assistant Secretary Paul Raymund Cortes said official data showed the death toll has reached 114, majority of whom are yet to be identified.

"So, the chances na may mga kababayan tayo na naapektuhan ng Maui wildfire is very, very high dahil mataas iyong population ng ating Filipino community sa Maui but the probability na

Philippine passport holder sila ay medyo mababa, nonetheless, kababayan pa po natin ang mga iyan, so nakikiramay po tayo (So, the chances that our fellow citizens are among the affected is very, very high because the population of the Filipino community there is also high but the probability that there are Philippine passport holders is low, nonetheless, they are still our fellow Filipino)," he said in a public briefing.

"We continue our prayers para sa mga kababayan natin na nasalanta ng tinatawag nilang fire hurricane (for our fellow citizens who were hit by what they describe as the fire hurricane)," he added.

Cortes said search and rescue operations are ongoing in Lahaina while the affected communities get temporary shelter, food, clothing and some financial assistance from the Hawaii Emergency Management Agency and Federal Emergency Management Agency.

The Philippine Consulate General in Honolulu, he said, is also assisting Philippine passport holders rebuild their documentation, specifically birth certificates and passports. (PNA)

Bills on local health boards, tree planting program get House nod

MANILA – The House of Representatives on Tuesday approved a bill that will strengthen the local health boards of every province, city, or municipality, by including the duly elected president of the Provincial Federation of Barangay Health Workers as its member.

House Bill (HB) 7447, introduced by Quezon (1st District) Rep. Wilfrido Mark M. Enverga, chairman of the House Committee on Agriculture and

Food, was approved with a vote of 238 votes.

The proposed measure also provides an additional function of local health boards which is to propose incentives or benefits for barangay health workers, as well as recommendations on other matters requiring expenditures of local funds on health matters.

"With this bill, we aim to strengthen local health boards by ensuring the representation of barangay health workers whom we continue to recognize as essential front liners in health promotion and advocacy," Speaker Ferdinand Martin G. Romualdez said in a statement.

Enverga said the bill seeks to further uphold the rights and promote the welfare of barangay heath workers who, through their "tireless dedication and selfless service," have been vital in addressing health issues in the community level.



"Without them, the government's fight against many diseases, and the pandemic, for instance, will not be successful. Hence, it is just appropriate that they become part of local health boards that serve as an advisory committee to the sanggunian (council)

concerned on health matters," he said in a separate statement.

three, the House also approved on the third and final reading HB 8568 that will provide mechanisms to ensure the effective implementation of a tree planting program across the country.

HB 8568 seeks to amend various sections of Republic Act 10176, or the Arbor Day Act of 2012, "to combat the loss of the country's natural resources and rejuvenate the environment."

"We recognize the vital role and importance of trees in ecological stability. I think we need trees more than trees need us," Romualdez said.

HB 8568 shall augment the existing Arbor Day Committee of the different local government units (LGUs) by suggesting the inclusion of field officers from the National Commission of Indigenous Peoples.

The measure mandates that the local government unit, with technical assistance from the Department of Environment and Natural Resources, shall identify suitable areas to be planted to various species of trees and plants, including bamboo. (PNA)

DOH: Proactive health measures curb spread of TB, HIV

MANILA – Tuberculosis (TB) and human immunodeficiency virus (HIV) infection could be prevented significantly, if not eradicated, through the implementation and observance of proactive health measures.

"In line with one of the marching orders of our President, our goal is clear, the DOH (Department of Health) remains committed to aiding Filipinos, especially individuals with tuberculosis, in further lowering TB cases in the country," Health Teodoro Secretary Herbosa said at the "TB at HIV Tuldukan, KonsulTayo!" event Tuesday.

The event, held in collaboration with the Lung Center of the Philippines (LCP), aims to provide accessible screenings to the community, offering individuals a chance to assess their TB status and take charge of their well-being.

It underscored

healthy habits and health-seeking behaviors through early consultations as vital steps in addressing the country's rising number of TB and HIV cases.

"It is also a testament to the shared dedication of health care professionals, community advocates, and the DOH in ensuring the well-being of every Filipino," Herbosa said.

Health experts also spoke about the signs, symptoms and risk factors associated with TB and HIV at the event.

Counseling services for quitting smoking and vaping through the DOH Quitline 1558 were also promoted.
