PBBM admininvesting heavily in innovation, technology in 2024

MANILA – The Marcos administration is seeking hefty allocation for its innovation and technology initiatives in 2024 to foster socioeconomic growth and development in the country, the Department of

Budget and Management (DBM) said on Tuesday.

In a statement, the DBM said that under the 2024 National Expenditure Program, around PHP25.94 billion would go to the Department of Science and Technology (DOST), including PHP8.23 billion for the Grants-in-Aid Program.

The DBM said about PHP3.61 billion would be used to support the National Science and Technology Agenda, such as the Science for Change and Small Enterprise Technology Upgrading Programs.

It said some PHP1.33 billion would be allotted for the research and development (R&D) initiatives of state universities and

Excess RCEF collections to boost agri production: Romualdez

MANILA – House Speaker Martin Romualdez on Tuesday lauded President Ferdinand R. Marcos Jr.'s directive to Department of Agriculture (DA) officials to use excess collections for the Rice Competitive-Enhancement ness Fund (RCEF) to help rice farmers boost agricultural production and ensure a steady food supply for Filipinos.

In a statement, Romualdez said excess collections from rice tariffs channeled into supporting rice farmers will enable them to access modern farming technologies, improve their agricultural practices, and increase their productivity.

"This gesture manifests the unwavering resolve of President Marcos Jr. to boost agricultural production, particularly of rice, to ensure a stable supply of food for every Filipino family at affordable prices and uplift the lives of our farm-

ers," he said.

The Presidential Communications Office (PCO), citing the President's recent meeting with DA officials, said the RCEF excess collection beyond the PHP10 billion requirement should be used to provide drying, mechanization, and other equipment support to rice farmers to sustain their productivity. colleges.

The National Economic Development Authority's (NEDA) Innovation Fund, meanwhile, would get PHP100 million to support enterprises engaged in developing innovative solutions to benefit the country's underprivileged sectors.

During the Central

Republic Act (RA) 11203 or the Rice Tariffication Act states that revenues collected from rice tariffs should pay for the yearly requirement of PHP10 billion for the RCEF to fund programs and projects that will raise the competitiveness and output of palay (unhusked rice) farmers.

Romualdez said through the additional assistance, the President wants to help cut production costs of rice farmers, which Luzon State University's (CLSU) 2023 Research Innovation and Development (RIDe) Festival on Monday, DBM Secretary Amenah Pangandaman said a robust innovation ecosystem could help create jobs, increase productivity and enhance the country's competitiveness.

Pangandaman said establishing a dynamic innovation ecosystem is at the heart of the socioeconomic transformation agenda of the government's Philippine Development Plan (PDP) 2023-2028.

"It is for this reason that the present administration is investing heavily in innovation and technology," Pangandaman said in a keynote speech delivered at the CLSU auditorium in Muñoz, Nueva Ecija.

"The PDP outlines that, over the medium term, the government will provide a nurturing environment for basic research and development or R&D and knowledge cre-

ation; support market-driven and customer-centered R&D; scale up technology adoption, utilization, and commercialization; and promote an innovative culture and entrepreneurship," she added.

Pangandaman also introduced "Filipinnovation," a whole-of-government approach to inclusive innovation.

"Through Filipinnovation, we eliminate silos [separations in business resources], as government agencies no longer work in isolation, and consequently, the impact of government funding is optimized with a multiplier effect," she said. (PNA)

irrigation projects under the 2024 national budget to support the President's goal to increase agricultural production in the country.

Aside from the use of excess RCEF collections, President Marcos also recently approved the release of PHP12.7 billion assistance to rice farmers.

The amount will be distributed to 2.3 million small rice farmers who will each get PHP5,000 under the Rice Farmers Financial Assistance program of the government.

The financial assistance is part of the government's efforts to support small rice farmers who will be affected by the lifting of the price cap on rice.

The National Food Authority Council, chaired by Marcos, also increased NFA's buying prices of palay

from PHP19 to PHP23 per kilo for dry palay and PHP16 to PHP19 per kilo for wet palay to give Filipino farmers better income.

Marcos also ordered the Department of the Interior and Local Government to enioin all local government units (LGUs) rationalize to the pass-through fees and other transport costs imposed on motor vehicles transporting goods like rice and other products, according to the PCO.

Executive Order 41, issued by President Marcos on Sept. 25, prohibits LGUs from collecting toll fees and charges from all vehicles transporting goods or merchandise while passing through national roads and other thoroughfares not built or funded by them. (PNA)

PH, Qatar vow to work closely to mitigate climate change

MANILA – The Philippines and the State of Qatar have pledged to leverage each other's strengths and expertise in building the skills and capacities of key stakeholders, including local communities, to adapt to and mitigate climate change and its impacts.

Climate Change Commission (CCC) Vice Chairperson and Executive Director Robert E.A. Borje thanked His Excellency Ahmed Saad N. Al- Homidi, the State of Qatar's Ambassador to the Philippines, for Qatar's continuing support to the Philippines over the years.

Borje recognized Qatar's partnership with the Philippines, citing that continued support, including climate change initiatives, would be an important dimension of bolstered, mature and

fur dioxide," Phivolcs Director Teresito Bacolcol told the Philippine News Agency.

He said Taal Volcano is "very clear" and its main crater is "very visible" on Monday because the situation was windy, causing vog to disperse easily.

Bacolcol clarified that vog could recur and Phivolcs could not say when it would totally disappear.

"It depends on (various factors) such as wind speed, how much S02 (sulfur dioxide) the volcano is emitting, rain temperature," and he said.

One could determine if vog completely disappears when the surroundings are clear and there is no haze and sulfuric smell, he added.

Taal Volcano is on Alert Level 1, which means it is still in abnormal condition and should not be interpreted to have ceased unrest nor the threat of eruptive activity.

Entry into Taal Volcao Island, especially the Main Crater and Daang Kastila fissures, and occupancy and boating on Taal Lake are still prohibited. (PNA)

MANILA – The Land Transportation Franchising and Regulatory Board (LT-FRB) on Monday announced the return of the "Libreng Sakay" (free ride) service contracting program in jeepneys and buses beginning November until the end of December.

In a press conference in Quezon City, LTFRB Chair Teofilo Guadiz III said the program's PHP1.3 billion budget and joint circular have been approved and will include free rides on popular routes such as the Epifanio Delos Santos Avenue (EDSA) busway.

"Itong buwan na ito ilalabas namin ang pera. Ibabalik po natin ang Libreng Sakay. Uunahin po natin ang Metro Manila, kasama po ang mga jeepneys (This month we're going to release the funds. We're bringing back free rides. We will start in Metro Manila and we'll include jeepneys)," Guadiz said.

The program will serve as an early holiday present to the public once it begins in November, he said.

It was first launched in 2020 under Republic Act 11494 or the Bayanihan to Recover as One Act and was meant to help the public in the middle of the pandemic by providing free transportation as well as additional income to participating public utility vehicle drivers and operators.

Israel has cut off water supply to Gaza Strip: Energy minister

JERUSALEM – Israeli Energy Minister Israel Katz said Monday that he had instructed authorities to cut water supply to the Gaza Strip.

"All the water supply pipes from Israel to the Gaza Strip have been disconnected," Israel's Channel 12 quoted Katz as saying.

He said electricity and fuel supplies were cut off from Gaza two days ago.

The latest move comes after Israeli Defense Minister Yoav Gallant decided on Monday to impose a "complete" siege on Gaza, saying no electricity, food,

water, or fuel will reach the Gaza Strip.

Since Saturday, Israel has closed all crossings with the Gaza Strip in both directions.

The Gaza-based Palestinian resistance group Hamas launched Operation Al-Aqsa Flood against Israel early Saturday, firing a barrage of rockets. It said the surprise attack was in response to the storming of Al-Aqsa Mosque in occupied East Jerusalem and growing settler violence.

In retaliation, the Israeli army launched Operation Swords of Iron against Hamas in

Meralco inspects facilities in polling centers ahead of BSKE

MANILA – The Manila Electric Co. (Meralco) on Monday said it has inspected electric facilities in nearly 3,000 polling and canvassing centers ahead of the Barangay and Sangguniang Kabataan Elections (BSKE) on Oct. 30.

In a statement, Meralco said its teams have already checked electric facilities in public schools and barangay halls within its franchise areas while also conducting maintenance activities for its distribution facilities to ensure stable and reliable power service during the election day.

"Meralco will be on alert 24/7 to respond to any distribution related problem until the conclusion of the election process. Our crews will be deployed in strategic locations across its franchise area and will be ready to address any possible problem on electricity service," Meralco spokesperson and Vice

President for Corporate Communications Joe Zaldarriaga said.

The distribution utility has 300 generator sets and nearly 800 flood lights on standby in case of unexpected power interruption. It also trimmed trees and removed hazards that could obstruct power lines.

Meralco crews are also on standby to respond to any electricity service concern on BSKE day.

Meralco advised personnel manning the polling and canvassing centers to refrain from plugging in unnecessary appliances to avoid octopus wiring, which can lead to overloading.

"The public, meanwhile, is urged to refrain from using balloons, firecrackers, confetti, party poppers, and the like near overhead lines and facilities to avoid tripping and power interruptions," it added. (PNA)

MANILA – The Bataan-Cavite Interlink Bridge (BCIB) and Panay-Guimaras-Negros Inter-Island Bridges (PGNIB) are expected to start their construction within the next two years, Department of Public Works and Highways (DPWH) Secretary Manuel Bonoan told senators on Tuesday.

For the BCIB, Bonoan said the detailed engineering design is almost complete and already set to be presented to the National Economic Development Authority (NEDA) within the week

Meanwhile, he said the PGNIB's engineering design will undergo a rebidding process by next year.

"For Panay-Guimaras, the detailed engineering design is for, unfortunately, it's going to be rebid -- the consultancy services for the detailed engineering design. But we are confident that we

DA sees minimal effect of Israel conflict on PH agri sector

projects.

MANILA – The Department of Agriculture (DA) on Tuesday assured that the conflict between Israel and Palestinian militant group Hamas would only have a minimal effect on the country's agricultural production.

"The Israel government has been a longtime partner of the DA in various initiatives particularly in water management and fertilization, and so we hope for the immediate resolve of the

conflict in the Middle East," DA Assistant Secretary for Operations Arnel de Mesa said in a statement.

He cited fertigation, an Israeli technology which combines the efficient distribution of plant nutrients through drip irrigation, has been adapted in various rice areas in the Philippines.

He noted that this technology has been gaining popularity among Filipino farmers as it enables them to apply the precise

"I'd like to commend the DPWH for their efforts. [It's] not always recognized, but it's amazing... the accomplishments of this department," Villar said.

The BCIB project, which the Asian Development Bank (ADB) has estimated the cost at PHP175.66 billion, is expected to reduce travel time between the provinces of Bataan and Cavite to 45 minutes from the current five and a half hours.

On the other hand, the PGNIB is expected to cut travel time from Panay to Negros Islands through ferries from three to four hours to just less than one hour. (PNA)
