PH logs 45% increase in flu-like illnesses from Jan. 1 to Oct. 13

MANILA - The country has recorded a total of 151,375 cases of influenza-like Illness (ILI) from Jan. 1 to Oct. 13, the Department of Health (DOH) said Wednesday.

In a message to reporters, the DOH said the tally translates to 45 percent increase compared to 104,613 ILI cases during the same period last year.

The agency also reported that ILI cases have increased by 26 percent in the recent three to four weeks from Sept. 3 to 16 compared to reported cases two weeks prior.

"Looking at historical data since 2009, case increases coincide with

the onset of rainy and colder months. Hence, we are implementing strict monitoring of cases as we anticipate rise in cases in the coming months," the DOH said.

It added the higher cases this year are observed in most diseases under surveil-

House panel OKs bill making senior high optional for

tech-voc pursuers

MANILA – A House Representatives panel on Wednesday approved a measure that would make Grades 11 and 12 optional for students who prefer pursuing a technical-vocational education.

During the hearing, the House Committee on Basic Education and Culture, chaired by Pasig City Rep. Roman Romulo, approved an unnumbered substitute bill, otherwise known as the "Education Pathways Act".

Romulo said the objective of the bill is to help the youth achieve their maximum potential and enhance

employability by establishing education pathways that "empower and equip the learners with the competencies that are necessary for college or employment".

The bill provides that the students, upon completing junior high school, shall have the option to choose between two education pathways: the college preparatory program under the Department of Education (DepEd) or the technical-vocational program under the Technical Education Skills Development Authority (TES-

90% of P427B foreign investments set for renewable energy proects

MANILA - Nearly the entire PHP427 billion worth of foreign investment approvals this year will be tapped for renewable energy (RE) projects, the Department of Trade and Industry (DTI) said Tuesday.

DTI Undersecretary Ceferino Rodolfo said foreign companies and investors from the European Union (EU) want to provide capital for RE development in the Philippines.

Rodolfo said the past overseas trips of President Ferdinand R. Marcos Jr. boosted the RE sector.

"By the nature of the PHP427 billion, I would say about 90 percent of that have been in the sector of renewable energy at saka galing sa (and will come from) EU countries. So, we are counting that really as having been significantly related to the visits of the President," Rodolfo said during the Palace briefing.

We want Filipinos to understand that tech-voc is globally highly competitive now and it is a highly skilled profession already, unlike how it is being treated right now," he added.

According to the bill, those who wish to pursue the college preparatory pathway will go through senior high school, which will be under the jurisdiction of the DepEd.

The DepEd shall develop and implement a comprehensive curriculum for Grades 11 and 12 that prepares students for admission to colleges and universities.

Meanwhile, the students choosing the technical-vocational pathway shall be un-

The farms that we use to send to China have the approval of the Bureau of Plant Industry and the approval of the General Administration of Customs China (GACC), because the government endorsed our farm through them," he said.

To ensure that durians being sent to China are of good quality, Belviz said they are following good agricultural practices.

"We follow good nutrient management on our farm. Every year we do soil testing, and we do nutrient evaluation in our trees," he said.

Agriculture as saying 54,000 tons of durian are expected to be exported to China this year.

Elyven Idulsa, a farm supervisor at the Beviz Farm, said she was grateful for the benefits they are reaping since they started exporting durian to China.

"Malaki po talaga ang impact noong nai-export mula Pilipinas sa China kasi lumaki na po iyong kita namin, at saka lumaki din ang sahod namin. So masaya po kaming lahat lalo na ang pamilya ko (Exporting to China really had a big impact on us because our earnings and salaries grew. So we are all happy, especially my family)," she said.

She said their farm had already adapted to new technology to improve the quality of their produce and increase their productivity. The farm currently grows 20 varieities of durian like D101, Duyaya, and Puyat, which is characterized by its sweet, yellow pulp.

Earlier this year, President Ferdinand R. Marcos Jr. said the protocol for the export of fresh Philippine durian was already signed, paving the way for Chinese importers to source the fruit from the Philippines.

Manila and Beijing agreed on a protocol of phytosanitary requirements for the export of fresh durians from the Philippines to China between the Department of Agriculture and China's General Administration of Customs. (PNA)
