SSS: Maximum funeral benefits raise to P60K

MANILA – The Social Security System (SSS) on Wednesday said it has raised its maximum amount of funeral benefits to PHP60,000 to incentivize active membership.

It noted that the implementation of the enhanced guidelines

for the Funeral Benefit Program started on Oct. 20. SSS President and

Chief Executive Officer Rolando Ledesma Macasaet said the provision of funeral benefits to claimants will also be streamlined "especially for surviving legal spouses."

The claimants of deceased members with 36 or more monthly contributions may receive a variable amount from PHP20,000 to PHP60,000 in SSS funeral benefits under the new guidelines.

Solon seek address rising cases of animal abandonment

MANILA - Senator Mark Villar on Thursday called for the passage of a bill that seeks to encourage the adoption of stray and impounded animals, as the rising number of abandoned animals remains highly disproportionate to the support they ought to receive despite projects and shelters that rescue them.

In pushing for Senate Bill No. 2257, or the Act Strengthening the former family pets or Adoption of Stray and Impounded Animals, Villar expressed his concern over the low pet adoption rate in the country, which is less than one percent, amid a large number of homeless animals.

According to the Philippine Animal Welfare Society (PAWS), there are around 12 million stray cats and dogs in the Philippines as of 2019, which are either

those who have reproduced in the streets due to lack of proper shelter.

Meanwhile, the People for the Ethical Treatment of Animals (PETA) said animal homelessness in the Philippines has reached a crisis point as stray animals struggle to live unsupervised in the streets and impounded ones (*Turn to p. 2*)

DPWH reactivates motorist assistance program from 'Undas'

MANILA – The Department of Public Works and Highways (DPWH) on Thursday said it will reactivate its composite teams to provide assistance to motorists in key thoroughfares for the All Saints' and All Souls' Days exodus.

In a statement, DPWH Secretary Manuel Bonoan said the program would be activated starting 8 a.m. on Oct. 31 and would be in effect until 5 p.m. of Nov. 2.

"For three days, our

'Lakbay Alalay' motorist assistance centers will be operational to provide prompt and reliable assistance to motorists and travelers going to visit their departed loved ones this long weekend," he said.

Bonoan said strategically-located stations will be manned round-the-clock bv uniformed personnel with equipment, who can provide emergency services to motorists and the traveling public.

Prior to the Undas

holidays and the commencement of motorist assistance program, the DPWH regional and district engineering offices nationwide were also instructed to conduct routine maintenance along national roads, especially routes leading to cemeteries, memorial parks and churches.

Implementing offices with ongoing projects along the same routes were also ordered to ensure proper road safety signages, while traffic advisories are posted to prevent traffic slowdown.

"These 12 million strays we have on record were back in 2019. Apat na taon na po ang nakalipas (It has been four years). With the pandemic placing a great burden on Filipinos, we can only expect na mas dumami na po ang mga stray animals na walang (a greater number of stray animals without) proper care and shelter. We must act on this and extend our aid in securing safe animal shelters," Villar said.

SB 2257 seeks to encourage the adoption of stray and impounded animals by providing tax incentive benefits to any individual or group who shall adopt stray and impounded animals.

It also seeks to reduce euthanasia for stray and impounded animals and outlines the provision for adoption, highlighting the role of the local government units (LGUs) in facilitating the im-

Senator Grace Poe has also filed a related measure seeking to strengthen animal welfare standards, policies, rules and regulations, implementation, and enforcement, as well as provide tougher penalties to violators.

Poe said her proposed measure seeks to establish an Animal Welfare Bureau that would have wider powers in ensuring the promotion of animal welfare in the country and their protection against cruelty. (PNA)

MANILA – The Philippine economic growth likely accelerated in the third quarter of the year, driven by the growth in government spending, according to an economist.

In a Viber message to the Philippine News Agency on Thursday, Rizal Commercial Banking Corporation (RCBC) chief economist Michael Ricafort said the economy is projected to grow by 6 percent in the third quarter of the year. "Philippine GDP

(gross domestic product) growth (will be) supported by catchup spending by the national government, especially on infrastructure, after some underspending earlier in 2023," Ricafort said.

The country's economic growth slowed to 4.3 percent in the second quarter of the year.

The economic team earlier vowed that the government's final consumption expenditure, which contracted by 7.1 percent in the second quarter, will be

PBBM sees immediate need **Benchmarking Activity of Ilocos Sur Provincial Jail** to modernize agri, fisheries

MANILA – President Ferdinand R. Marcos Ir. on Wednesdav stressed the immediate need to modernize the agriculture and fisheries sector, as part of the efforts to make the Philippines a "foodand nutrition-secure" nation.

Marcos made the remark during the celebration of the 70th founding anniversary of the Federation of Free Farmers (FFF) at the Salvador Escudero Hall of the National Meat Inspection Service on Visayas Avenue, Quezon City.

"This administration is steering the growth of our fisheries and farming industries with urgency," he said, noting that the Department of Agriculture (DA) has allocated PHP4.73 billion as an investment for the large-scale agriculture and fishery mechanization and modernization.

Marcos, who also leads the DA, expressed optimism about realizing his bid to modernize the agri-fisheries industry, given the allocation of PHP85.88 billion for the sector in 2023 and the proposed allotment of PHP92.4 billion in 2024.

He said his administration is striving to implement effimechanization cient strategies to reduce post-harvest losses and ensure the optimal vield at an affordable cost.

He said the government is also doing its best to increase the exportation of the country's agricultural products, acknowledging that the move is "an essential driver in the competitiveness of our economy."

"In line with that collective mission, I wish to reaffirm one of the top priorities of this administration, which is the enhancement of our agricultural productivity, the guarantee of our food supply, the affordability of our food supply, and our lessening dependence on importation," Marcos said.

"This includes pursuing policies that will support and protect the overall welfare of our farmers, our fishers, our manufacturers, and the consuming public," he added.

Marcos also hoped for a closer collaboration with the FFF, as he recognized its long-standing cooperation and partnership with the government in sustaining development in the areas of agri-fisheries, agrarian reform, and agricultural cooperatives.

He assured the organization that the government is pursuing the strengthening of various agricultural associations and cooperatives, to provide beneficiaries with business and investment opportunities.

"This will definitely elevate the standard of living, improve the lives of the farmers and our fishers and that of their families," Marcos said.

PBBM sees immediate need to modernize agri, fisheries

Ferdinand R. Marcos Jr. on Wednesday stressed the immediate need to modernize the agriculture and fisheries sector, as part of the efforts to make the Philippines a "foodand nutrition-secure" nation.

Marcos made the remark during the celebration of the 70th founding anniversary of the Federation of Free Farmers (FFF) at the Salvador Escudero Hall of the National Meat Inspection Service on Visayas Avenue, Quezon City.

"This administration is steering the growth of our fisheries and farming industries with urgency," he said, noting that the Department of Agriculture (DA) has allocated PHP4.73 billion as an investment for the large-scale agriculture and fishery mechanization and modernization.

Marcos, who also leads the DA, expressed optimism about realizing his bid to modernize the agri-fisheries industry, given the allocation of PHP85.88 billion for the sector in 2023 and the proposed allotment of PHP92.4 billion in 2024.

He said his administration is striving to implement efficient mechanization strategies to reduce post-harvest losses and ensure the optimal vield at an affordable cost.

He said the government is also doing its best to increase the ex-

MANILA - President portation of the country's agricultural products, acknowledging that the move is "an essential driver in the competitiveness of our economy."

> "In line with that collective mission, I wish to reaffirm one of the top priorities of this administration, which is the enhancement of our agricultural productivity, the guarantee of our food supply, the affordability of our food supply, and our lessening dependence on importation," Marcos said.

> "This includes pursuing policies that will support and protect the overall welfare of our farmers, our fishers, our manufacturers, and the consuming public," he added.

Marcos also hoped for a closer collaboration with the FFF. as he recognized its long-standing cooperation and partnership with the government in sustaining development in the areas of agri-fisheries, agrarian reform, and agricultural cooperatives.

He assured the organization that the government is pursuing the strengthening of various agricultural associations and cooperatives, to provide beneficiaries with business and investment opportunities.

"This will definitely elevate the standard of living, improve the lives of the farmers and our fishers and that of their families," Marcos said.

DOH chief orders creation of committee to probe PhilHealth cyberattack

MANILA – Department of Health (DOH) Secretary Teodoro Herbosa has ordered the creation of a committee that would investigate the recent cyberattack on the Philippine Health Insurance Corporation (PhilHealth) website last September.

"Nagpa-create din ako ng investigating committee to investigate really the gross negligence allegations, incompetence and all that stuff," he told reporters in a Palace briefing Tuesday.

"An investigation has to happen, due process, the usual... kasi these are government people eh kaya kailangan ng due process (because these are government people hence due process is necessary)."

Last week, PhilHealth senior vice president and data privacy officer Nerissa Santiago said at least 13 million of their members have been affected by the Medusa ransomware cyberattack and about 600 to 800 employee data have been leaked.

Herbosa said that most of the Phil-Health's system are already up even though "a lot of data" were compromised.

He added that the agency was instructed

to create a crisis committee that would handle possible similar issues in the future.

Several members of PhilHealth's executive committee are expected to be transferred or reassigned following the decision of the agency's Board of Directors.

"I was the chair but I was a non-voting chair. It was the members of the board that voted against members of the executive committee of Philhealth. The executive vice president, the vice president for finance, they were named actually," Herbosa said.

"They were dismayed due to the recent Medusa hacking because of the antivirus software that wasn't updated plus they cited many other instances in the past, the delayed publication for the dialysis, etc. so it was a unanimous board decision."

However, the transfer or reassignment is yet to be implemented because PhilHealth's president and chief executive officer Emmanuel Ledesma Jr. requested more time as he waits for comments from the Governance Commission for Government-owned or Controlled Corporations. (PNA)
