64 OFWs from Israel home this week

MANILA – A total of 64 overseas Filipino workers (OFWs) from Israel are home this week, according to the Department of Migrant Workers (DMW).

The fifth batch of repatriates, composed of 22 OFWs and an infant, arrived Monday via Etihad Airways flight EY 424 at Ninoy Aquino International Airport Terminal 3.

The cremated remains of Mary Grace Prodigo-Cabrera, a native of Iloilo province, was accompanied by her sister, Mary June Prodigo, who also works as an OFW in Israel.

The next group of 42 will be home by Tuesday.

"Nineteen of the returning OFWs [on Monday] are caregivers while the remaining 3 are hotel work-

ers," Cacdac said in a statement on Monday.

Cabrera, the daughter of her 95-year-old ward, and the daughter's former husband were abducted by the terrorist Hamas group on Oct. 7.

The OFW's body was found on Oct. 19.

Her urn will be laid to rest in their hometown in Maasin, Iloilo.

DOTr chief: Railway projects vital in fixing NCR gridlock

MANILA – The Department of Transportation (DOTr) on Monday highlighted the importance of the big-ticket railway projects of the government in addressing traffic congestion in the National Capital Region (NCR).

During Monday's forum organized by the Economic Journalists Association of the Philippines (EJAP) in Intramuros, Manila, DOTr Secretary Jaime Bautista said better public transportation would push the public to leave their cars at

home, thereby reducing the number of vehicles on the road.

He cited the North-South Commuter Railway (NSCR), the Metro Manila Subway Project (MMSP), the Metro Manila Transit Line 7 (MRT-7), and the extension and rehabilitation projects for the existing LRT-1, LRT-2, and MRT-3 as critical in freeing NCR from the daily gridlock of motor vehicles.

"The effect on traffic will be significant when we start the MMSP [and other railway projects]," he said. While these projects are slated for partial operations in 2028 and 2029, he said projects such as the public utility vehicle (PUV) modernization program (PUVMP) and the Epifanio de los Santos Avenue (EDSA) Busway at present address the public's need for public transportation.

"We have allowed P2P (point-to-point) buses to use the EDSA busway and their travel time has been reduced by 45 minutes to 1 hour. We encourage those who live in these areas to use these

One facet of the PU-VMP, he said, is the Local Public Transport Route Plan (LPTRP) which aims to rationalize existing PUV routes as well as create new routes to optimize the country's land transportation system.

PBBM priority 'Tatak Pinoy' bill gets Senate nod

MANILA – One of President Ferdinand R. Marcos Jr.'s 12 priority measures he enumerated in his last State of the Nation Address (SONA) was approved on Monday by the Senate with 23 affirmative votes, zero negative and no abstentions.

Senate Bill No. (SBN) 2426 or known as the "Tatak Pinoy" (Proudly Filipino) Bill mandates the formulation, financing, implementation, monitoring, and evaluation of comprehensive and multiyear "Tatak Pinoy" Strategy (TPS).

It will also require the

government agencies to collaborate with the private sector to ensure that all the strategies and interventions introduced would be focused on the expansion and diversification of the productive capabilities of local enterprises.

world's most vibrant and strongest economies.

Angara cited as an example Taiwan, which in the past decades had a reputation of producing cheap but sub-standard products, but after imbibing the spirit of complexity, it has transformed itself as one of the world's biggest manufacturers of high-tech goods and has positioned itself firmly in the global supply chain.

"We must have a commitment from all parties to move up to the production of higher-value products. There are infinite possibilities but finite time and resources. So we have to make difficult decisions such as focusing on products that could be big winners in the world economy," Angara said.

He said the Philippines, ranked by the Atlas Economic Complexity as 33rd among 128 countries, has a lot of potential to produce complex and high-value products but this has yet to be unlocked.

"This is where the 'Tatak Pinoy' strategy and the TPC comes in to ensure three-car trains.

With the theme "Powering the Economy Through Infrastructure Development," EJAP's forum hosted Bautista, Developers of Renewal Energy for Advancement Inc. president Atty. Jay Layug, and Philippine Institute for Development Studies research fellow Dr. Kris Francisco to discuss the challenges and solutions in the country's push for new and better infrastructure. (PNA)

that the philosophies of constantly improving, adding value, becoming more sophisticated becomes fully imbibed within our government and even in the private sector," Angara said, noting that four representatives from the private sector will join the TPC as members.

Tatak Pinoy also calls for close collaboration between the government and the private sector to achieve a common goal of equipping and enabling Filipino industries and services to become more productive and competitive, producing more complex and higher quality goods.

It also calls for becoming an integral part of the global supply chain, providing high-paying, quality jobs for Filipinos and making the economy more vibrant.

It likewise aligns with the Philippine Economic Development Plan 2023 to 2028 and the new Philippine Export Development Plan, which Angara said are the building blocks to achieve strong economic growth. (PNA)

Fluss thanked the OFWs for staying with their employers despite the dangerous situation.

He said Filipinos and Israelis have the same values, making it easier for OFWs to blend in and adapt.

"When I talk about the connection between Israel and the Philippines and why Filipinos want to go to Israel as caregivers and hotel workers, and why usually they do not want to come back, is because they have become a part of our family," Fluss said.

"We have very similar culture and values, family eating, when we have guests we must have food on the table, so I think you are very much at home when you are in Israel and that's the reason why Israel is a very popular destination for Filipinos," he added.

Cacdac assured the returning OFWs of a whole-of-government approach in providing them assistance.

He said they were mandated by President Ferdinand R. Marcos Jr. to look after their welfare and ensure their safety.

Quizzed as to what kind of "production support" the government would provide, Edillon said it is more of the distribution of high-yielding varieties of seeds and fertilizers, as well as ensuring proper irrigation.

Edillon said there is no exact allocation yet for the provision of support to the affected provinces, but noted that there was a com-

Food, rice assistance program kicks off in Metro Manila, Laguna

MANILA – The House of Representatives and the Department of Social Welfare and Development (DSWD) on Sunday led the launch of a cash and rice assistance program where more than 300,000 initial beneficiaries are expected to receive the aid.

The Cash and Rice Distribution (CARD) program simultaneously kicked off in Metro Manila's 33 legislative districts and two cities in Laguna province, led by House Speaker Ferdinand Martin Romualdez and DSWD Secretary Rex Gatchalian.

The program is in response to President Ferdinand R. Marcos Jr.'s challenge to create a program that will aid the poor and most vulnerable members of society.

"Makasaysayan po ang araw na ito, hindi lamang dito sa Laguna kundi maging sa buong Metro Manila. Ngayong umaga, pormal nating sisimulan pinakabagong programa ng ating pamahalaan, ang (This is a historic day, not only here in Laguna but also in the entire Metro Manila. This [Sunday] morning, we will formally begin the newest program of the government, the) Cash Assistance and Rice Distribution or the CARD program," Romualdez said as he introduced the program in the City of Biñan, Laguna province coinciding with the launch of the Bagong Pilipinas Serbisyo Fair (BPSF) that brings govern-ment services to communities.

The aid will be distributed in four payouts. Each recipient will receive at least PHP2,000 cash and a 25-kilogram sack of rice.

Meanwhile, around 3,000 beneficiaries in Biñan and 2,000 from the City of Santa Rosa will get the same benefits.

The DSWD is tasked to identify the beneficiaries and may increase the amount of assistance in some areas depending on its evaluation of prevailing circumstances. Romualdez said the program, which will go beyond Metro Manila and Laguna, was conceived amid the escalating rice prices and other challenges faced by Filipino consumers, empowering them to gain access to rice at better prices and augment their buying capacity. The government is prepared to ensure that the "worst scenario will not happen," Edillon added.

Edillon said the government might also provide cash assistance to help the vulnerable sectors.

In July, the Department of Agriculture - Disaster Risk Reduction and Management Center (DA-DRRMC) said some 66 areas nationwide may experience dry conditions, dry spell and drought until the end of the year.

The DA-DRRMC said dry conditions may prevail in three

areas in Luzon, five in the Visayas and 20 in Mindanao, while a dry spell is looming in 32 areas in Luzon and four in the Visayas.

The provinces of Camarines Norte and Southern Leyte may also experience drought.

Dry spell is defined as three consecutive months of below normal rainfall condition while dry condition is defined as two consecutive months of below normal rainfall condition, both 21 to 60 percent reduction from average rainfall.

Drought is three consecutive months of way below normal rainfall condition (60 percent reduction from average rainfall). (PNA)

PH inflation eases to 4.9% in October

MANILA – Headline inflation eased to 4.9 percent in October this year from 6.1 percent in September, the Philippine Statistics Authority (PSA) reported on Tuesday.

Last month's headline inflation rate was also lower than the 7.7 percent recorded in October last year.

Core inflation, which excludes volatile oil and food items, was also down to 5.3 percent from 5.9 percent in September.

In a briefing, National Statistician Dennis Mapa said the downtrend was due to the slower year-on-year increase in the heavily-weighted food and non-alcoholic beverages at 7.0 percent in October from 9.7 percent in September.

Mapa said the deceleration of inflation was primarily brought about by the lower annual growth of vegetables, tubers, plantains, cooking bananas and pulses at 11.9 percent from 29.6 percent in September.

Lower year-on-year growth rates were also seen in other food groups such as flour, bread, and other bakery products; meat and other parts of slaughtered land animals; fish and other seafood; sugar, confectionery and desserts; and ready-made food and other food products.

Rice inflation also slowed to 13.2 percent from 17.9 percent the previous month.

"Price of rice decreased month-on-month," Mapa said.

He said the average price of regu-

lar-milled rice went down to PHP45.40 per kilogram (kg) from PHP47.50 per kg in September.

For well-milled rice, the average price also declined to PHP51 per kg from PHP52.70 per kg the previous month.

"If we don't see any supply shocks, our outlook is inflation will go down [for the remaining months of 2023]," Mapa said.

The restaurants and accommodation services, with an inflation rate of 6.3 percent in October from 7.1 percent in September 2023, also contributed to the downtrend of the headline inflation.

Year-to-date, headline inflation settled at 6.4 percent while core inflation was at 7.0 percent.

Inflation in the National Capital Region (NCR) also decelerated to 4.9 percent from 6.1 percent in September.

For areas outside NCR, headline inflation also slowed down to 4.9 percent in October from 6.0 percent the previous month.

Inflation for the bottom 30 percent households meanwhile also

eased to 5.3 percent from 6.9 percent in September this year.

In a separate statement, the National Economic and Development Authority (NEDA) said the government will continue to help the most vulnerable sectors as El Niño or the long dry spell is expected to linger until mid-2024.

"As inflation eases, it is crucial to continue monitoring the prices of commodities, particularly food, transportation, and energy, amid global challenges such as geopolitical uncertainties and El Niño," NEDA Secretary Arsenio Balisacan said.

The Philippine Atmospheric, Geophysical and Astronomical Services Administration (PAGASA) earlier said the country is experiencing a moderate El Niño
