PhilHealth to partner facilities: Strictly apply senior citizens, PWD member discounts

QUEZON CITY, (PIA) -- Philippine Health Insurance Corporation (Phil-Health) President and Chief Executive Officer (CEO) Emmanuel Ledesma Jr. reminded its accredited health facilities anew regarding the timely application of statutory discounts that are entitled to senior citizens and persons with disabilities (PWDs).

This, as the corporation received reports stating that a number of their partner hospitals failed to deduct the mandatory discounts from the total medical bills of patients prior to hospital discharge.

"We have to give whatever the law mandates. This is our responsibility to our members, and one of them is to ensure that their senior citizen or PWD privileges, whichever is applicable, are properly deducted from their hospital bills," said Ledesma, referring to Republic Act Nos. 9994 and 10754 or the Expanded Senior Citizens Act of 2010 and (Turn to p. 3)

DepEd, DOH to address various health issues in schools

MANILA – The Department of Education (DepEd), in partnership with the Department of Health (DOH), vowed to collaborate in addressing health issues directly affecting school-aged children.

In a meeting on Monday, Vice President and Education Secretary Sara Z. Duterte and Health Secretary Ted Herbosa discussed the

clustering of Influenza-like Illnesses (ILI) in schools, reported HIV/AIDS incidences among school-aged children, teenage pregnancies, mental wellness of students, and other factors that significantly impact the overall development of learners.

Efforts will also be made to raise awareness, provide accurate information, and implement preventive programs to combat the increasing incidence of HIV/AIDS among school-aged children.

The two agencies will jointly develop comprehensive strategies to reduce the number of teenage pregnancies and provide support to pregnant students, ensuring they can continue their education.

Programs that address mental health issues among students, such as stress management, counseling services, and the creation of a supportive environment will also be implemented.

By prioritizing the physical and mental well-being of students, both agencies aim to create a conducive learning environment that nurtures the holistic development of every learner.

The PhilHealth-accredited health facilities shall also remember that only one discount applies if the patient is both a senior citizen and a PWD member.

The facilities that will be found liable in the mis- and non-application of discounts are intended to face corresponding sanctions including the payment of fines and the suspension or revocation of PhilHealth accreditation following their Performance Commitment with the corporation.

All PhilHealth Regional Offices (ROs), on the other hand, are strongly encouraged to implement the Healthcare Provider Perfor-

mance Assessment System (HCP AS) to monitor the compliance of accredited health facilities with their Performance Commitment.

Members can report instances of mis- and non-deduction of Phil-Health discounts to the Office of Senior Citizens Affairs (OSCA) in their respective local government or to the National Council on Disability Affairs.

MMDA suspends road excavations in NCR for now

(PIA) -- The Metropolitan Manila Development Authority (MMDA) will temporarily suspend all road excavation activities on all national and city roads in the National Capital Region (NCR) during the holiday season.

The MMDA said in a notice that the suspension of road excavations will begin Monday, November 13, and will last until January 8, 2024.

According to the MMDA, the suspension is also in preparation for the expected influx of vehicles during the Christmas season.

"Effective Monday, November 13 to January 8 next year, excavation activities for road reblocking, pipe laying, road upgrading, and other excavation works will be suspended," according to the MMDA.

Meanwhile, some road projects including the government's Flagship

OUEZON CITY, projects are exempted from the suspension; bridge repair and construction by the Department of Public Works and Highways (DPWH); flood interceptor catchment project (box culvert); asphalt overlay projects without reblocking works; sidewalk improvements; drainage improvement projects, including sidewalks that do not occupy any part of the roadway; and even footbridge projects.

The suspension also does not include emergency leak repairs or water line damage by Manila Water Company and Maynilad Water Services Incorporated; new water service or electrical service connections; road activities without excavation (traffic clearance only); Meralco relocation works that will affect major government projects and other projects allowed by the MMDA after its application. PHP0.70 per liter and a rollback of PHP3 per liter for diesel.

Caltex, Seaoil and Shell will also cut kerosene prices PHP2.30 per liter.

Other oil firms have yet to announce price adjustments.

This will be the second week of price rollback for gasoline and third straight week for diesel and kerosene.

According to the Department of Energy, pump prices in Metro Manila since the effectivity of the adjustments last week range from PHP59.75 to PHP75.80 per liter for gasoline; PHP57.40 to PHP82.85 per liter for diesel; and PHP74 to PHP87.14 per liter for kerosene. (PNA)

Nature-based solutions key to addressing climate action gap by 2030

MANILA – The Climate Change Commission (CCC) has underscored the importance of enhancing collaboration on nature-based solutions to address the climate action gap.

During the Pre-COP28 event "Accelerating Collaboration on Nature to Close the Climate Action Gap to 2030" in Abu Dhabi, United Arab Emirates on Oct. 30 to 31, CCC Commissioner Rachel Anne Herrera highlighted the importance of carbon sequestration as a fundamental aspect of nature's climate role in reducing greenhouse gas concentrations.

"Ecosystems, including forests and wetlands, act as vital carbon reservoirs that stock and sequester carbon. They also serve as buffers for storm surges made more dangerous by the rising sea level and as havens for the spawning of fish to ensure food security. By accounting for and valuing these ecosystem services, new financial flows may be generated from carbon and biodiversity credit systems that also manage climate risks locally and globally," she said.

The Philippines is developing a geospatial database in support of a new system of natural capital accounting to recognize its real economic and social contributions to sustainable development.

In the National Adaptation Plan, which provides a clear picture of the gaps and needs and

the actions it needs to take to minimize climate change losses and damage, scaling up of nature-based solutions is a key adaptation strategy.

Measuring progress will require the use of standardized metrics and monitoring, reporting and verification (MRV) systems for nature-based solutions, including robust scientific research, data transparency and accessibility to assess the performance and impact of these solutions.

"It is only by recognizing the interconnectedness of human, natural and engineered systems that we can collectively drive transformative change and close the climate

action gap by 2030," Herrera said.

The Pre-COP28 event was hosted by UN Climate Change High-Level Champion, H.E. Razan Al Mubarak, who also serves as president of the International Union for Conservation of Nature (IUCN).

Airlines see continued rise in demand through Q4

MANILA – Two airline companies have expressed optimism that the rise in demand for travel would continue until the fourth quarter and that their pre-pandemic levels could be surpassed by 2024

South Korea's flag carrier Korean Air (KAL) on Tuesday reported that its passenger business revenue for the third quarter rose by 76 percent year on year, or about 2.55 trillion Korean won.

The airline attributed the sharp increase to the strong demand during peak season, especially the first summer and Chuseok holiday post-pandemic.

In its financial report sent to reporters, KAL forecast a continued increase in passenger demand in the fourth quarter, and eyes restoring its pre-pandemic seat capacity levels.

It will work on maximizing profits by securing new demand and operating additional special flights, the report added.

KAL's revenue for the

third quarter was 3.86 trillion won, 5 percent higher year on year.

Meanwhile, in a statement, low-cost carrier Cebu Pacific (CEB) said they are optimistic about the travel demand in the fourth quarter, as the Gokongwei-led airline saw a 55 percent domestic market share in October.

"We expect that by the end of the year, our systemwide network will be at 103 percent of pre-pandemic levels; domestic will continue to exceed pre-pandemic levels, while international is seen to be at about 93 percent," CEB chief executive officer Michael Szucs said.

He added that by yearend, CEB expects to service 60 destinations through more than 100 routes and at least 2,700 weekly flights.

CEB is also looking forward to an increase in seat capacity, between 5 percent and 8 percent more in 2024.

"We continue to explore various opportunities to supplement the fleet and ensure operational resilience, including securing both brand new and used aircraft, as well as exploring aircraft leases," Szucs said. (PNA)
