DOLE: Wage hike for Mimaropa workers takes effect December 7

MANILA – Minimum wage earners and household workers (kasambahays) in Region 4-B (Mimaropa) will get a higher pay effective Dec. 7, the Department of Labor and Employment (DOLE) said on Wednesday.

This was after the Regional Tripartite

Wages and Productivity Board (RTWPB) issued Wage Order RB-MIMAROPA-11, granting a PHP40 increase in the minimum pay for private sector workers.

On the other hand, Wage Order RB-MI-MAROPA-DW-04, allowed a PHP1,000 in-



crease in the monthly pay of kasambahays.

A total of 46,861 minimum wage earners across all sectors in the region are expected

DBM approves P303.5M for construction of 120 classrooms in 21 sites

MANILA – Budget Secretary Amenah Pangandaman has approved the release of funds worth PHP303.5 million for the construction of 120 classrooms in 21 sites nationwide.

In a statement Wednesday, the Department of Budget and Management (DBM) said the Department of Public Works and Highways (DPWH) and the Department of Education (DepEd) made a joint request to release the funds under the Basic Education Facilities (BEF) Batch 2 for the calendar year 2023 to build more classrooms in the country.

The DBM said Pangandaman approved the DPWH and the DepEd's request after the requirements for the release of funds were completed.

The requirements include the list of schools approved by the DepEd Undersecretaries for School Infrastructure and Facilities, and Finance; Budget Execution Document No. 1-Financial Plan; Physical (Turn to p. 2)

PBBM: Unity vital in battling global warming, climate change

MANILA – President Ferdinand R. Marcos Jr. on Wednesday emphasized the importance of unity in mitigating the effects of global warming and climate change.

In his pre-recorded video message during the opening of the 16th Annual Global Warming and Climate Change Consciousness Week, Marcos enjoined the Climate Change Commission (CCC) to promote unity and cooperation

for a "more resilient and adaptable nation."

The President made the call, as he expressed hope to reach his goal of having a "new Philippines that is strong in trials, peaceful, and safe for the people and full of hope for a good future."

"The impact of global warming and climate change is becoming more evident in our present time. Rising temperatures, extreme weather events, and a decline in biodiversi-

ty are stark reminders of the need to quickly respond to this immediate environmental concern," he said.

"We all have a role to play in this mission. So we must work together, take a stance in support of our planet. Let us be involved in creating solutions to mitigate the effects of global warming and climate change."

Under Proclamation 1667 issued on Nov. 18, 2008, the Global Warming and Climate Change Consciousness Week is celebrated every Nov. 19 to 25.

In adherence to this proclamation, the CCC organizes a series of activities aimed at raising awareness and fostering collaboration among various stakeholders.

The 16th Annual Climate Change Consciousness Week underscores the importance of community collaboration and collective action to address climate change.

"The total authorized appropriation for Special Provisions in the FY (fiscal year) 2023 DepEd budget of P15.7 billion is being implemented by DPWH. This includes P15.6 billion for the construction, replacement, and completion of kindergarten, elementary, and secondary school buildings and technical vocational laboratories, among others," the statement read.

"Learners and teachers can expect more classrooms to be built in various schools," it added.

Pangandaman stressed the need to strengthen the education sector, saying it is a crucial factor in promoting the country's social and human devel-

The DOLE said the wage orders were approved on Oct. 24 and published on Nov. 21. They shall take effect after 15 days from publication, or on Dec. 7.

The last wage orders for workers in private establishments and domestic workers in the region became effective in June 2022.

Los Baños joins call to be RICEponsible

LOS BAÑOS, Laguna (PIA) - Taking responsibility in eating and consuming rice is crucial in achieving food security, the Municipal Agriculture Office of Los Baños said during the National Rice Awareness Month (NRAM) celebration this month.

Municipal agriculturist Cheryll Laviña-Gonzales emphasized the importance of not wasting rice as embodied in this year's celebration that carries the theme, "Be RICEponsible" to heighten public awareness on efforts to attain rice self-sufficiency and address malnutrition and poverty.

"The goal of the celebration is to raise awareness among our local residents about responsible rice consumption and avoid wastage even as we are not currently experiencing rice shortage," she said.

In a Malacañang briefing on November 9, the Philippine Rice Research Institute (PhilRice) said around two tablespoon of rice is wasted by every person each day, costing around P7 million every year.

The country celebrates National Rice Awareness Month every November under Proclamation 524 issued on January 5, 2004.

Los Baños, known as the Special Science and Nature City of the Philippines, is committed to institutionalizing the celebration through the Kautusang Pambayan Bilang 2021-2160.

In line with the celebration, the town provided assistance to 130 registered farmers under the Department of Agriculture's Registry System for the Basic Sectors in Agriculture (RSBSA). The farmers receive free seedlings, fertilizer, and machinery to support their

livelihood.

The local government of Los Baños also held various programs and contests, including a poster making contest, agri trivia shows, quiz contest, parol making, and an exhibit of government agencies such as the Agricultural Systems Institute-College of Agriculture and Food Science (ASI-CAFS) of the University of the Philippines Los Baños and the Philippine Rice Research Institute (PhilRice).

One of the event highlights is the parol making contest where participants from different barangays showcase giant Christmas lanterns adorned with 'palay' (unhusked rice).

In addition to these efforts, Los Baños Mayor Anthony Genuino has implemented scholarship programs for children of farmers, aiming to encourage them to pursue agriculture-related courses in college.

This initiative, called the Farmer Field School (FFS) under the Rice Competitiveness Enhancement Fund (RCEF), is done in collaboration with the local government. The goal is to change the youth's perception of farming as a viable and noble career path. At least 22 scholars have completed and graduated from the town's agriculture program.

To be eligible for the scholarship program, students must demonstrate an interest in agriculture and present initiatives to further develop the livelihood of their parents.

"With the Mayor's initiative of providing scholarships to our young farmers, we encourage the youth to engage in agriculture, particularly in rice farming," added Gonzales. (CO/PIA4A)

panse within the Caliraya-Lumot Watershed.

In partnership with the National Power Corporation (NPC) and the Paete Sagip Sigla Palay Farmers Association Inc, the Climate Change Commission, through the NZC, targets to plant 15,625 seedlings across a 25-hectare area in the Caliraya-Lumot Watershed, covering the towns of Lumban, Kalayaan, and Cavinti, Laguna.

Prices of over 150 Noche Buena items rise

MANILA - The Noche Buena price guide will be released on Wednesday ahead of the holiday season, with a noticeable price increase in over 150 shelf keeping units (SKUs), Department of Trade and Industry-Consumer Protection Group (DTI-CPG) Assistant Secretary Amanda Marie Nograles said.

In a press conference in Makati City Tuesday, Nograles said 83 Noche Buena items out of 240 SKUs have minimal price increases ranging from 1 to 5 percent; 37 SKUs have raised their prices by 6 to 10 percent; and 32 SKUs have hiked prices by more than 10 percent.

"There are various reasons for the increase, such as the increasing prices of raw materials, packaging materials, labor, power and distribution cost, according to the manufacturers," Nograles said.

She said keso de bola had the largest increase in prices in this year's Noche Buena price guide, which is about PHP49 higher than the retail price in the previous price bul-

letin.

While prices of majority of the Noche Buena items increased, Nograles said 34 SKUs did not change their prices while costs of 21 items declined.

"This is effective immediately until Dec. 31, 2023," she added.

DTI Secretary Alfredo Pascual said the Noche Buena price guide operates differently from the suggested retail price (SRP) bulletin of the agency.

"This is really a guide to help the consumers to decide what brand to buy, for example," Pascual said.

He added the items in the Noche Buena price guide are not among the basic necessities and prime commodities listed in the Price Act. Products listed in the Noche Buena price guide include ham, fruit cocktail, cheese, keso de bola, mayonnaise, sandwich spread, pasta/spaghetti, elbow macaroni, salad macaroni, spaghetti sauce, tomato sauce and creamer/ all-purpose cream.

"These prices are the suggested retail prices by manufacturers for their products. The way this will operate, if there are retailers that are selling higher than what the manufacturers have specified, and our monitors are able to detect this deviation, we will call the attention of the manufacturers so the manufacturers will help to take care dealing with the retailer selling their (Back to p. 6)

CCC Week 2023 kicks off with commitment to net zero carbon dioxide

PAETE, Laguna – The Climate Change Commission (CCC) began the commemoration of the 16th Annual Global Warming and Climate Change Consciousness Week 2023 (CCC Week 2023) with a tree planting and growing activity dubbed "Net Zero Challenge" at the Caliraya-Lumot Watershed in Paete, Laguna on Sunday.

The Net Zero Challenge (NZC) is part of the CCC's Carbon Neutrality Program in the Caliraya-Lumot Watershed, which aims to offset carbon emissions through nature-based solutions.

This initiative is projected to sequester 75.5 tons of carbon dioxide from 2023 to 2027. The tree planting and growing goes beyond commitments to achieving zero carbon emissions. It also offers advantages in disaster risk reduction, where trees stabilize slopes to minimize the likelihood of landslides and flash floods in the area.

Secretary Robert E.A.
Borje, CCC Vice Chairperson and Executive
Director, led the activity, which was attended
by Paete Mayor Ronald
Cosico, Paete Vice Mayor Vergilio Madridejos
Jr., and representatives of
Laguna Governor Ramil
Hernandez, Laguna 2nd
District Rep. Ruth Hernandez, and Kalayaan
town Mayor Sandy Laganapan.

In his speech, Borje emphasized the significance of 5Ps: planet, people, plant, partnership and prosperity.

"We are here for our planet. We are here for the people who are affected the most by climate change. We need to plant more trees, dahil malaki ang naitutulong ng mga puno bilang carbon sinks (because trees play big role as carbon

sinks)," Borje said.

"Bukod dito, ang mas maraming puno ay nakakatulong sa pagsigla ng ating watershed, nakakatulong din ito sa pagpigil ng baha at pagguho ng lupa (In addition, more trees help revitalize our watershed, it also helps prevent floods and soil erosion). Partnerships with other national government agencies, LGUs [local government units], civil society organizations and communities will give us a better chance of achieving our goal of resiliency and prosperity, lalo na kapag inalagaan natin ang ating kalikasan (especially if protect our environment)," he add-

Cosico expressed his support for the CCC's net zero initiative, emphasizing the need to promote and utilize renewable resources.

"Sa mga ganitong gawain, ang inyo pong lingkod ay very supportive. Tama talagang dapat na natin pagtuunan ng pansin ang climate change. Iba't iba na ang nangyayari sa ating bansa. Tayo, sa bayan ng Paete, nararanasan na rin natin (ang epekto ng climate change). Talagang tayo'y kinakailangan nang magtanim, magtanim, at magtanim dito sa ating bayan ng Paete (I really support this kind of activities. We really have to focus on climate change. Different things are happening in our country. In Paete, we are already experiencing the impact of climate change. We really need to plant more trees here in our town of Paete)," Cosico said.

Together with various organizations and stake-holders, including the Philippine Red Cross and the Net Zero Carbon Alliance, the CCC led the planting of 625 seedlings across a one-hectare ex-
