DA chief eyes marine-agro-industrial estates to modernize fisheries

MANILA - Agriculture Secretary Francisco Tiu Laurel Jr. has called for amendments to the Philippine Fisheries Development Authority (PFDA) charter to expand its function in the development and management of marine and agro-industrial estates nationwide ensuring ample food supply.

In a news release on Tuesday, Laurel said the measure is in accordance with the Philippine Rural Development Program (PRDP) and the goal of President Ferdinand R. Marcos Jr. to modernize the agriculture sector.

He said the marine agro-industrial and estates would be onestop shops housing ports, cold-storage facilities, silos and warehouses to store farm and marine products such as rice, sugar, vegetables, palm oil and other basic commodities, and ensure their stable supply.

No backlog in social pension payouts for senior citizens-DSWD spox

MANILA - Department of Social Welfare and Development (DSWD) spokesperson Assistant Secretary Romel Lopez on Tuesday said the agency is on time when it comes to the distribution of the PHP500 monthly social pension to all indigent senior citizens.

Lopez made this clarification following reports that the DSWD is facing a cash aid distribution backlog of up to 466,000 seniors.

In the report, the WB identified potential funding sources for Philippine agriculture like grant funds from the European Union and the Global Environment Facility to support marine protected areas.

Apart from this, Laurel underscored the WB's suggestions on the need for digital transformation in agriculture as well as improving the sector's logistics.

"Definitely, we need a logistics masterplan. That is one thing I think is lacking in the DA," he said.

Laurel said he will soon appoint an assistant secretary whose sole focus would be logistics to ensure public funds are well spent.

To increase farm production and raise incomes of farmers and fisherfolk, Laurel dis-

Lopez said the budget increase for the social pension program in 2024 will only cover the additional PHP500 to the current monthly stipend of the indigent senior citizens in accordance with Republic Act (RA) 11916 or an "Act Increasing the Social Pension of Indigent Senior Citizens."

The PHP500 additional pension, he said, will also be given starting next year once the proposed 2024 budget is approved.

RA 11916, which lapsed into law in July 2022, provides for a 100 percent increase in the monthly pension of indigent

senior citizens from PHP500 to PHP1,000. Lopez said eligible senior citizens should

fall within the following criteria to receive social pension: frail, sickly or with a disability; without pension from the Social Security System (SSS), Government Service Insurance System (GSIS) or from any sources of pension in government and private agencies; and without any permanent source of income, compensation or financial assistance from relatives to support their basic needs.

The social pension program aims to augment the daily subsistence and other medical needs of indigent senior citizens. (PNA)

PGC Conducts Orientation on Handling Former Rebels and Former Violent Extremists

The Provincial Government of Cavite, through the Office of the Provincial Social Welfare and Development Officer spearheaded the Orientation on Handling Former Rebels (FRs) and Former Violent Extremists (FVEs) focused on their rehabilitation and reintegration. The activity also aimed to capacitate the frontline workers to effectively engage with these FRs and FVEs. The two-day event, held on November 23-24, 2023, at The Bayleaf Hotel in General Trias City, gathered key stakeholders to strategize and collaborate on addressing the challenges associated with the reintegration process.

Attended by a diverse group of 50 participants, including representatives from the Armed Forces of the Philippines, Philippine National Police, Department of the Interior and Local Government (DILG), academe, local government units (LGUs), former rebels (FRs), and members of the Provincial Enhanced Comprehensive Local Integration Program (E-CLIP) Committee, the event fostered a collaborative environment to explore comprehensive solutions.

Provincial Administrator for Community Affairs Mr. Alvin Mojica, shared insights on the importance of preparedness in providing social welfare services for rebel returnees and their significant role in achieving holistic peace in the province.

The event featured Informative presentations and discussions covering a spectrum of crucial topics on Legal Framework and Assistance Program. Ms. Lhyrey Vicentino from DILG provided comprehensive insights into Executive Order No. 70, institutionalizing the whole-of-nation approach in attaining inclusive and sustainable peace, creating a national task force to end local communist armed conflict (NTF-ELCAC), and directing the adoption of a national peace framework; the situation of rebel returnees in CALABARZON region, and the benefits and assistance available through DILG-DND JMC no. 01 Series of 2021 or the "Implementing Guidelines on the Provision of DILG-administered Package of Assistance to Former Rebels (FRs) and Former Violent Extremists (FVEs).

Ms. Elena May Romano of DSWD IV-A delved into the implementation of DSWD programs under EO 70, shedding light on the assistance programs available to former rebels. Mr. Carl Jerome Teodoro facilitated discussions on the Joint AFP-PNP Intelligence Committee, the E-CLIP Information System, and Monitoring, Evaluation, Learning Tool. Ms. Carol B. Nuyda from DSWD discussed the Transformative Justice Framework as a method for working with FRs and FVEs. Effective case management strategies for handling former rebels and violent extremists was discussed by Ms. Blessy Costelo from DSWD IV-A. LT Sean Pelandas of the Philippine Army presented insights into understanding the complexities and dynamics of former rebels, aiming to provide a nuanced perspective. Ms. Maria Aura D. Fuentes highlighted the OPSWDO's programs and services tailored to support former rebels.

In a compelling orientation session, FRs alias Ka Mimi and Ka Leo, recounted their personal journey as former insurgents and the profound motivation that led them to reintegrate themselves into the government fold. They also shared their transformative experiences, shedding light on their decision to embrace a path toward reconciliation and contribute positively to the community.

The event concluded with reflections and feedback from participants, emphasizing the collaborative efforts and commitment to effective recuperation.

Overall, the event marked a significant step in aligning efforts among various stakeholders toward fostering a supportive environment for the successful reintegration of former rebels and violent extremists into society. ---OPIO

CIF 2023: Cultivating conducive conditions for climate investments

MANILA – Key stakeholders from the public and private sectors have sought to establish conducive conditions for climate-related investments aligned with national policies and sectoral needs.

During the Climate Investment Forum (CIF) 2023 at Crowne Plaza Manila Galleria on Nov. 20, the participants called for stronger collaboration between the government and private sector to scale up sustainable and green investments that propel economic growth, as laid out in the Philippine Development Plan (PDP) 2023-2028.

In his keynote address, Department of Finance Secretary Benjamin Diokno outlined the country's first Sustainable Finance Roadmap which sets the stage for a comprehensive whole-of-government approach to promote sustainable finance.

The roadmap includes strategic plans such as integrating risk management, encouraging climate related disclosures, and participating in international initiatives.

"We are laying the groundwork for enabling a just transition where every sector, every community, and individual can thrive," he emphasized.

Diokno highlighted the crucial role of the "Green Forces" referring to the Inter-agency Technical Working Group for Sustainable Finance that reviews the sustainable finance landscape, addresses policy gaps, and intesustainability grates microeconomic into policies.

Director Nieva Natural of the National Economic and Development Authority presented enabling mechanisms for climate

investment, including the PDP 2023-2038, emphasizing the need for investments from the private sector to augment public investments and funds.

The World Bank, through its Country Climate and Development Report, explained the benefits of investing in climate solutions.

"The cost of climate adaptation is substantial but easily outweighed by the economic benefits of reduced climate damage. Mitigation measures would increase GDP by about 0.5 percent in 2040 and generate 80,000 jobs," it said.

Dr. Selva Ramachandran, Resident Representative of the United Nations Development Programme, reiterated their commitment to support the country's efforts in climate-resilient development and accelerating climate investment and financing.

Together, we can forge a path towards sustainable development, harnessing the strength of bayanihan for positive change," Ramachandran said, emphasizing the need for increased private sector engagement,

The event also featured a presentation on the Strategic Investment Priority Plan by Director Sandra Marie Recolizado of the Board of Investments.

During the panel discussions, panelists discussed topics such as security concerns in climate programs, private sector thoughts on new technologies, and challenges faced by organizations in investing more in climate action.

PhilHealth hikes benefits for stroke patients

MANILA - State insurer Philippine Health Insurance Corporation (PhilHealth) has increased the benefits for people suffering from stroke.

In a public advisory, the PhilHealth said stroke patients spend a high cost for treatment expenses and recovery.

The state insurer increased the benefit package for ischemic stroke PHP28,000 from to PHP76,000.

Ischemic stroke is characterized by the presence of blood clots or clogged

nerves leading to the brain.

It also increased the benefit package for hemorrhagic stroke or bleeding in the brain due to nerve rupture from PHP38,000 to PHP80,000.

Stroke is second among the most common causes of death among Filipinos with a 0.9 percent prevalence rate.

About 70 percent of these stroke-related deaths are classified under ischemic stroke while the remaining 30 percent is under hemorrhagic stroke. (PNA)

DOH: Measures in place vs. possible hike in respiratory illnesses

MANILA – The Department of Health (DOH) on Wednesday said measures are in place against possible increase of respiratory illness cases nationwide.

The agency made the statement following reports on the uptick of respiratory illnesses in northern China.

The DOH reiterated that there is no need for alarm as the government prioritizes the safety of Filipinos through "vigilant" surveillance and information dissemination.

"At present, continued surveillance and reporting of influenza-like illnesses (ILI) in the country indicate that cases have started to plateau. Nonetheless, the EB [Epidemiology Bureau]shall continue to strengthen ILI surveillance in coordination with the WHO [World Health Organization] and China," the DOH said in a statement.

The WHO has been monitoring the increase in influenza-like illnesses in China since mid-October.

It noted reports from the media and the International Society for Infectious Diseases of clusters of undiagnosed pneumonia in children's hospitals in select areas in China this month. for Disease Control and Prevention (China CDC) and Beijing Children's Hospital have clarified that the increase in consultations and admissions were "within the expected levels based on historical data and not unusual given the lifting of Covid-19 restrictions".

They attributed the case increases to mycoplasma pneumoniae (a common bacterial infection which typically affects young children), respiratory syncytial virus, adenovirus, and influenza.

The China CDC added that no changes in the disease presentation and no unusual or new pathogens have been detected.

The WHO has recommended general preventive measures against respiratory diseases must be observed.

To date, no specific measures for travellers and border control were recommended by the WHO.

The DOH has urged the public, especially the children and the elderly to stay vigilant and to observe layers of protection — voluntary masking, regular handwashing, isolating when ill, ensuring adequate ventilation and getting vaccinated — to avoid respiratory illnesses. (PNA)
