Water, power, food, supply enough amid El Niño threat: Task force

MANILA – The country has sufficient water, power and food supply amid the threat of El Niño, according to the coordinating body tasked to consolidate measures to mitigate the impacts of the phenomenon.

Task Force El Niño spokesperson and Communications Assistant Secretary Joel Villarama gave the assurance on Tuesday, even as he shared that the number of areas to be affected by the El Niño phenomenon has gone down to 41 from the previous 50, based on the latest assessment of the Philippine Atmospheric, Geophysical, and As-

tronomical Services Administration (PA-GASA).

"First off, a bit of good news. Doon sa initial o doon sa last report ng PAGASA, 50 provinces ang affected. Ngayon ay na-reduce na lang to 41," Villarama said in a Palace press briefing.

House panel directed to review PhilHealth charter to enhance

benefits

MANILA – The House Committee on Health will conduct a thorough review of the Philippine Health Insurance Corporation (PhilHealth) charter to expand patients' benefits.

Speaker Martin Romualdez on Tuesday directed the review that specifically targets an increase in benefits, including coverage of at least 50 percent of the cost in private hospital wards and free examinations for the early detection of deadly diseases, such as cancer.

Early cancer detection measures would include critical diagnostic exams like X-rays for lung cancer, mammography for

breast cancer, and the human papillomavirus vaccine to prevent cervical cancer, among others.

In a statement, Romuladez said there is a need for PhilHealth to function as a health maintenance organization, focusing its resources on safeguarding the health of the populace rather than investing in commercial banks and bonds.

"With substantial annual allocations from Congress and regular contributions from private employees, there is no excuse for Phil-Health to scrimp on coverage. The effectiveness of the Universal Health Care system depends on our ability to provide for our citizens, ensuring they receive the medical attention and preventive

DTI, DA urged to increase discounts cap on groceries for seniors

MANILA – A joint panel of the House of Representatives on Tuesday directed the Department of Trade and Industry (DTI) and the Department of Agriculture (DA) to increase the senior citizen's discount on basic goods from PHP65 per week to PHP125 per week, or a total of PHP500 per month.

During the hearing, the House committees on senior citizens, persons with disabilities, and ways and means approved the motion directing the DTI and DA to revise the administrative order granting special discounts to senior citizens on the purchase of groceries by increasing the cap on discounts to PHP125 weekly.

Under the current means system, promulgated through DTI-DA Joint Administrative Order 10-02, senior citizens are entitled to a special discount of 5 percent of the regular retail price, without exemption from value-added tax, of basic necessities. The total value of goods discounted is capped at PHP1,300 per week, or a PHP65 discount.

House ways and

means committee chair Joey Salceda said the proposed new rate was determined by using food inflation rates from 2010 to 2024.

"Using food inflation rates, we determined that by now the total value of the discount should have been adjusted to around PHP126.31 per week. So, adjustment to PHP125 is more or less where we should be by

Batangas guv targets expanded healthcare services

BATANGAS CITY The provincial government here will expand free healthcare services as part of its flagship Health, Education, Livelihood and Protection (HELP) program.

In an interview on Batangas Tuesday, Hermilando Gov. Mandanas said the national government's existing health initiatives, such as Republic Act No. 11223 or the Universal Health Care Act and "Libreng Laboratoryo, Konsulta, at Gamot Para sa Lahat (LAB for ALL)," will be leveraged to bolster provincial efforts.

He said the provincial government is poised to hire more employees, purchase additional diagnostic equipment and acquire new ambulance units for all district hospitals.

Additionally, Mandanas said his administration is expanding the delivery of more free medical services and free medicines to financially struggling

Batangueños.

The governor admitted, however, that expanding healthcare services has been putting a strain on the provincial government's coffers.

Mandanas made a case for the full implementation of the Supreme Court's Mandanas-Garcia ruling, which allocated more money to local government units (LGUs).

He emphasized that landmark

ing was intended to strengthen financial decentralization giving LGUs a larger share of the taxes collected by national government agencies.

On Feb. 8, the governor inaugurated a new provincial healthcare facility in Bauan, intended to deliver services to the over 90,000 residents of this first-class municipality.

The new facility is

equipped with laboratory services that cover clinical microscopy, immunology and serology, complete blood count and blood chemistry, according to the Provincial Information Office.

During the same event, he said that the Lab for All caravan launched by First Lady Liza Araneta-Marcos in the province last vear has been extremely helpful. (PNA)

"As the President has emphasized, our approach to El Niño is number one intervention. Number two, mitigation and then we enjoin everyone, it's a whole of government approach," Villarama said.

He said the task force is committed to carrying out the President Ferdinand R. Marcos Jr.'s order of taking proactive steps.

"Basically, the challenge is for the unforeseen events but as I said, as the President mentioned in his speech in Davao last week, under 'Bagong Pilipinas, we try to nip the problem in the bud, not let them catch us off

lic there is close coordination among member-agencies of the Task Force El Niño to mitigate the impact of the phenomenon.

"The challenge of course is to anticipate based on models what the unforeseen effects," he said. "In terms of the work of the task force and the government, we are forward looking to mitigate the effects until maybe June to September."

He said losses in rice and corn due to the El Niño phenomenon amounted to PHP131.24 million and PHP10.04 million, respectively.

"The DTI and the DA are so directed to adjust the rates prescribed in the administrative order... This is just an administrative order, so it can be adjusted with immediate effect."

He said the estimated cost to society of these discounts is at least PHP31.1 billion every year, which is a "burden shared equally among all others."

'This is the overarching doctrine of these discounts - everyone else has a responsibility to take care of elders,

simply because everyone else will become elders at some point. The policy decision we have made as a society is that we will all distribute the burden amongst ourselves, as sellers will likely pass these costs on to other consumers," he said.

House Speaker Martin Romualdez earlier directed a technical working group to study his proposal of increasing the discounts on groceries and food supplements for senior citizens and persons with disabilities. (PNA)

VP Sara to bring home educ strategies, 'happy stories' from Malaysia

MANILA – Vice President and Education Secretary Sara Duterte was delighted over her "productive" engagements with the Malaysian government and the Filipino community leaders.

"Ang baon ko ay iyong happy stories ng ating mga kababayan at iyong natutunan ko doon sa early childhood care course (I will bring home the happy stories of our fellow Filipinos and what I have learned in early childhood care course)," she said in an interview on Tuesday.

Duterte recounted some of the positive experiences Filipino community leaders discussed during their dinner on the sidelines of her engagement as president of Southeast Asian Ministers of Education (SEAMEO) in Malaysia.

"Walang naglapit ng issue or challenges nila. In fact, ang sharing nila kanina ay mga happy stories nila. Iyong isang kababayan natin bago lang kinasal sa isang Malaysian (No one raised any issue or challenges. In fact, they shared their happy stories. One of our fellow Filipinos just got married to a Malaysian national)," she said.

She also lauded some of the strategic approaches of Malaysia in terms of early childhood development care.

"Ito yung mga batang kailangan nating tutukan at alagaan kasi sila yung wala pa sa mga public schools natin. Wala pa sa paaralan natin (These are the children that we need to focus on and take

care of because they are those who have not yet entered our public schools)," she said.

Duterte referred to the early childhood development course provided to babies and kids up to 4 years old in a vocational school in Malaysia.

"We can discuss this with the early child-hood development council. Ang Department of Education ang chairperson ng council na ito (is the chairperson of this council)," she added.

Besides early child-hood development courses, she also thanked the Malaysian government for its support to Filipino doctors and scientists through the SEAMEO Tropical Medicine and Public Health Network (TROPMED).

In her speech, Duterte recognized the contribution of SEAM- EO Regional Center for Education in Science and Mathematics (RECSAM) and SEAMEO Regional Center for Special Education Needs (SEN) in advancing quality education in Malaysia, one of the vital Sustainable Development Goals of the United Nations.

"They also offer valuable insights for the Philippines in the implementation of our MATATAG Agenda and curriculum," she said.

T R O P M E D , RECSAM, and SEN are part of SEAMEO centers initiated by the Malaysian Ministry of Education and cover a wide array of learning avenues including medicine, science and mathematics, and inclusive disability education, respectively. (PNA)

PBBM orders FDA to further streamline drug regulatory processes

MANILA – President Ferdinand R. Marcos Jr. has directed the Food and Drug Administration (FDA) to continue the streamlining of the country's drug regulatory processes.

Marcos gave the directive in a sectoral meeting at Malacañan Palace in Manila on Tuesday morning in an effort to improve Filipinos' access to medicines and lower drug prices, FDA director general Samuel Zacate said.

"The President has directed the Food and Drug Administration to further streamline the drug application process in the Philippines and to provide further drug accessibility for all the Filipinos, and in the future, the cheaper medicine for us," Zacate said in a Palace press briefing.

Zacate said the FDA has already crafted several policies to ensure the proper registration of local and international drug manufacturers' products.

He added that there is a policy extending the validity of the license to operate and the certificate of product registration from the initial three-year license and five-year renewal to an initial five-year license and 10-year renewal.

Zacate said there will also be a revision of fees to make sure that the country's laboratory and testing capabilities will be "at par with the other international

regulations."

Pharma-zones

Marcos also broached the idea of establishing pharma-zones which will serve as one-stop shops to make the drug application process more accessible and efficient, Zacate said

Zacate said the creation of three pharma-zones by the Philippine Economic Zone Authority will allow the entry of more foreign common drugs.

"The FDA will have a role so that pagpasok po ng isang gamot, diretso testing, diretso registration para po magkaroon po ng mabilis at malaki ang lawak ng (when a drug comes in, there will be a direct resting and registration to ensure the swift and expanded) coverage, especially those essential medicines, like for example the generic drugs and the antibiotics that has been approved by the stringent regulatory authority of the different countries," he said

He said the FDA is currently in talks with the Department of Information and Communications Technology and the Anti-Red Tape Authority for the establishment of the one-stop shop.

Veterinary vaccines

Marcos likewise directed the FDA and the Department of Agriculture to address the issues of work delegation to approve the necessary drugs for avian and African swine fever, Malacañang Press Briefer Daphne Oseña-Paez said.

"President Marcos stressed the urgency of veterinary vaccines as this may affect our country's agriculture and nutrition needs,"

Center for Drug Regulation and Research Director Jesusa Joyce Cirunay said the FDA is still waiting for the applications for veterinary vaccines but noted that there are three potential applicants.

"For now, it is still a speculation. But we know that there could be three but unfortunately, we cannot give you the details of these possible three applicants," she said. (PNA)

eTravel registration free of charge, BI reminds travelers

MANILA - The Bureau of Immigration (BI) on Wednesday warned travelers against scammers purportedly charging fees for the electronic travel declaration system or eTravel.

Commissioner Norman Tansingco clarified that registration in the eTravel platform is free of charge, thus travelers should be wary of unscrupulous elements who charges fees from passengers via fake websites.

"The eTravel registration process is absolutely free of charge. We, therefore, advise the traveling public to register only in the government's cial website at https:// etravel.gov.ph," he said in a statement.

Fees allegedly collected from the passengers amount to between PHP3,000 to PHP5,000 when converted to peso as the fees charged by the scammers are usually in US dollars.

The BI chief urged the public to beware of the such fraudulent websites or entities which require any form of online payment.

Likewise, he asked them to report to the Cybercrime Investigation and Coordinating Center (CICC) via its website at https://cicc. gov.ph/report/.

Tansingco issued the warning following reports of passengers at the airports who claim

they have already registered in the eTravel platform and "paid" the supposed fees that were charged to them.

BI officers at the Ninoy Aquino International Airport (NAIA) have reported instances of many passengers who were surprised when informed that they have to register in the eTravel as the digital QR code they presented could not be accessed in the system.

"It is only when they encounter our officers at the airport that these passengers would realize they have been duped by these fraudsters and scammers in the internet," he add-

The eTravel was launched earlier this year, and serves as the single data collection platform for arriving and departing passengers. It establishes an integrated border control, health surveillance and economic data analysis.

It is a joint project of the agency with the Department of Tourism (DOT), the Department of Information and Communications Technology (DICT), the Bureau of Quarantine (BOQ), the Bureau of Customs (BOC), the Department of Health (DOH), the Department of Transportation (DOTr), the Department of Justice (DOJ) and the Nation-
