## **GSIS-Maya partnership to** simplify loan payments

MANILA - Borrowers of the Government Service Insurance System (GSIS) will now have another option to pay for their loans as the state pension fund announced on Wednesday its partnership with Maya (formerly PayMaya).

Through this partnership, GSIS President

and General Manager Wick Veloso said Maya becomes one of the payment choices available within the GSIS Touch, facilitating faster and more secure loan payments.

"We are enhancing our digital payment platforms to provide convenience to our members and pen-

sioners. Maya further simplify the payment process, enabling borrowers to settle their loans conveniently anytime, anywhere," he said in a press release.

Veloso said this partnership is in accordance with Republic Act (RA) No. 8792

# PBM says 8% economic growth target within his term 'doable'

MANILA – President Ferdinand R. Marcos Jr. has expressed confidence that attaining the economic growth target of 8 percent during his term is within his administration's reach.

"Sure. Why not? You know, we plan. We always plan for the ideal. We don't plan for a mediocre result. We plan for a very good result," Marcos said

in an interview with Bloomberg Television's Haslinda Amin at Malacañan Palace in Manila on Tuesday night, when asked if he thinks his administration can achieve the 8-percent economic growth target under his watch.

"And as I said, we just have to adjust along the way, as we continue to transform the economy. But, yes, I think it is, I think it is doable," he added.

Marcos said he is also optimistic that the government would reach its goal of hitting a 6.5 to 7.5-percent growth target for 2024.

He said the government is implementing policies aimed at propelling economic growth and addressing the impacts of economic shocks of the coronavirus pandemic

on the country.

"Much of the policies that we've taken on are really to spur growth. That's part of the most, that's the most important part, because it is only growth that will pull us out of this the morass that was left after the pandemic," Marcos said.

"That seems to be the key. Is it sustainable if we continue down this road, if we defend all

## DBM: P91-B health emergency allowance released

MANILA – A total of PHP91 billion has been released so far for the Public Health **Emergency** Benefits and Allowances (PHEBA) of all health workers since 2021, the Department of Budget and Management (DBM) reported Wednesday.

In a statement, the DBM said it has released to the Department of Health (DOH) PHP12.1 billion for 2021; PHP28 billion for 2022; PHP31.1 billion for 2023; and PHP19.96 billion for

In a letter to the DOH, the budget department noted that it has already released a total of PHP91.28 billion for the PHEBA, consisting of PHP73.26 billion for the Health **Emergency Allowance** (HEA)/One Coronavirus disease 2019 or Covid-19 Allowance (OCA), PHP12.90 billion for the Special Risk Allowance (SRA), PHP3.65 billion for Covid-19 Sickness and Death Compensation, and PHP1.4 billion for other benefits, such as

meal, accommodation, and transportation allowance.

Based on the DOH report, out of the amount, the agency was able to release PHP76 billion.

The two departments earlier agreed that there is a need for the DOH to urgently finalize the computation of the HEA claims in arrears to enable the DBM to determine if additional funding requirements are

necessary despite the cumulatively released **PHEBA** allocations for our health care and non-health-care work-

The DBM suggested that the DOH develop HEA mapping that would capture and present all PHEBA claims and payments by region/health facilities for the period cov-

ered by the benefit.

The inter-agency Development Budget Coordination Committee (DBCC) earlier announced that it aims to achieve an economic growth of 6.5 percent to 8 percent from 2025 to 2028.

The DBCC also set a 6.5 percent to 7.5-percent target for this year. **Peso gain 'a good indication'** 

Marcos also said the peso climbing to a three-month high against the dollar is a "good" indication that the Philippine economy is getting more robust.

"It's an indication of the strength of the economy. There is a downside to it for the Philippines because of our overseas workers where the dollar is worth a little less than it normally would be. But I see it as an affirmation that the economy has grown stronger, and that is, that's one of those obvious tests," he said.

"And the dollar, I mean, of course, because it's a relative, it's a relative measure, the dollar has not depre-

ciated. So if the value of the peso is increasing, then that is a good indication that, again, the economy has gained strength," Marcos added.

Data from Bankers Association of the Philippines data showed that the local unit closed at PHP55.31 per dollar on March 12, strengthening by six centavos from its PHP55.37 finish on March 11, the peso's strongest close in over three months or since its PHP55.30-per-dollar finish on Dec. 7, 2023.

#### Cut rate not yet feasible

Marcos, however, said cutting interest rates could not be done for now, citing that the country continues to deal with inflation.

He said shocks "keep coming in" because core inflation has an impact on the prices of basic commodities, particularly agricultural products.

"We're still battling inflation. Inflation is still our biggest problem," Marcos said. "Perhaps we look at it almost every week to see if it's time to bring down the rates. We are not yet there." (PNA)

### Taiwan pushes for more renewable energy investments

TAIPEI, Taiwan – Taiwan is encouraging cities worldwide to be proactive in promoting renewable energy investments to address the impact of climate change.

This comes as the island's government implements policies to reduce greenhouse gas emissions and transition towards environmentally sustainable energy sources.

"We are promoting a second wave of energy transitions. We need to significantly reduce greenhouse gas emissions," Taiwanese Premier Chen Chienjen said in his address during the Net Zero City Leaders Summit, as part of the 2024 Smart City Summit and Expo at the Taipei Nangang Exhibition Center Hall 2 on Tuesday.

Chen further stated that the renewable energy sector continues to show significant growth amid international efforts to pursue net zero emissions in 2050.

Net zero is the state of balance between producing and removing greenhouse gases from the atmosphere.

"Under the leadership of President Tsai Ing-wen, Taiwan is implementing initiatives towards net zero in 2050. We will continue to work with other cities across the world to achieve net zero goals," according to the high-ranking Tai-

GSIS Touch allows payments for several loans, including GSIS Multipurpose Loan Flex, GFAL-Education Loan, Policy Loan, Emergency Loan and Pension Loan.

Borrowers with e-wallet accounts in Maya, GCash, JuanCash, Starpay, TayoCash, and **USSC Money Services** Inc. (UMSI); as well as bank accounts in AllBank, AUB, Cebuana Bank, Chinabank, Landbank, Metrobank, PNB, PSBank, UnionBank RCBC, and VYBE by BPI, can use the Maya option. (PNA)



# DOT reminds travelers: Patronize accredited establishments

CALAMBA CITY (PIA) – Planning a trip this Holy Week break? Make sure to check into accommodations only accredited by the Department of Tourism (DOT), the agency advised the public.

Jhera San Valentin, DOT senior tourism operations officer said that the accommodations that have been accredited by the agency have undergone stringent safety checks to ensure a quality vacation experience for tourists.

"During vacations, we usually advise tourists to only deal with DOT-accredited accommodations. Since they are DOT-accredited, we can assure that they are safe and will experience standard [hospitality] services," San Valentin explained.

While it is highly encouraged to opt for accredited hotels and accommodations, the

Tourism department noted that there are still tourists who are unaware of whether their lodgings are accredited or meet government standards.

To address this, the DOT Calabarzon regional office maintains its coordination with local government units to monitor complaints coming from guests of accredited and even non-accredited establishments.

She added: "Non-DOT-accredited accommodations are outside of our jurisdiction, but we coordinate with local government units to check on these places. Through our advisories, they can double-check with these facilities."

DOT also banks on their counterparts in local governments to look after these places. San Valentin said: "We usually have a meeting with local tourism officers to remind them to be vigilant and take care of tourists during these times. We do this on top of regular issuances of related Memorandum Circulars."

Expecting the influx of travelers during the long weekend, the Philippine Ports Authority (PPA) and the DOT have started inspecting Batangas Port and other ports of entry in the region to ensure public safety.

The newly-built passenger terminal building at Batangas Port which can hold up to 8,000 passengers is now fully operational, in time for the Lent and the summer season.

Throughout the Calabarzon region, there will be 26,851 police officers and force multipliers who will be deployed for the Holy Week and Summer season, particularly in places of convergence and tourist spots. (PB/PIA-4A)

# Local industries, MSMEs drive economic progress in Laguna

SANTA CRUZ, Laguna (PIA) – Micro, small, and medium enterprises (MSMEs) and multinational corporations are the main drivers of economic progress in the province of Laguna, as the province was recognized for having the largest share of the national Gross Domestic Product (GDP).

In the 2022 Provincial Product Accounts (PPA) data released by the Philippine Statistics Authority (PSA) on Feb. 19, Laguna accounted for the largest share among the 82 provinces in the country with P990 billion value in the 2022 GDP, which accounts for the 5 percent share of the national GDP.

During the Laguna Business Stakeholders Convention and Innovation Summit held at the Cultural Center of Laguna, Sta. Cruz on March 15, Senators Imee Marcos and Mark Villar and local leaders headed by Governor Ramil Hernandez and Vice Governor Karen Agapay showed their appreciation for the contribution of businesses and affirmed their commitment to support the business sector.

Senator Imee Marcos recognized the contribution of the private sector who remained strong and optimistic after the COVID-19 pandemic, and called on everyone to help the local businesses in

regaining their losses.

The senator, who chairs the Cooperatives Committee in the Senate, stressed the importance of collaboration to make the most out of the economic successes that Laguna has achieved.

"We see that all our businesses, whether huge multinational corporations that have seen fit to locate in Laguna, whether these are small and micro enterprises, all of you form the bedrock of the Philippine economy -- driving growth, creating employment, and fostering innovation," she added.

as solar and wind power, promote green industries and low-carbon technologies, and ensure a just transition for workers and communities impacted by the shift to newer sources of energy.

The plan, titled "Tai-wan's Pathway to Net-Ze-ro Emissions in 2050," which was published in 2022, will particularly focus on research and development on green technologies and passing legislation that will strengthen carbon reduction goals.

National Development Council Minister Kung Ming-hsin, meanwhile, is urging the public to change lifestyles to further reduce carbon emissions worldwide.

Among these lifestyle changes being pushed by the Taiwan government to its citizens are promoting public transportation, cycling, walking, and carpooling to reduce dependence on private automobiles; offering incentives for energy-efficient appliances in households; and best practices on waste management, such as composting and promoting recyclable products like shopping bags to encourage responsible consumption.

"If we can change people's lifestyles, we can reduce carbon emissions by 40 to 80 percent. Cities need to take a leading role on this. We want the world to go toward zero emissions in great strides," he said.

Kung said the Net Zero City Leaders Summit and Expo provides a platform for government departments to showcase their net-zero initiatives while research institutions and businesses will exhibit corresponding net-zero emission solutions. He expressed hope that more enterprises would join the net-zero efforts, becoming new drivers for economic growth.

Meanwhile, Dr. James Liao, president of the Academic Sinica of Taiwan's National Academy of Sciences said they are pushing for a science and technology approach towards net-zero carbon emissions in the island.

He said five key technologies can be used to achieve net zero – methane pyrolysis to power, geothermal energy, ocean current energy, high-efficiency solar energy, and biocarbon storage.

Methane pyrolysis is the process where thermal energy is applied to methane to break the chemical bond between carbon and hydrogen, generating hydrogen gas and a solid carbon product with no carbon dioxide emissions.

#### Call to action

At the joint global press conference on the sidelines of the SCSE, resource persons touted the event as an effective way to educate more stakeholders on the importance of smart city and net zero initiatives.

"We are very excited to see new participants, as well as good ideas and innovations, artificial intelligence, smart solutions. The target is to enhance the resilience of communities and the development of these initiatives," Taiwan Smart City Solutions Alliance chairperson Jason Chen said

Meanwhile, Kaohsiung City Deputy Mayor Charles Lin said the event showcases the long-term benefits smart city and net zero initiatives for citizens.

"We want to use this platform as a way to reach the international community. We can be the platform to move the industry across borders," he said, adding that there is a need to "run to zero," which means an urgent need to implement net zero measures.

Asked on how smart city initiatives can help address traffic congestion in the Philippines, Lin said this could be done by continuously educating Filipinos on these measures.

## Laguna prioritizes women's health programs

STA. CRUZ, Laguna (PIA) – The provincial government of Laguna is placing a strong emphasis on ensuring that the physical and mental health of women are attended to as it celebrates the National Women's Month this March.

In an interview with the Philippine Information Agency Calabarzon's Usapang PIA radio program, the province's gender and development focal person, Merell Sales shared that some of their programs include medical drives and free leisure activities intended for the 'stars' of the month-long celebration.

Sales announced that they will hold a pneumococcal vaccination drive for women, together with senior citizens, and Persons With

Disability (PWD).

"Although this is not exclusive to them, we will prioritize these groups because some of them are getting left behind in our vaccination program, especially for pneumococcal vaccines," Sales

The office also partnered with the Laguna Chest Center and the Provincial Health Office to facilitate a free breast examination and pap smear as part of their breast cancer and tuberculosis awareness campaigns.

"They can stop by our office for a free examination. We also launched free chest x-rays for 200 people as part of our advocacy and awareness campaign on tuberculosis," the focal person said.

They also collaborated



with other provincial departments to be able to offer free health and grooming services for women and an awareness drive focusing on skin diseases.

Beyond the monthlong celebration, the GAD office and their partners will advocate for more programs and services, primarily on gender issues, the localized ordinance on safe spaces and teenage pregnancy.

"Board members

from the Committee on Gender and Development [in Sangguniang Panlalawigan] have been supportive in addressing cases of teenage pregnancy in our province. With the support of the Philippine National Police through their Women's Desk, we are working to come up with suggestions on how the Sangguniang Panlalawigan can support our cause." (PB/PIA-

# PH lifters to join final Olympic qualifier in Thailand

MANILA – Hidilyn Diaz will lead the country's last hurrah for Olympic berths in the International Weightlifting Federation (IWF) World Cupscheduled in Phuket, Thailand on March 31 to April 11.

Joining the 2020 Tokyo Olympic gold medalist in the tournament, which is the final qualifier for the Paris Olympics, are fellow Zamboangueñas Rosegie Ramos (W49kg.) and Kristel Macrohon; Lovely Inan of Angono, Rizal (W49kg.); John Febuar Ceniza (M61kg.); Elreen Ann Ando of Cebu City; and Vanessa Sarno of Bohol.

Macrohon and Sarno are both competing in the W71kg. while Diaz and 2023 Hangzhou Asian Games bronze medalist Ando are entered in the W59kg. category.

The athletes, accompanied by Samahang Weightlifting ng Pilipinas president Monico Puentevella and coaches Antonio Agustin Jr. and Diwa delos Santos (Zamboanga City), Nicolas Jaluag (Bohol), and Christopher Bureros (Cebu City), will leave on March 29.

Based on the IWF

Olympic qualifying rankings, Ceniza is 6th; Sarno, 5th; Diaz, 8th; and Ramos, 9th.

Only the top 10 lifters will earn a quota place and bodyweight category through the IWF Olympic Qualification Ranking tournaments for the period Aug. 1, 2022 to April 28, 2024.

The World Cup will be the first tournament for Diaz after sustaining a knee injury at the 2023 IWF Grand Prix II in Doha, Qatar.

She skipped last month's Asian Championships where the Philippines bagged two silver medals courtesy of Ramos and Ando. In the Southeast Asian Games, Sarno won the gold medal in Vietnam (2022) and Cambodia (2023) while Macrohon triumphed in Manila (2019).

Sarno also bagged two medals at the Asian Championships -- a gold in Tashkent, Uzbekistan (2020) and a silver in Jinju, South Korea (2023).

Ceniza, 25, got the silver medal at the 2023 World Grand Prix II in Qatar.

He registered a total of 298kg. despite finishing fourth in snatch (133kg.) and fifth in the clean and jerk (165kg.) -- all new national records. (PNA)



Capability Building Event Strengthens Efforts Against Trafficking and Violence in Cavite

More than 60 dedicated attendees comprising members of the Cavite Provincial Committee on Anti-Trafficking and Violence Against Women and their Children (PCAT-VAWC) together with municipal and city social workers from various Local Government Units (LGUs) in the province, gathered recently, at The Bayleaf Hotel in the City of General Trias for a capability building event.

The discussion sessions were led by distinguished speakers who provided comprehensive understandings and expertise. Atty. Mary Marjorie P. Martin-Chan, Senior Leader of the National Prosecution Development, and International Justice Mission presented crucial topics such as Understanding Online Sexual Abuse or Exploitation of Children, OSAEC Law and its implementing rules and regulations, and Localizing OSAEC Law through local ordinance. Additionally, Mr. Teodulo R. Romo, Jr., Former Assistant Secretary of the Department of Social Welfare and Development (DSWD), shed light on the Gaps and Challenges in Providing Care to OSAEC victims and survivors, emphasizing the necessity of a robust network of support.

The open forum provided a platform for fruitful exchanges and brainstorming on future strategies, followed by a post-test to gauge participants' understanding and retention of the discussed topics.

In her closing remarks, Ms. Precyl T. Ramos expressed gratitude to all participants for their active engagement and reaffirmed the commitment of the Provincial Government of Cavite to continue its unwavering support in combating trafficking and violence.--- OPIO
