DOH expects more does vs. pertussis, vaccine-preventable diseases

MANILA - The Department of Health (DOH) is expecting the arrival of additional doses of vaccines against vaccine-preventable diseases.

In a statement Monday night, the DOH said around three million pentavalent vaccine doses are "arriving at the soonest possible time."

These pentavalent vaccines protect against pertussis, diphtheria, tetanus, hepatitis B, and hemophilus influenza type B.

The DOH has also ordered at least five million more measles-rubella vaccine doses "further to what is available on hand." "Of this quantity, Secretary Teodoro Herbosa has instructed to fast-track the immediate dispatch of one million doses that may be delivered as soon as possible. These will add to the more than 64,400 and 2.6 million doses of pentavalent measles-rubella and vaccines, respectively, already being distributed," the agency said. (*Turn to p. 2*)

La Niña to prolong drought;13 to 16 typhoons to hit PH in Q4

MANILA – The likelihood of La Niña developing by the second half of 2024 will prolong the drought condition until August and delay the onset of the rainy season, Science and Technology Secretary Renato Solidum said Tuesday.

In a Palace press briefing, Solidum said the increasing probability for La Niña's occurrence in the June-July-August season is at 62 percent.

He said that while the El Niño phenomenon will transition from "strong" to "neutral"

April-May-June by season, hotter and drier conditions will still likely persist until August.

Solidum said that in August, around 10 provinces in the country will likely experience drought, one to suffer from dry spell, and two others to feel the effects of dry conditions.

"Because of the possibility of La Niña and the fact na (that it is) dry and hotter, mapu-prolong niyan 'yung mga month na meron pang drought condition hanggang under the dry spell and

August (the months that there will be drought condition will be prolonged until August)," he said.

"So, our actions before were intended ng parang second half lang ng year, [pero] kailangan nating ipagpatuloy hanggang (just for the second half of the year but we have to continue until the) third quarter for the El Niño and drought effect," he added.

As of March 24, around 37 provinces experienced drought conditions, 17 were

13 felt dry condition, Solidum said. Solidum said about 48 provinces will likely be affected by drought by

efforts in allocating spaces that foster economic growth, social well-being, and environmental harmony," the President said in a news release.

The DHSUD, through its Environmental, Land Use and Urban Planning and Development Bureau (ELUPDB), launched the PLANADO Program in February in Cebu City.

PBBM lauds DHSUD's **'PLANADO' Program**

MANILA – President Ferdinand R. Marcos Jr. has conveyed his "utmost support and appreciation" to the Department of Human Settlements and Urban Development (DHSUD) for its unwavering commitment to enhancing land use planning and urban development through

its recently-launched PLANADO (Plan & Do) Program.

President Marcos, in a message of support on Tuesday, touted PLANADO as a strategic response to the goal of establishing "organized and wellplanned settlements" as envisioned under Bagong Pilipinas brand of governance.

"As we harness the advantages brought by urbanization, we must also address the various challenges that go along with it. Thus, it is imperative for us to ensure that our land and resources are responsibly and sustainably managed so that we can safeguard our

affected by the combined effect of El Niño and the preparation for La Niña which would bring in less normal rainfall. Hence, we need to continue doing the operations for El Niño preparedness but also keeping in mind that we need to prepare for La Niña in the second half of the year," he added.

Typhoons to enter

Analiza Solis, chief of the Climate Monitoring and Prediction Section at the Philippine Atmospheric, Geophysical and Astronomical Services Administration (PA-GASA), said around 13 to 16 typhoons are expected to hit the Philippines in the fourth quarter of 2024. Solis said the number of tropical cyclones that will make landfall this year is "below normal" than the average 19 to 20 typhoons that usually enter the country.

Solidum underscored the importance of government and public preparedness given the shorter lead time to take the appropriate actions to mitigate the possible effects of the typhoons that will hit the country.

"People should really make sure that they are always ready," he said. "Itong bagyo, mas malapit, mas kaunti lang ang panahon nating maghanda so dapat handang-handa tayo parati sa mga bagyo (We have less time to prepare so we must always be prepared for typhoons)."

Mitigation efforts

In preparation for the prolonged effects of the combined El Niño and preparation stage of La Niña, Solidum said standby deepwells will be reactivated to ensure the sufficient

water supply during the dry conditions.

This, as Solidum cautioned that the water level of farms in the country would be at the "critical" level by May.

"Kaya itong mga deep well ay makakatulong sa pagbibigay ng dagdag na volume ng water. Alam ninyo naman na hindi natin pinagpatuloy ang paggamit ng mga deep wells sa mga lugar na mayroon ng supply ang dalawang concessionaire (So these deep wells will help in providing extra volume of water. You know that we have not continued the use of deep wells in the areas where the two concessionaires have supply)," he said.

"Iniingatan din natin na gumamit ng deep well kasi kapag sobra ang gamit ng tubig ay may epekto sa ground. So kaya nga mina-manage muna kung kailan ito io-operate at binabantayan nang mabuti (We are also careful in using a deep well because when we use too much water, it has an effect on the ground. So, we first manage when to operate it and we are monitoring it carefully)," he added.

Solidum said the Department of Agriculture is also monitoring the supply of basic commodities and agricultural products to ensure food security amid the El Niño phenomenon. (PNA)

The DOH said its Regional Epidemiology and Surveillance Units (RESUs) at the Centers for Health Development are in touch with local government units.

"We expect updated Pertussis and Measles data to be available in the next few days, and that will guide the nationwide response," it said.

"Accurate and responsible reporting has drawn attention to the need to catch up with vaccination after the pandemic. After all, these are vaccinepreventable diseases," it added.

The DOH said Herbosa and a team of DOH officials and staff are in the field coordinating with local Public Health Emergency

"PLANADO" is an initiative to streamline and digitalize land use and urban planning and development processes, with the aim of fostering the creation of smart, green, resilient, and inclusive human settlements.

Anchored on the national housing and urban development strategic plan framework, the program intends to achieve two primary outcomes - to eliminate the backlog on Comprehensive Land Use Plans and Provincial Development and Physical Framework Plans by 2028 and promote urban develOperations Centers following the orders of President Ferdinand R. Marcos, Jr.

"We ask for the public's patience with information releases for security reasons, and to minimize disruption while the outbreak response is carried out," the DOH said.

The interior ministry said residency fines are set at two Kuwaiti dinar per day, equivalent to about PHP365.

The DMW said the Kuwaiti government will allow overstaying foreigners to leave without paying immigration fines, but those with travel bans and pending criminal complaints can depart only after the cases are resolved.

"Overstaying foreigners who depart Kuwait during the amnesty period may

return after complying with entry requirements. After the grace period, those who refuse to depart will be subject to arrest and permanent deportation," the DMW said.



MANILA – The Philippines and India have agreed to accelerate maritime cooperation and hold an inaugural dialogue soon, which will cover potential partnerships from marine environment protection down to security.

The Track 1 or government-to-government maritime dialogue was formally announced by Foreign Affairs Secretary Enrique Manalo after his bilateral meeting with visiting Indian Foreign Minister Subrahmanyan Jaishankar on Tuesday.

"Our cooperation is growing in the sense that not only are we pursuing newer activities, such as training and joint committee meetings, but also exploring other ways where we can con-

DMW to assist overstaying **OFWs in Kuwait avail of** amnesty program

MANILA – The Department of Migrant in the repatriation of Workers (DMW) has overstayassured ing overseas Filipino workers who wish to avail of the Kuwaiti government's amnesty program that the Philippine government is ready to assist them.

In a news release on Tuesday, the DMW said that its Migrant Workers Office (MWO) in Kuwait is ready to provide information on the process and steps to be followed to avail of the amnesty, including securing new passports at the Philippine embassy in case they are expired.

Overstaying Filipinos without a valid passport but who intend to apply or regularize their stay in Kuwait will need to apply for a new passport during the three-month amnesty period from March 17 to June 17.

DMW will also help overstaying OFWs who will choose to return home.

"As of March 24, 2024, MWO-Kuwait provided advice to around 500 OFWs regarding their queries on Kuwait's amnesty program," the release read.

On March 14, the Kuwait Interior Ministry announced the threemonth amnesty period for foreigners with residency violations, specifically those whose civil identification cards have expired or been canceled.

Under the amnesty, foreigners who illegally stay in Kuwait, including their family members, but wish to continue their residency may adjust their immigration status provided they pay for overstaying fines and comply with other re-(Back to p. 2)

No flight disruptions during Holy Week, CAAP assures

MANILA – The Civil Aviation Authority of the Philippines (CAAP) assured on Tuesday there will be no flight disruptions this Holy Week, when passengers flock to the airports for the holidays.

Contingencies are in place, and all systems of the Communications, Navigation and Surveillance/Air Traffic Management (CNS/ ATM) are working, it said in a statement.

It can be recalled that hundreds of flights got canceled and delayed, and thousands of passengers were affected when the CNS/ATM had a system glitch on Jan. 1, 2023.

"We have to ensure that all equipment are operational, all personnel are present, and can attend to any issues we may face during Holy Week. With that, we see that CAAP is ready, and we thank you for preparing for this Lenten season," Transportation Secretary Jaime Bautista was quoted as saying when he inspected CAAP's CNS/ATM on Tuesday.

According to CAAP, the CNS/ATM enables aircraft to transmit accurate locations for takeoffs, landings, and air traffic control.

This is being operated by personnel in three shifts for 24/7 operations.

DSWD assistance

The Department of Social Welfare and Development (DSWD) said its disaster management and response teams and six field of-



fices are ready to respond to any eventualities that may arise during Holy Week.

"Under the directive of Secretary Rex Gatchalian, all Quick Response Teams (QRT) of the department will be on standby status and ready for deployment should any event necessitate their intervention," DSWD Assistant Secretary for Disaster Response Management Group (DRMG) Irene Dumlao said on Tuesday.

"Our National Resource and Logistics Management Bureau (NRLMB) is also on top of replenishing food and non-food items necessary for resource augmentation to local government units, whenever necessary," she said.

Dumlao said the department is closely coordinating with the Philippine Atmospheric, Geophysical and Astronomical Services Administration (PAGASA) for relevant weather updates and information.

She said the DSWD has PHP388.3 million standby funds and 1,214,479 family food packs in strategic areas around the country in time for the week-long observance. "We urge the public to stay safe, remain vigilant, and heighten awareness to avoid emergencies, particularly during the Lenten Season break," she added.

Ensuring smooth travel

The Department of Public Works and Highways (DPWH) will also reactivate its road emergency assistance project to assist motorists and commuters this Holy Week.

In a statement Tuesday, Secretary Manuel Bonoan said that under the 'Lakbay Alalay' Program, motorist assistance teams will be stationed along strategic national roads and shall be mobilized round-the-clock from Maundy Thursday to Good Friday.

The 'Lakbay Alalay' teams are composed of DPWH uniformed field and crew personnel with maintenance equipment on standby at standard navy blue-colored tents on strategic parts of national roads.

Tax breaks for stores offering bigger goods discounts to seniors eyed

MANILA - A lawmaker on Tuesday appealed to the Bureau of Internal Revenue (BIR) to consider granting tax credits to supermarkets and other retail outlets required to give price cuts in conjunction with the implementation of the higher discounts monthly on essential grocery items purchased by senior citizens and persons with disabilities (PWDs).

Camarines Sur Rep. Luis Raymund Villafuerte Jr. said granting tax breaks or deductions to supermarkets and other retail stores would ensure greater compliance with the expanded discount scheme, which hiked the weekly cap covered by the 5-percent discount from PHP1,300 to PHP2,500.

"Such a tax break would spell financial relief for them—and help ensure their greater compliance with this new House-initi-
