# **DOH** raises alert on pertussis in Calabarzon

CALAMBA CITY (PIA) - The Department of Health (DOH) in CALABARZON has activated its Incident Management Team (IMT) to augment the needs of local health offices following the declaration of a code blue alert in the region against pertussis.

In a Code Blue Alert,

LGUs and health facilities are expected to provide surveillance reports on pertussis cases to the Incident Command Systems to facilitate timely updates and data analy-

Regional Disaster Risk Reduction and Management in Health (RDRRM-H)

officer-in-charge, Joehl Francisco, urged local health offices to actively report suspected and confirmed cases of pertussis within 24 hours to prevent the virus from further spreading.

# NFA bent on securing rice stocks despite competition with traders

MANILA - The National Food Authority (NFA) expressed confidence on Tuesday in securing the country's rice buffer stock despite local competition with traders.

In an interview, NFA administrator cer-in-charge Larry Lacson said there is no need to worry considering the high productivity of rice amid the peak harvest season.

"Confident tavo na madadagdagan iyong ating stocks. Makakahabol pa tayo sa harvest season na ito (We are confident that

we will increase our stocks. We will be able to catch up this harvest season)," he said.

The NFA needs to secure around 300,000 metric tons (MT) of rice for its nine-day minimum national rice buffer stock, using the buying price set at PHP19/kg for wet palay (unhusked rice) and PHP23/kg for dry

Meanwhile, competitive traders are buying palay at a price range of PHP25 to PHP27/

5 percent accomplishment lang, ngayon naging 6.48 percent (The procured [volume] increased. Before it's only 5 percent accomplishment, now it has reached 6.48 percent)," Lacson said, citing the first quarter

volume purchase.

The Department of Agriculture (DA) earlier projected around 1.1 percent increase in rice productivity,

equivalent to a total production of 4.78 MT for the dry season.

#### Possible measures

Lacson, meanwhile, assured that the NFA is exploring other options to effectively play with traders.

"May mga measures kaming ikinakasa so we can reach or at least lumapit sa target natin (We are rolling out measures so we can reach or get near our targets). We are hoping that within this week,

we can come up with that," he said.

Lacson also mentioned an increase in the buying price, which shall further benefit local farmers.

"That's a possibility. Pero marami iyan ha, hindi lang isang solusyon para sa isang problema, marami (But we have many [options], not one solution per problem, multiple [considerations])," Lacson said.

# New mega health center seen to decongest hospitals in Cavite

CAVITE CITY (PIA) - A new 100-bed 3-storey mega health center in Cavite that will cater to the needs of a growing population in Cavite's 1st district aims to ease overcrowding in hospitals.

The Cavite City Medcare Mega Health Center, located in Barangay 28, Sea Breeze, Cavite City will provide free, accessible, and quality public health care services to Caviteños through its medical outpatient, surgical, diagnostic, birthing, emergency, and pharmacy services.

Health Secretary Dr. Teodoro Herbosa together with DOH Assistant Secretary Dr. Ariel Valencia, led the turnover ceremony,

which was graced by Cavite City 1st District Rep. Ramon Jolo B. Revilla III, Cavite City mayor Denver Reyes-Chua, Cavite board member Ram Revilla-Bautista, and other city officials.

Cavite's 1st district is composed of Cavite City and the towns of Noveleta, Kawit, and Rosario.

Sec. Herbosa assured the public that the DOH will continue its commitment to im-

proving the quality of

health services in the

country, and will support the efforts of local government units and its leaders to alleviate poverty through the 8-point action agenda

ANKARA – Oil prices rose on Tuesday after hopes fell that negotiations between Israel and Hamas would lead to a ceasefire in Gaza amid concerns the lingering conflict could disrupt supplies from the Middle East, a key oil-producing region.

International benchmark Brent crude traded at USD90.93 per barrel at 12 noon local time (0900GMT) on Monday, up 0.60 percent from the closing price of USD90.38 per barrel in the previ-



ous trading session.

American benchmark West Texas Intermediate (WTI) traded at USD86.92 per barrel at the same time, up 0.56 percent from the previous session, which closed at USD86.43

per barrel.

Oil prices spiked as the conflict between Israel and Palestine and Russia-Ukraine war continued to put global energy supply routes at risk.

In a statement, LT-FRB Chair Teofilo Guadiz III said the extension on consolidation granted by the President would be the

President Ferdinand Marcos Jr. on Sunday said his administration is taking a multipronged approach to address Metro Manila's chronic traffic conges-

In a vlog posted on his official Youtube page (link here), the President emphasized the need for both infrastructure development and a cultural shift towards road discipline.

Marcos recognized the limitations of solely relying on expanding Metro Manila's infrastructure, Marcos plans to develop surrounding provinces like Bulacan, Pampanga, Cavite, and Laguna.

"Metro Manila is congested. That's why we are planning to develop nearby areas and cities. We want to develop Bulacan, Pampanga, Northern provinces, Cavite, Laguna, and other Southern provinces," he added.

This aims to create economic opportunities outside the capital, potentially reducing commuter traffic.

The government, Marcos said, remains committed to ongoing construction of bridges, flyovers, subways, and train systems to improve the capacity of Metro Manila's transportation network.

Moreover, the President said that he welcomes public participation and invited netizens to share ideas through the "Com-

fleet management as the second phase.

In January, Marcos extended the consolidation deadline for PUVs after clamors

Marcos also urged Filipinos to prioritize traffic rules and courtesy on the road.

"What we Filipinos lack the most on the road is discipline. We should adhere to traffic rules," Marcos said.

"Old habits still persist even if there are newly built roads. It seems like we're always running out of streets," he added.

"It won't matter if our roads are new if our attitude does not change," he further

He believes undisciplined driving habits, such as stopping in the middle of the road or ignoring bike lanes, significantly contribute to congestion.

The President called for a change in behavior, emphasizing gratitude for fellow drivers and respecting emergency vehicles.

"When someone gives

way to us, learn how to say 'Thank you'. Even just a little wave is a big deal," he said.

Marcos also acknowledged the importance of leading by example. He stressed that government officials also have a responsibility to follow traffic laws.

"It is not in our oath as public officials to violate traffic rules. The government will lead all agencies in being disciplined while on our roads," the President said.

He said he aims to dismantle the notion that disregarding traffic rules is a privilege for those in power.

"Abusing and disregarding traffic laws is not a privilege of those sworn to serve the nation," he emphasized.

By combining infrastructure advancements with a focus on public discipline and participation, the government hopes to alleviate commuter woes and create a more efficient transportation (JCO/PIAsystem. NCR)

Quantum Geographic Information System (QGIS) Tutorial and IEC Campaign Equips Communities in Cavite with Essential Disaster Preparedness Knowledge

In an effort to enhance disaster preparedness and resilience in the communities of Cavite, a comprehensive Quantum Geographic Information System (QGIS) Tutorial and Information Education and Communication (IEC) Campaign was conducted recently. Organized by the local government units in partnership with various agencies and experts, the event aimed to equip selected personnel and students with essential knowledge on hydrometeorological hazards and flood mitigation measures.

The first leg of the event, recently, featured a QGIS Tutorial attended by personnel from the City Government of General Trias, particularly from the offices of City Disaster Risk Reduction and Management, Planning and Development Coordinator, and Engineering. The Barangay Officials of Bacao I and II and Barangay Navarro had the opportunity to learn the structural and non-structural measures of flood mitigation presented by Mr. Koji Kusaka and Ms. Emelita "Mimi" Estaris from Cavite Industrial Area – Flood Risk Management Project (CIS-FRIMP), respectively. Held at the Audio-Visual Room, General Trias Sports Park in Barangay San Tiago, City of General Trias, the session also featured enlightening presentations on Understanding Weather Systems and Warning Information by Ms. Vivian Gay Agassid, and Understanding Floods and the PAGASA Flood Warning System by Ms. Rosalie Pagulayan, both Weather Specialists from the Department of Science and Technology - Philippine Atmospheric, Geophysical, and Astronomical Services Administration (DOST-PAGASA).

Recently, an IEC Campaign was conducted for selected students of Noveleta Elementary School in Barangay San Rafael, Noveleta, Cavite. These young learners were provided firsthand insights into floods, tropical cyclones, rainfall, storm surges, and other hydrometeorological hazards by experts from DOST-PAGASA. Furthermore, members of the CIA-FRIMP, Mr. Shuji Kaku and Ms. Mimi Estaris, offered valuable perspectives on flood mitigation measures, particularly emphasizing the implementation of non-structural measures (NSM) in Cavite. This educational session was crafted to harmonize understanding across communities and enlighten the younger generation on effective disaster preparedness measures.

Key agencies involved in the event included DOST-PAGASA, Department of Public Works and Highways Unified Project Management Office – Flood Control Management Cluster (DPWH UPMO-FCMC), Department of Education – District of Noveleta, and Japan International Cooperation Agency (JICA). Their collaborative efforts with the local government units, Local Disaster Risk Reduction Management Officers (LDRRMOs), and City/Municipal Planning and Development Coordinators played a pivotal role in the success of the initiative.

The QGIS Tutorial and IEC Campaign exemplify the commitment of stakeholders to build resilient communities and enhance disaster preparedness in Cavite. By equipping participants with essential knowledge and practical measures, the event contributes to safeguarding lives and properties against the impact of natural disasters.
