Social protection among top priorities in PBBM-approved 2025 NEP

MANILA - The Department of Social Welfare and Development (DSWD) will continue to fulfill its mandate to develop, implement and coordinate social protection and poverty-reduction solutions for the poor, vulnerable and disadvantaged, a senior official of the agency said on Thursday.

DSWD Assistant Secretary for External Assistance and Development Juan Carlo "JC" Marquez said social protection is among the top priorities in proposed 2025 National Expenditure Program (NEP) which President Ferdinand R. Marcos Jr. approved on July 2.

"The DSWD, under

the leadership of Secretary Rex Gatchalian, assures the public that our ongoing initiatives are in line with the priorities of the Marcos administration," Marquez said during the weekly media forum at the DSWD central office in Quezon City.

DA:TROon EO 62 may cause delay in imports, lowering retail rice

MANILA – The Department of Agriculture (DA) on Thursday said an issuance of a temporary restraining order (TRO) against the implementation of Executive Order (EO) 62 might cause delays both in the importation of rice and the expected lowering of retail rice prices in local markets.

The DA made the statement shortly after agricultural groups filed a petition before the Supreme Court, praying for a TRO against EO 62, alongside the demand for the due course and its declaration of nullity and unconstitutionali-

EO 62 indicates the lowering of tariffs on imported rice from 35 to 15 percent, which is set to take effect on July 6.

"In general, kung magkaroon man ng (if there will be a) TRO, the TRO is not good for our rice stocks kasi (because) it will cause delay on the importation ng ating mga private importers kung hanggang kailan man iyon na (of our private importers on until when will be the) TRO," Agriculture Assistant Secretary Arnel de Mesa said in a press

briefing in Quezon of prices in the market City.

De Mesa said a TRO might cause a "hesitation delay" on the part of importers which will also affect the country's national rice stock.

Despite this, De Mesa assured consumers that "the government is always ready" for the possible implications of a TRO considering the downward trend of rice prices in the global market.

"Iyong presyo sa international market ay patuloy na bumababa at inaasahan natin ang India na maalis na rin iyong ban (The prices in the international market continue to decline and we are expecting India to remove its ban)," he said.

The prices of retail rice, however, are expected to drop by PHP6 to PHP7 per kilogram under EO 62.

DOH augments health services in Calabarzon with new urgent care mobile centers

CALAMBA CITY (PIA) – The Department of Health Center for Health Development (DOH-CHD) CALABARZON has announced a new program aimed at decongesting hospitals and widening the coverage of state-provided healthcare throughout the region.

The Bagong Urgent Care and Ambulatory Services (BUCAS) Centers will be established in areas without DOH-run hospitals inadequate or with healthcare facilities, providing immediate and primary care, including outpatient and diagnostic services, regardless of geographical barriers.

During the Kapihan sa Bagong Pilipinas on July 2, DOH Assistant Secretary and concurrent Calabarzon Regional Director Dr. Ariel Valencia said that the main goal of BUCAS centers is to lessen hospital visits for patients, especially if not for urgent care needs.

"The idea of BUCAS is to fill in the gaps between primary care and apex hospitals. If

As of Wednesday, the prevailing price range of imported regular milled rice in Metro Manila ranges from PHP47/kg. to PHP51/ kg. and PHP52/kg. to PHP55/kg. for wellmilled rice, according to DA Bantav Presvo (Price Watch).

The local regular milled rice, meanwhile, is set at PHP48/ kg. to PHP52; and PHP48/kg. to PHP55/ kg. for local wellmilled rice.

Meanwhile, the National Economic and Development Authority said it was aware of the decision by certain farmers' groups to initiate legal proceedings against the implementation of EO 62.

"We are currently awaiting the receipt of the petition and wish to express our utmost respect for the legal process. Please be assured that NEDA, through the Office of the Solicitor General, will respond appropriately in due course," said NEDA Secretary Arsenio Balisacan. (PNA)

policy guidance, social protection is among administration's priorities alongside food security, healthcare, housing, disaster resilience, infrastructure, digital connectivity, and energization.

Social protection is one of the expenditure priorities that are geared towards achieving the President's 8-Point Socioeconomic Agenda and the Philippine Development Plan 2023-2028.

The NEP, once approved by both houses of Congress, will be known as the Gen-**Appropriations** Bill (GAB) and will eventually become the General Appropriations Act (GAA) once signed into law.

Under the approved NEP amounting to PHP6.352 trillion, the DSWD's proposed budget for 2025 is PHP229.3 billion.

Almost half of the DSWD 2025 budget goes to the Pantawid Pamilyang Pilipino Program (4Ps), the

government's ship program for poverty alleviation that provides cash grants to household-beneficiaries to make them self-sufficient.

"Recently, we partnered with private agencies in digitizing the disbursement of cash grants to 4Ps beneficiaries and other social protection programs of the Department," Marquez said.

Under the Human Capital Development, establishment and upgrading interoperable social registries and targeting systems for vulnerable sectors, and shifting to digital payments of cash transfer programs are some of the presented plans for social protection.

Marquez said achieving a universal, modern, and integrated social protection system, and developing and implementing adaptive and shock-responsive interventions are also included in the priorities under social protection.

New DepEd chief wants 'undelivered' K-12 employability addressed

MANILA - Incoming Department of (DepEd) Education Secretary, Senator Juan Edgardo "Sonny" Angara, on Wednesday urged government agencies and companies to hire Senior High School (SHS) graduates in jobs that require simple tasks.

Angara, who was appointed by President Ferdinand R. Marcos Jr. as new DepEd chief, said most job qualifications in the country still demand the completion of college degrees, making the promise of K to 12 employability "undelivered.'

"Sa ngayon, hindi totoo iyan, hindi nangyayari iyan (For now, that's not true, it's not happening)," Angara said in a radio interview, referring to the promise of K to 12 employability.

"Hindi lang naman mga eskwelahan ang may kasalanan diyan. Iyong mga employers, o ahensya mismo, lagi nila nilalagay na college graduate. Kung simple lang naman ang mga gawin, bakit college graduates (This is not solely the fault of schools. The employers and even government agencies, they always demand [applicants] to be college graduates. If the tasks are simple, why college graduates)?'

Angara will replace resigned Education Secretary, Vice President Sara Duterte,

who earlier launched a review of the K to 12 curriculum due to some challenges since its official launch in 2012.

"Gusto nating i-convince ang ating mga (We want to convince our) employers, even starting with the government agencies, iyong mga lower-level jobs po, dapat ay K to 12 graduates in certain competencies or certain skills na tinuro sa kanya, dapat sapat na po iyon (that in the lower-level jobs, certain competencies or certain skills taught to K to 12 graduates must be enough)," he said.

Angara said he would wait for the result of the ongoing K to 12 curriculum review to identify the needed revisions and address the skills mismatch and employability challenges.

Meanwhile, DepEd spokesperson Michael Poa said once enacted, Senate Bill 2367 or the Batang Magaling Act, which seeks to revise the eligibility requirements for government employment in consideration of SHS graduates, would help boost their employability, with government agencies setting the example of applicable qualification standards.

Angara also called for a holistic approach in terms of improving the education system, including a more flexible option, such as lad-

derized education.

Cavite Animal Health Congress 2024: Advancing Veterinary Knowledge and Practices

Recently, the Cavite Animal Health Congress 2024 was held at Rolle Hall, Cavite State University, Indang Campus. Organized by the Office of the Provincial Veterinarian, under the leadership of Dr. May M. Magno, the event brought together veterinary experts, agriculturist, and participants from various cities and municipalities across Cavite.

The program began with an inspirational message from Dr. Melbourne R. Talactac, Vice President for Research & Extension at Cavite State University, who warmly welcomed the attendees and set a positive tone for the day. Dr. May M. Magno then provided the rationale for the seminar, highlighting the importance of collaborative efforts in advancing animal health in the region.

The morning session featured several esteemed speakers: Dr. Maria Shella G. Ordinario, the National Focal Person for the Rabies Program, provided updates on the National Animal Rabies Program, emphasizing the ongoing efforts to combat rabies; Mr. Jomell V. Mojica, RN, MPH, Regional Rabies Program Coordinator, discussed the latest developments in human rabies and the National Rabies Prevention and Control Program; and, Dr. Alvin William A. Alvarez, Department Chair of Clinical and Population Health at the College of Veterinary Medicine and Biomedical Sciences, presented his research titled "Towards a Rabies-free Cavite: Assessing Public Knowledge, Attitudes, and Practices," shedding light on public perceptions and practices related to rabies prevention.

The afternoon session kicked off with a product presentation by Dr. Razzel Raymond O. Urriza, DVM, from Pet Options, showcasing products designed to improve daily pet care. Subsequent speakers included: Dr. Mark Anthony S. Barreyro, Veterinarian II and National African Swine Fever Luzon Cluster Coordinator, who reviewed the African Swine Fever (ASF) program and vaccination guidelines; Mr. Robert F. Liao, Agriculturist II at National Veterinary Quarantine Services, who discussed quarantine updates, local shipping permit requirements, and common violations encountered during transport; and, Ms. Jamille Kay T. Malate, Science Research Specialist II at the Office of the Undersecretary for Livestock, who detailed the National Urban and Peri-urban Agriculture Program (NUPAP).

The seminar concluded with closing remarks from Dr. Rezin C. Bahia, Dean of the College of Veterinary Medicine and Biomedical Sciences. Dr. Bahia expressed his enthusiasm for the knowledge shared during the event and looked forward to the next Cavite Animal Health Congress in 2025.

The Cavite Animal Health Congress 2024 was a resounding success, underscoring the commitment to enhancing animal health standards and fostering a rabies-free Cavite. The collaborative efforts of the participants and organizers played an important role in the event's success, contributing to the ongoing advancement of veterinary practices in the province.

Participants, comprising community members, local officials, and environmental advocates, worked tirelessly to plant more than 400 seedlings. The diverse mix of fruit bearing and non-fruit bearing trees promises to bring both ecological and economic benefits to the area.

'Back to basic'

Angara underscored the need to bring back the country's education system to "basic".

He made the remark as the Philippines ranked in the bottom 10 out of 81 participating countries in the 2022 Programme for International Student Assessment (PISA), particularly in areas of reading comprehension, mathematics, and science, and even second to the last in creative thinking.

ing.
"Iyong curriculum, gawin nating simple tapos siguro iyong pagbabasa, I think back to basic ho tayo (Our curriculum, we should make it simple and the reading, I think we should go back to basic)," he said.

He said DepEd may improve learners' capacity by strengthening "the building blocks" of knowledge and streamlining its programs.

"Halos nandoon tayo sa dulo, especially sa mga kapasidad natin sa reading, sa agham, at saka sa matematika, pababa ho iyan.... Siguro iyon nga, medyo naging cluttered iyong curriculum natin, marami masyadong tinuturo sa mga bata (we're almost at the bottom, especially in reading, science, and mathematics capacity, it's dropping... Perhaps, curriculum became cluttered. A lot of things are being taught to the kids)," he said.

He said a streamlined method would mean changing styles into a more focused teaching approach, alongside redirection of where to find credible learning tools amid the rise of artificial intelligence, just like in other well-performing countries.

Besides reading, mathematics, and science, Angara also mentioned the need to discuss history and good

manners in schools.

Increasing teachers' ben-

Asked if a PHP50,000 entry-level salary may be feasible, Angara expressed his support not only in increasing the benefits but also in reducing the workloads of teachers in public schools.

"Tayo po 100 percent in support po tayo for all teacher increases dahil alam natin apektado po iyong kalidad ng edukasyon kapag inspired iyong mga teachers and you attract iyong pinakamagagaling (We are 100 percent support for all teacher [benefit] increases because we know that the quality of teaching is affected if the teachers are inspired and you attract the most excellent), the best and the brightest," he said.

Angara, however, said the salary increases are subject to various considerations and coordination with the Department of Budget and Management (DBM), Department of Finance (DOF), and Congress, among others.

In terms of workloads, Angara said teachers should have more time in teaching and dealing with learners rather than in administrative tasks.

Earlier, Duterte approved DepEd Order No. 5 to ensure more streamlined and classroom-based work for public school teachers, rationalizing their workload and removal of their administrative tasks.

Under DO No. 5, teachers shall render eight hours of service per day, with six hours devoted to actual classroom teaching and two hours for remaining ancillary tasks, which may be done inside or outside school premises.

It also indicated the grant of overtime pay and overload pay for teachers. (PNA)
