Labor group appeals P35 minimum wage hike in NCR

MANILA – A labor group on Wednesday filed an appeal before the Regional Tripartite Wages and Productivity Board-National Capital Region (RTWPB-NCR) to reconsider its bid of a PHP597 wage increase, to make the daily minimum pay rate in Metro Manila PHP1,207.

"Wherefore, premises considered, it is respectfully prayed for the NCR-Regional Wage Board to consider its July 1, 2024 declaration and declare for the living wage in the region as prayed for by the petitioner. The said July 1, 2024 declaration of the new minimum (wage rate) in the region was

marred by tantamount abuse of discretion on the member of Regional Wage Board," the Unity for Wage Increase Now (UWIN) said in its memorandum of appeal.

Senate building cost could balloon to P27-B due to inflation

MANILA – The cost of the new Senate building project could climb to PHP25 billion to PHP27 billion due to inflation.

At the Senate Committee on Accounts inquiry on Wednesday, the Department of Public Works and Highways (DPWH) disclosed that the total estimated cost of the project was based on 2021 rates and does not reflect the present cost of materials.

"Iyong sinubmit namin na 'yon, aaminin namin na 'yon po ay hindi updated. So, sa term niyo pwede nating i-update 'yon (The one that we submitted, we will admit it, was not updated. However, we can update that under your term)," DPWH Buildings and Special Projects Management Cluster project director Soledad Florencio told Senate Committee Chairperson Alan Peter Cayetano.

Florencio did not provide an estimate but former DPWH Undersecretary Antonio Molano Jr. said the updated construction inflation rate could reach at least 20 percent to 25 percent.

"To my estimate, from the time the project was bid out, more or less 20 to 25 percent," he said.

PBBM to distribute assistance to El Niño farmers in Calabarzon

BATANGAS CITY (PIA) President Ferdinand R. Marcos Jr. is expected to lead the distribution of the Presidential Assistance for Farmers, Fisherfolk, and their Families to an initial 4,740 farmers and fisherfolk in the provinces of Laguna, Cavite, and Batangas, who were affected by the El Niño phenomenon, on Thursday, July 11.

In a press briefing, Jose Maria Villarama II, Task Force El Niño spokesperson and Presidential Communications Office Assistant Secretary for Radio, announced that the Presidential Assistance for Farmers, Fisherfolk, and their Families will be distributed to 82 provinces.

"The President aims to provide assistance from his office to all 82 provinces in the Philippines," Villarama said.

Launched last May 9 in Zamboanga Peninsula, the Presidential Assistance for Farmers, Fisherfolk and their Families has provided aid amounting to Php 10 billion, which includes farming inputs and equipment.

"To date, we have distributed assistance amounting to Php10 millionin cash and inkind worth of assistance. This includes farm equipment and farm inputs, fertilizers, seeds for High-Value crops for farmers and fisherfolk, among other equipment for aquafisheries,"

Depending on the number of beneficiaries identified by the Department of Agriculture (DA) and cross-checked with the Department of Social Welfare and Development (DSWD), each province may re-

CFO vows full digitalization by 2025

MANILA – The Commission on Filipinos Overseas (CFO) has vowed to go fully digital by 2025 as it assures Filipino emigrants that the Philippine government has programs and services to support them.

"As per the instruction of PBBM (President Ferdinand R. Marcos Jr.), all our front-line services will be fully digital po in a way that hindi na kail-

angan ng mga CFO clientele na magpunta onsite (CFO clientele need not go onsite)," CFO chairperson Secretary Romulo Arugay said in an interview on Wednesday.

This is in line with the CFO's goal to expand and strengthen the agency to serve the growing number of Filipinos who leave the country to settle abroad better.

cluding the cost of land plus the inflationary cost)."

The current cost of the project totals PHP23.37 billion, at least PHP8.9 billion of which was for the building's core and shell, PHP2.5 billion for the fit-out, PHP10.33 billion for the works to complete, and PHP1.6 billion for the land acquisition.

In the latest hearing, a heated exchange ensued between Cayetano and Senator Nancy Binay over the total construction cost, with the latter arguing that the amount was only PHP21.73 billion, excluding the land.

At the July 10 inquiry, Senator Francis Tolentino quipped, "So, we're now talking of a figure higher than the previously disagreed upon figure between PHP21 to PHP23 (billion)." Binay did not attend.

Cayetano, at the start, apologized to the public, saying the argument between him and Binay was an issue they would deal with

"We just all have to remind ourselves: eyes on the ball. What is the ball? Simple lang, paano matapos 'yong project na to (It's simple – how to finish this project)," he said.

Meanwhile, he instructed the DPWH to recompute the cost based on current market prices and create an efficient workflow organizational chart that maintains high construction standards. (PNA)

ceive between Php10 million up to Php50 million to fund the distribution of assistance.

Villarama added: "Each identified beneficiary receives Php10,000. The President acknowledges that this amount is small for a farmer whose livelihood has been damaged. However, the President emphasizes that this is seed money to help the farmers start anew," he stressed.

Villarama clarified that while the financial assistance will be used by affected farmers and fisherfolk for their livelihoods, the beneficiaries also have the freedom to spend the cash on their basic needs.

"The President hopes that the financial assistance will be used by the affected farmers and fisherfolk to revive their livelihood."

The official added: "However, during the peak of El Niño, many indeed lost their livelihoods, sources of income, and even food for their families. But if they use it for their food and their other needs, they have the discretion to do so."

Distribution of aid to additional beneficiaries, entrusted to local government units, will be publicized through Facebook Live to ensure transparency.

"To ensure that the Provincial Government will be transparent in identifying [the beneficiaries], the distribution of cash aid to additional beneficiaries will be aired through Facebook Live within 30 days of receiving the fund." (PB/PIA 4A)

The Philippines was chosen over seven other contenders namely

Antigua and Barbuda, Armenia, The Bahamas, Barbados, Eswatini, Togo, and Kenya.

The 26-member LDF Board selected the Philippines as the host during its second board meeting in Songdo, South Korea on July 9, 2024.

The DOF said that by hosting the LDF Board, the Philippines will play a leading role in helping attract significant support from developed countries and development partners to provide financial concrete contributions in averting, minimizing, and addressing losses and

PH on right track to taming food inflation -NEDA

MANILA – The National Economic Development Authority (NEDA) is "quite optimistic" that food inflation will start to decelerate in the coming months.

"[Are] better days ahead? Yes, I am quite optimistic that we are moving in that direction," NEDA Secretary Arsenio Balisacan said in a Palace press briefing Tuesday.

Balisacan said the high food inflation recorded in June 2024 was due to "a confluence of factors," such

as the extreme drought due to the El Niño phenomenon, the unsteady global supply, and the African swine fever.

"So, those are some of the things that have happened in the past and our efforts in the past few months have been to address those issues particularly in agriculture," he said.

Balisacan also cited the increase in the proposed 2025 budget of the Department of Agriculture which will help stabilize food prices.

The increase in the budget of agriculture is "very high" compared to many other sectors, the NEDA chief said.

The country's headline inflation decelerated to 3.7 percent in June from 3.9 percent in May, well within the government's 2 percent to 4 percent target.

Meanwhile, food inflation rose to 6.5 percent from 6.1 percent in May due to higher prices of vegetables, meat, and corn. (PNA)

SolGen: EO 62 implementation may proceed sans TRO

MANILA – The Office of the Solicitor Wednesday said the implementation of Executive Order No. 62 lowering the tariff on imported rice and other products may proceed until otherwise restrained by the Supreme Court (SC).

"We do not know whether the Supreme

Court will issue a Temporary Restrain-General (OSG) on ing Order (TRO) or not in the days to come. I suppose the SC justices are also presently evaluating whether any injunctive relief is necessary. As far as the government is concerned, however, the EO will be implemented unless temporarily restrained by the

SC," Solicitor General Menardo Guevarra told reporters.

"We have received a copy of the petition, but we have not received a copy of any SC resolution requiring us to comment. Be that as it may, the OSG is presently studying the legal issues involved," he said.

PH human rights consultation rolls across country

Cavite (PIA) - Rediscussions gional for the drafting of the country's new human rights plan have continued as the Presidential Human Rights Committee Secretariat (PHRCS) conducts the third leg of the joint regional consultations in the South Luzon and Bicol regions.

During the Philippine Information Agency Sulong Calprogram, abarzon **PHRCS** Executive Director Usec. Severo Catura discussed the whole-of-government approach in crafting the 4th Philippine Human Rights Plan (PHRP4) for 2024— 2028.

Regional consultations are part of ongoing efforts to gather input from various sectors. After the consultations in Luzon and Metro Manila, the PHRCS will focus its discussions on Visayas and Mindanao.

Catura said that during the consultation sessions, various government agencies, including the Department of Justice (DOJ), the National Economic and Development Authority (NEDA), the Philippine Commission on Women (PCW), and the Council for the Welfare of Children (CWC), had their inputs and initiatives laid down for the creation of PHRP4 to ensure local human rights issues were addressed.

Each agency is assigned specific responsibilities aligned with international treaties; for instance, the DOJ oversee civil political rights, NEDA will focus on economic and social

TAGAYTAY CITY, rights, and the CWC will handle the rights of children to ensure comprehensive human rights coverage across various sectors.

> PHRCS also invites NGOs and civil society organizations to hold discussions focusing on prevalent human rights issues and concerns in the country, which include civil and political rights; women empowerment; opportunities for people with disabilities; Indigenous Peoples' rights; migrant worker protection; and the prevention of cruel, inhumane, and degrading treatment.

> "This is not just the responsibility of government agencies; it means that all sectors of society should be included in the consultation," Catura said.

> During the 75th anniversary of the Uni-Declaration versal of Human Rights in 2023, the Philippines pledged to create the Fourth Philippine Human Rights Plan.

> Under the administration of President Ferdinand R. Marcos Jr., the PHRP4 is aligned with the "Bagong Pilipinas" agenda, which emphasizes a renewed commitment of the state to uphold human rights and international obligations.

> The creation of the PHRP4 is rooted in the Philippines' commitment to the 1993 United Nations convention held in Vienna, where members agreed to develop human rights plans for their countries. Since 1995, the Philippines has implemented these plans, with the most recent being in 2022. (TP/ PIA4A)

Marcos: LDF Board hosting gives PH voice on climate issues

MANILA – The Philippines' upcoming hosting of the Board of the Loss and Damage Fund will provide the country with an influence in addressing climate change, President Ferdinand R. Marcos Jr. said Wednesday.

"Magiging malaki ang ating impluwensiya para lahat ng ating pangangailangan, lahat ng ating pananaw tungkol dito sa subject matter na ito ay maaari nating sabihin at maaring magka-influence tayo... May boses tayo na malakas (We will have an influence to say for all our needs, all our views on this subject matter we can say it and we can influence others. We will have a strong voice)," Marcos told reporters in an interview.

"Iyan ang pinaka-importanteng resulta sa pag-host ng Pilipinas sa Loss and Damage Fund Board (That is the most important result of the Philippines hosting the Loss and Damage Fund Board)," he added.

The Loss and Damage Fund is the global finance mechanism to assist developing countries in responding to economic and non-economic and damage associated with climate change, including extreme weather and slow-onset events.

The Board, as the Fund's decision-making body, is responsible for setting the strategic direction, operations and work program of the mechanism.

It comprises 26 members from parties to the UNFCCC and the Paris Agreement, with 12 members from developed countries and 14 from developing countries.

The Philippines sits in the Asia Pacific Group of the Board. (PNA)

CAVITEX connector roads' on-time completion gets fresh momentum from Presidential support

The on-time completion of the two connector roads of the Cavitex Expressway (CAVITEX) has recently acquired fresh momentum, inspired by the expression of support by President Ferdinand R. Marcos Jr., when he led the groundbreaking and inauguration of the three CAVITEX links or connector roads in different locations in one day.

"The Presidential declaration of support for these major infrastructure projects has energized us all in completing the projects on time, leaving no stone unturned to finish the job," thus declared Raul L. Ignacio, president of the CAVITEX Infrastructure Corporation," a subsidiary of the larger Metro Pacific Tollways Corporation (MPTC) of the MVP Group.

'Final step to enhance transport infra. In his speech, President Marcos called the actions taken only last week as "the final step in completing the CAVITEX C5 Link Expressway, enhancing our transportation infrastructure network on behalf of countless motorists and passengers." And "the [CAVITEX]-CA-

LAX Link, originating from Kawit, Cavite, is a 1.2-kilometer connection whose length may be short, but its impact will be substantial. By establishing a direct connection to CALAX, we also ease the traffic congestion at the busy intersection of Tirona Highway and Centennial Road." With this, we anticipate a significant improvement in the road network connectivity from Kawit to the greater CALA-BARZON region.

President Marcos and his transport-related Cabinet members were joined by Manuel V. Pangilinan, MPTC Chairman, Mr. Rogelio Singson, President and CEO of Metro Pacific Tollways, and Mr. Raul L. Ignacio, President and General Manager of Cavitex Infrastructure Corporation.

Two contractors: Beat the deadline. DMCI, under a P3.3 billion contract, has committed to meet the construction deadline to finish Segment 3B, the final portion of the CAVITEX C5 Link, a six (6) lane 2.0 km expressway connecting CAVITEX at Paranaque in the West and C5 Road Taguig in the East. This seg-

ment will enable motorists to travel from Cavite to Taguig City, bypassing a number of service roads.

EEI will be completing the 1.3-km. dual 2-lane CAVITEX-CA-LAX Link Extension also in August 2025, envisioned to stimulate commerce and industry in Cavite, Laguna and Metro Manila.

"The Presidential imprimatur has resonated as the President's marching orders for our CIC project managers and our two contractors to speed up the construction so that the two segments will be ready for full operations on August 2025," Ignacio pointed out.

Right-of-way acquisition. For both construction projects, Ignacio earlier met his right-of-way (ROW) acquisition team in order to resolve all issues to ultimately clear the way for the road alignments and access roads. Progress has been made in CIC's mix of persuasive initiatives addressed to project affected persons (PAPs) made up of legal, financial and communication strategies, Ignacio added.

At press time, the







ROW status of Segment 3B of the C5 Link stands at 70.60 percent, leaving the CIC ROW project managers only 29.4 percent balance to finish the job, Ignacio added. On the other hand, the

progress of the CAVI-TEX-CALAX Link ROW acquisition is ahead with 77.14 percent, leaving CIC only 22.86 percent to clear the way for this alignment.

"With this new impe-

tus from the Palace, we will beat our construction deadline – and the winner is every motorist and passenger south of Metro Manila and beyond," Ignacio said.
