21 areas in Bataan, Cavite under state of calamity due to oil spill

MANILA – A total of 21 areas in the provinces of Bataan and Cavite have declared a state of calamity due to the impact of the oil spill caused by the sinking of the M/T Terranova, the National Disaster Risk Reduction and Management Council (NDRRMC) said Tuesday.

In its situation report,

the NDRRMC said the figure includes Bataan's 11 towns and capital city Balanga as well as Cavite's seven towns and two cities -- Kawit, Noveleta, Rosario, Tanza, Naic, Maragondon, Ternate, Cavite City and Bacoor City.

The oil spill has so far affected 25,145 fisherfolk in Calabarzon, it

Operations are now ongoing to contain the oil spill.

The M/T Terranova sank off Lamao Point in Limay, Bataan last July 25 at the height of bad weather due to Super Typhoon Carina and the enhanced southwest monsoon.

DA: Cheaper rice in more Kadiwa sites to further influence rice prices

MANILA – The Department of Agriculture (DA) said on Tuesday that operations of PHP29 and Rice for All programs in more Kadiwa sites may help further drop rice retail prices in local markets.

"Kapag mas marami iyong area mo na nagka-Kadiwa, mas magiging malaki iyong influence niyan sa market. Lalo na iyong mas malapit doon sa Kadiwa sites, mas malaki iyong chances na they will also offer prices regular na malapit doon sa (If you have more areas operating Kadiwa, there will be bigger influence in the market. Especially those near Kadiwa sites, there's

more chances that they will offer regular prices that's close to that of the) Kadiwa," DA Assistant Secretary Arnel De Mesa said in a phone interview.

The DA made the statement after rice inflation dropped to 20.9 percent in July from 22.5 percent in June, according to the latest report of the Philip-

pine Statistics Authority (PSA).

BFAR conducts sensory testing in Cavite coastal areas

KAWIT, CAVITE (PIA) – The Bureau of Fisheries and Aquatic Resources (BFAR) is conducting sensory testing in municipalities of Cavite with coastal areas of Cavite City, Noveleta, Rosario, Tanza, and Naic.

The testing was conducted after the degree of petrochemicals was reported in random fishes caught in the area.

After the testing, fish samples from Noveleta and Rosario were proven tainted with petrochemicals.

Meanwhile, samples gathered from Cavite City, Tanza, and Naic remain free from contamination.

"Nevertheless, the Bureau maintains that as a precautionary measure, fish harvested from areas where oil slicks are observed be deemed unsafe for human consumption," the BFAR announced in a bulletin.

Days ago, Cavite Governor Juanito Victor Remulla already signed Executive Order No. 38, series of 2024, where the provincial government declares Kawit, Noveleta, Rosario, Tanza, Naic, Maragondon, and Ternate, as well as the cities of Cavite and



Bacoor as no-catch and no-sell zones for shellfish.

"There is a need to declare a no-catch and no-sell zone in the coastal areas in the province to ensure the health and well-being of Caviteños and the consuming public [from the effect of the oil spill]," the EO reads.

Fisherfolk who were affected by the ban, on the other hand, were given aid by the Cavite provincial government. (PIA-4A; with reports from Cavite PIO/BFAR)

sold)," De Mesa said.

As of Monday, the prices of local regular milled rice in Metro Manila range from PHP45 per kilogram to PHP50/kg., and PHP47/kg. to PHP55/ kg. for local wellmilled rice.

Meanwhile, imported regular-milled rice ranges from PHP46/ kg. to PHP48/kg., and PHP51/kg. to PHP53/ kg. for imported wellmilled rice.

De Mesa said the prices of rice may still drop in the coming months with the effects of the lower tariffs on imported rice, which is at 15 percent.

The P29 program refers to the sale of PHP29 per kilogram of aging but good quality rice stocks from the National Food Authority (NFA) for the vulnerable sector, including members of the Pantawid Pamilyang Pilipino Program (4Ps), senior citizens, persons with disability (PWD), and solo parents; while PHP45/kg of commercial wellmilled rice is accessible in Kadiwa sites for the general public through the DA's Rice for All program.

To date, both programs are being oper-

ated in 17 Kadiwa sites in the Bureau of Animal Industry Dome and National Irrigation Administration in Quezon City; Bureau of Plant Industry in Malate, Manila: Food Terminal Inc. in Taguig City; Philippine Fiber Industry Development Authority in Las Piñas; Bayani Fernando Central Terminal or BFCT and Barangay Fortune in Marikina; as well as sites in Llano, Caloocan; Valenzuela; Pantao Fisherfolks Consumer Cooperative in Malabon; Navotas Institute in Navotas; San Jose del Monte, Bulacan; Antipolo City; Bacoor, Cavite; and San Pedro City Hall and Santa Rosa, Laguna, every Thursday to Saturday. The DA targets to ex-

pand the program in Cebu, Maguindanao, and Sulu within August.

Masagana program

The DA, meanwhile, said the review of the Masagana Rice Industry Development Program is underway to further boost local palay production and increase farmers' income.

"We're recalibrating the program to identify areas for enhancement, including the distribution of improved seeds, expansion of irrigation systems, and adjustments to rice cropping schedules," DA Secretary Francisco Tiu Laurel Jr. said in a separate statement.

The DA said rice yield could reach as high as 7.5 metric tons (MT) per hectare or 150 bags (50 kg/bag) using "right inputs and

Dengue cases 33% higher, deaths lower

MANILA – The Department of Health (DOH) on Wednesday reported 128,834 dengue cases as of July 27, a 33 percent increase from the same period in 2023.

In a news release, the DOH said there were 97,211 cases recorded for the same period last year.

However, dengue deaths recorded this year at 337 is lower compared to last year's 378 for same time period.

"The lower number of deaths this year despite the higher number of cases is an indication of people seeking early consultation, and hospitals doing better case management," the DOH said.

The DOH said dengue cases are still on an uptrend, showing an increase from 12,153 cases recorded from June 16 to 29. to 18,349 cases from June 30 to July 13.

The regions which showed continuous rise in cases in the past six weeks are Western Visayas, Central Visayas, Cagayan Valley, and Calabarzon.

Meanwhile, two weeks after super typhoon Carina and an enhanced southwest monsoon (habagat), the DOH recorded only 67 cases of leptospirosis from July 14 to 27.

The DOH said there are most likely delayed reports.

The incubation period of leptospirosis may range from two to 30 days, usually showing symptoms around one to two weeks after exposure to floodwaters, it said.

From Jan. 1 to July 27, 1,444 cases with 162 deaths have been recorded or 42 percent lower compared to the 2,505 cases in the same period last year.

The DOH reminded the public to avoid floodwaters and to take available antibiotic prophylaxis by prescription after walking in floodwaters.

The price freeze for doxycycline, antibiotic prophylaxis for leptospirosis, remains until Sept. 23, it said. (PNA)

Senator vows to boost public info on El Niño, La Niña

MANILA - Senator Robinhood Padilla on Tuesday assured that he will push for a budget allocation that will strengthen the public information campaign regarding El Niño and La Niña next year.

Padilla made the assurance during the public hearing of the Senate Subcommittee on Senate Resolution No. 987 which seeks to look into the effectiveness of the information and awareness campaign of the national government on the impact of El Niño phenomenon in the country.

During the hearing, Philippine Information Agency (PIA) Deputy

Director General Adolfo Ares Gutierrez also asked for additional budget in 2025 to effectively implement the campaign.

DepEd: All schools open nationwide

MANILA - The Department of Education (DepEd) on Tuesday reported the full opening of public schools nationwide after an initial postponement due to the effects of the enhanced southwest monsoon and Super Typhoon Carina.

In a Viber message, DepEd Media Relations chief Dennis Legaspi said all schools are now in normal operations for school year 2024-2025.

"Open na po lahat ng schools (All schools open) nationwide today. Wala na din pong schools ang ginagamit (No more schools are being used) as evacuation centers," he said.

During the opening of classes on July 29, some 1,063 schools postponed their official start, with the highest number recorded in Central Luzon with 457 schools.

The Ilocos region followed with 310 affected schools, Metro Manila with 225 Calabarzon schools. with 67 schools, and four schools in Soccsksargen.

The DepEd, meanwhile, logged 87.2 percent of its target enrollment on Tuesday, recording 24,178,797 out of 27,722,835 target enrollees from elementary to senior high school (SHS) in all public and private schools.

These include 290,461 enrollees in the Alternative Learning System (ALS).

To date, the highest number of learners was reported in Calabarzon with 3,516,873 enrollees; followed by Central Luzon with 2,557,435 enrollees, and Metro Manila with 2,489,979 enrollees.

Free school kits for Manila kinder learn-

Some 1,000 kindergarten learners in the city of Manila received free school supplies.

Mayor Honey Lacuna led the distribution of the school kits for Kinder 1 and Kinder 2 at the Fugoso (Delpan) Sports Complex in Tondo and in Barangay 830 in Paco on Tuesday, ahead of the opening of pre-school classes in the city on Aug. 19.

the program of the PIA)," he said.

He said the PIA can only amplify the information being disseminated by the Task Force El Niño through various information platforms, including face-to-face information forums through the agency's regional offices.

But he said the role of public information officers in local government units should also be used to ensure that proper information will reach the grassroots level.

Padilla volunteered to attend the budget deliberations of the Presidential Communications Office, in which the PIA is under, to push for the allocation.

DA: Agri commodities supply stable despite -3.3% annual output drop

MANILA – The Department of Agriculture (DA) on Wednesday assured a stable supply of agricultural commodities in the country despite the -3.3 percent year-onyear drop in agriculture and fisheries production in the second quarter of 2024.

The Philippine Sta-Authority tistics (PSA) earlier reported the agri-fishery output contraction at PHP413.91 billion, with a -8.6 percent production decline in crops worth PHP220.04 billion, and a -0.3 percent drop in livestock worth PHP63.33 billion.

Annual positive increments, however, were posted in the poultry and fishersectors, hitting percent worth PHP70.15 billion, and 2.2 percent amounting to PHP60.40 billion, respectively.

"Sapat ang supply, lalo na ng bigas. Kung nagkaroon ng (There's enough supply, especially of rice. If there's a) reduction, this is still within the limit, year on year," DA Assistant Secretary Arnel De Mesa said in an interview

He said the country's rice sector has a stable supply, considering the dry harvest season output alongside the continuous arrival of imported rice under the lower tariffs.

"Iyong huling report ng BPI (The latest report of the Bureau of Plant Industry), as of Aug. 1, 150,000 metric tons (MT) iyong

pumasok sa ating bansa (arrived in the country) for the whole of July," De Mesa said.

Overall, he said, the BPI has recorded the arrival of about 2.49 million MT of rice imports since the start of the year.

Mitigation measures

For crops, which accounted for 53.2 percent of overall production value, De Mesa pointed to the effects of the El Niño phenomenon as the main driver of production decline.

These include a -42.3 percent annual drop in sugarcane, as well as a -20.3 percent and -9.5 percent annual decline in corn and palay production, respectively, according to the PSA.

De Mesa said these figures could have been worse without the resilience of the agriculture sector and administration's mitigating measures.

"Kung hindi nagawa iyong mga mitigating measures before, including itong mga support measures na naibigay during the El Niño, definitely mas malaki (If we were not able to institute mitigating measures, including these support measures distributed during the El Niño, the damage could have been bigger). It's within the projected losses," he said, citing the DA's PHP14.54 billion worth of intervention to 333,195 affected farmers and fishers.

These include PHP8.59 billion in financial aid to 1,431,823 farmers na-

tionwide through the Rice Farmers Financial Assistance; PHP4.72 billion worth of production support and financial assistance to farmers, fishers, and farmers cooperatives and associations; and PHP659.17 million worth of agricultural inputs.

The DA has also indemnified 56,112 farmers through the Philippine Crop Insurance Corp., amountto PHP452.56 million; while 66,039 native animals worth PHP18.08 million were distributed to 604 farmers nationwide.

About PHP99.38 million worth of Survival and Recovery (SURE) aid loan was also given through the Agricultural Credit Policy

On farmers' affected employment, De Mesa noted an expected rebound, considering wider areas for land preparation, farm establishment, and harvesting during the wet season.

He, meanwhile, ascontinuous preparations to prevent further agricultural production decline with the looming La Niña.

DBM OKs release of P5B for 2023 4Ps grants in arrears

MANILA - The Department of Budget and Management (DBM) has approved the release of PHP5 billion for the additional funding of the Pantawid Pamilyang Pilipino Program (4Ps), government's flagship anti-poverty program under the Department of Social Welfare and Development (DSWD).

In a statement Tuesday, the DBM said the additional funds will be sourced from the 2023 Continuing Appropriations and used to cover the 2023 4Ps grants in arrears resulting in the deactivation/suspension of 4Ps beneficiaries to around 703,888 households.

"Makakatulong po

ito para maibsan ang epekto ng inflation sa ating mga kababayan (This will help our countrymen cushion the impact of inflation). The DBM will do its part to streamline budget processes so that our citizens benefit from faster and more efficient delivery of essential services such as our 4Ps," Budget Secretary Amenah Pangandaman said.

The allocation, according to Pangadaman, will allow the DSWD to continue its "critical work without interruption, providing much-needed tance to our most vulnerable citizens."

76% of Filipinos want cellphones banned in schools – survey

MANILA – A Pulse Asia survey commissioned by Senator Sherwin Gatchalian showed that almost eight out of 10 Filipinos support the banning of cellphones in schools.

The results of the survey, conducted from June 17 to 24, showed that 76 percent of 1,200 adult respondents nationwide agree with having a cellphone ban inside schools. Thirteen percent said they disagree, while 11 percent said they cannot say whether they agree or disagree.

According to the survey, Filipinos across all socioeconomic classes also support the cellphone ban in schools, with the strongest support from Class ABC, with 80 percent; 76 percent from Class D; and 71 percent from CLass E.

Eight out of 10 respondents in the National Capital Region, or 80 percent, support the proposal; with 79 percent in Balance Luzon; 61 percent in the Visayas; and 81 percent in Mindanao.

In a news release on Tuesday, Gatchalian said the results of the survey show that Filipinos see the benefits of imposing a ban on cellphone use in schools, especially because distraction from mobile phones in schools is linked to poorer learner performance.

"Malinaw na suportado ng ating mga kababayan ang ating panukala na ipagbawal ang paggamit ng mga cellphones sa mga

paaralan, lalo na't ang paggamit nito sa oras ng klase ay maaaring makapinsala sa kanilang pag-aaral (Our countrymen clearly support our proposal to ban the use of cellphones in schools, especially because their use during class can harm their studies)," he said.

According to an analysis of the 2022 Program for International Student Assessment by the Senate Committee on Basic Education, eight out of 10 Filipino learners aged 15 reported being distracted in class by using their smartphones, while another eight out of 10 reported being distracted by other students' smartphone use.

"Kaya naman patuloy nating isinusulong ang panukalang batas na magbabawal sa paggamit ng cellphone sa oras ng klase (That's why we continue to push for the bill that will ban the use of cellphones during class)," he added.

Gatchalian recently filed Senate Bill 2706 or the Electronic Gadget-Free Schools Act, which seeks to prohibit learners' use of mobile devices and electronic gadgets from kindergarten to senior high school within school premises during school hours.

It mandates the Department of Education to establish guidelines for the prohibition, which covers learners from kindergarten to senior high school in both public and private institutions, including teachers.

The bill, however, provides some exceptions – learning related-exceptions, as classroom presentation or class-based learning activities; health and well-being-related exceptions, such as learners with health conditions and requiring the use of mobile devices and electronic gadgets; and exceptions related to managing risks, such as emergencies, response to perceived threats or dangers, and during field trips or activities outside school premises.

All public and private basic education institutions, as well as learners, who will fail to comply, shall be subject to appropriate sanctions. (PNA)

CSC offers special eligibility to senior office equipment technicians

MANILA – Senior Office Equipment Technicians interested in applying for government positions may take advantage of the special eligibility provided by the Civil Service Commission (CSC).

Under CSC Memorandum Circular (MC) No. 8 dated 7 September 2023, the Senior Office Equipment Technician A and Senior Office Equipment Technician B positions are now included in the list of positions for Equipment Technician eligibility under Category II of CSC MC No. 10, s. 2013.

"The special eligibility for Senior Office Equipment Technicians A and B represents a significant advancement in acknowledging the expertise of our building and office maintenance personnel in the public sector. Qualified individuals will no longer be required to take the Career Service Examination to gain eligibility and apply for plantilla positions," said CSC Chairperson Karlo Nograles in a press release.

Under CSC MC No. 11, s. 1996, Skills Eligibility is granted to individuals who meet the requirements for specific positions, qualifications for which are not measurable by written tests.

The special eligibility can be obtained only by completing one year of Very Satisfactory actual performance under temporary status of appointment.

The skills eligibility,

although appropriate for specific categories of positions outlined in CSC MC No. 11, s. 1996, as amended, is not equivalent to or comparable with Career Service Sub-Professional and Professional eligibilities.

To apply for the special eligibility, individuals holding Senior Office Equipment Technician A and Senior Office Equipment Technician B positions must submit the following requirements to the CSC Regional Office or Field Office having jurisdiction over the agency where they have completed one year of very satisfactory actual work performance:

Properly accomplished CS Form 101-G (Revised, Sept. 2013);

Original and photocopy of the Appointment Paper of the applicant, specifically indicating the status of appointment as "Temporary";

Certification (using the prescribed CSC-ERPO Cat. II Form No. 1, Revised Oct. 2009) from the agency head/highest HRMO that the appointee obtained at least Very Satisfactory rating for the two rating periods during the one-year temporary

appointment as such; Statement of Actual

Duties and Responsibilities (using the prescribed CSC-ERPO Cat. II Form No. 2, January 2011) of the applicant executed by the applicant's immediate supervisor; and Authenticated copy of the applicant's Performance Rating Form, duly confirmed by the agency's Performance Evaluation and Review Committee (PERC), for the two rating periods covered by the one-year temporary appointment.

Applicants are reminded that their applications must be submitted not earlier than one week before the expiration of the one-year temporary appointment.

However, filing of applications after the expiration of the one-year temporary appointment may be allowed provided the applicant is still in the service with the same position title.

MANILA - Aira Villegas' Cinderella run in the women's 50-kilogram boxing division of the Paris Olympics came to an end early Wednesday (Philippine Time) after losing in the semifinals to Turkiye's Buse Naz Cakiroglu as the entire boxing event shifted to the Roland Garros Stadium in downtown Paris.

Despite the defeat, Villegas is taking home the bronze med-

Cakiroglu was just too much for Villegas, rightfully proving why she was the third seed in the competition.

Cakiroglu began her boxing clinic in the first round through more accurate shots, and a right straight at the 2:22 mark of the round wobbled Villegas, referee Wade Peterson stepped in to give her the standing eight-count.

Villegas thought she had her moment just before the final minute of Round 2 when she seemed like she knocked Cakiroglu down with a right hook

However, Peterson, whose scorecards in bouts involving Filipino fighters as a judge have been criticized by

The 24-year-old pride of Manila ruled the men's floor exercise and vault to become the first Filipino to win gold medals in a single Olympics.

FDA warns Pinoys vs. health products submerged in floodwaters

MANILA - The Food and Drug Administration (FDA) on Tuesday reminded consumers anew not to purchase or use health products that have been submerged in floodwaters.

Massive flooding and prolonged power disruptions affected the National Capital Region and nearby regions due to Super Typhoon Carina and enhanced southwest monsoon or habagat.

These left several factories, warehouses, and establishments involved in the manufacturing, processing, packing, or storage of health products - including drugstores and retail outlets- submerged in floods.

In a public advisory, the FDA emphasized that the quality, safety, efficacy, and purity of such health products have already been viders compromised.

Hence, Department Circular 2012-014 "Disposition of Flood-Affected Health Products" must be implemented.

"This warns establishment and the public about health products that were submerged or otherwise affected by floods and are now being offered for sale or resale," it said.

Individuals who may have consumed affected health products are advised to consult their healthcare pro-

immediately especially if they have become ill.

Drugstores, retail stores and distributors are advised not to offer affected health products for sale, to return them to their sources, and to submit a report to FDA not later than one week.

Concerned food-drug regulation officers are instructed to identify affected establishments and conduct monitoring, and to seize damaged or affected health products. (PNA)
