PH, Singapore boost partnership on climate action

MANILA – The Philippines and Singapore have committed to strengthening partnership in the fight against climate change through sustainable measures.

This came as Department of Environment and Natural Resources (DENR) Secretary Maria Antonia Yuluncheon for Singaporean President Tharman Shanmugaratnam at The Peninsula Manila Hotel on Aug. 16, the agency said in a news release on Tues-

The two sides discussed deeper collaboration and exploring innovative solutions for inclusive and cli-

MANILA – The Department of Agriculture (DA) on Tuesday assured strategic vaccination to eligible farmers' hogs against African swine fever (ASF) in Batangas.

The assurance was made after the Bureau of Animal Industry (BAI) conducted its first orientation of the government-convaccination

emergency procured ASF vaccines in the province, with the municipality of Lobo as the first area set for rollout.

In a phone interview, DA Assistant Secretary Arnel De Mesa underscored the need for a clustered rollout to prevent vaccine wastage.

MANILA – The head of the Philippine Institute of Volcanology and Seismology (Phivolcs) on Tuesday said there were no volcanic quakes recorded in Taal Volcano for the past 12 days, indicating a "good" sign.

"Not even one volcanic earthquake was recorded since August 8.

Eligible hogs will be subjected to blood sampling before vaccination and will be followed by stringent monitoring for progress assessment.

More than 160 smallhold, semi-commercial, and commercial farmers attended the initial orientation in Lobo, and signified their intent to join the ASF vaccinations.

De Mesa said Lobo was the first area to declare a state of emergency, and its raisers were among the most active and supportive of the vaccination program.

He, however, said BAI's validation process includes strict adherence to requirements on biosecurity measures.

De Mesa said BAI is

now looking into the possible augmentation of manpower for the vaccine rollout, alongside the utilization of more laboratories to fully monitor the vaccinated pigs.

"Iyan nga iyong pinag-uusapan kasi itong bakuna ay dapat (That's what we are discussing because the vaccines should be) administered by BAI – if there is a need to deputize additional veterinarians to help in the vaccination rollout," he said.

The DA, meanwhile, is also set to launch its orientation and vaccination efforts in Lipa and Taysan. (PNA)

Manila starts misting in public schools to curb dengue

MANILA – The city government of Manila has started its month-long misting in all public elementary and high schools to prevent the spread of dengue amid the rainy season.

In a statement on Tuesday, Mayor Honey Lacuna said the Manila Health Department (MHD) misting teams started going around the city's 103 public schools on Monday.

Misting and spraying will be conducted after class hours until Sept. 20.

Lacuna also appealed to residents to help maintain clean surroundings and asked village officials to assist in information dissemination efforts on anti-dengue measures.



Article 6 of the Paris climate pact recognizes that some parties choose to pursue voluntary cooperation in implementing their Nationally Determined Contributions to allow for higher ambition in their mitigation and adaptation actions and promote sustainable development and environmental integrity.

Before the signing, representatives from the two countries, consisting of the private sector and government agencies, discussed efforts in sustainable development, leveraging technology to address shared challenges, attract international investments, and adopt best practices.

During the discussion, Loyzaga and Undersecre-**DENR** tary for Integrated Environmental Science Carlos Primo David presented an overview of the DENR Geospatial Database Office's (GDO) water resource management initiatives, showcasing its achievement in mapping the country's natural resources, including water bodies, forests, and mangrove ecosystems.

Loyzaga said both sides would work together in achieving tangible gains against the impacts of climate change for both nations and setting a benchmark for science-informed bilateral and public-private cooperation in environmental stewardship. (PNA)

BSP, National Bank of Cambodia sign deal for enhanced cooperation

MANILA - The Bangko Sentral ng Pilipinas (BSP) and the National Bank of Cambodia (NBC) recently signed a memorandum of understanding (MOU) to foster closer cooperation.

The MOU was signed by BSP Governor Eli Remolona Jr. and NBC Governor Dr. Chea Serey on Aug. 19 in Siem Reap, Cambodia.

In a joint statement on Tuesday, BSP and NBC said the MOU signifies the willingness and commitment of both parties to provide a clear framework for the facilitation of bilateral ties and the enhancement of cobetween operation

the two central banks, which have had a history of collaboration in both bilateral and regional fronts.

The signing ceremony was followed by a high-level bilateral meeting where the BSP and NBC exchanged views on recent macroeconomic and financial developments and outlook, payment system developments, artificial intelligence, cybersecurity, and sustainable finance.

The two central banks also discussed opportunities for further cooperation in these areas.

NAPC: Recalibrate targets to help 740K poor families

MANILA – The Na-Anti-Poverty tional Commission (NAPC) on Tuesday said there is a need to review baselines for determining food thresholds and the number of food-poor individuals.

In a statement, NAPC Secretary Lope Santos III said targets and measurements must be recalibrated, focusing on 740,000 families classified as foodpoor or those whose incomes fall short of meeting their basic food requirements.

"Beyond mere numbers and prices, many families are at an advantage," he said. "We expect that the revised metrics will more accurately reflect the real food needs of the

PCCI urges DepEd to address skills mismatch, improve education system

MANILA - The Philippine Chamber of Commerce and Industry (PCCI), through its Human Resource Development Foundation (HRDF), Inc., submitted policy recommendations to Department of Education (DepEd) Secretary Sonny Angara to revitalize the country's education system.

In a statement on Tuesday, the PCCI cited the need to align education outcomes with industry demands to address the persistent skills mismatch that hampers the competitiveness of the Filipino workforce.

The business group said among its recommendations were the enhancement of Technolo-Science, gy, Engineering, and Mathematics (STEM) programs and strengthening partnerships between schools and businesses to foster onthe-job training opportunities.

pushing for the amendment of the Enhanced Education Act to harmonize with the higher education curricula, promoting a multi-sectoral approach in early childhood education, and developing micro-credentialing certify skills acquired through various forms of learning.

The recommendations were presented to Angara during a meeting led by PCCIHRDF President Alberto Fenix Jr. on Aug. 12.

Also present in the meeting were members of the Education Task Force (ETF), Philippine Normal University (PNU) president Bert Tuga, former Technical Education and Skills Development Authority (TESDA) director general Irene Isaac, and PCCIHRDF executive director Marlon Miña.

S. Korea's heat-related patients near 2nd-highest record

SEOUL – The total number of heat-related patients surpassed 2,800 on Monday amid an unwavering heat wave, approaching the second-highest record in history, the state disease control agency said.

The Korea Disease Control and Prevention Agency reported 41 new patients, bringing the total to 2,814 since May 20, when the agency began monitoring heat-related illnesses for this year. The monitoring will continue until Sept. 30.

This tally is just four short of the 2,818 cases recorded in 2011, which stands as the country's second-highest heat-related patient record.

The highest number was recorded in 2018 with 4,526 cases.

So far this year, 24 patients have died due to extreme heat.

Of the total, men accounted for 77.3 percent. People in their 50s and 60s made up 18.7 percent and 18.6 percent of the cases, respectively.

By occupation, manual workers represented the largest portion at 22.6 percent.

The Korean Society of Emergency Medicine warned that heat-related illnesses can occur even in the morning hours, as some people begin working very

Meanwhile, the country's maximum power demand reached 95.6 gigawatts at 6 p.m., marking the high-est level in history and breaking records for the fifth time this summer, according to the Korea Power Exchange.

The record high in power demand was driven by scorching hot weather, dry winds, and the influence of a typhoon bringing hot and humid air to the region.






that could benefit both regions.

Filipino IM Quizon upsets 6th seed Amin of Egypt in Abu Dhabi tourney

MANILA – Filipino International Master Daniel Quizon showed incredible poise as he caught a big fish in sixth seed Grandmaster Bassem Amin of Egypt in the fourth round Monday night to stay half a point off the pace in the Masters section of the 30th Abu Dhabi International Chess Festival.

Seeded just 66th out of 217 participants, the Olympiad-bound 19-year-old bet from Dasmariñas did not flinch amid a strong pressure put up by the heavily favored Amin in the opening in carving out a 36-move win of a Sicilian duel.

It catapulted Quizon to a heavy 25-player logiam at No. 15 with three points, or just half a point behind a 14-man lead pack headed by top seed GM Amin Tabatabaeei of Iran.

Quizon was battling Uzbek GM Shamsiddin Vokhidov in the fifth round at the press time of this nine-round tournament the former is using to earn rating points to achieve 2500 rating and claim the GM title outright.

He is also using the meet as part of his preparation for the Olympiad set Sept. 10 to 22 in Budapest, Hungary where he will make his much-awaited debut and join teammates GMs Inno Sadorra, John Paul

Gomez, and IMs Paolo Bersamina and Jem Garcia.

Quizon's recent effort just a few days after pulling off a solid 16th-place effort in the blitz section where he ended up scoring eight of the possible 11 points with impressive triumphs over GMs Mikheil Mchedlishvili of Georgia, Puria Darini of India and Yakubboev while drawing with GMs Volodar Murzin of FIDE's refugee team and Vokhidov.
