## LTO extends deadline on ban vs. temporary plates until Dec. 31

MANILA – The Land Transportation Office (LTO) extended its deadline on the ban against the use of improvised and temporary plates for motor vehicles.

In a statement Monday, LTO chief, Assistant Secretary Vigor Mendoza II said instead of Sept. 1, the

prohibition on temporary plates will take effect on Dec. 31.

"We ask motorists to claim and install their respective license plates as soon as they are available either in the car dealerships and replacement plates in our offices," Mendoza

The installation of li-

cense plates, he said, would help as a crime prevention measure as some are being used in criminal activities.

# DA OKs movement of ASF-negative hogs from red zones

MANILA - Movements of healthy and African swine fever (ASF)-negative hogs from red zones or barangays with active ASF cases are now allowed, according to the Department of Agriculture (DA).

This is in accordance with the DA's Administrative Circular (AC) No. 6, series of 2024, or the guidelines on the movement protocols for live pigs for release it)," DA Secslaughter purposes, signed on Aug. 29.

## P40/kg of rice under Rice for All possible in Kadiwa stores by October

MANILA - The public may soon have access to PHP40 per kilogram of mixed imported and local wellmilled rice in its Kadiwa stores in October, according to Department of Agriculture (DA) Secretary Francisco Tiu Laurel Jr.

In an interview with Anthony Taberna aired on Facebook late Sunday, Tiu Laurel said this is possible as retail prices in local markets are expected to drop to PHP45 per kilogram with the new stocks of imported rice coming in under the lowered tariffs.

President Ferdinand R. Marcos Jr. earlier ordered the implementation of Executive Order No. 62 or the

lowering of tariffs on imported rice from 35 percent to 15 percent.

"Tingin ko mga October... Kung PHP52 ngayon dapat maging (I think by October... If it's PHP52 now, it should be) PHP45," Tiu Laurel said, referring to the PHP6/kg. to PHP7/kg. expected price decline in local markets under the

"Ang (The) Kadiwa, eventually, will be going, kung PHP45 na iyan sa market, sa Kadiwa (if that's PHP45 in the market, in Kadiwa) by that time should be PHP40, iyong (under the) Rice for All," he said.

Kadiwa's Rice for All program intends to provide the general public with cheaper rice compared to the prevailing market price.

This is on top of the P29 program or the sale of PHP29/kg of aging but good quality stocks of National Food Authority (NFA) rice to members of the vulnerable sector including members of the Pantawid Pamilyang Pilipino Program (4Ps), senior citizens, persons with disabilities (PWDs), and solo

## Power interruptions in 4K Meralco customers due to 'Enteng'

MANILA - The Manila Electric Company (Meralco) reported that as of 6 a.m. Tuesday, about 4,000 customers were experiencing service interruptions due to the impact of Tropical Storm Enteng.

In a statement, Meralco said most of the affected customers are in Metro Manila and the provinces of Cavite and Rizal.

"With majority of the remaining customers in areas still affected by floods, we would like to ask for their patience and understanding as we have to follow protocols and prioritize their safety," Meralco vice president and head of corporate communications Zaldarriaga said.

Meralco said more than half of the affected customers are in flooded areas.

"Rest assured that our crews and personnel (are) working round the clock to restore electricity service to all remaining affected customers

# Leptospirosis cases 5% higher from Jan. 1 to Aug. 17

MANILA – A total of 3,785 leptospirosis cases were recorded nationwide from Jan. 1 to Aug. 17, five percent higher compared to the 3,605 cases reported in the same period last year.

The tally included the increase in leptospirosis cases following the floods brought by Super Typhoon Carina and the enhanced southwest monsoon in July.

"From July 7 to 20, only 251 cases were recorded. This went up almost five times to 1,184 from July 21 to August 3, the height of Typhoon Carina and enhanced monsoon floods," the Department of Health (DOH) said in a statement Monday.

The cases have gone down to 699 cases on Aug. 4 to 17.

"DOH epidemiologists anticipate that, without proper precautions like prophylaxis, the number of cases will most likely go up again due to floods brought about by Tropical Storm Enteng," it said.

The public is reminded to avoid wading through floodwaters and to wash with soap and clean water if doing so cannot be

avoided.

Individuals experiencing symptoms (high temperature, headache, colds, diarrhea, body aches and pains, red eyes, loss of appetite) are advised to consult a doctor immediately.

# DSWD ramps up disaster response ops for 'Enteng'

MANILA – The Department of Social Welfare and Development (DSWD) on Tuesday intensified its disaster response operations as Tropical Storm Enteng accelerates and continues to pummel Northern Luzon, an official of the agency's Disaster Response Management Group (DRMG) said.

DRMG Assistant Secretary and spokesperson Irene Dumlao said the agency has been giving augmentation support to the local governments units (LGUs) affected by the tropical storm enhanced by the southwest monsoon.

"Sa kasalukuyan, ongoing pa rin po ang isinasagawa natin na koordinasyon sa LGUs (As of now, coordination with local government units is ongoing) especially that Enteng is battering naman (again) the northern part of the country, Region 2 (Cagayan Valley)," Dumlao said during an interview over state-run Radyo Pilipinas.

Based on the September 3 DSWD-Disaster Response Operations Management, Information, and Communication report, there are 219 families or 805

persons in the Cagayan Valley Region affected by the weather disturbance.

The DSWD Field Office 2-Cagayan Valley is closely coordinating with all Local Disaster Risk Reduction and Management Office and Local Social Welfare and Development Office to monitor their respective areas of responsibility.

# San Pedro raises 'extreme risk' alert as Enteng intensifies

SANTA CRUZ, Laguna (PIA) – The city government of San Pedro on Monday, September 2 raised the Charlie Protocol or Red Alert status throughout the city as Tropical Depression Enteng brought strong to torrential monsoon rains beginning Sunday.

San Pedro City mayor Art Mercado said that the City Disaster Risk Reduction and Management Office (CDRRMO) regularly conducts meetings to ensure appropriate response are being implemented.


"We are currently conducting emergency meetings led by the San Pedro CDRRM Council Response Cluster and Incident Management Team. The rescue and evacuation response is still ongoing in the affected areas," Mercado said in a Facebook post.

# RDRRMC in Calabarzon assures aid for Enteng-hit areas

CALAMBA CITY (PIA) – The Disaster Risk Reduction and Management Council in Calabarzon said government aid is ready for dispatch in areas affected by Tropical Storm 'ENTENG.'

Carlos Eduardo Alvarez III, Office of Civil Defense IV-A Regional Director, said the RDRRMC has placed its Regional Emergency Operations Center under 'BLUE' alert status to ensure quick and seamless relief response in affected areas.

"The Regional DRRM Council is on top of the situation. At present, our Regional Emergency Operations Center is on Blue Alert Status and with the DSWD (Department of Social Welfare and Development-CAL-ABARZON, we have already activated our Response Cluster."

Alvarez added: "We are in close coordination with all the re-



gional-line agencies and our LGUs to ensure provision of necessary humanitarian assistance to our affected population. The government is really working to manage the situation."

The DSWD Field Office IV-A has been coordinating with the Provincial Social Welfare and Development Offices (PSWDO) to ensure that the provisions of for the affected residents are on standby.

Barry Chua, Regional Director of DSWD IV-A, has also advised the City Government of Bacoor to utilize

the Family Food Packs in their satellite warehouses as provisions for the affected families. Other LGUs with prepositioned food and non-food items are also preparing relief packs that will be distributed in the affected areas.

In its report, OCD IV-A logged 1,455 families or 5,358 individuals currently taking temporary shelter in evacuation centers across the Provinces of Cavite, Laguna, Rizal, and Quezon. (PB/PIA-4A; with reports from OCD CALABAR-ZON)

### La Mesa Dam level reaches 80m; likely to rise further

MANILA – The weather bureau said La Mesa Dam's water level reached 80.03 meters as of 3 p.m. Monday and it is expected to rise further due to continuous rains.

The dam's spilling level is 80.15 meters.

The Philippine Atmospheric, Geophysical and Astronomical Services Administration (PAGASA) said this is expected to affect low-lying areas along the Tullahan River from Quezon City, Valenzuela and Malabon.

Residents of those areas, especially near the river banks, are advised to be alert against further increase of water level along the river.

Tropical Storm Enteng (Yagi) enhances the southwest monsoon, bringing heavy rains in many parts of Luzon, including Metro Manila.

Road closures due to floodsThe Department of Public Works and Highways (DPWH), meanwhile, reported that three national roads are closed while seven others are open only to heavy vehicles in Calabarzon due to floods caused by Tropical Storm Enteng and the southwest monsoon.

Based on the report of agency's Bureau of Maintenance (BOM), the impassable roads in Rizal province are the Manila East Road --Barangay San Juan in Morong, Barangay Gamo and Tandang Kutyo sections in Tanay town and Barangay Takungan and Bagumbayan sections in Pililla town; J.P. Rizal St. in Baras town; and Sagbat Pililla Diversion Road in Barangay Maybancal in Morong town.

The roads with limited access are: General Evangelista Road in Barangay Maliksi I, Bacoor City in Cavite; Imelda Avenue in Barangay Sto. Domingo, Cainta town; Cainta Kaytickling Antipolo Teresa Road in Barangay San Juan, Taytay town; Manila East Road (Taytay Bayan) Barangay Isidro, Taytay town; San Mateo-Rodriguez Road, Barangay Ampid, Dulong Bayan, and Maly sections in

San Mateo town and Barangay Mangahan section in Montalban town; Tanay Sampaloc Road, Barangay Plaza, Aldea; and Rodriguez San Jose-Quezon City Road, Barangay San Jose, Montalban town. Motorists are advised to avoid these flooded areas and use alternate

routes.
The Manila City government, meanwhile, activated response measures amid bad weather due to Enteng.

Mayor Honey Lacuna has mobilized all of the six city-run hospitals, along with the Manila Disaster Risk Reduction Management Office (MDRR-MO), the Department of Engineering and Public Works and the

city's Department of Social Welfare to assist those who are affected by the storm.

She also visited the affected areas that include Barangays 101 and 128 in Tondo, as well as Baseco and Isla Puting Bato, among others.

Families in areas that are hardest hit during typhoons were also ordered evacuated to ensure their safety.

The Department of Public Services was directed to assist the MDRRMO and the Engineering Office in clearing roads of fallen trees and other forms of obstruction that may have been caused by floods. (with Ferdinand Patinio/PNA)

## Japan records hottest summer for 2nd year in a row

ISTANBUL – Japan has experienced its hottest summer in 2024 since record-keeping began in 1898, matching the high set in 2023, local media reported on Monday.

The average temperature between June and August was 1.76 degrees Celsius (35.1 degrees Fahrenheit) higher than the average recorded from 1991 to 2020, Japanese Kyodo News reported, citing the Japan Meteorological Agency.

The country reported 8,821 occurrences of "extreme heat" at

or above 35 degrees Celsius, exceeding the previous year's high of 6,692, the media outlet added.

During this time, 144 out of 914 monitoring locations across the nation either broke or matched their historical temperature records, it said.

The weather agency has warned the public to prepare themselves for prolonged high temperatures into September, recommending heat stroke prevention measures such as using air conditioning when necessary. (Anadolu)
