### DTI, NEDA to review P64 daily food threshold: solon

MANILA – The National Economic and Development Authority (NEDA) has committed to review the country's food poverty threshold of PHP63.87 per person a day, according to a lawmaker.

During the plenary deliberations on the proposed budget of the Department of Trade and Industry (DTI)

for 2025, Pangasinan Representative Christopher de Venecia said the DTI and NEDA are working together to address concerns over the PHP64 per day food threshold, with the NEDA pledging to review it further.

"NEDA itself has acknowledged the need to revisit their methodology for this particular dataset that really elicited a lot of reaction from the Filipino people," De Venecia said.

De Venecia, the DTI's budget sponsor, said the agency will be coordinating with the NEDA particularly with regards to the methodologies and the prescription of the (Turn to p. 2)

# **Significant drop in rice prices** to be felt in January: DA

MANILA – With the reduced tariff on imported rice, a significant drop in its market price is expected in January, according to Department of Agriculture (DA) Secretary Francisco Tiu Laurel Jr. on Wednesday.

"Since demand for food usually spikes in December, we anticipate seeing a more substantial drop in rice prices by January," he

said in a statement.

Economic managers earlier projected around PHP5 to PHP7 per kilogram drop in rice retail prices due to tariff reduction from 35 percent to 15 percent under Executive Order No. 62.

Tiu Laurel said the public may observe the prices declining by October.

DA Assistant Secretary Arnel de Mesa, however, said they are monitoring already lower price levels as early as now.

"We can say na mababa na iyong presyo kasi may nakita na tayo na PHP42 sa limang pamilihan... coming iyan sa PHP50 noong mga nakalipas na buwan (that the price is dropping because we have seen some PHP42/kg in some markets...

That's coming from level)," PHP50/kg he said in a separate phone interview.

As of Tuesday, the prevailing price of imported regular-milled rice in Metro Manila is set at PHP42/kg and PHP45/kg to PHP55/ kg for imported wellmilled rice, according to DA-Bantay Presyo.

The local regular-milled rice rang-(Turn to p. 2)

### **Solar-powered water systems** to provide Batangueños reliable supply

CALAMBA CITY, Laguna – The Department of Public Works and Highways in Calabarzon (Region IV-A) has announced the completion of three solar water system projects in Batangas province that are expected to provide residents with reliable supply.

In a phone interview on Thursday, engineer Jehela Roxas, head of the agency's 4th District Engineering

Office (DEO), shared details about the integration of solar power technology into water systems in Barangay Castillo, Padre Garcia town; Barangay Catandala in Ibaan; and Barangay San Guillermo in Lipa City.

He said the projects were funded under the General Appropriations Act of 2023 at a total cost of PHP10 million. The care and maintenance of these facilities are supervised by the respective beneficiary barangays.

The projects, Roxas added, feature the installation of elevated tanks, waterworks syssolar-powered tems, submersible pumps, powerhouses with solar panels, and pipelines.

Notably, the project in Padre Garcia, situated within the Padre Garcia Polytechnic Compound, has significantly enhanced water accessibility for

### Farmgate prices

Tiu Laurel assured to monitor the welfare of local farmers as the country approaches the wet harvest season.

"Given the wet season, some areas are seeing palay being bought at PHP16 to PHP 17 per kilo. We need to monitor this closely to ensure farmers are not shortchanged," he said.

To date, the national average of fresh palay is at PHP19.42/ kg, lower than last August's PHP20.51/kg.

"Iyong (The) lowest is PHP16.5, the highest was PHP21 nitong (this) September... Nag-start na rin kasi ngayon iyong harvest season (the harvest season has also started)," De Mesa said.

Federation of Free Farmers Cooperatives national manager Raul Montemayor, meanwhile, urged the DA to recommend bringing the higher tariff back, especially during the peak harvest season in October to November.

"Pagdating ng anihan, kasi ang dami ngang supply dahil umaani ang mga magsasaka, iyon iyong time na dapat ibalik nila iyong taripa sa (When the harvest comes, because there's a huge supply due to harvesting farmers, that's the time they should revert to the old tariff of) 35 percent," he said.

"Kung ang dami-dami na ngang ina-ani locally, sabayan mo pa ng local imports dahil binabaan mo iyong tariff, ang resulta niyan oversupply. Sobra-sobra ang supply sa merkado, babagsak ang presyo ng palay (If there's so much local harvest, alongside rice imports at the lower tariff, it will result into an oversupply. That's more than enough supply in the market, the farmgate price of palay will surely drop)," Montemayor added.

De Mesa, however, assured that the National Food Authority (NFA)'s higher buying price of palay is still in place in case traders take advantage of local farmers.

"So long as hindi magkaroon ng pagbabago, and I don't think there will be changes at the moment doon sa (in the) buying strategy ng (of) NFA," he said.

The NFA's higher price ranges from PHP17/kg to PHP23/ kg for fresh or wet palay; and PHP23/kg to PHP30/kg for clean and dry palay.

"Hindi pa naman nauubos iyong pondo nila... Remember, mayroon pa silang excess fund noong last year na pwedeng magamit pa hanggang (They have not yet utilized all their funds. Remember, they still have excess fund last year which can still be utilized until) this year," he added.

De Mesa also said they are intensifying efforts to improve the capacity of NFA's post-harvest facilities including warehouses, drying, and milling.

To date, the NFA has PHP5 billion worth of funds for its post-har-

diet as informed by the Food and Nutrition Research Institute (FNRI) to align it with the current nutritional needs of Filipinos and prevailing food prices.

De Venecia noted that the threshold set by NEDA is limited in scope, excluding additional costs like cooking gas or liquefied petroleum gas (LPG), transportation, or dining out.

He said a family of five would need a much larger budget than the current per capita threshold to meet daily food needs.

To ensure availability and affordability of essential commodities, De Venecia said the DTI collaborates with private sector partners to make these products accessible to the public.

"It is imperative upon the DTI to work with the private sector that these be made available to the consumers so that they will be able to procure these commodities and items so that they can eat," he said.

In terms of the agency's interventions, De Venecia pointed out that the DTI is conducting the "Diskwento Caravan," which ensures the supply of basic necessities priced in accordance with or lower than the suggested retail prices.

De Venecia reiterated that the expansion of

### the "Diskwento Caravan" is crucial but dependent on the allocation of additional

funds to DTI's consumer protection programs.

He also mentioned the establishment of a food terminal in Tarlac, as well as similar initiatives like the Department of Agriculture's Kadiwa stores.

"So hopefully, mas maibsan yung mga pinagdadaanan ng ating mga kababayan (this would help alleviate the difficulties our fellow citizens are experiencing) with regards to their budget for their everyday food consumption," he said.

NEDA Secretary Arsenio Balisacan has earlier addressed the misconceptions about the food and poverty threshold.

In 2023, the amount needed to meet the basic food and non-food needs of a family of five, or the poverty threshold, was set at PHP13,873 per month.

The amount needed by a family of five to meet their basic food needs per month or the food threshold was PHP9,581.

"We recognize that poverty pertains to a state of deprivation and an individual's perception of the quality of life they enjoy compared to their aspirations. The food threshold represents

emphasized. "They also reduce electricity consumption and promote a safe, healthy, and productive environment for local residents." (PNA) the cost of a food bundle that meets the energy and micronutrient requirements of the average Filipino," Balisacan said.

He said these thresholds are part of a broader set of tools used to assess the country's development progress and measure the effectiveness of the government's policies and programs in addressing poverty.

"They are not, and were never intended to be, prescribed budgets for a decent standard of living. They do not dictate how much a family should spend on food, nor do they provide an idea of a desirable household budget. Instead, these thresholds, along with other socioeconomic indicators, are metrics that we use to determine the inclusiveness of the country's economic growth and if our policies have improved the well-being of the poor," he said.

Balisacan assured that the government, together with various sectors of society, is working tirelessly to address the root causes of poverty through a range of social protection programs, policy reforms, and development initiatives. (PNA)

### Malaysia reports 1 more mpox case, toll hits 10

ISTANBUL – Malaysia on Tuesday reported one more case of mpox, taking the overall toll to 10, the country's Health Ministry said.

The ministry said on X it received 58 suspected cases of mpox this year and a confirmed case of clade II variant.

There is no recent travel history of the patient, while health authorities are tracing the contacts of the pa-



tient.

Malaysia has recorded a total of 10 cases of mpox since July last year.

The World Health Organization (WHO) declared mpox a public health emergency of international concern on Aug. 14, after the new variant that appears to spread more

### **DENR collects over 2K tons of e-waste**

MANILA – The Department of Environment and Natural Resources- Environmental Management Bureau (DEN-EMB) has collected 2,350 tons of Cathode Ray Tubes (CRTs) or electronic waste found in electrical and electronic appliance, including television sets, during the past seven years. At the Polychlorinated biphenyl-Waste Electrical and Electronic Equipment (PCB-WEEE) Project Closing held at the Manila Hotel on Wednesday, DENR Undersecretary and Chairperson of the PCB/WEEE Project

PCB/WEEE Project Steering Committee Jonas Leones shared a positive outlook of the project.

The project aimed to get the cartridges from electronic appliance like TV sets, known as persistent organic pollutants that are detrimental to health, according to Leones.

"Itong project natin ang target sana natin makakuha tayo ng cartridge dun sa tv natin, pag binaklas natin, mga 50,000 units ang kailangan natin makuha at dun natin kukunin yung led. Kailangan natin ma-resolve yung POPs (persistent organic pollutants) natin because these substances or wastes ay very detrimental sa health natin (Our target for this project is to get a cartridge from TVs, when we disassemble it, we need to get about 50,000 units, and that's where we'll get the led. With this project, we need to resolve our POPs because these substances or wastes are very detrimental to our health)," Leones said.

He said that studies have shown that chemicals and substances from e-waste are carcinogenic or cancer-causing agents.

"Ngayon katapusan ng project natin (Now that the project has ended) we have accomplished more than the targeted amount or volume that we need to collect," he said.

The PCB-WEEE Project, which started in 2017, has collected and processed a total of 107,000 units of CRTs TVs and monitors.

From this, 145 tons or 131,542 kilograms of recyclables were generated, 900 tons of lead-containing glass from the CRTs, and 1.12 tons of Polybrominated Diphenyl

### Ethers (PBDEs) were disposed of.

The DENR said that the established materials recovery facility (MRF) used to segregate and store wastes was upgraded into treatment, storage, and disposal (TSD) facilities, renovating the space to collect and treat e-waste properly. This has also resulted in the creation of green jobs for residents coming from the four focus areas including Bagong Silang and Camarin in Caloocan City, Longos in Malabon, Capulong in Tondo, Manila, and Baguio City.

Aside from television sets, e-waste also includes other appliance such as refrigerators, freezers and other cooling equipment, computers, telecommunications equipment such as cellphones, consumer electronic devices, solar panels, and monitors and screens, among others.

Meanwhile, Carmela Centeno, chief of the Responsible Materials and Chemicals Management Unit of the United Nations Industrial Development Organization (UNIDO), which serves as co-implementor of the project, said the country is very new in e-waste management and has a long way to go.

However, she said that UNIDO sees a lot of hope in the Philippines in terms of e-waste management as local government units respond positively.

She also noted that more Filipinos, and even producers and manufacturers from the business side, have become aware of the issue.

UNIDO Chief for the Division of Circular Economy and Green Industry Smail Alhilali said that e-waste is one of the fastest waste streams in terms of generation as there are many ICT (information and communication technology) products in the market.

"In terms of e-waste generation on the global level, around 50 to 60 million tons per year," he said. (PNA)

### Largest Pinoy 'grocerant' in N. America opens digital hub for OFWs

MANILA – The largest Filipino grocery and restaurant (grocerant) in North America Seafood City launched here Wednesday its comprehensive digital marketplace for Filipinos across the world.

SFC+, Seafood City's digital hub, aggregates top Filipino and US brands that allows users to shop online for products and food available in Seafood City physical stores.

Aside from online shopping, SFC+ users can pay bills, send zero-fee remittances, do online banking, purchase a condominium, donate in charity organizations, and earn points, among others.

During the SFC+ launching at Makati Shangri-La in Makati City, SFC+, Inc. president and chief executive officer Elewin Rebaya said the digital marketplace's initial target market is Seafood City's 1 million weekly in-store traffic and over 400,000 active membership base in North America.

"Our major objective is actually to go globally to other parts of the world so that all the Filipinos have exclusive access to the app," said Rebaya, who is also the executive vice president for Seafood City.

He added they are looking into launching SFC+ in regions where overseas Filipinos are present in the future.

The company partnered with Talino Venture Studios for the development of the app.
