PBBM scores 50% approval, trust ratings: Pulse Asia polls

MANILA – President Ferdinand R. Marcos Jr. scored 50 percent on the latest Pulse Asia survey on the performance and trustworthiness of the country's top government officials, which was released Monday night.

The survey, conducted from September 6 to 13, 2024 indicated

that Marcos' approval and trust scores were at 50 percent.

Meanwhile, Vice President Sara Duterte's approval went down by 9 percentage points, while her trust rating dipped by 10 percentage points.

The President's satisfaction rating in September is 3 points lower than June's figure of

53 percent.

The September survey found that 29 percent of the respondents were undecided and 21 percent were dissatisfied with Marcos' performance.

The President's trust score in September also slightly dropped 2 points from the 52 percent recorded in June.

DA stresses urgency of commercializing ASF vaccines

MANILA – The Department of Agriculture (DA) on Tuesday emphasized the need for the approval of the AVAC live vaccines for commercial distribution before the year ends, following the rising number of areas affected by the African swine fever (ASF).

The DA-Bureau

of Animal Industry (BAI) earlier reported that ASF-affected barangays in the country rose from 472 last Sept. 6 to 524 on Sept. 20 despite stringent biosecurity measures and the ongoing government-controlled vaccination in Lobo, Batangas.

Chiz: PhilHealth has enough fiscal space to cut premium rates

MANILA – Senate President Francis "Chiz" Escudero on Tuesday said the Philippine Health Insurance Corp. (Phil-Health) can afford to slash the mandatory contribution paid by its members due to the huge amount of unutilized funds that it has accumulated over the years.

In a news release, Escudero noted that Phil-Health's reserve fund

has now reached nearly PHP500 billion, plus the substantial annual government subsidy that it receives.

In 2021, the subsidy to PhilHealth amounted to PHP71.3 billion, PHP80 billion in 2022, PHP79 billion in 2023, and for this year, it was down to

PHP40.3 billion.

"The huge subsidies allocated annually to PhilHealth, coupled with its continually increasing reserve fund, provide the state health insurer ample room to reduce the premium

rate of its members," Escudero said.

He also maintained that the government would still be able to reallocate a significant amount of funding for other purposes for sev-

tinuous challenge. So, we really need to have the vaccines commercialized)," DA Assistant Secretary Arnel de Mesa said in a phone interview.

"We're hoping that within the year, before the year ends, mayroon nang (we already have a) commercial approval."

De Mesa stressed the urgency of its immediate approval considering the "most dreaded" season in the livestock industry on top of the ASF threat.

He said the third quarter of the year, marked by monsoon rains, is historically the season for widespread diseases in livestock.

He, however, said the DA will continue to implement stringent border control measures.

en years if these subsidies were to be sourced from the firm's reserve fund

"Pero imbes na gawin 'yon, isa sa mga istratehiya na pwede nilang pag-aralan ay ang gamitin na lang (ang reserve fund) para pababain yung premium na karamihan naman ay gobyerno rin ang nagbabayad (But instead of doing that, one of the strategies they can study is to just use the reserve fund to lower the premium, which is mostly paid by the govern-ment anyway)," Escudero said.

The Senate President has been pointing out to PhilHealth that it is losing around PHP20 billion a year in terms of value by not utilizing its PHP500 billion reserve fund.

"Kaya para sa akin mas maganda na gamitin ang perang 'yan para matulungan ang In terms of the ASF government-controlled vaccine rollout, de Mesa said the BAI and the Food and Drug Administration had committed before the Senate to wrap up and secure results in November.

To date, 524 barangays in 125 municipalities and 31 provinces were still classified as red zones.

The highest number of affected barangays are in North Cotabato with 127, Quezon with 97, Batangas with 72, and La Union with 40.

In Calabarzon alone, which serves as one of the major pork sources in Metro Manila, 200 barangays are considered red zones. (PNA)

Escudero is also pushing for PhilHealth to adjust its case rates based on the amount of contributions paid by its members, ensuring that members paying higher premiums receive higher benefits.

He noted that this "adjustment mechanism" for premiums

DOJ launches awareness campaign on critical issues

MANILA – The Department of Justice Action Center (DO-JAC) has launched its "Justice in Action Lecture Series" to raise awareness, provide a platform for open dialogue, and empower individuals to take action against violence and discrimination, as well as other critical issues.

"By engaging experts, advocates, and community leaders, the lecture series seeks to educate and inspire participants to advocate for justice and equality," the DOJ said in a news release Tuesday.

Working with women's rights group Kababaihan, the inaugural session gathered law students from the San Sebastian College of Law in Manila on Monday to tackle vital topics of rape and the Safe Spaces Act, according to the DOJ.

DOJAC head Undersecretary Margarita Gutierrez underscored during the session the urgency of the awareness campaign in addressing abuse against women.

"It is heartbreaking to know that for every case we hear or study about, countless others remain silent and unreported, trapped in shadows of fear and stigma. We see only the tip of the iceberg, while beneath the surface lies a vast ocean of suffering and unspoken truths," she said.

"We must be the voices for those who cannot speak, the advocates for those who have been silenced by fear."

Gutierrez encouraged the participants and members of the community to join the lecture series and be part of the movement towards a safer and more equitable society.

Justice Secretary Jesus Crispin Remulla, meanwhile, said the legal lecture series plays a vital role in empowering the people the much-needed wisdom about law and justice.

He said they can utilize this knowledge "to protect themselves and their loved ones from violence, discrimination and other forms of attack."

Earlier, the DOJ and the Philippine Association of Law Schools (PALS) entered into a memorandum of agreement to strengthen access to legal services

In a separate statement, the DOJ said it has launched a manual of writing style which aims to institutionalize legal writing and communications in the department.

The document provides a streamlined guideline in legal writing which includes form, style and certain principles to provide easier and better understanding between the DOJ and its clients.

"Attuned to the present times, this manual will serve as a blueprint on legal writing, style and other formal correspondence," Remulla said. (PNA)

The survey showed that 22 percent of the respondents had little or no trust for the President, while 28 percent were undecided.

Among geographical areas, the President got the highest satisfaction rating in Balance Luzon at 61 percent, followed by Metro Manila and Visayas both at 52 percent.

He got the lowest score in Mindanao at 26 percent

President Marcos' trust rating was highest in Balance Luzon at 64 percent, while the lowest was recorded in Mindanao at 21 percent.

Marcos' approval and trust ratings were highest among the Class D income bracket both at 52 percent.

Duterte's approval went

and benefits was also mentioned by President Ferdinand R. Marcos Jr. during the recently-held Legisdown from 69 percent in June to 60 percent in September, while her trust rating went down from 71 percent to 61 percent.

For other government officials, Senate President Chiz Escudero had an approval rating of 60 percent and a trust rating of 56 percent.

Speaker Martin Romualdez received a 32 percent approval score and a 31 percent trust score among respondents.

The September 2024 Ulat ng Bayan national survey was conducted through face-to-face interviews with 2,400 respondents nationwide. The survey has a ±2% error margin at the 95% confidence level. (PNA)

Elderly population worldwide to surpass youth by 2030

ANKARA – By 2030, the global population aged 65 and older is expected to outnumber the youth, with the elderly projected to double the number of children under five.

In 1990, the UN declared Oct. 1 as the "International Day of Older Persons" to address the challenges of an aging population and improve the conditions of the elderly.

Recent UN forecasts project the global population to reach about 8.5 billion by 2030, 9.7 billion by 2050, and 10.4 billion by 2100.

By 2030, the number of individuals aged 65 and older is expected to surpass that of the youth population, with the elderly projected to double the number of children under five.

The UN defines the youth population as those aged 15 to 24.

The global population aged 65 and older is projected to more than double, reaching 1.6 billion by 2050. If this forecast holds true, the elderly will comprise over 16 percent of the world's population.

In 1950, individuals aged 65 and older represented one in 20 people globally. By 2021, this ratio had changed to one in 10, and it is projected that by 2050, this age group will account for one in six people worldwide.

Asia, Europe host most of world's oldest populations

According to the UN's 2023 World Social Report, Asia and Europe host most of

the world's oldest populations.

Japan leads with 30 percent of its population aged 65 and older, followed by Italy at 23 percent.

Finland, Portugal, and Greece each have an elderly population rate of around 22 percent.

Meanwhile, Hong Kong and South Korea are expected to surpass Japan, with their elderly populations reaching up to 40 percent.

Southern Europe, which includes Greece, Italy, Malta, Portugal, and Spain — where the elderly population has reached 21 percent— is considered "the world's oldest region."

Aging population increasing in developing countries

Population aging is progressing more rapidly in developing countries than in developed ones.

By 2050, the majority of the world's elderly population is expected to reside in developing countries.

Most developed nations have long implemented policies to address the societal needs of their aging populations. In contrast, many developing countries lack the infrastructure to meet the needs of their rapidly aging citizens.

As a result, there are calls for developing nations to take action

to address the needs of their aging populations.

Calls for review of policies addressing aging population

Each year, conferences and events are held around a specific theme to commemorate Oct. 1, "International Day of Older Persons."

This year, marking the 34th observance by the UN, the theme for 2024 has been set as "Dignified Aging: The Importance of Strengthening Care and Support Systems for Older Individuals Worldwide."

Aging populations require societies to adapt and create the necessary social and physical environments for this age group.

The aging population has significantly increased the demand for healthcare, and social services, particularly for the elderly with conditions like dementia.

This includes protecting the rights of elderly individuals in care, respecting their dignity, beliefs, needs, and privacy, and promoting such approaches.

The UN is calling for the development of strengthened policies for care and support systems for older individuals, as well as a review of existing legislation on this issue. (Anadolu)

PH factory index in September highest in 2 years

MANILA – Philippine factories solidified their performance at the end of third quarter of the year, recording a 53.7 purchasing managers' index (PMI), the highest since mid-2022, S&P Global Manufacturing PMI reported Tuesday.

The country's manufacturing PMI in September 2024 was also stronger compared to the 51.2 index in August this year.

S&P Global Market Intelligence economist Maryam Baluch said the significant improvement in the Philippines manufacturing performance in September was mainly driven by the sharp expansions in factory output and new orders.

Baluch said the domestic demand buoyed the local industry despite the notable drop in orders from overseas markets.

"While weak international demand and supply chain issues will act as headwinds, robust domestic demand is expected to drive growth," she said.

The survey said manufacturers also increased their hir-

ing and purchasing activities amid higher production and heightened business confidence for the next 12 months.

S&P said job generation in September remained modest but the strongest since March this year.

On the other hand, inflationary pressure due to higher supplier prices and weather disturbances was also observed last month.

"However, inflationary pressures remain historically subdued which supports the central bank's recent decision to ease monetary policy," Baluch

said

Meanwhile, compared to ASEAN neighbors that recorded positive manufacturing PMI in September, only the Philippines posted an increase in index.

Malaysia, Indonesia, Vietnam, and Myanmar posted indices below 50, reflecting a deterioration of their local manufacturing sector.

Those above the neutral scores of 50, including the Philippines, Singapore, and Thailand, meant an improvement in their factory performances. (PNA)

Reproductive health education helped drive down teen pregnancies in CALABARZON, says CPD

CALAMBA CITY (PIA) – Empowering the youth to make informed reproductive health choices has helped reduce teenage and adolescent pregnancies in CALABARZON, according to the Commission on Population and Development (CPD).

In an interview with the Usapang PIA radio program, Regional Director Marilyn Ogaya said CPD CALA-BARZON implements information dissemination drives and programs targeting the youth with the help of the Department of Health (DOH), Department of Education (DepEd), and various local government units.

"We are empowering the youth, their teachers, parents, and the entire community, including the SK (Sangguniang Kabataan), to make informed choices. We provide training to all of them to help avoid early pregnancy and engaging in sex at a young age," Ogaya explained.

In its latest data, CPD CALABARZON reported that Laguna logged the highest number of teenage pregnancy cases among the region's five provinces. Meanwhile, Tanza, Cavite, ranked first among the 20 local government units with the highest number of pregnancy cases for girls aged below 15 years old.

"Although there are still many girls aged below 15 years, whom we call 'very young adolescents,' getting pregnant, the number of 15- to 19-year-olds who have become mothers is decreasing," Ogaya explained.

"This decline can be attributed to the massive information dissemination efforts by the Commission on Population and Development, along with our partner agencies like the Department of Health, DepEd, and the local government units who helped implement our programs," she added.

Citing the 2021 Young Adult Fertility and Sexuality study by the University of the Philippines's Population Institute, CPD CALABARZON's chief explained that adolescent pregnancies are the result of a combination of socioeconomic factors, including migration, social media, and lack of parental guidance. Urbanization and technology have also influenced the sexual behaviors of adolescents and young adults.

The same study also found that young women aged 15 to 24 have very little access to information (39 percent) on reproductive health and sexuality, gathering material from social media (31 percent). Meanwhile, 26 percent of young men gather their information on sex from social media, or have no access at all (44 percent).

Ogaya noted: "There are more opportunities, such as access to technology, and the current generation of youth is different from our generation in the past."

"Youngsters get curious, and sometimes parents cannot watch over their children, what they see online, and how they use their gadgets. And because kids are curious, they experiment," she add-

The Responsible Parenthood and Reproductive Health Act of 2012—more commonly known as the RH Law-became instrumental in providing women and girls with universal access to methods of contraception, fertility control, sexual education, and maternal care.

Other issuances. such as Executive Order 141 signed by then-President Rodrigo Duterte, provided CPD the opportunity to mobilize governmechanisms ment to address the rising number of teenage pregnancies in the country.

In 2022, the Philippine Statistics Authority (PSA) reported that 10.1 percent of registered births were to mothers aged between 15 and 19 years old, which are considered high-risk pregnancies due to complications during pregnancy and labor that may result in higher morbidity and mortality for both mother and child. DHSUD promotes open spaces in 4PH housing projects

CALAMBA CITY (PIA) – The Department of Human Settlements and Urban Development (DHSUD) in CALABARZON stressed the need to balance promoting open spaces within the government's flagship housing program.

In a briefing during the Kapihan sa Bagong Pilipinas, Regional Director Jean Paul Ilao explained that the Pambansang Pabahay Para sa Pamilyang Pilipino Program (4PH) requires real estate developers that 40 percent of the total land area of the project be dedicated to open spaces.

"Our Secretary [Rizalino Acuzar] has required real estate developers who wish to participate in the 4PH program to dedicate 40 percent of the housing site to open spaces. This must be complete: open spaces and commercial spaces,"

These standards, Ilao emphasized, follow the Batas Pambansa No. 220 and Presidential Decree 957 which aim to protect buyers from fraudulent and unscrupulous real estate developers.

Jenica Hosingco, Project Development Officer of DHSUD



IV-A, emphasized that local government units are major stakeholders to the Marcos Jr. administration's flagship housing program, as they determine both national and local government lands suitable for human settlement, enabling key shelter agencies to build housing facilities.

"One of the roles of local government units is to propose sites for housing purposes, which will then be inspected by the DH-SUD. These sites must meet the required standards. They shouldn't be too elevated or hilly. As much as possible, the proposed sites should be flat and suitable for residential purposes."

Engr. Emmanuel Glipo, chief of Housing, Real Estate Development and Regulation DivisioN (HREDRD) of DHSUD IV-A assured that prospective developers undergo careful compliance measures to ensure the

area's suitability for inhabitation, including its location and environmental impact.

"Before releasing permits, we make sure that prospective developers have submitted complete documents. We have never issued a license with incomplete requirements because we also consider the area's suitability with the environment and location, both of which were determined by the LGU,"

Glipo emphasized: "We do not issue licenses to developers who submit incomplete documents that do not meet our list of requirements."

In 2024, DHSUD CALABARZON conducted orientations on the 4PH program to 55 local government units, exceeding its initial target of 10 LGUs.

It has also inked 23 Memoranda of Understanding for the implementation of 4PH, including the munic-
