## UN cites DSWD LAW-BINHI as one of best practices vs climate change

MANILA – The Department of Social Welfare and Development (DSWD) has gained another badge of honor after the United Nations Office for Disaster Risk Reduction (UNDRR) lauded Project LAWA and BINHI for its invaluable contribution to climate resilience initiatives.

"In a LinkedIn post by UN Assistant Secretary-General Reena Ghelani, she mentioned our LAWA and BINHI project, citing it as among the best practices in response to the prevalent issues related to climate crisis and El Niño," DSWD spokesperson Irene Dumlao said in a statement on Tuesday. DSWD's Project LAWA and BINHI stands for Local Adaptation to Water Access and Breaking Insufficiency through Nutritious Harvest for the Impoverished.

Ghelani lauded the implementation of Project LAWA, saying it "developed as a sustainable solution to wa-

# DA to lower NFA's palay buying price for wet harvest

MANILA – The Department of Agriculture (DA) is set to lower the buying price of palay of the National Food Authority (NFA) to help ease retail prices of rice during the wet harvest season.

"World prices, medyo bumaba na rin and hindi bababa ang price ng bigas sa merkado kung ang buying price (of palay) pa rin ng trader at gobyerno ay mataas (somewhat decreased and the retail price of rice will not drop if the buying price of palay of traders and the government remain high)," DA Secretary Francisco Tiu Laurel Jr. said in an ambush interview on Wednes-

day at the sidelines of the Senate committee budget hearing.

"Hindi na ho (It's no longer) PHP30. As of today PHP26, PHP27 na. By next week, nag-usap na kami ni NFA Administrator Larry Lacson, ibababa natin (I already talked with NFA Administrator Larry Lacson,

we will lower it) to PHP23. But of course, we have to inform the farmers first para hindi sila ma-shock (so that they will not be shocked)," Tiu Laurel said.

Under the NFA's higher buying price scheme, prices range from PHP17 to PHP23 per kilogram for fresh or wet palay and PHP23 to PHP30/kg for clean and dry palay.

Tiu Laurel, however, assured that farmers would still secure profit despite the drop in buying price.

For his part, Lacson said the lowered buying price will remain in a range to be able to play with the market.

"It's not really an abrupt going down of price. As mentioned by the Secretary na (that) in a matter of 8 to 10 days, bababa na iyan (it will go down)," he said.

Lacson added that the move will also help NFA buy a higher volume of palay for the national rice buffer stock and help more farmers.

Earlier, Tiu Laurel said the public may start to experience the lower retail price of rice by mid- or end-October, considering import arrivals under the lower tariffs and the wet harvest season, with the full effect expected in Jan-

# Bus service from UP Los Baños to UP Diliman now operational

LOS BAÑOS, Laguna (PIA) – A more convenient point-to-point bus from two major campuses of the University of the Philippines (UP) in Los Baños, Laguna to Diliman, Quezon City is now operational.

According to UPLB, this initiative was made to address the increasing demand for a direct bus service between the said campuses that has surged due to various purposes, including inter-campus coordination, research collaborations, and participation in university events.

In order to implement the dedicated bus route, UPLB administration has partnered with local bus compa-

ter scarcity caused by the El Niño drought."

"LAWA, which means pond in Tagalog, was the first of its kind and built on the success of previous government-supported cash-for-work programs. The project provided temporary employment and empowered disadvantaged communities to build small farm reservoirs to ensure access to water for irrigation," Ghelani's LinkedIn post read.

The UN executive also praised Project BIN-HI in communities that capitalized on water irrigations to operate vegetable gardens and plant climate resilient crops.

Ghelani was likewise impressed by the Cashfor-Work mechanism of the program, citing it as a leverage to community involvement in addressing scarcity in nutrition and food security.

The DSWD assured that under the leader-ship of Secretary Rex Gatchalian, the agency will continue to implement LAWA and BIN-HI projects and equip vulnerable communities

"On behalf of the entire DSWD community, we appreciate your favorable remarks on our project. What makes this extra special for us is it is from someone who has traveled the world, one who has witnessed competitive climate change responsive mechanisms," Dumlao said.

Project LAWA and BINHI is designed to maintain agricultural productivity during dry periods and to manage excess water during periods of heavy rainfall associated with La Niña.

The project is among the DSWD's innovations that focuses on mitigating the impact of food insecurity and water scarcity caused by El Niño while preparing for the potential effects of the rainy season.

Project LAWA and BINHI was cited by President Ferdinand R. Marcos Jr. in his third State of the Nation Address (SONA) on July 22, prompting the DSWD chief to say that "our small idea has become a SONA program." (PNA)

#### PhilHealth mulls emergency care packages in 2025

MANILA – The Philippine Health Insurance Corporation (PhilHealth) is studying how it could include emergency care services in the benefit packages offered to members next year.

PhilHealth Health Finance Policy Sector senior vice president Israel Francis Pargas on Monday affirmed that there is a "gap" in the health benefits they provide which already include the primary health care and confinement packages.

The gap being the emergency or urgent care package, he said during a media forum in Quezon City.

"Ayon sa Universal Health Care Law, binabanggit na dapat makapag-provide ang PhilHealth ng ganitong

benepisyo, 'yan po ay pilit na nating tuparin ngayon at pinag-aaralan na po (According to the Universal Health Care Law, it says that Phil-Health must be able to provide a benefit such as this. We will try to accomplish this and we're studying) on how we can actually cover the emergency care," Pargas said.

"Hopefully, matapos and polisiya by this year and hopefully by 2025, meron na po tayong emergency care package (Hopefully, the policy is completed this year and hopefully by 2025, we already have an emergency care package)."

#### PhilHealth backs reduction of premium rates to 3.25%

MANILA – The Philippine Health Insurance Corporation (PhilHealth) on Monday said it supports the reduction of the mandatory contribution paid by its members.

"I think if I am not mistaken, it's from five percent, they will bring it down to 3.25 percent," PhilHealth president and chief executive officer Emmanuel Ledesma Jr. said in a media forum in Quezon City.

"That will be a huge help, I think, to the people... that will be around PHP40 billion a year.. ang laking savings niyan sa mga tao (that will be a huge savings for the people). Once the bill is passed, we will definitely follow, we will be happy to move po," he added.

The Senate has approved the bill seeking to amend the Universal Health Care Act to bring down the premium rate paid by the direct contributors of the state insurer.

Ledesma noted that PhilHealth has adequate funds which explains its aggressive expansion of the health benefit packages, reducing the outof-pocket expenses of its members.

Apart from the continuous increase in premium rates as mandated by law, Ledesma said the excess funds of Phil-Health were brought about by the 10-year non-enhancement of the benefit packages

and few benefit claims during the Covid-19 pandemic.

PhilHealth Senior Vice President Renato Limsiaco Jr. said that PhilHealth's investments have reached PHP512 billion as of Oct. 5 this year with over PHP9 billion remitted to the national government.

Its payouts for case packages have reached PHP120 billion as of Sept. 30.

When asked about going bankrupt amid the increases in benefit package rates, Ledesma said the state insurer adjusts the case rates and enhances members' benefits. (PNA)

Manila and Seoul signed the bilateral FTA on Sept. 7, 2023, four years after the trade negotiations were initiated in June 2019.

This made the Philippines-South Korea FTA the country's third bilateral trade pact aside from Japan and the European Free Trade Association.

On Sept. 23, 2024, the Senate concurred with the trade pact.

The Korean government, on the other hand, has yet to ratify the deal.

"The ratification bill submitted to the National Assembly at the end of last year was scrapped as the 21st National Assembly came to an end," Seoul's Ministry of

Trade, Industry, and Energy through Korean Culture and Information Service told the Philippine News Agency in a message Tuesday.

"The ratification bill was submitted to the Foreign Affairs and Unification Committee in August, with the Ministry of Foreign Affairs being the submitting entity," the Korean government added.

Unlike trading under most-favored-nation (MFN) treatment, or the normal trade relations of countries with no special tariff advantages, FTAs provide better market access among FTA parties through lowered or scrapping of trade duties. (PNA)

#### Sagging PH banana industry gets boost from FTA with S. Korea

MANILA – The Department of Trade and Industry (DTI) is optimistic that the Philippines-South Korea free trade agreement (FTA) will save the country's banana exports to South Korea, which is currently losing its market to Vietnam and other Latin American countries.

In an interview with Pilipinas Bagong Ngayon Tuesday, DTI Undersecretary Allan Gepty said the market share of fresh bananas in South Korea dropped to 65 percent in 2023 from a high of 98 percent in 2013.

Gepty said the increasing market competition and the FTAs of South Korea with other banana exporting countries such as Vietnam, Ecuador, Colombia, and Peru are becoming a disadvantage to the Philippines.

This year, fresh banana from Vietnam enters South Korean market tariff-free because of their bilateral FTA, while Philippine banana products are slapped with 30 percent duty.

Gepty said that with the Senate's concurrence of the FTA between Manila and Seoul, Philippine banana exports will gradually become zero-tariff when entering South Korean borders, five years after the trade pact enters into force.

"To our stakeholders, take advantage of these various free trade agreements that we have negotiated and concluded," he said.

"Because right now, the market is not just confined here in the Philippines, it's the rest of the world. These FTAs are [a] platform for you to conduct business in a stable and predictable business environment," said Gepty, who is the country's top negotiator for trade deals.
