CALAMBA CITY, LAGUNA (PIA) – The Department of Education (DepEd) in Calabarzon is expediting the hiring of teaching and non-teaching personnel to better improve the quality of education and reduce the administrative workload on teachers.

Citing Education Secretary Sonny Angara's directive to fill vacant



positions, DepEd IV-A Assistant Regional Director Loida Nidea said that they are targeting to complete this

Cavite, Laguna motorists to benefit from MTP South road segments

TRECE MARTIRES CITY, Cavite (PIA) — Motorists from Cavite and Laguna will soon benefit from the completion of several key segments of the Cavite-Laguna Expressway (CALAX) and CAVITEX C5 Link, currently being developed by Metro Pacific Tollways Corporation (MPT South).

In a statement released by MPT South, these segments include the CALAX Governor's Drive Interchange, Open Canal Interchange, and Kawit Interchange, as well as the C5 Link Segment 3B, which



will connect the current Sucat Interchange to the C5 Link Flyover Extension, spanning from SLEX-Taguig to E. Rodriguez in C5.

The CAVITEX-CA-LAX Link, currently under construction, will integrate these two major toll roads, creating a more seamless travel route for motorists.

According to MPT South, traffic growth of more than 30% is expected by the end of 2025, translating to over 340,000 daily motorists, a significant increase from the current 259,815. These road segments are set to be operational before the end of 2025, expanding MPT South's total road network to 67 km.

PHLPost resumes issuance of postal ID

MANILA – The Philippine Postal Corporation (PHLPost) has resumed the issuance of the postal functional card (Postal ID) nationwide.

In a news release Thursday, the PHL-Post said the Postal ID registration started on Oct. 15 to provide address verification to anyone who needs the card.

Government and private institutions can use the Postal ID to ensure correct delivery of letters and parcels.

"We expect that people will be going to renew or apply for a Postal ID card at the very least, and the public should be aware not to fall from scammers who will try to get money and obtain their personal information via text or messages and through social media sites," PHLPost Postmaster General Luis Carlos said.

Funding legitimate concern in disaster risk management

MANILA – Environment and Natural Resources Secretary Maria Antonia Yulo-Loyzaga on Thursday said funding is an extremely important concern that must be addressed amid efforts to strengthen disaster risk management.

At the closing press conference of the Asia-Pacific Ministerial Conference on Disaster Risk Reduction (APMCDRR) in Pasay City, Loyzaga and Special Representative of the United Nations Secretary-General for Disaster Risk Reduction and head of the UNDRR Kamal Kishore underscored the need for better funding to support the management of disaster risk reduction.

"This issue of financing will not go away. We need to address this head-on and for us in the developing countries in the Asia-Pacific, I think it's extremely important to look at the profile of our development financing that we have available and to see that these in fact are risk-sensitive and are locally driven in terms of the way they have been engineered and structured," Loyzaga said.



about funding disaster risk reduction management.

"This conversation encompasses financing from national budgets, financing from international sources, climate finance, private finance, and use of insurance instruments," he said.

Among the issues discussed include the funding for preventive investments and disaster response, increased access to finance for people-centered and inclusive local resilience, enhancing the involvement of the private sector in disaster risk reduction financing, creating conditions for financing and investment for disaster and climate-resilient infrastructure, and data-driven decision-making for risk-informed development and financing.

Meanwhile, Loyzaga emphasized the importance of stakeholders' engagement, particularly with the academe, the civil so-

ciety organizations (CSO), and the private sector, which she believed had the resources to fill the financial gaps.

With the limited fiscal space that the Philippines has, she said the government needs all the help it can get to address the growing disaster risks.

Through the APMC-DRR meeting, Loyzaga said Asia-Pacific countries should work beyond the potential synergies and take advantage of learnings gained.

"So the approach towards alignment of resources and accessing resources need to be more proactive in terms of the way we look at the international financing that we've been able to access, the way we are managing the lean resources that we have, and therefore the need for better science in order to prioritize where these resources should go," Loyzaga said. DSWD ready to assist repatriated OFWs **from Lebanon**

MANILA – The Department of Social Welfare and Development (DSWD) assured on Thursday that it is ready to assist the overseas Filipino workers (OFWs) who will be repatriated from Lebanon amid the rising tension in the region.

"Meron tayong mga tulong na ipapahatid karagdagan sa ipapamahagi na rin ng Department of Migrant Workers [DMW] (We will be providing some assistance in addition to the aid to be given by the DMW)," Assistant Secretary Irene Dumlao told reporters during a media forum at the DSWD Central Office in Quezon City on Thursday.

"Sa kasalukuyan, ina-assess ng Field office NCR [National Capital Region] yong tulong na ibabahagi at mamaya magtutungo tayo sa Terminal 1 ng NAIA [Ninoy Aquino International Airport] para salubungin itong mga kababayan natin who have been repatriated (FO-NCR is currently assessing the assistance to be provided, and we are going later to NAIA Terminal 1 to welcome our repatriated countrymen)," she said.

Dumlao, also spokesperson of DSWD, said the agency will join other concerned government agencies to welcome the 48 OFWs who are scheduled to arrive later Thursday. As an initial response,

Dumlao said DSWD social workers will be deployed to conduct assessment and interviews to determine the appropriate assistance for the repatriates.

Subject to the social workers' assessment, she said, the cash aid is not only limited to the Assistance to Individuals in Crisis Situation (AICS) or the Ayuda para sa Kapos ang Kita (AKAP), but may vary based on the unique cases of the repatriates.

"Our social workers need to interview itong mga (the) repatriated OFWs because AICS and AKAP, particularly cash assistance, may be just among the interventions. Pwede rin naman kasi na livelihood dahil matagal nga silang mawawalan ng trabaho (Livelihood assistance may also be provided because they were without work for a time)," Dumlao said, referring to the Sustainable Livelihood (Turn to p. 7)
