DA targets 260 more Kadiwa ng Pangulo stores by 2025

MANILA - The Department of Agriculture is targeting to establish at least 260 more Kadiwa centers nationwide by mid-2025, Agriculture Secretary Francisco Tiu-Laurel Jr. Tuesday.

At the launch of the first-ever Kadiwa ng Pangulo (KNP) Expo at the Philippine International Convention Center in Pasay City, Tiu-Laurel said 41 Kadiwa centers, which sell rice at PHP29 and PHP42 per kg., have been established nationwide to date.

"Our target for the Kadiwa for the second quarter of next year is to add another 260 stores, hopefully by May to June next year, and the eventual target by 2028 is a total of 1,500 Kadiwa stores nationwide," he said.

In his speech, Tiu-Laurel said the combined expertise and resources of concerned government agencies have been instrumental in the success of the KNP program and its bene-(Turn to p. 2)

House leader demands accountability on rice price manipulation

MANILA – A House leader on Tuesday called for accountability in the "biggest agricultural price manipulation case" involving alleged rice importation anomalies during the Duterte administration that cost Filipino consumers billions of pesos.

Speaking at the inaugural hearing of the newly formed Murang Pagkain

mittee, panel chair and Albay Rep. Joey Salceda said the manipulation of rice import permits between 2016 and 2018 led to a surge in rice prices.

Salceda cited systemic failures that allowed cartels to exploit the country's food supply.

"The biggest case of price manipulation in the agricultural sector remains to be the cor-Supercom- nering of import per-

mits in 2016-2018,' Salceda said, estimating the total economic loss at PHP88.6 bil-

He noted that consumers paid up to PHP8 more per kg. of rice during the period.

Salceda attributed the price spike to private sector control over rice importation and the manipulation of permits under the Na-

MANILA – President to commemorate 50 years of "very strong and friendly, and rapidly progressing bilateral ties" between the

Ferdinand R. Marcos Jr. returned to the Philippines Wednesday, following what he described as a "short, but highly productive" one-day working visit to the United Arab Emirates (UAE).

In his arrival statement, Marcos said his visit was meant Philippines and the UAE.

During his visit, Marcos said he reaffirmed the Philippines' commitment to further strengthen bilateral ties with the aim of "progressing towards new spheres of engagement."

Several bilateral agreements were signed during the President's visit, covering areas such as culture. energy transition, legal cooperation, artificial intelligence and digital economy, improvement of government activities, visa waiver for holders of diplomatic, special, and official passports, and investment cooperation.

Marcos also met with UAE President, His Highness Sheikh Mohamed bin Zayed Al Nahyan, express-

tional Food Authority (NFA).

He highlighted how the problem eased only after the Rice Tariffication Law abolished the NFA's permit system in 2019.

Salceda questioned the lack of resolution in the scandal, including allegations of a PHP2-billion bribery scheme within the NFA in 2018.

He noted that officials previously named in Senate hearings—including Marlon Barillo, Marigold De Castro, Richie Carpio, Mercedes Yacapin, Rocky Valdez, and Judy Carol Dansalhave faced no known consequences.

Dansal was later appointed NFA administrator by then president Rodrigo Duterte.

"What happened to the charges that then Presidential Spokesperson Harry Roque said the government was going to file in September 2018?" Salceda asked.

The lawmaker requested the supercommittee's secretariat to send letters to the Department of Justice (DOJ) and the Office of the Ombudsman to determine whether cases have been filed against implicated officials.

He also sought confirmation from the DOJ on whether a formal investigation had been initiated into former NFA Administrator Jason Aquino.

Salceda likewise directed letters to the NFA and the Bureau of Customs requesting records on rice import permits and arrivals from 2016 to 2018, warning that the committee may invoke subpoena powers to obtain the documents.

Salceda alleged that cartels exploited the NFA's diversion of palay procurement funds—intended support farmers—to pay off loans.

"No one has gone to jail for allegations of bribery in obtaining import permits, or for the NFA's failure to undercut cartels by diverting palay procurement funds to loan payments," he said.

The Murang Pagka-Supercommittee, formed under House Resolution No. 254, aims to address critical issues in the food supply chain, including price manipulation, smuggling, and hunger.

It consolidates efforts from key House committees to ensure affordable and accessible food for all Filipinos.

Salceda reiterated the committee's commitment to holding accountable those responsible for the rice importation anomalies. (PNA)

The KNP, a flagship project of President Ferdinand R. Marcos Jr., aims to empower farmers and fisherfolk, including the agricultural sector, and bring accessible food products to consumers.

The DA said the KNP has attained milestones through collaboration among government agencies and stakeholders, including the Department of Labor and Employment, Department of the Interior and Local Government, Department of Trade and Industry, Department of Social Welfare and Development, Presidential Communications Office and Presidential Management Staff.

Through the program, the DA hopes to further improve the food supply chain and achieve sales targets through the exhibition of agri-fishery products.

Tiu-Laurel noted that the KNP provides essential logistical support to farmers by linking them to the market.

Meanwhile, he said the DA is looking at improving the KNP with a "food train".

Benefit packages must ensure equitable access to health services

Philippine Health Insurance Corporation (PhilHealth) on Monday highlighted the importance of protecting the process of benefits development against undue influence to ensure quality healthcare services.

At the 41st ASEAN Social Security Association (ASSA) Conference and Board Meetings, PhilHealth Senior Manager for Benefits Development and Research Department Melanie Santillan said the process must be secured against conflict of interest, especially from people outside the technical group tasked to develop health benefit packages.

"So, we have influences from legislators, from lobbyists. We have a set process and this is to ensure that our criteria are explicit and can stand to foster public satisfaction with the PhilHealth coverage of universal access and reduction of out-of-pocket and maintain financial sustainability," she said.

All Filipinos are covered by social health insurance as stated in Republic Act 11223 or the Universal Health Care (UHC) law.

The PhilHealth is the national strategic purchaser of individual-based health goods and services, ensuring equitable access to health services without causing financial hardship under the UHC law.

These goods and services include individ-

MANILA - The ual-based entitlements covering primary care; medicines; diagnostics and laboratory tests; and preventive, curative and rehabilitative services.

> The state insurer is also mandated to expand and improve benefits coverage, design an explicit benefits package (HBP), develop the benefit plan, implement benefits development planning protocol (BDPP) and conduct periodic review of the HBP.

> Santillan noted that the BDPP includes processes such as benefits prioritization, provider payment mechanism, development and design of benefits package, implementation of benefits policy, benefits monitoring and evaluation and policy review.

> Benefits are prioritized according to need and not want, she

> The first factor influencing benefits prioritization is the epidemiologic data or burden of disease wherein PhilHealth is guided by data on diseases people are dying and getting sick of.

> Other factors include financial risk protection with consideration on equity, Health Technology Assessment Council recommendations, tainable development goals, the Philippine Development Plan, objectives national for health, legislative mandates for health and public interest.

House panel readies recommendations to lower rice prices

MANILA – Albay 2nd District Representative and House Wavs and Means Chair Joey Sarte Salceda, who serves as the overall chair of the newly formed Quinta Committee (Murang Pagkain Super Committee), announced on Wednesday that they would soon present initial recommendations to President Ferdinand R. Marcos Jr. on resolving the alleged rice price manipulation in the country.

Salceda mentioned that the committee is investigating rice price manipulation trends over the past decade, specifically examining spikes in rice prices from 2012-2013 and the years 2016-2018 aimed to determine if the same network of smugglers and cartels is still operational.

"Kailangan may masampolan na (They need to be punished) profiteers, hoarders, smugglers and cartelists and regulatory patrons in both 2016-19 rice price spikes and the 2024 stubborn high prices despite tariff reduction from 35 percent to 15 percent and fall in 14 percent fall in global rice price," he said in a media release.

Salceda emphasized that the Philippines already has sufficient laws in place to enforce accountability. prosecute, and punish those who abuse and manipulate the market.

"By Christmas, we aim to provide initial

"We will try to push the envelope as close to that as possible. What I can tell you is that it looks like there is a path to PHP30 per kilo," Salceda said.

He explained that the prices of rice, which accounts for as much as 22 percent of total expenditures by poor households, and food in general, takes up as much as 54 percent of total spending by low-income families.

"A big part of that is cutting down excessive middleman cartel profits. The landed price of imports - including movements in world prices and the tariff reduction implemented last July – has declined by around 24.9 percent year on year. However, consumer retail prices have risen 9.0 percent over the same period. It's puzzling and an unmistakable sign of shenanigans in the rice trade sector," Salceda said.

He added that President Marcos has pursued all available policy options to lower rice prices.

"The landed cost of Thailand rice is currently PHP35.52 per kilogram, which means industrial users are already benefiting from these prices. We are nearing PHP30 per kilogram. The key question is: where does the benefit of the reduced tariff go, and how can we eliminate these excessive profits?" he asked.

Salceda also highlighted that the farmgate price in Central Luzon is now just PHP20.02. "Assuming milling yields 65 percent, the milled rice should come out to PHP30.08 per ki-

Gilas qualifies for FIBA Asia Cup 2025 in Saudi Arabia

MANILA - Gilas Pilipinas formally qualified for the FIBA Asia Cup 2025 in Saudi Arabia after New Zealand defeated Chinese Taipei, 91-64, in the 2025 Qualifiers at the Wolfbrook Arena in Christchurch, New Zealand on Monday.

Gilas first trounced Hong Kong, 93-54, on Sunday night at the SM Mall of Asia Arena in Pasay City to complete a 2-0 sweep of their November window homestand.

Gilas turned to a solid second-half defense that saw Hong Kong getting held to only 19 points after the latter somehow made things interesting in the first

Carl Tamayo, who was seldom used in Gilas' upset 93-89 win against New Zealand on Nov. 21 at the Mall of Asia Arena, stepped up and led Gilas, now 4-0 in Group B, with 18 points, six rebounds, and one assist.

June Mar Fajardo added 14 points, eight rebounds, one assist, one block, and one steal, while Kai Sotto chipped in 12 points, 15 rebounds, two assists, and two blocks.
