Ombudsman orders reinstatement of 72 NFA warehouse supervisors

MANILA - The Office of the Ombudsman has ordered the reinstatement of 72 warehouse supervisors of the National Food Authority (NFA) suspended last March.

The group was among the 139 respondent officials and employees placed on a six-month preventive suspension on March 1 amid the

BIR urged to hit revenue collection target to spur economic growth

MANILA – House Representatives of Speaker Martin Romualdez on Tuesday urged the Bureau of Internal Revenue (BIR) to hit its revenue collection target so that the government could ramp up spending and contribute more to economic growth.

In a statement, Romualdez said that while the BIR's total collections increased by 17 percent last year, such growth would only bring in PHP2.94 trillion for the agency this year, falling short of the 2024 collection goal of PHP3.05 trillion.

"Year on year, the BIR's revenue collections grew by 17 percent this year. That's welcome news, and I credit the BIR for that," he said. "But 17 percent growth from total collections last year will mean the BIR will fall short of PHP3.05 trillion target set by the economic managers."

Congress, he said, has given the BIR the necessary tools to collect more effectively from taxpayers, particularly citing the Ease of Paying Taxes Act, which

aims to modernize and increase the efficiency and effectiveness of tax administration.

"We enacted the Ease of Paying Taxes, effective this year, to digitalize most of BIR's transactions and encourage taxpayers to comply voluntarily. The law will also broaden the base of taxpayers since we made registering as a

national poverty reduction strategy that caters to 4.4 million household beneficiaries nationwide.

"We extend our heartfelt gratitude to the DBM, headed by Secretary Amenah Pangandaman, for the creation of these new contractual positions that will further enhance the delivery of services under 4Ps,"

Assistant Secretary for Disaster Response and Management Group (DRMG) Irene Dumlao said in a statement on Tuesday.

"These contractual items will substantially alleviate the caseload burden on our dedicated front-line workers, allowing them to focus more on the individual needs of 4Ps beneficiaries, as well as enhanc-

In its 23-page order dated May 10, Ombudsman Samuel R. Martires and Special Prosecutor Edliberto G. Sandoval said "there is insufficient ground to believe that their continued stay in office may prejudice the investigation of the case filed against them."

"Thus, the continued preventive suspension of the afore-named warehouse supervisors is no longer necessary," the ruling read.

The Ombudsman and the Department of Agriculture's (DA) internal panel of investigators are conducting an investigation into the alleged improper sale of 75,000 bags of NFA rice buffer stock worth over PHP93.7 million. More NFA warehouses to reopen

The DA welcomed the Ombudsman order, saying more NFA warehouses are now ready to reopen and help the agency procure additional rice supply.

"I'm happy that the suspensions have been lifted on the 72 warehouse supervisors. I instructed the NFA to immediately implement the Ombudsman's order," DA Secretary Francisco Tiu Laurel Jr. said in a statement.

The 72 warehouse supervisors oversee warehouses in Central Luzon, Calabarzon, Mimaropa, Bicol Region, Western Visayas, Central Visayas, Zamboanga Peninsula, Northern Mindanao, Soccsksargen, Caraga Region, and the Bangsamoro Autonomous Region in Muslim Mindanao.

The NFA targets to secure 300,000 metric tons of palay for buffer stocking.

Laurel, meanwhile, said the DA shall soon complete its parallel investigation on the matter, and results will be shared with the Office of the Ombudsman. (with Stephanie Sevillano/PNA)

ic growth this year depends in large part on the government carrying out this year's budget, emphasizing the need to fund both programmed spending unprogrammed and appropriations to meet the growth targets for 2024.

"Of course, the sooner the BIR can collect the cash, the faster the government can fund its programs. Government final expenditure grew by only 1.7 percent during the first quarter, so I'm hoping that the BIR will be able to collect more in the second quarter so government spending can also catch up," he said.

"Tax is the lifeblood of government, and the vitality of economic growth this year depends on whether the BIR can supply that lifeblood."

According to the Development Budget Coordination Committee Medium-Term Fiscal Program, the total revenue collection target for this year is expected to reach PHP4.3 trillion.

The bulk of the tax revenues amounting to PHP3.05 trillion will be generated by the BIR, while the Bureau of Customs is expected to collect nearly PHP1 trillion.

The BIR collected PHP591.8 billion in the first quarter 2024, higher by of 17.15 percent than the PHP505.2 billion it generated in the same

1st 'super health center' to open in Laguna, 12 more in pipeline

CALAMBA CITY, Laguna - Lawmakers from both houses of Congress are collaborating with the Department of Health (DOH) and concerned local government units (LGUs) to build a total of 13 "super health centers" or SHCs in this province.

With the imminent opening of the first SHC in Calauan town, 12 more will be in the throughout pipeline the province, according to Senator Lawrence "Bong" Go.

Go took part in an inspection of the soonto-open Calauan SHC on Sunday, accompanied by local officials.

He said the SHC initiative in this province "reflects a commitment to democratizing access to quality healthcare, particularly in remote areas."

In an interview, Go said SHCs are set apart from the typical community health center in the number of medical services that they offer. He said SHCs will be equipped with X-ray and ultrasound machines for its outpatient services.

These will also have birthing rooms, surgi-



Meralco hikes power rate in May

MANILA – The tight power supply in the Luzon grid during the yellow and red alerts in April has pushed electricity rates up in franchise areas of Manila Electric Company (Meralco).

Meralco announced Tuesday that power rates in May increased by PHP0.4621 per kilowatt hour to PHP11.4139 per kWh from PHP10.9518 per kWh in the previous month.

This means that a residential customer consuming 200 kWh a month can expect an increase of PHP92 in electricity bill for May.

Generation rate, transmission fee, and other charges went up this month.

In a statement, Meralco said overall generation charge rose PHP0.455 per kWh due to higher prices at the Wholesale Electricity Spot Market (WESM) and Power Supply Agreements (PSAs).

Electricity rate from WESM jumped PHP1.7913 per kWh because of the higher demand in the Luzon grid while some of the power plants went on unplanned shutdown.

"There were three days with yellow alerts and five days with yellow/red alerts from normal conditions the previous supply month. In addition, the secondary price cap was triggered 19 percent of the time in April versus only 7 percent the previous month," Meralco said.

"Similarly, charges from PSAs increased by PHP0.2871 per kWh due to lower excess energy deliveries of some PSAs," the distribution utility said.

The weaker peso against the US dollar also affected the increase in dollar-dominated PSA rate.

On the other hand, the electricity rate from Independent Power Producers (IPPs) tempered the higher WESM and PSA charges.

"WESM, PSAs, and IPPs accounted for 30 percent, 36 percent, and 34 percent respectively of Meralco's total energy requirement for this period," Meralco said. Meanwhile, transmission and other charges had a net increase of PHP0.0166 per kWh. (PNA)

New international container terminal to rise in Batangas town

BAUAN, Batangas – A new international container facility is set to be built in this municipality and is targeted for completion by the end of 2027.

In an email on Monday, the International Container Terminal Services Inc. (ICTSI) said design and engineering studies on the new terminal are already underway with the commencement of construction scheduled in the first quarter of 2025.

"The new terminal represents a significant leap forward for Southern Luzon. We are building a worldclass facility that will unlock a wave of economic benefits for the region and the country. It will create new employment opportunities, improve the quality of life for our host communities... and solidify Southern Luzon's position as a key player in global trade, Christian Gonzalez, ICTSI executive vice president, said.

The terminal, which is estimated to entail a US\$800 million investment, is envisioned to play a role in providing the marine handling needs required by the country's renewable energy transition strategy for Southern Luzon.

Gonzalez said the Bauan-San Pascual-Batangas-STAR tollway diversion road and other expressway projects from Cavite to Bauan have significantly enhanced the accessibility of the planned terminal.

Strategically locat-

ed 120 kilometers south of Manila and nine kilometers west of Batangas City, the Bauan facility is expected to become the premier international gateway for shippers based in Calabarzon, according to ICTSI.

ICTSI is touted as the Philippines' largest multinational and transnational company, having established operations in both developed and emerging market economies in Asia Pacific, the Americas, Europe, the Middle East and Africa. (PNA)

PH accedes to UN convention on registration of space objects

MANILA – The Philippines government has deposited the instrument of accession to the United Nations (UN) Registration Convention, a treaty that calls for the registration of all objects launched into outer space.

Philippine Permanent Mission to the UN in New York Antonio Lagdameo handed over the instrument to UN Office of Legal Affairs Treaty Section chief David Nanopoulos on May 14 (New York time).

The UN Convention on Registration of Objects Launched into Outer Space or simply the Registration Convention contributes to the promotion, exploration, and use of outer space for peaceful purposes.

In depositing the document, the Philippine Mission in the UN recognized the need to establish and maintain a public register to reduce the possibility of having unidentified objects in space.

The convention was adopted by the UN General Assembly in 1974 and requires the registration of objects launched into earth orbit or outer space by

an appropriate national space agency.

Under this, information concerning the space object, including the date and location of launch, basic orbital parameters, and its general function must be communicated to the UN Secretary-General as soon as practicable.

Manila's accession comes as it bolsters its exchanges on space development through the Philippine Space Agency (PhilSA).

In a statement Wednesday, Lagdameo highlighted PhilSA's role as the primary agency addressing all national issues and activities related to space science and technology (S&T).

"We support PhilSA, the central government agency addressing all national issues and activities related to space S&T applications, in advancing the Philippine strategic roadmap for space development, particularly in international cooperation," he said.

Earlier this month, the Philippine government held its inaugural Space Dialogue with the United States and agreed to explore ways to expand collaboration, including on space industry sector development. (PNA)

Sofitel closure 'significant loss' to PH tourism sector

MANILA – The closure of the iconic Sofitel Philippine Plaza would be a "significant loss" to the country's tourism sector, the Department of Tourism (DOT) said Tuesday.

The 48-year-old fivestar hotel announced it will cease operations by July 1, citing safety reasons.

In a meeting with Sofitel executives in Makati City on Monday, Secretary Christina Frasco said the DOT was "very dismayed" when it first heard the closure announcement but conveyed its support behind the decision to prioritize the safety of employees and guests.

"[W]e are in complete agreement in terms of prioritizing worker and tourist safety as that is paramount over and above anything else," she said.

"We are very dismayed with the announcement of the impending closure of

Sofitel, being an icon in Philippine hospitality. We heard the news with much concern, especially that we view our hotel and accommodation sector as a critical component of the industry, especially now that we are making efforts to elevate the status of Philippine tourism vis-a-vis our ASEAN counterparts," she added.

The tourism chief said the DOT sees the closure as a significant loss for the tourism industry, as well as for the employees and stakeholders.

The agency, she said, stands ready to provide assistance through its job fairs that will be held for the affected employees.

In its news release, the DOT quoted Philippine Plaza Holdings, Inc. president and owner of Sofitel Philippine Plaza Esteban Peña Sy, as saying they "remain optimistic of future developments," especially that the performance of the hotel "has had its best years ever in 2022 and 2023."

He said occupancy rates during these years reached 86 percent to 100 percent.

Sofitel Philippine general manager Olivier Larcher also noted that the bay-side property was doing well prior to the announcement, with 2022 and 2023 as their best years in business.

Peña Sy, meanwhile, said separation packages and job training seminars are being made available for the affected employees "so they will be adequately equipped" as they transition to new roles. Sofitel Philippine Plaza has been open without interruption since 1976 and has served

MANILA – The partnership between US equity firm Cerberus and South Korea's HD Hyundai Heavy Industries in the strategically located Subic Bay will allow the Philippines to regain its footing in the global shipbuilding industry, President Ferdinand R. Marcos Jr. said Tuesday.

During the announcement of the partnership in Malacañang, Marcos welcomed the two global companies to the Philippines and expressed optimism about the project's potential impact on the country's economy.

He said Hyundai's investment would not only open "new doors for our offshore wind industry but will also bring maritime manufacturing back to Subic and eventually restore the glory days of shipbuilding to our shores."

"Not only would it generate thousands of jobs, but also enable the transfer of critical skills and improve the Philippines' position in the global market," he said.

"The Philippines is also quite excited to see the realization of Cerberus' plans, including its interest in microelectronics, semiconductors, and critical metals."

Hyundai already performs ship repairs and maintenance at the Aguila Subic yard, which Cerberus acquired in 2022 after its former owner went bankrupt.

In his message, Marcos noted that since Cerberus' takeover of the shipyard, it has been "hard at work to revitalize the shipyard" and even attracted other tenants, including Sancom, the world's leading subsea cable company, and V2X, a global logistics corporation.

Cerberus is a global alternative investment firm with assets across credit, private equity, and real estate strategies.

"And you have worked closely with our Philippine Navy while establishing a world-class operating base for our Navy," he said.

Currently, the Philippine Navy has a naval operating base in Subic with nearly 1,000 personnel.

The Chief Executive also acknowledged HG Hyundai, one of the largest producers of ships in the world, saying that its foray into the country would "usher in a new era of shipbuilding" in the Philippines.

In 2022, according to Marcos, the country was the seventh-largest shipbuilder in the world, contributing almost 400,000 gross tons of newly built sea and ocean-going vessels.

More power capacity coming online to prevent yellow, red alerts

MANILA – The Department of Energy (DOE) assured lawmakers that there are more power plants coming online that would prevent a repeat of recent yellow and red alerts raised due to tight power supply.

In a hearing of the Committee on Energy at the House of Representatives Tuesday, DOE Undersecretary Sharon Garin reported that about 1,194 megawatts of power capacity are currently under test and commissioning stage as of April and will be added to the energy mix within the year.

"These power plants under test and commissioning were likewise able to contribute for the power supply to meet the demand most of the times during these peak period of April and May," Garin said.

Additionally, as of March, at least three power plants with a total capacity of 171 MW were already on commercial operation.

"Another 172 MW battery energy storage system (BESS) were also available for commercial operation to provide ancillary services to the grid," the DOE official said. vent yellow, red alerts

there are 4,148 MW of committed power projects.

"Committed means that they already have either financial closing or already under construction," Garin explained.

Until 2028, Garin said there a total of 12,982 MW of additional capacity from committed power projects, which are expected to meet the power demand growth rate of 7 percent annually.

She added that nine transmission projects between 2024 and 2028 will also augment the power supply in the country.

The Hermosa–San Jose 500 kV Transmission Project, the Tuy 500/230 kV Substation Project Stage1, and the Laguindingan 230 kV Substation Project are seen to be delivered in the second half of the year.

Other transmission projects that will be delivered during the Marcos administration include the Ambuklao-Binga and Binga–San Manuel 230 kV Transmission Line in August 2025, the Cebu-Lapu-Lapu 230kV Transmission Line Project in December 2026, and the Batangas-Mindoro Interconnection Project in December 2027.
