House passes bill on Rice Tarification Law amendments

MANILA - The House of Representatives on Tuesday approved on final reading the measure seeking amendments to the Rice Tariffication Law (RTL).

With 231 affirmative votes, 3 negative votes, and 1 abstention, the chamber approved House Bill 10381, which seeks to restore the price stabilization and supply regulation functions of the National Food Authority (NFA).

In an interview with PTV's "Bagong Pilipinas Ngayon," Agri Party-list Rep. Wilbert Lee said the NFA's role would be an "equalizer" by purchasing palay (unhusked rice) from local farmers at a higher price and selling it at a lower price to consumers.

PH remains low risk for Covid-19 amid new variants

MANILA – The Philippines remains at low risk for the coronavirus disease 2019 (Covid-19) amid reports of new variants monitored abroad, the Department of Health (DOH) said on Tuesday.

The agency said it was in close coordination with international health authorities in monitoring newly designated Covid-19 variants.

The World Health Organization (WHO) Covid-19 Epidemiological Update on May 17 noted three new variants under monitoring (VUM) -- JN.1.18, KP.2 and

> As of May 12, only 11 percent or 119 out of 1,117 dedicated Covid-19 intensive care unit (ICU) beds were occupied.

Only 1,238 or 13 percent of dedicated Covid-19 non-ICU beds were used.

Based on hospital reports in the DOH Data Collect application, severe and critical Covid-19 cases admitted in various hospitals total only 116 as of May 12.

About 877 new Covid-19 cases were reported, with an average of 125 cases reported per day from May 7 to 13, 2024.

"Five deaths were recorded, which occurred in the recent two weeks (April 30 to May 13)."

The DOH called on doctors, including their clinics, hospitals, and other health facilities "to accurately and immediately report cases of Covid-19, whether tested by PCR



(polymerase chain reaction) or rapid antigen test" as mandated by law.

"This will help guide public health decision-making," DOH said.

MANILA - The Commission on Elections (Comelec) on Tuesday vowed to ramp up voter registration activities for qualified Filipinos even as it breached its target of 3 million new voters for the 2025 midterm polls.

"(We will) proceed until the very end. What is important is the assurance that they are able to vote. A vote not cast is a voice not heard," Comelec chairperson George Erwin Garcia said in a phone interview.

Based on Comelec's latest data, around 3,020,999 registrants to become voters as of Monday, more than three months since the start of voter registration on Feb. 12.

Of the number, Calabarzon topped the number of applicants with 541,724; followed by the National Capital Region with 440,857; Central Luzon with 349,926; and Central Visayas

How South Korea won the battle vs. food waste

ANKARA – When it comes to food, the world is divided, as in many other ways, between the haves and have-nots: hundreds of millions face immense hunger as millions more waste staggering amounts of food.

This glaring contradiction was illustrated in a recent UN report, which showed that households worldwide discarded more than 1 billion meals every single day in 2022 - at a time whenover 783 million people, or one-third of humanity, grappled with food insecurity.

Overall, 1.05 billion tons of food went to waste that year, and the majority of 631 million tons – or up to 60 percent - came from households, according to the UNEP Food Waste Index Report 2024.

While many countries around the world are still struggling to rein in food waste coming from homes, there is one particular nation that could serve as a model for all: South Korea.

Over the past three decades, the East Asian nation has shown how change at scale is possible, raising its rate of food recycling from a minimal 2 percent to over 95 percent.

In 2019, there was an average of 14,314 tons of food waste in South Korea per day, of which 13,773 tons, or 96.2 percent, were recycled. This followed a recycling rate of 97 percent in 2018 and 97.1 percent in 2017, according to data from the South Korean Environment Ministry.

The transformation began in the 1990s when South Korea enforced a raft of policies to tackle a burgeoning waste crisis, Doun Moon, a policy researcher at the Global Alliance for In-Alternatives cinerator (GAIA) based in Seoul, told Anadolu.

By the mid-1990s, as landfills and incineration facilities became unable to handle the burgeoning waste output driven by urbanization, South Korea started to develop an overall framework

for waste management, starting by becoming "one of the first countries to implement a volume-based system for food waste nationwide," Doun said.

This was the Volume-Based Waste Fee (VBWF) system that essentially gave people economic incentives to reduce the amount of waste they were throwing out and increase their recycling.

Under this system, people were given five different kinds of waste bags to sort out their trash into different categories, including domestic and food waste, and pay different fees for each kind.

In less than a decade, the VBWF system brought down waste generation by 23 percent and diverted 53 million tons of waste from landfills and incinerators, according to Doun's research, leading to cost savings of some \$8 billion and a 175 percent spike in recycling.

Key outcomes and success factors

Building on this suc-South Korea cess, pushed ahead with a ban on direct landfilling of food waste in 2005, followed by a "pay-as-you-throw policy" intro-duced in 2014, the same year it also started generating biogas from food waste, all of which combined to further increase source separation and recycling of food waste.

Another major step was the implementation of a radio-frequency identification system (RFID), which is a more sophisticated digital ticketing mechanism that allowed for people to be charged monthly based on the weight of their food waste, said Doun.

Currently, the food waste RFID system has been introduced in 166 municipalities, covering over 6.5 million households and 65 percent of apartments in the coun-

Higher buying price allows NFA to increase palay inventory



MANILA – The National Food Authority (NFA) said Wednesday the decision of its council to raise the buying price of palay (unhusked rice) has allowed the agency to exponentially increase its palay inventory within a month.

In a news release, the NFA Council raised the procurement price per kilogram of palay to PHP23 to PHP30 for clean and dry palay from PHP19 to PHP23 while the buying price for fresh and wet increased to PHP17 to PHP23 from PHP16 to PHP19 on April 11.

"This allowed NFA to compete with private traders in order to build its buffer stock. NFA started buying palay at higher prices on April 17," the NFA said.

The last time the palay buying price increased was in September 2023.

During Thursday's NFA Council meeting, the NFA reported that since the approval of the higher buying price for palay, the agency has procured an additional 2.41 million 50-kg. bags as of May 15.

Between Jan. 1 and April 15, NFA only procured 142,244 bags of palay.

"The new price scheme is really the game changer," NFA acting administrator Larry Lacson said.

"I think the NFA Council's strong understanding of NFA's challenges has resulted in stronger collaboration. We thank Secretary Francisco Tiu Laurel Jr. and the Council for this."

In all, 2.5 million bags of palay were bought between Jan. 1 and May 15, representing 82.76 percent of the 3.08-million sacks target for the period.

"We're still aiming to hit that target since there are other areas like Bulacan where farmers haven't completed their rice harvest," said Lacson.

"Farmers I spoke to are very happy with this initiative of the administration of President Ferdinand Marcos Jr. to help farmers increase their income." As of May 15, the volume of milled rice has reached 111,720 metric tons, or 14.6 percent higher than in the same period last year.

He said the rice stocks would have been higher if not for disbursements for assistance to El Niño-affected areas.

The rate of recycling has climbed to around 97 percent, which is proof of successful implementation of policies, she said.

Regarding the reasons for the success, she pointed to the involvement of various stakeholders in the planning and execution process, from government officials to environmental groups and civil society organizations, she added.

As with all major policy shifts, Doun said there were some initial problems in implementation, with a major concern at the beginning being that people would resort to more illegal dumping to avoid the charges enforced under the new system.

Over time, however, education and awareness campaigns conducted for this specific purpose helped overcome the potential hurdles, she said. (Anadolu)

Marcos approves return to old school calendar

MANILA - President urday classes. Ferdinand R. Marcos Jr. has approved the country's return to the old school calendar amid clamors for the immediate restoration April-May the school break, Malacañang announced Wednesday.

In a news release, the Presidential Communications Office (PCO) said the opening of classes for School Year (SY) 2024-2025 would begin on July 29 this year and end on April 15, 2025.

This would start the gradual return of the school year to June of every year until the end of March the next year, the PCO explained.

Marcos gave his approval during a sectoral meeting with Vice President and Education Secretary Sara Duterte during a meeting at the Palace on Tuesday.

During the meeting, Marcos told the Department of Education (DepEd) to start the return of the standard school calendar days starting SY 2024-2025.

The Vice President presented two options to the President for the school calendar shift.

The first option comprised 180 school days with 15 in-person Saturday classes while the second option was to have 165 school days with no in-person Sat-

Both options will end the SY on March 31,

The President, however, said the 165-day school calendar is "too short" as such an arrangement significantly reduce the number of school days and contact time that may compromise learning outcomes, the PCO noted.

He also did not want students to go to school on Saturdays to complete the 180-day school calendar, saying it would "jeopardize their well-being and demand more resourc-

The Chief Executive said that instead of ending on March 31, 2025, DepEd should adjust the SY to end on April 15, 2025 to enable students to complete 180 days without going to school on Saturdays.

"Habaan lang natin 'yung school days. Para matagal, dagdagan na lang natin 'yung school days basta huwag natin gagalawin 'yung Saturday (Let's just extend the school days. Let's just increase the number of school days so long as we don't hold classes on Saturdays). So, school day will remain the same. Standard lang (just the standard)," Marcos said. (PNA)

PH's Agra rises to No. 2 in Asia Pacific Padel Tour rankings

MANILA – The Philippines' Jessica Agra has climbed to the No. 2 spot based on the latest Asia Pacific Padel Tour (APPT) women's rankings.

She garnered 2380 points, behind No. 1 Patricia Garcia of Spain (2600).

Agra's latest ranking came after she teamed up with Indonesian Beatrice Gumulya to win the pro women's title over Chinese pair Michelle Wu and Zhaiya Chaiu, 6-0, 6-4, at the Phuket Open in Thailand on May 12.

Agra and Gumulya beat Russians Olga Khlopetskaya and Irina Chernaya, 6-2, 6-3, in the quarterfinals; and Indonesians Jessy Rompies and Jessica Johan, 6-2, 6-1, in the semifinals.

"I'm very excited about being ranked No. 2 in the Asia Pacific Padel Tour. It has been fun focusing on padel more this year and it feels good to be seeing improvements and results," the 32-year-old lawyer said in an interview on Tuesday."

"I'm also happy to be representing the Philippines internationally again in a racket sport that I really enjoy playing. I'm looking forward to playing more padel tournaments and

to seeing how far I can go."

This is the first pro women's title in the APPT Tour for Agra.

Gumulya, a member of the 2023 Southeast Asian Games champion team, is at No. 3 with 2200 points; followed by Maria Mayoral of Spain (2000); Constanza Kokorelis of Portugal (1600); Sandy Gumulya of Indonesia (1500);Kim Ben Attar of France (1260); Yoshino Kushima of Japan (1200); and Zhaiyu Chaiu of China (1140). Last month, Agra was ranked No. 6 following her semifinal finish with compatriot Jessica Lucas in the women's open of the Hong Kong Grandslam.

Agra, a former top junior tennis player who won three ITF doubles titles, also reached the semifinal of the Vietnam Open in Ho Chi Minh in March with Kazakhstan's Dasha Berezhnaya.

Her other title victories were the APPT Vietnam Open (mixed pro), MartinX Academy's Tournament Open, 4th Philippine National Padel (mixed open), 2nd Philippine National Padel (women's open) and 1st Play Padel Open (women's open).

The next APPT leg is scheduled June 7 to 9 at Bali Social Club in Indonesia.

Bali will host another leg in September while the other legs will be held in Singapore, Tokyo (Japan) and Dubai (United Arab Emirates).

"I will be joining all the legs this year, that's the plan," Agra said. "Next year, I will focus more on the International Padel Federation tournaments." (PNA)
