PhilHealth to study doubling coverage for hemodialysis to P5,200

MANILA – The Philippine Health Insurance Corp. (Phil-Health) will study the proposal to double its coverage amount for hemodialysis from the current PHP2,600 per session to PHP5,200, an official said on Tuesday.

In a press conference at the Batasang Pam-

bansa Complex, Phil-Health Executive Vice President Eli Santos said the goal of this proposed increase is to remove out-of-pocket costs of hemodialysis patients.

"Ang PhilHealth po ay pag-aaralan yung pag-increase po nito to PHP5,200... binigyan po kami ng one month po na pag-aralan po ito (The PhilHealth will study the increase [of the coverage] to PHP5,200... we are given one month to study this)," Santos said.

Santos said erythropoietin, which is used by people on dialysis, is usually purchased outside of dialysis facilities, which increas-

PBBM to DSWD, other agencies: Ensure aid for 'Aghon' victims

MANILA – President Ferdinand R. Marcos Jr. on Tuesday directed the Department of Social Welfare and Development (DSWD) and other government agencies to ensure the continued delivery of assistance and relief services to individuals affected by Typhoon Aghon.

Before leaving Manila for a two-day state visit to Brunei Darussalam, Marcos provided updates on government efforts after the

onslaught of Aghon, which dampened most of Luzon.

He said Calabarzon, Mimaropa, Bicol, Central Visayas, and Eastern Visayas were among the hardest-hit areas by the typhoon.

He added that three airports and 29 seaports were rendered non-operational as Aghon was crossing Luzon.

Currently, six cities and municipalities are experiencing power outages while

13 flooding incidents and three rain-induced landslides were also recorded, Marcos reported.

So far, the DSWD has provided PHP1.35 million worth of assistance while PHP607.9 million is on standby.

Meanwhile, the Bureau of Fire Protection, Armed Forces of the Philippines, and Philippine Coast Guard have prepared 841 search and rescue teams, while 465 (Turn to p. 2)

Mobile command centers to boost DSWD's disaster response capability

MANILA - Department of Social Welfare and Development (DSWD) Secretary Rex Gatchalian and Senator Joel Villanueva on Tuesday led the inauguration of the agency's new Mobile Command Centers (MCCs) seen to boost its capabilities to respond during disasters and calamities.

In his message during the inauguration, Gatchalian said the 14 new MCCs will be deployed in different regions in the country to complement the DSWD's Disaster Response Command Center (DRCC) that was inaugurated by President Ferdinand R. Marcos Jr. last January.

"Pero ang nangyari (But what happened), we have a hub but we can't talk to our regional offices. This (MCC) now completes the picture, that no matter what happens,

no matter how far, the mobile command centers can be deployed in a disaster area and can continue transmitting data to our regional and to our central office so that we can react commensurate to the disaster that is happening real time," Gatchalian said.

Gatchalian thanked Villanueva, chairman of the Senate Committee on Labor, Employment and Human Resources Development, for pushing and funding the MCC project that would help DSWD "cope with our mandate of disaster response."

Villanueva, for his part, said as one of the major frontliners in the public service and fight against poverty, the DSWD could save more people if well-equipped and capacitated.

transportation assets and 436 telecommunications equipment will be deployed to help typhoon victims.

"Kaya't tuluyan kong inatasan ang DSWD, DA (Department of Agriculture), DOH (Department of Health), para makapagbigay ng assistance sa lahat ng mga naging biktima ng Typhoon Aghon (With that, I am directing the DSWD, DA, and DOH to continue the provision of assistance to victims of Typhoon Aghon)," Marcos said.

He also tasked the Department of Public Works and Highways and the Department of Transportation to immediately repair damaged infrastructures.

"Patuloy pa rin ang ating search at rescue efforts (Our search and rescue efforts continue)," he said.

1 confirmed dead

In its situation update on Tuesday, the National Disaster Risk Reduction and Management Council (NDRRMC) confirmed one death and one injured due to the typhoon, both from Northern Mindanao.

The agency is also validating reports of seven injured in Bicol.

A total of 12,436 families, consisting of 36,143 individuals, have been affected by the weather disturbance.

Of this number, 4.076 families, or 16,426 individuals, are sheltering in 161 evacuation centers while 1,245 families, or 5,614 persons, are receiving aid outside evacuation centers.

The Office of Civil Defense earlier said affected families include those displaced and those not needing transfer or removal from their residence.

Meanwhile, 18 houses in Eastern Visayas were reported damaged, while four were wrecked. (With Priam Nepomuceno/PNA)

House Deputy Majority Leader and ACT-CIS party-list lawmaker Erwin Tulfo expressed optimism that increasing the coverage amount to PHP5,200 is "doable" following his meeting with PhilHealth officials.

"Base sa meeting namin kanina is do-Base able naman. doon sa funding at year pondo, every nagbibigay naman ng pondo ang Congress sa PhilHealth, so maaring doon ho huhugutin (Based on our meeting earlier, I think it's doable. Congress allocates funds for PhilHealth each year based on available budget, so that could be a source)," he said.

Tulfo said the current hemodialysis cost of PHP2,600 per session does not typically cover the vials to be injected to the patients.

"The good news is hopefully by next month, wala na talagang ica-cash out yung mga nagpapadialysis lalo na yung mga three time a week. Kasi ngayon kailangan nila

and spokesperson Irene Dumlao said the MCCs will ensure the continuous, effective, reliable, and timely emergency telecommunications support needed in disaster response operations.

"The MCCs use satellite technology managed by DSWD deployment teams. Through the system, our teams will be able to provide uninterrupted critical information for humanitarian response efforts and disaster response operations in the disaster-stricken area," Dumlao said.

Santos said the capitation rate for the Konsulta program has been increased to PHP1,700 per patient for both government and private Konsulta package providers.

"We are currently exploring it, studying it, looking closely to doing (a) study," Phil-Health president and chief executive officer Emmanuel Ledesma said in at a media forum in Pasig City.

He added that the PhilHealth has enough funds for such services.

Meantime, Phil-Health Benefits Development and Research Development senior manager Melanie Santillan said the Philippine Dental Association (PDA) still needs to come up with the guidelines for dental practice.

"Sa kanila kase ngayon palang nila ini-i-standardize 'yung dental services. Kunwari, ano ang gingawa during oral prophylaxis. Baka iba iba sila ng practice (They are standardizing the dental services just now. For example, what do they do prophylaxis. during They might have different practices)," she said. "We do not want patient safety to be compromised."

Senators are considering amendments on the UHC law so it can cover basic dental services like checkups and cleaning since 73 million Filipinos suffer from tooth decay, based on a National Health Survey in 2018

The PDA reported in February that 72 percent of the population have cavities. (PNA)

Southwesterly wind flow to bring rains, gusty winds across Luzon

MANILA - The southwesterly wind flow, partly influenced by Typhoon Aghon, will cause rains and gusty winds across Luzon, the weather bureau said Wednesday.

Moderate to heavy rains will prevail over the western portions of Northern and Central Luzon and Mimaropa until Thursday.

Occasional gusty conditions may be experienced in the next three days in Batanes, Ilocos Region, Zambales, Bataan, northern Aurora, southern mainland Quezon, Polillo Islands, Palawan, Lubang Islands, Romblon, Marinduque, and Camarines Norte.

The Philippine Atmospheric, Geophysical and Astronomical Services Administration (PAGASA) added that the southwesterly wind flow and the frontal system would cause moderate to rough seas over the coastal waters of Batanes.

PAGASA urges mariners of motorbancas and similarly sized vessels to take precautionary measures.

Meanwhile, Aghon was last tracked 870 km. east-northeast of extreme Northern Lu-

It is forecast to exit the Philippine Area of Responsibility within the day.

The typhoon packs maximum sustained winds of 130 kph near the center and gusts of up to 160 kph.

No tropical cyclone wind signal was hoist-

Gov't aid tops P4-M, 16K families affected

In its situation report Wednesday, the National Disaster Risk Reduction and Management Council (NDRRMC) said the government has provided more than PHP4.12 million worth of aid to areas hit by Aghon.

The amount covers accommodation and transportation assistance, family food packs, hot meals, hygiene kits, and "malongs" distributed in Calabarzon, Mimaropa, Bicol, and Central Visayas.

The disaster response body has also reported that the number of families affected by the weather disturbance has reached 16,336, or equivalent to 51,659 individuals.

Of this figure, 3,878 families, or 14,816 individuals, are being sheltered in 185 evacuation centers while another 1,585 families, or 6,409 persons, are receiving aid outside evacuation centers.

The confirmed casualties from the typhoon remain at one dead and one injured, both in Northern Mindanao.

The NDRRMC is validating reports of another seven injured in the Bicol region. (with Priam Nepomuceno/ PNA)

BAY, Laguna — A tary pointed out. new government-run medical facility being constructed in this municipality is poised to revolutionize healthcare accessibility, not only within Laguna, but across neighboring provinces in Calabarzon.

Department of Health (DOH) Assistant Secretary and Regional Director Ariel Valencia told reporters on Friday that the soonto-rise Laguna Regional Hospital (LRH) will be the central pillar in a new healthcare strategy that also includes the network of Super Health Centers (SHCs) across the province.

LRH will unburden the Batangas Regional Hospital in Batangas City and Southern Tagalog Hospital in Bacoor City, Cavite, which are the frequent destinations for Laguna's patients.

It will likewise streamline healthcare delivery and alleviate congestion in existing medical centers, he explained.

Valencia said the DOH's vision for the new hospital "revolves around ensuring equal access to top-tier healthcare services for every individual."

From primary care encompassing immunization, nutrition, and maternal health to specialized services like cancer screening and non-communicable disease prevention, the hospital aims to address a spectrum of health needs effectively, the assistant secre-

Earlier, the DOH and the provincial government also announced that a total of 13 SHCs are being built in La-

The small but wellequipped SHCs will serve as crucial gateways, ensuring timely and appropriate healthcare interventions before patients are referred to hospi-

On Thursday, national health officials and provincial leaders gathered for the groundbreaking ceremonies of the LRH in a two-hectare property in Barangay Puypuy.

Laguna 2nd District Representative Hernandez, the driving force behind House Bill No. 9623, which mandated the hospital's establishment, announced a PHP150 million initial budget for its construction.

Meanwhile, the Laguna provincial government announced that it has set aside a one-hectare piece of land in this municipality for the development of a commercial complex under its management.

Governor Ramil Hernandez told reporters on Friday that the land is part of a four-hectare parcel of prime real estate in Barangay Puypuy that is owned by the provincial government and is being subdivided to serve various purposes.

The envisioned LRH which will be operated by the DOH, will eventually occupy two

DPWH on track with key Calabarzon infra projects

CALAMBA CITY, Laguna – The Department of Public Works and Highways (DPWH) in Region 4A (Calabarzon) is on track with projects aimed at easing traffic congestion and enhancing road access to various parts of the region under the Marcos administration's Build Better More program.

During the "Kapihan sa Bagong Pilipinas" media forum, DPWH-4A Regional Director Jovel Mendoza said the rehabilitation of the portion of Maharlika Highway within their jurisdiction, which spans 231 kilometers from Calamba City to Tagkawayan in Quezon, is being diligently pursued by the incumbent administration.

"Maharlika Highway is the major thoroughfare of motorists (travelling) from Calamba City to Tagkawayan, Quezon in the region... linking Bicol up to Visayas and Mindanao," he told reporters during the forum that took place at the DPWH regional office in this city.

The DPWH official did not specify the target completion date of the highway rehabilitation project but called it "a top priority."

President Ferdinand R. Marcos Jr. last week said the reconstruction of this key highway has been ongoing for 12 years, but this is the only government that has put serious attention to its completion.

"All those rehabilitations, you know, we only really started two years ago. Because nothing was done in the previous administration, nothing was done in the administration before that," Marcos said about his administration's infrastructure initiatives.

Meanwhile, Mendoza also underscored the significance of the South Luzon Expressway TR4, a 48-kilometer bypass road from Santo Tomas in Batangas to Lucena City, Quezon, which is envisioned to alleviate congestion in San Pablo City.

This ongoing infrastructure project is intended to significantly reduce travel time in the region from four hours to one hour, making it a more convenient alternative to the congested Daang Maharlika.

Barring any unforeseen delays, the road is expected to be partially passable by 2025.

In Cavite, Mendoza said the 40-kilometer East Lateral Road from Aguinaldo Highway to Nasugbu, Batangas, once complete, will ease traffic in Tagaytay City, particularly on weekends when tourist traffic

Additionally, the flyover in Mendez town, Cavite, is expected to alleviate congestion at the Mendez junction leading to Nasugbu, Batangas.

Mendoza also highlighted the construction of a 1.42-kilometer bridge linking Lopez in the mainland to Perez in Alabat Island, providing a faster alternative to boat or barge travel.

"This locally funded project enhances connectivity to remote areas," Mendoza said. (PNA)

MPT South Joins LGRC-MSAC to Enhance Governance Initiatives

Olympic fencer Esteban moves past heartbreak, builds up Paris training

MANILA – Maxine Esteban spent five days in the Philippines before flying to Germany on Saturday to resume her training for the Paris Olympics.

After all the brouhaha over her naturalization in Cote d'Ivoire and eventual qualification to the Summer Games, the 23-year-old fencer is drowning out the unwanted noise.

She is fulfilling a dream she has nurtured since she was eight, although she still feels "weird" wearing the orange, white and green of the country she is representing.

"Yeah, I felt sad at first because I've always wanted to represent the Philippines but it is," Esteban, ranked world No. 35 in foil, told the Philippine News Agency in an interview.

She admitted she was "heartbroken" when she was dropped from the national pool by the Philippine Fencing Association (PFA).

After a tournament in Hong Kong, her Italian coach, Andrea Magro, granted her a brief vacation that allowed her to renew her sponsorship contract with a sportswear brand; watch a game of Alas Pilipinas in the Asian Volleyball Confederation Challenge Cup to support her friend from Ateneo de Manila, Faith Nisperos; grant media interviews; and spend time with her family before she sees them again in Paris in July.

She will compete in the Championnats d'Afique in Morocco on June 6, train in Poland, and join a training camp in Paris with the Japanese and French national teams in the run-up to the Olympics.

Esteban tied for 83rd at the 2024 Absolute Fencing Gear FIE Foil Grand Prix in Washington, D.C., United States on March 15. Her ranking points were enough to top the Olympic qualifying race for the African continental zone.

"For all the second chances, opened windows, miraculous feats and generous provisions, thank you, Heavenly Father," Esteban wrote on Facebook the day after her qualification. "This is for Cote d'Ivoire, the country that embraced me, believed in me and supported me all the way, and for the Philippines, the country my heart will always beat proud of."

Philippine Olympic Committee president Abraham Tolentino also immediately congratulated Esteban through a text message sent to her father.

She initially wanted to fight for her slot in the Philippine team even after her reinstallment pleas to the fencing pool were denied. In the end, she decided it was best to move on.

Esteban said Filipinos whom she encounters abroad always give her a feel of home.

"They welcome me everywhere," she said. "They are always sweet and welcoming. Even my new teammates are nice. They remind me of my former teammates."

Among her former teammates in the Philippines, Samantha Catantan is also going to Paris after ruling the Asia-Oceania Zonal Olympic Qualifier in Fujairah, United Arab Emirates on April 27.

Catantan and 12 other Filipinos have qualified to date -- gymnasts Carlos Yulo, Aleah Finnegan, LeVi Jung-Ruivivar and Emma Malabuyo; world No. 2 pole vaulter Ernest John Obiena; boxers Eumir Felix Marcial, Nesthy Petecio and Aira Villegas; weightlifters Vanessa Sarno, Erleen Ann Ando and John Febuar Ceniza; and rower Joanie Delgaco.

The PFA previously said it chose Catantan, the world No. 273, because of a better head-to-head record against Esteban. Thus, a higher chance to qualify via the Asian zone.

As in all the previous tournaments she joined in, Esteban said she will give it her all to be deserving of her slot because she knows an athlete's career is unstable.

"I am ready for the Olympics. I fought for this because I cannot wait for the next [Olympic] cycle," she said.

Her biggest weapon?

"My parents, my family. They are always my biggest supporters," she said. "They don't pressure me at all. They just want me to do what I love." (PNA)
