DA ramps up efforts to address spike in ginger price in MM

MANILA – The Department of Agriculture (DA) on Tuesday said it is ramping up efforts to address the price spike of ginger in Metro Manila amid a supply shortfall and growing demand from the processing industry.

This came after the prevailing ginger price in Metro Manila hit PHP280 per kilogram on May 31, according to the DA-Bantay Presyo (price watch).

In an interview, DA Undersecretary for High-Value Crops Cheryl Marie Natividad-Caballero said the growing demand for processing contributed to the declining supply available in the market. "We must understand na ang luya, hindi lang natin ginagamit pangbahay, pangluto... So nag-aagawan ngayon ng supply (that ginger is not only used at home, for cooking... So, there's a current supply grab). This is also being used now for processing. So, the spike in prices shows that there is a tight

Launch of mobile app providing assistance to OFWs set in July

MANILA – A mobile application providing comprehensive assistance and information to overseas Filipino workers (OFWs) globally will be launched in July.

OFW Party-list Rep. Marissa Magsino said the OFW App will synergize the digitization efforts of government agencies and provide access to welfare assistance, various benefits, and a crucial emergency button that connects directly to the Overseas Workers and Welfare Administration (OWWA).

Magsino, Department of Information and Communications Technology (DICT) Secretary Ivan John Uy and OWWA Administrator Arnaldo Ignacio signed the memorandum of understanding (MOU) on the OFW App at the OFW Tulong at Serbisyo Center at Ayala Malls Manila Bay in Parañaque City on Tuesday.

Migrant Workers (DMW) Secretary Hans Leo Cacdac and DICT Undersecretary for E-Government David Almirol were also present during the signing to express support for the initiative.

"The OFW App will revolutionize the way OFWs access vital services and information, bringing essential support right at their fingertips," Magsino said.

PH Covid-19 cases increase slow, manageable-DOH

MANILA – The Department of Health (DOH) on Tuesday said it has observed a slow increase in coronavirus disease 2019 (Covid-19) cases which are tagged as mild, making all regions remain at low-risk status.

Latest DOH data showed that the average number of daily reported cases for the week May 21 to 27 this year is 319.

"This is higher than

the previous week's figure (202), but is still less than half compared to around 500 per day at the start of this year, and also compared to around 1,750 per day in the middle of May 2023," the DOH said.

As of May 27, only 14 percent or 174 of 1,235 intensive care unit (ICU) beds dedicated for Covid-19 were occupied. Only 15 percent or 1,601 of 10,910 Covid-19 beds were Based on hospital reports in the DOH Data Collect application, severe and critical Covid-19 cases admitted in various hospitals total to only 185 or 10 percent of the total admissions.

The DOH said it is operating "with the assumption that the flagged Omicron sub variants are already likely in the country."

"Recent sequencing data by the Universi-



ty of the Philippines - Philippine Genome Center (UP-PGC) confirms this, with the identification of 30 cases of JN.1, 2 cases of JN.1.8, and 2 cases of KP.2," it said. tion that the new variants under monitoring continue to be clinically mild and manageable," it said.

The earliest sample collection date for JN.1 in the Philippines is November 2023.

Meanwhile, the earliest sample collection date for KP.2 is May 2024.

"It may be likely that there are earlier KP.2 cases, but because of limited sequencing we have not detected and

access to services, emergency assistance, and vital information in just a few clicks. I have been pitching this idea to IT experts before, but it was only throught DICT's technical assistance, which allowed us to move forward with the project. Magsino said the evolving features will later include services of government agencies with frequent transactions with OFWs, with the DMW signifying its intent to link vital services to the OFW App.

The simulation of the app will commence through the participation of select OFWs all

over the world for their feedback. The app will be formally launched after finetuning of the interface and its services through consultation with end-users.

"I would like to thank DICT Secretary Ivan John Uy and Undersecretary David Almirol for walking hand in hand with the OFW Party List to bring our idea to life," Magsino said.

"I am also thankful that OWWA accepted our invitation to collaborate on the delivery of services, especially welfare assistance. Our world is fast evolving through digital technology and we should be in sync with the innovations in how we bring our services to our OFWs," she said. (PNA)

The four variants under monitoring (VUM) are JN.1.7, JN.1.18, KP.2, and KP.3.

All of these are descendants of JN.1. Variants KP.2 and KP.3 are the proper names of what is informally known as "FLiRT" variants.

FLiRT is a nickname coined by some researchers to describe amino acid changes in the Covid-19 virus' spike protein, specifically from phenylalanine (F) to leucine (L) at position 456, and from arginine (R) to threonine (T) at position 346.

However, the DOH said it avoids using "FLiRT" to refer to the sub variants, as the term is informal and casual, and "using it might result in a miscommunication of health risk."

The World Health Organization said "there are currently no reported laboratory or epidemiological

reports indicating any association between VOIs/VUMs and increased disease severity." There is still no ev-

idence now that the KP.2 and KP.3 variants are causing severe to critical Covid-19, both locally and internationally.

Further assessment continues to determine transmissibility and capacity to evade immune response.

The DOH advised the public to practice good respiratory hygiene (covering coughs), washing hands, chooscoughs), ing less crowds, and ensuring good airflow and ventilation to prevent Covid-19 and other acute respiratory illnesses.

Those who feel ill are urged to stay at home for the meantime, or to properly wear a mask should there be a need to go out.

Taiwan extends visa-free entry to Filipinos until July 2025

MANILA - Taiwan has extended its visa-free entry program for Philippine passport holders until July 31, 2025.

The announcement was made by the Taiwan Ministry of Foreign Affairs-Bureau of Consular Affairs on June 4, renewing for another year its "trial visa-free entry" for nationals of its "New Southbound Policy" including partners, Thailand and Brunei.

supply availability as of the moment," she said. The emerging need in the processing industry for ginger includes salabat tea, which is considered one of the organic and natural health remedies, as well as yellow ginger which may be used as turmeric, colorant, flavoring, and for other medicinal purposes, among others.

"So, the effects of typhoon Aghon have nothing to do with the mounting prices considering that ginger harvest was done last March to April, with the latter part completed in May," Cabellero said.

"If we have to make sure that there's stability in prices, we must be able to produce in two

Possible challenges in logistics, however, are being taken into account since the farmgate prices of ginger vary, with the basic wholesale price set around PHP100/kg.

"Ang rule of thumb kasi nila is nasa times two iyan parati (The rule of thumb is you multiply it by two) from the farmgate price. So, that is how we do the assessment. But you must understand kahit iyon iyong rule of thumb, ang tanong doon is nasaan iyong supply (that's a rule of thumb, but the question is where is the supply)," Caballero said.

To date, the DA is ramping up efforts to source supply from various provinces near Metro Manila to minimize transport costs, just like in the Pinatubo area.

The possibility of importation is also not out of the table, she said. (PNA)

Orientation on New Assessment Tool for Child Development Centers

Child development workers and teachers from across the province gathered at the Ceremonial Hall of the Provincial Capitol in Trece Martires City for an orientation on the new assessment tool for registration and granting permits to public and private child development centers and learning centers spearheaded by the Office of the Provincial Social Welfare Development Officer recently.

The two-day event aimed to equip participants with essential knowledge and skills to enhance the quality of early childhood education in the province. The program commenced with a warm welcome and opening remarks, setting the stage for an engaging and informative session.

Ms. Melody Ronquillo, Regional ACDEV Secretary, kicked off the first day with a comprehensive discussion on the Competency Standards for Child Development Workers and Child Development Teachers. She emphasized the importance of adhering to these standards to ensure the delivery of high-quality education and care for young children.

Following Ms. Ronquillo's session, Ms. Perla Reyes, National CDW President took the floor to delve into Developmentally Appropriate Practice. Her presentation focused on the principles and practices that support the optimal development and learning of young children, stressing the need for educators to be attuned to the developmental stages and individual needs of their students.

The second day of the orientation continued with an insightful session led by Ms. Precyl Ramos, OIC-OPSWDO. She provided an Overview on the National Early Learning Curriculum and the National Early Learning Framework, highlighting the curriculum's goals, structure, and implementation strategies. Her session aimed to align the educators' teaching practices with national standards and expectations.

In the latter part of the day, Mr. Aries Panganiban, PECCD Focal Person, presented the New Standards and Guidelines, along with the Guidelines on the Registration and Granting of Permit and Recognition to Public and Private Child Development Centers and Learning Centers. His detailed discussion outlined the procedures, requirements, and criteria for registration and recognition, ensuring that all attendees were well-informed and prepared to comply with the new regulations.

The orientation concluded with an open forum where participants had the opportunity to ask questions and seek clarifications from the speakers. The interactive session allowed for the exchange of ideas and best practices, fostering a collaborative spirit among the child development workers and teachers.

The activity marks a significant step forward in the province's commitment to providing high-quality early childhood education. By equipping educators with the necessary tools and knowledge, the Provincial Government of Cavite ensures that its youngest citizens receive the best possible start in life.

EO on reduced tariffs to lower prices of rice, other commodities

Ferdinand R. Marcos as well as the increas-Jr. is set to issue an executive order (EO) to calibrate the current tariff rates until 2028 the government as moves to ensure access and affordability of rice and other essential commodities.

In a Palace press briefing Tuesday, Socioeconomic Planning Secretary Arsenio Balisacan said Marcos, as chair of the National Economic and Development Authority (NEDA) Board, approved the new Comprehensive Tariff Program for 2024-2028 covering various agricultural and industrial products.

Among the products that will get a major reduction is rice, which will have reduced tariff of 15 percent duty rate for both in-quota and out-quota rates from 35 percent until 2028.

"This decision aims to lower the price of rice further and make it more affordable," Balisacan said.

Based on the latest inflation report of the Philippine Statistics Authority, rice contributed about two percentage points (or over 50 percent) to the headline inflation.

Upward price pressures for rice, Balisacan said, are driven by the effects of the

MANILA - President El Niño phenomenon, ing demand given the steadily growing population and economy.

Reducing rice tariffs is expected to bring down rice prices for consumers while supporting domestic production through tariff cover and increased budgetary support to improve agricultural productivity, especially as global rice prices remain elevated, the NEDA chief noted

The NEDA Board also agreed to merge tariff lines on certain chemicals and chemical products, textiles, machinery, and transport equipment to simplify the tariff structure for more efficient customs administration and improve the ease of doing business.

Meanwhile, tariff reduction will likewise be implemented on certain chemicals and coal briquettes to improve energy security and reduce input costs.

The reduced tariff rates on corn, pork, and mechanically deboned meat under Executive Order 50, s. 2023, will be maintained until 2028 to ensure a stable supply of these commodities, help manage inflation, promote policy stability and investment planning, and enhance food security. (PNA)

Local gov't improves health services in Batangas Provincial Jail

BATANGAS CITY – The Provincial Health Office (PHO) here has begun conducting monthly medical missions inside the Batangas Provincial Jail (BPJ) to prevent the transmission of infectious diseases among persons deprived of liberty (PDLs).

In an interview on Tuesday, Dr. Rosalie Masangkay, assistant department head at the PHO, said almost 1,000 PDLs benefitted from their medical mission during the last week of May.

Masangkay said the recent scorching temperatures also contributed to the urgency of improving health services within the province's main detention center.

"We are monitoring those with maintenance medication to see if their condition improves or worsens. We are treating several skin infections because of the extreme heat recently but there is no skin disease that is contagious," she said.

Masangkay assured that her team will conduct regular medical and dental checkups, medicine distribution, and laboratory tests to prevent any infectious disease transmission in the jail facility.

She said the provincial government wants to reassure the family of the PDLs that the provincial government is taking good care of them while inside the facility.

"We are thankful that Batangas Governor Hermilando Mandanas and Provincial Jail Warden Atty. Genaro Cabral for their support to our recommendation to build an infirmary to effectively treat our sick PDLs. The moment an inmate comes in... we give them a check up," Masangkay said.

She said the improved health services also include giving "special diets" to all sick PDLs to boost their recovery and ensure their nutrition.

Masangkay shared that essential medicines and vitamins are also provided for free by the provincial government to cure seasonal diseases like fever, cough, and colds, among others.

Aditionally, a dental mission is conducted every quarter and a free laboratory test such as chest x-ray, electrocardiogram, blood chemistry, and urinalysis is organized twice a year, she said.

Meanwhile, Joselito Eguia, administrative officer of Batangas Provincial Jail, said this support from the PHO is very crucial to preventing infectious diseases since the facility is overcrowded.

"Right now, the number of our PDL is 944 with 864 male and 80 female. Our population is crowded because based on previous reports, its capacity is only 450," he said.

Eguia revealed that a new detention facility is already being built in Barangay Malainin, Ibaan, Batangas to help decongest the BPJ. (PNA)

DSWD chief: Enough resources for Kanlaon-affected families

MANILA – Department of Social Welfare and Development (DSWD) Secretary Rex Gatchalian on Tuesday assured the agency has sufficient family food packs (FFPs) in regions affected by the volcanic activity of Mt. Kanlaon in Negros Island.

Gatchalian said President Ferdinand R. Marcos Jr. directed the DSWD to stay on top of the situation and ensure no family will be left behind.

"As we speak right now, may 10,000 tayong FFPs kagabi -- almost 5,000 sa Negros Occidental, 5,000 sa Negros Oriental. Kanina, may sampung libo ulit na FFPs na dumating dito at galing yan sa packaging center natin sa Cebu (we have 10,000 FFPs last night -- almost 5,000 in Negros Occidental, 5,000 in Negros Oriental. A while ago, 10,000 FFPs from the packaging center in Cebu arrived here)," Gatchalian said in a press conference

PGC extends Medical and Dental Mission Program to Dasmariñas Residents at PCU.

On May 24, 2024, a successful medical and dental mission was held at Philippine Christian University (PCU) in the City of Dasmariñas, benefiting a total of 193 patients. Spearheaded by the Provincial Government of Cavite (PGC) and involving

PH athletes going to Paris Olympics assured of cash incentives

MANILA – Filipino athletes who qualified for the Paris Olympics will receive cash incentives from senators.

Philippine Sports Com-(PSC) Chair mission Bachmann Richard made the announcement on Tuesday during the Philippine Sportswriters Association Forum at Rizal Memorial Sports Complex (RMSC) in Manila.

"Twenty-three million is only from Senator Risa Hontiveros, then Senator Bong Go has a figure already. He has additional. There's also additional from other senators direct to the athletes already na pinasa lang sa (that was just coursed through the) PSC and I just signed a cheque siguro mga (of around) PHP30 million

plus," Bachmann said. So far, 15 Filipino athletes have booked tickets to the Paris Games. They are pole vaulter EJ Obiena; gymnasts Carlos Yulo, Aleah Finnegan, Levi Ruivivar and Emma Malabuyo; boxers Aira Villegas, Nesthy Petecio, Hergie Bacyadan, Eumir Marcial and Carlo Paalam; rower Joanie Delgaco; weightlifters Vanessa Sarno, John Ceniza and Elreen Ando; and fencer Sam Catantan.

At the 2021 Tokyo Games, the Philippines won its first gold medal coming from weightlifter Hidilyn Diaz. Paalam and Petecio pocketed silver medals while Marcial got a bronze.

"We have until June 30 to see who else will qualify," said Bahmann.

The PSC has allotted PHP52 million for the Paris Olympics, covering preparation, training and actual participation, as well as airfare, luggage and parade uniforms.

"We've already spent PHP43 million so I have PHP8 to PHP9 million left. If it's not enough, I will look fore more," Bachmann, a former professional basketball player, said.

Meanwhile, he bared the construction of a seven-story athletes' dormitory inside the RMSC.

Demolition of the old boxing and pencak silat buildings, where the new dormitory would be built, is scheduled in July. The groundbreaking is set in August. (PNA)
