Senate panel to probe water shortage

MANILA -- The provinces. Senate Committee on Public Services is set to conduct a congressional inquiry into the water shortage besetting parts of Metro Manila and Rizal province, as well as several farming communities in the

The hearing is scheduled on Tuesday, March 19 at the Senate Session Hall at 10 a.m.

Senator Grace Poe, panel chair, said the hearing is part of the committee's oversight functions over the country's utilities.

"What we are seeing now is not normal and something that our households and farmers do not deserve," Poe

QC residents urged to conserve water amid El Niño

Quezon City Vice Mayor Joy Belmonte on Wednesday urged business establishments, offices and households to strictly practice water conservation measures amid water service interruptions and depleted water supply in Metro Manila.

"We should use water wisely, especially now that we are experiencing the effects of El Niño, lalo na sa mga tahanan natin dahil diyan

nagsisimula practice ng water conservation (especially in our homes where the practice of water conservation starts)," Belmonte said in an interview.

She was referring to the El Niño weather phenomenon or the prolonged dry spell that has caused water at the La Mesa Dam to drop to a critical level and has led water service interruptions in Metro Manila and some parts of


Rizal province.

"Also, establishments should not forget to check their water system for leakage. I urge citizens to also report any broken faucet or pipe leak that they see in offices. schools. restaurants and establishments to their respective owners or managers so that it would be fixed immediately," she added.

Belmonte noted that the service interruptions will continue to affect

some parts of Quezon City while some barangays are already experiencing low water

"It is very unfortunate here in QC (that we have a water supply problem), especially since there are fire incidents suddenly happening. In Barangay Baesa for one, the fire marshals really had trouble putting out a fire. Because of those incidents, we could not help but just ask for the public's cooperation as



The fire in Barangay Baesa razed more than 300 houses on the same day there was a water service interruption.

"I am also calling for restaurants to observe our Anti-Water Wastage ordinance. It mandates them to serve water only upon the request of their customers. Dahil minsan, may customers talaga na (Turn to p. 2)



BFP gets 266 new fire trucks

MANILA -- The the dry season. Bureau of Fire Protection (BFP) is set to boost its firefighting capabilities with the acquisition of 266 new fire trucks.

Department of the Interior and Local Government (DILG) Secretary Eduardo M. Año said the new fire trucks, which are set to be distributed to key cities and municipalities this year and next year, will further beef up the fire prevention and suppression efforts of the BFP, especially during March with the onset of

Of the 266 fire trucks, 56 units with 1,000-gallon capacity, which were part of last year's procurement program, will be delivered anytime soon for distribution to fire stations without fire trucks and to re-fleet 20year-old units.

"Fire incidents usually peak during summer and we want our firefighters to be ready to be of assistance to the during conflagrations and other emergencies," Año said in a statement.

"We are hopeful that with the acquisition of new fire trucks, the BFP will be more than equipped to rush to the location of the blaze to put out the fire and rescue possible victims," he

For this year's procurement, the DILG chief noted that the acquisition of another 56 units worth around PHP700-million, 1,260 sets of self-contained breathing apparatus, and three units of rescue trucks have already

passed the early procurement stage and a Notice of Award will soon be issued to the

No medical marijuana legalization under Duterte's term: Palace

-- President Rodrigo R. Duterte does not see the legalization of medical marijuana happening within his term since he does not want to risk the spread of addiction in the country, Malacañang said on Tuesday.

Spokesperson Salvador Panelo confirmed the President is no longer in favor of the legalization of marijuana even for medicinal purposes citing the risk that people could develop a dependence on the drug.

I asked him...absolute? Yes. He doesn't like kasi ang feeling niya you will be using that as an excuse baka lumaki ng lumaki lang (He doesn't like to legalize it because he feels that people will be using it as an excuse to expand its use)," Panelo said in a Palace briefing.

Kaya not during my time sabi niya. Sa ibang panahon siguro (That's why he said, 'not during my term. Perhaps some other time')," he added.

Panelo further said the lack of definitive findings on the effectiveness of medical marijuana could be a reason for the President's reluctance to allow its legalization.

"Ang sabi niya pa, dapat yung mga medical muna ang mag-decide kung totoong nakakagamot 'yan. Kasi sa ngayon, hindi definitive ang findings -- may nagsasabing puwede, may nagsasabing hindi (The President said medical experts should first decide if it can really treat some conditions. Because now, the findings are not definitive -- some say it can, some say it can't)," Panelo said.

"He doesn't want to risk the spread of addiction in this country," he added.

Spokesperson, however, said that Duterte may still change his mind if definitive findings confirm its advantages.

Kung definitive yung findings (If findings become definitive) he might change his mind,"" Panelo said.

Earlier, Panelo said Duterte's changed his mind about the legalization of medical marijuana noting that the chief executive may want more safeguards before its use is allowed in the country.

Panelo said that the President himself admitted that he knew little about the use of medical marijuana with respect to specific cases.

Duterte bared he is no longer in favor of the legalization of medical marijuana during a PDP-Laban campaign rally in Negros Occidental on March 8.

The Comprehensive Dangerous Drugs Act of 2002 has listed marijuana as a prohibited substance. (PNA)

acquisition of 28 other units of fire trucks for the B a n g s a m o r o Autonomous Region in Muslim Mindanao, which is being handled by the DBM Procurement Service, is still ongoing.

DOTr, JCI ink MOA on free bus rides to and from PITX

'Province of Cavite, March 11 (PIA)—The full operation of the Parañaque Integrated Terminal Express (PITX) brought changes in the transport system in this part of the region.

The primary aim of the PITX is to relieve the heavily congested EDSA by prohibiting provincial buses to ply this route thus the PITX, the South Central terminal where provincial buses from Cavite will unload commuters going out of the province and transfer to buses or jeepneys that will ferry them to different destinations in Metro Manila.

And as much as the g o v e r n m e n t 's expectation of the benefits it would give the commuters from the south, it had been more of an inconvenience because of the lack of buses coming into PITX, commuters spend so

In answer to the outcry, Domingo Roque, Jr. president of the Junior Chamber International Senate Philippines, Department of Transport Secretary Art Tugade and Megawide Corporate Foundation, Inc. signed a memorandum of agreement to grant free bus rides to selected destinations in Metro Manila.

Roque announced that: "at least six airconditioned buses started plying last February 14, 2019 to load commuters from the PITX to destinations like Baclaran, cities of Parañaque and Pasay and Lawton in Manila."

The free bus rides is called "SerBus: a Service to Humanity Project" which will somehow lessen the commuters difficulty in getting a ride.

Ordinance 2437, or the "Anti-Water Wastage Ordinance", was crafted in 2015 in accordance with the city's aim to conserve water due to a decline in water levels in Angat Dam.

The ordinance mandates a fine, ranging from PHP1,000 to PHP5,000, to be imposed on restaurants,

hotels, inns, canteens, and eateries that would violate its provisions.

"All we are asking is for us to cooperate and work on this. Maliit na sakripisyo sa pagtitipid pero para sa kapakanan ng mas nakararami. Administrator Reynaldo V. Velasco will meet with Daegu Metropolitan City officials at the Makati Diamond Residences in Makati City on Thursday to discuss the matter.

A delegation from Daegu will be attending the Asia Water Council (AWC) Board of Council meeting in

The MWSS is hosting the event with its concessionaires Manila Water, Maynilad and Luzon Clean Water Development Corporation.

Top officials from the Department Environment and Natural Resources (DENR), Department of the Interior and Local Government (DILG), Metropolitan Manila Development Authority (MMDA), and lawmakers from both houses of Congress are expected to attend the conference.

cooperation with Daegu can be explored in the following areas: Manila Bay clean-up; Three-River System Improvement Program; improved treatment technology and design capacity for Sewerage Treatment Plants (STPs): upgrade of Central Manila Sewerage System; setting-up of wastewater treatment facilities in defined catchment areas and major interceptor lines; and adoption of a creek and drainage outflow interception.

Daegu officials also expressed interest in Velasco said the collaborating

programs that address standard-setting, sewer ordinance policymaking and continuous awareness campaign on water reuse, Velasco said.

The meeting will follow through the memorandum understanding (MOU) between MWSS and Daegu Metropolitan City signed last year by Velasco and Daegu Mayor Young Jin Kwon.

As stipulated in the MOU, MWSS and Daegu will, among other things, work together to develop technical solutions for water resources-related

challenges and share strategic technologies in connection with water and sewerage system.

Velasco welcomed the signing of the MOU as it afforded MWSS the opportunity to tap Daegu Environmental Corp. to serve as third party consultant and help assess the overall sewerage wastewater management system in Metro Manila.

"I look forward to my meeting with the delegation from Daegu to discuss areas and programs where collaborative efforts for the attainment of water and sanitation goals can be employed," Velasco said.

Before the signing of the MOU, a delegation from Daegu Metropolitan City, led by Deputy Mayor for Economic Affairs Yon Chang Kim, submitted a proposal for government-togovernment cooperation support for advanced water technology demand area; improvement of inefficient operation of water purification plant and sewage treatment plant; improper sewage discharge system improvement; and installation of water purification system.

The proposal was officially submitted following the successful visit of President Rodrigo Duterte to South Korea in June last year. (PNA)

1st QUARTER CPPOC, PADAC AND PDC MEETING

Members of the Cavite Provincial Peace and Order Council (CPPOC) and Provincial Anti-Drug Abuse Council (PADAC) convened for the joint 1st Quarter CPPOC & PADAC meeting followed by the Full Council meeting Provincial Development Council (PDC) on March 8, 2019 at Sherwood Hills Golf and Country Club in Trece Martires City. The whole day assembly was spearheaded by the Department of Interior and Local Government in coordination with the Provincial Planning and Development Office in order to discuss matters on peace and order, insurgency and programs for former rebels, drug abuse prevention programs and drug-free city/municipality status of LGUs, and development programs of the province.

The joint CPPOC and PADAC was called to order by Provincial Administrator for Internal Affairs Renato A. Abutan on behalf of Governor Jesus Crispin "Boying" C. Remulla upon determination of quorum by DILG-Cavite OIC Provincial Director and Head Secretariat Eloisa G. Rozul.

Police Chief Inspector Jonathan Asnan of Cavite PPO presented the current peace and order situation of the province with data which reflects a 58.99% decrease in eight focus crimes for the 1st quarter of 2019 as compared to the same period in 2018. Jail Officer 3 Jenylin Ouintana of the Bureau of Jail Management and Penology (BJMP) reported the status of

inmates in different which showed that detention facilities in the province wherein overcrowding of inmates is the most pressing concern. Bacoor City Mayor Lani Mercado Revilla announced that they have put up a new detention facility to address the said problem in their city jail and asked for the support of the council to secure the area through fencing assistance.

Castro, Bacoor City Fire Marshal also presented the report of the Bureau of Fire Protection on the programs they are conducting towards fire prevention and the need for additional personal protection equipment of firefighters. For the internal security updates, Brigadier Gen. Arnulfo Marcelo Burgos Jr. shared the various encounters that have had with armed groups operating in the CALABARZON region and the activities that they initiated to curtail the proliferation of leftleaning groups. He urged the council members particularly the local chief executives to be on guard and to not let these groups infiltrate their localities. He announced that Cavite was declared as a province with Stable Internal Peace and Security last December 4, 2018 and proposed for the creation of a Provincial Task Force to End Local Communist Armed Conflict to spearhead local antiinsurgency measures.

The report on antidrug abuse initiatives and drug-free status of LGUs was presented by Agent Theonette Solar of the Philippine Drug Enforcement Agency

Tagaytay City and the municipalities Amadeo, Magallanes and Mendez have been declared drug-free by the Regional Oversight Committee Dangerous Drugs. The municipalities of Alfonso, General Emilio Aguinaldo and Maragondon have achieved 100% drug-free barangays but are yet to be declared drug-free municipality pending the setting up of Balay Silangan, a reformatory institution for drugpushers which was included in the criteria for declaring drug-free cities and municipalities.

In the afternoon, the PDC- Full Council Meeting was called to order by Provincial Planning and Development Coordinator Jesus Barrera. The discussion proper for businesses started with the presentation of Mr. Sammy C.M. Yip of Ove Arup & Partners Hong Kong Ltd. on the Bataan Cavite Interlink Bridge (BCIB) Project that aims to ease the traffic congestion and provide convenience in Metro Manila and South and North Luzon gateway, and provide opportunities for economic growth. The said project sought the endorsement of the PDC to the Regional Development Council.

Updates and Status Solid Waste Management in the province was tackled by Ms. Anabelle Cayabyab, Head of the Provincial Government-Environment and Natural Resources Office, revisiting the 10-year solid waste management plan of the province and the different LGUs.

WHO lauds PH for passing child safety in vehicles law

MANILA -- The die from road crashes World Health Organization (WHO) has lauded the Philippines for passing a law that will require vehicle owners to use child restraint systems when traveling with children.

The WHO said Republic Act 11229 or the Child Safety in Motor Vehicles Act recently signed by President Rodrigo R. Duterte will help prevent injuries that might be sustained by children at road accidents.

"The WHO congratulates the Philippines as President Rodrigo Duterte signed into law the Child Safety in Motor Vehicles Act or Republic Act 11229. The initiative makes Philippines among the few countries in Asia to pass child restraint legislation," organization said in a statement Wednesday.

"In the Philippines, more than 600 children

each year. The legislation is a significant step towards prioritizing the safety and welfare of infants and children on Philippine roads, and preventing traffic-related deaths and injuries," it added.

The Child Safety in Motor Vehicles Act also restricts children from sitting in the front seats of automobiles.

The use of child restraints in vehicles keeps children secured on their seats as they are not thrown against the car interior or ejected in cases of sudden braking or road collisions, the WHO said.

"Evidence has shown that child restraints reduce the likelihood of a fatal crash by approximately 70 percent among infants and between 54-80 percent among young children," the statement read.

The organization has committed to provide its support to the Philippine government in crafting the implementing rules and regulations (IRR) of RA 11229.

The Department of Transportation, in consultation with the Department of Trade and Industry, Department of Health (DOH), Department of the Interior and Local Government, Philippine National Police-Highway Patrol Group, Metro Manila Development Authority, Council for the Welfare of Children, and other concerned agencies and stakeholders must promulgate the IRR on child restraint systems within six months from the effectivity of the law.

Various government agencies, as well as private agencies and organizations, must conduct a nationwide information campaign on the proper installation, use, and maintenance of the child restraint system. (PNA)

PRRD signs Child Safety in Motor Vehicles Act

MANILA, -President Rodrigo R.
Duterte has signed into law a bill that requires motor vehicle owners to use child restraint systems when traveling with children.

Duterte signed Republic Act No. 11229 or the Child Safety in Motor Vehicles Act on Feb. 22 and a copy of which was released to media on March 12.

"It shall be unlawful for the driver of a covered vehicle not to properly secure at all times a child, in a child restraint system while the engine is running or transporting such child on any road, street, or highway unless the child at least 150 centimeters or 59 inches in height and is properly secured using the regular seat belt. The child restraint system shall be appropriate to the child's age, height, and weight," the law reads.

Under the law, the Department Transportation (DOTr), Philippine Information Agency (PIA), Department of Health (DOH), Department of Education (DepEd) and private agencies and organizations must undertake regular nationwide information, education, communication campaign within six months from the passage of this act.

The campaign must include information on the proper installation, use, and maintenance of the child restraint system The DOTr may call upon any government agency, including the Philippine National Police (PNP) and nongovernment organizations (NGOs) to extend their full support and cooperation for the implementation of this act.

It must also conduct and submit to Congress a periodic review on the implementation of this act at the end of the third year from the date of effectivity year thereafter.

The DOTr, in consultation with the Department Department of Trade and Industry (DTI), DOH, Department of Interior and Local Government (DILG), Philippine National Police-Highway Patrol Group (PNP-HPG), Metro Manila Development Authority (MMDA), Council for the Welfare of Children (CWC), and other concerned agencies and stakeholders must promulgate implementing rules and regulations (IRR) on child restraint systems within six months from the effectivity of this act.

The act shall take effect 15 days after its publication in the Official Gazette or in two national newspapers of general circulation.

That act which is a consolidation of Senate Bill No. 1971 and House Bill No. 6938 was passed by the Senate and the House of Representatives on Dec. 11, 2018. (AP/PNA)

MANILA-- Two captain

In an e-mail sent by the Chinese Embassy in Manila on Wednesday, it said the victims' boats were found overturned and broken in Guimaras Strait when the marine water depth measurement team from China Communications Construction Company (CCCC) Limited Highway Consultants Co. Ltd saw them on March 1.

Feng Minhua, one of the surveyors, recalled that as their survey ship sailed five kilometers away from the coast, "the captain suddenly discovered human figures floating with waves in the distance."

"When they were close, the surveyors gradually heard calling for help from planks of a broken small fishing boat. The voice was low because of exhaustion, and two fishermen were holding the planks tightly," the embassy's statement read

"As there were big waves due to rising tide, the two fishermen were in great danger since they might be overturned and drowned by waves at any time. The surveyors and the crew immediately throw life ropes and life jackets to the fishermen," it added.

After rescuing the fishermen, the survey ship

also managed to tow two damaged fishing boats back to Sibunag wharf.

The fishermen, who were not identified, narrated that the sea conditions suddenly changed as they were fishing that day.

The strong wind and waves, they said, caused the boat to overturn and broke in the sea.

According to the embassy, the surveyors were in Guimaras Strait to conduct a feasibility study on the PGN Island Bridge Project, which was signed in the presence of President Duterte and President Xi Jinping who recently visited Manila last year.

The embassy said: "the feasibility study project is going on smoothly." (PNA)



Gov't vows clean water for all

MANILA -- The government will do everything it can to provide clean water for everyone, National Disaster Risk Reduction and Management Council (NDRRMC) Executive Director Ricardo Jalad said Wednesday.

"We want to assure the public that the government is doing everything to ensure adequate water supply for all," Jalad said in a statement sent to reporters.

The NDRRMC Technical Management Group convened a meeting with concerned government and private agencies at about 2 p.m. Wednesday, to discuss updates and plans to mitigate the effects of the El Niño weather phenomenon in the country.

Present were Jalad, Department of Science and Technology

Undersecretary Ricardo Solidum, representatives of the Department Environment and Natural Resources - National Water Resource Board, Philippine Atmospheric, Geophysical Astronomical Services Administration, the departments of social welfare, agriculture, education, energy, and interior, National Economic Development Authority, National Power Corp., National Electrification Authority, Armed Forces of the Philippines, Bureau of Fire Protection, Philippine National Police, Philippine Coast Guard, Local Water Utilities Administration, Metropolitan Manila Development Authority, Commission Elections, and Office of Civil Defense (OCD).

Private groups, such as the Philippine Disaster

Resilience Foundation, as well as water concessionaires, Maynilad and Manila Water, were also in attendance.

The OCD offices in the Zamboanga Peninsula, Davao region, Soccsksargen, and Mimaropa also participated through teleconference.

"NDRRMC member-agencies shall submit their respective Action Plans (with) regard to the impact of El Niño to the OCD by 15 March 2019. These will be consolidated and presented at the NDRRMC Full Council Meeting on 20 March 2019. (In the) meantime, everyone is encouraged to remain calm, avoid water wastage, and practice always sustainable water management in their respective homes," Jalad said. (PNA)

No deportation of OFWs from UAE: DOLE

MANILA -- The Department of Labor and Employment (DOLE) on Wednesday assured that there will be no deportation of overseas Filipino workers (OFWs) from the United Arab Emirates (UAE).

Citing a report from the International Labor Affairs Bureau (ILAB), Labor Secretary Silvestre Bello III made the assurance amid the news circulating online that the Middle Eastern country will deport all foreign workers starting next

According to the article, foreign workers in 35 job categories who are over the age of 40 will be terminated and deported to give opportunity to

UAE nationals, especially the young graduates, in a bid to solve the country's unemployment problem.

Among the occupations mentioned are pharmacist, medical secretary, administrative clerk, human resource officer, receptionist, treasurer, librarian, security guard, purchasing manager, debt collector, cashier, tour guide, etc.

In a report to ILAB, Philippine Overseas Labor Offices (POLOs) officials in Abu Dhabi and Dubai have said that UAE officials denied the reports.

Labor Attache Alejandro Padaen of the POLO in Abu Dhabi quoted Dr. Omar Abulrahman Salem Alnuami, Assistant Secretary for Communication and International Relations of the Ministry of Human Resources and Emiratisation (MOHRE) telling him the story is "fake news."

Another UAE official, Asmaa Alamadani, the executive director of MOHRE's International Bilateral Relations Department, spoke to Labor Attache Felicitas Bay of POLO Dubai, who assured her that the news is "not true at all."

The article also circulated in other Gulf Cooperation Council countries such as Saudi Arabia and Oman. (PNA)
