Kennon Road, 5 other Luzon roads closed due to 'Falcon'

MANILA – Four road sections in the Cordillera Administrative Region (CAR) and two in Cagayan Valley (Region 2) were closed to traffic due to Tropical Storm Falcon, the Department of Public Works and Highways (DPWH) reported on Wednesday. According to the DPWH-Bureau of Maintenance (BOM), the roads have been closed to vehicles due to a road cut, road slip, soil erosion, flooding, and unsafe road conditions brought by the storm.

4th SONA to highlight Duterte Legacy, path for next 3 years

MANILA --Presidential Communications Operations Office (PCOO) Secretary Martin Andanar on Tuesday said President Rodrigo Duterte's fourth State of the Nation Address (SONA) would highlight the legacy of the current administration and its path for the next three years.

In a television interview, Andanar said President Duterte will likely discuss the government's efforts to reduce poverty, bigticket infrastructure projects, and peace and order programs in his fourth SONA. "Number one, poverty alleviation, bringing poverty rate down from 21 to 14 and making the economy upper middle class by the end of his term. Second would be the infrastructure projects," Andanar said. "And thirdly, there's the peace and order highlighting the national task force to end local communist armed conflict, because you can never have progress without peace and order. And I think diyan tututok ang Presidente sa tatlong mensahe na iyan (those three topics would be the

focus of the President [in controversies that could his speech])," he added. also be addressed in

Andanar noted that other accomplishments under the economic and the business cluster, as well as the policies and programs of government agencies, would possibly be discussed on July 22. Cavite helps raise awareness on Hemophilia

Medical practitioners in Cavite including city and municipal health officers, doctors and dentists from public hospitals, nurses from the rural health units, members of the PWD federation, employees of the provincial government mainly from the Provincial Health Office (PHO), Provincial Social Welfare and Development Office (PSWDO), Provincial Information and Community Affairs Department (PICAD) and some members of Hemophilia the Advocates Philippines (HAP) convened at the Cavite Collaboration Center for Public Health Auditorium in Trece

Martires City recently for the first Hemophilia Awareness Symposium in the province.

With the noticeable low level of public awareness and even of some hospital personnel on hemophilia, the HAP-Cavite Chapter led by Ms. Lota N. Madamba tapped the provincial government through Provincial Health Officer Dr. Gilbert Ilog and Epidemiologist Dr. Nelson Soriano for the conduct of the one-day activity that encompassed talks about the bleeding disorder, its history and how it affects children and female patients. Guest Speaker Norielyn C. Narciso, Principal II of Kaytitinga National High School in Cavite Alfonso, congratulated the graduates and believed that they will also be successful citizens when they return to the mainstream of society. Vice-Governor Jolo Revilla who was the Guest of Honor likewise congratulated the graduates and stressed



that education is not limited to those outside prison but also to those behind bars. He gladly shared that his father, Senator Bong Revilla was also an Alternative Learning System graduate. Vice Governor led the awarding of 9 elementary and 6 high school honor students. Present during the ceremony were Mokja Church Pastors Park Seungil and Koo Bonshik, service providers from Korea, families and friends of the graduates, teachers, CPJ employees and staff and other inmates. — (PICAD)

raise social and political awareness for them to lobby their advocacy and seek legislative measures that will address the hemophilia medical condition.

Dr. Soriano who delivered a message on behalf of Dr. Ilog highlighted the importance of having a Hemophilia Treatment Directory and identification cards of PWH which can be presented to healthcare providers in availing medical and dental services. Likewise, Dr. Soriano underscored the value of the activity, believing in the principle that one must know the enemy in order to defeat it. Education is still the key with proper along information dissemination. He also thanked the attendees for their time and hoped that hemophilia be included in the Universal Health Care Bill.

Provincial Administrator for Community Affairs Dr. Alvin Mojica visited the activity on behalf of Governor Jonvic Remulla signifying support to the advocacy which gave more hope and strength to HAP-Cavite.

Participants showed much interest to the topics presented, thanking pediatric hematologist from the Korean-Philippines Friendship Hospital and a hemophilia advocate Dr. Melissa Montoya, for sharing significant inputs on pediatric bleeding disorder and a few tips on how to manage cases in children. Dr. Montoya also shared the vital application of the acronym RICE for patients with hemophilia, which stands for Rest, Ice Packs, Compress and Elevate; while hemophilia in female patients was tackled by Dr. Jayson Dadural, adult an hematologist of Emilio Aguinaldo Medical Center. He said that bruising and other symptoms of hemophilia must be taken seriously and should be consulted immediately to doctors.

In addition, Dr. Montoya told audience alreadv that she recommended to the Department of Health (DOH) for the allocation Factor 8 of (F8) concentrate to the Gen. Emilio Aguinaldo Memorial Hospital (GEAMH). Clotting factor concentrate prophylaxis aims to preserve joint function by converting s e v e r e hemophilia (factor VIII or IX less than 1%) into a clinically milder form of the disease. This news provided more hope to PWH given the fact that very few hospitals have the capacity to handle patients with bleeding

disorders. On the other hand, PWHs in Cavite gave testimonials on the challenges they face day by day, from pain levels, hospital bills, to transportation, down to stories of being refused by healthcare providers whenever being informed of their case. To assist them, Social Welfare Officer III Brendalyn Salazar of PSWDO discussed the simplified procedure and requirements on seeking financial/medical assistance, as well as on requesting for wheelchairs to the Office Provincial of the Governor. She also pledged that their office will lobby for PWH patients to be included in the special cases like chemotherapy and dialysis patients who are qualified to receive financial assistance from the provincial government on a regular term. The statement uplifted the spirits of hemophilia advocates, patients and their families, knowing that their needs are also being addressed by the government.

In closing, PHO's National Blood Program Ralph Coordinator Figueroa, Laurence acknowledged the organizers and participants who made the event possible, underlining the significance of equitable distribution of resources, giving priorities to indigents in the province, since majority of Filipinos with bleeding disorders live below poverty line as per study

Hemophilia is a genetically-inherited bleeding disorder in which the person's blood does not clot normally. People with hemophilia can experience spontaneous bleeds with no known cause, internal bleeding and painful swollen joints. Medical scientists have not found a cure yet for what is termed a Royal Disease. Symptoms of hemophilia may include nosebleeds, bruising, bleeding for no reason, blood in urine and stool, nonstop bleeding after a cut, tooth extraction or circumcision or a heavy prolonged

menstruation. Understanding hemophilia is a great first leap towards achieving the "Right to Live" campaign of HAP.

There are about 10, 000 Filipinos with hemophilia and about a million others with von Willebrand disease and other bleeding disorders in the Philippines, but only about 1,500 have been registered with the Philippine Hemophilia Foundation.

In Cavite, as of June 2019, according to HAP-Cavite Chapter there are 28 registered patients in their organization while others -PICAD

Mandatory reporting of health emergencies now a law

MANILA --President Rodrigo R. Duterte has signed a law on the mandatory reporting of epidemics and other health emergencies.

The "Mandatory Reporting of Notifiable Diseases and Health Evens of Public Health Concern Act" was signed into law on April 26 but a copy of the document was only released to reporters on Tuesday (July 16).

Under the law, "the DOH, though the Epidemiology Bureau, shall issue the official list of institutionalized public health information disease system, surveillance and response systems for mandatory reporting of notifiable diseases and health events of public concern."

The DOH and its local counterparts are mandated to implement the mandatory reporting of notifiable diseases and health events of public concern, the law read.

It should also establish and maintain functional disease surveillance and response systems.

All public and private physicians, allied medical personnel, professional societies, hospitals, clinics, health facilities, laboratories, institutions, among others are

required to accurately and immediately report these concerns.

The law also establishes a public health information system disease surveillance and response systems in private and public deemed facilities necessary to protect the health of the population.

The Health Secretary will have the authority to declare epidemics of national and/or international concerns unless it threatens natural security.

The Philippine President will, meanwhile, declare a state of public health emergency and mobilize governmental and nongovernmental agencies to respond to the threat.

Provincial, city or municipal health offices may only declare a disease outbreak within their respective localities.

It prohibits acts, including the unauthorized disclosure of confidential information, tampering of records or intentionally providing misinformation, non-operation of the disease surveillance and response systems, among others.

Violators will be imposed with a fine ranging from PHP20,000 to PHP50,000 or imprisonment of a month to six months. (PNA)
