## **DOLE prepares for OFW's** mandatory repatriation from Libya

MANILA — The Department of Labor and Employment (DOLE) is preparing for mandatory repatriation of overseas Filipino workers (OFWs) in Libya after the Department of Foreign Affairs (DFA) raised the alert level from 3 to 4 in the host country.

"The Alert Level was raised to (Alert Level) 4, so we will implement a mandatory repatriation," said DOLE Secretary Silvestre Bello III in an interview on Wednesday on the sidelines of the Trabaho, Negosyo, Kabuhayan (TNK)-Build Build-Jobs,

There are 2,600 documented OFWs in Libya, most of whom are health workers.

## MMDA reimplements 'heat stroke break' policy for field personnel

QUEZON CITY, (PIA)—The Metro Manila Development Authority (MMDA) is reimplementing a policy that allows additional 30minute daily "heat stroke break" to on-duty traffic enforcers and street sweepers in order to cope with the summer heat.

MMDA Chairman Danilo Lim has signed a memorandum to protect its field personnel from heat exhaustion, heat stroke and heat cramps

According to the MMDA chair, on-duty field personnel are allowed to leave their posts in shifts and take a break to allow their bodies to cool down.

"Heat stroke break shall be done alternately by those who are assigned in a particular

area to maintain visibility of traffic enforcers and street sweepers and to ensure that field operations are not hampered," said Lim.

Field personnel may also avail themselves of additional 15-minute break time in case the heat index in Metro Manila reaches 40 degrees Celsius and above.

## Death toll from Indonesia's floods, landslides climbs to 31

JAKARTA -- The death toll from floods and landslides in Indonesia's western Bengkulu province and the capital of Jakarta jumped to 31 on Monday, while the search for 13 missing people was underway, disaster agency officials said.

Floods and landslides have struck Bengkulu province since Friday, although the water have receded, but disaster agency official warned people to exercise caution as further torrential rains are expected.

In Indonesia's capital of Jakarta, the floods have started receding, it said.

The death toll in the province rose to 29 on Monday, Abdul Rohman, head of data and information of the provincial disaster management agency, told Xinhua.

More than 12,000 people are taking shelters as the floods and landslides destroyed 184 houses, seven educational facilities, and 40 others infrastructure facilities, including roads, bridges, water channels and facilities in the province, said Rohman.

Tents, rubber boats, fast foods, clean waters, baby foods, bailey bridges and reconnecting transportation are among the dire needs, he added.

The disaster has damaged transport infrastructure and cut off electricity which has hampered communication and distribution of aids to affected areas, said Sutopo Purwo Nugroho, spokesman of the national disaster management agency.

"It is difficult to reach affected-areas as all the roads to the impacted areas are totally cut off. Distribution of aids is hampered," Sutopo said.

"The people are urged to keep on alert as the rains with high intensity are expected to pour down in Indonesia," the spokesman added.

Yusuf Latief, head of communication for media of national search and rescue office, said that a search operation was conducted in the affected areas.

"The operation is prioritized in the impacted areas whose communities reported that there are people missing," he said.

"Rubber boats and other equipment are being deployed to support the mission." Yusuf said.

the Philippine Overseas E m p l o y m e n t Administration (POEA) said it is still waiting for the official recommendation from the DFA as to the repatriation of Filipinos workers.

POEA administrator Bernard Olalia noted that the procedures for the total deployment ban require the official communication from the DFA to DOLE.

"After that, we will have consultation. Upon proper advice from DFA they will recommend the total deployment, and then we will have a Governing Board meeting," he said in a separate interview.

The POEA head said as of this time, they have yet to receive an official recommendation from the DFA.

On Wednesday, the DFA has raised the alert level to 4 in Libya due to fighting around the capital. Last month, the DOLE also deployed a quick response team to Tunisia to assist in repatriating Filipino workers back home. (PNA)

## Palace leaves P710 pay hike petition to wage boards

MANILA -- It is up to the wage boards to decide whether they will act on petitions to increase the daily minimum wage of private sector workers in Metro Manila and other regions, Malacañang said on Tuesday.

Presidential Spokesperson Salvador Panelo made this remark after labor group Trade Union Congress of the Philippines (TUCP) sought for a PHP710 increase in daily minimum wage for workers amid increasing costs of goods and services and the tax reform program.

"Whatever petitions they will have to file have to go through the wage board," Panelo said in a Palace briefing, a day before Labor Day (May 1).

Asked if the Palace will support a salary hike, Panelo said the it will not interfere with the decision of the wage boards.

"Ang wage board ang magde-determine niyan eh, kung kailangan o kung hindi depende sa (The wage board will determine it, if it is necessary or if it will depend on) circumstances surrounding whatever petition they have in mind,"

Panelo said.

They know their jobs," he added.

Panelo, meanwhile, said workers are free to hold protests on Labor Day to seek higher wages, better jobs, and the passage of the Security of Tenure bill.

"It's their right to protest. You can even join them. You can even join them if you feel like joining," Panelo said.

Earlier, the Department of Labor and Employment (DOLE) said it was unlikely that it would announce a wage increase on Labor Day.

However, the board expressed openness to review the TUCP petition and see whether it could eventually grant a salary hike for minimum wage earners.

On Labor Day last year, Duterte signed an executive order (EO) banning illegal contracting or subcontracting, an act strengthened employees' security of tenure.

The President said although an EO could help "alleviate" employment problems, it is still the Congress that needs to do the work by amending the existing Labor Code. (PNA)

### DoT invites the public to visit Museo de Intramuros

MANILA, May 1 -As the Philippines celebrate National Heritage Month this May, the Department of Tourism (DOT) invites the public to explore and learn about Philippine culture and history by visiting Museo de Intramuros in Manila.

Managed by the Intramuros Aministration Museo (IA). Intramuros is located in important reconstructions inside the walled city: the San Ignacio Church and the Mission House of the Society of Jesus. The museum was designed to house the period art collections of IA that includes ecclesiastical art, furniture, vestments, and textiles and other artifacts.

Museo Intramuros' official opening, which took place on April 29, 2019, was among the highlights of the Intramuros Administration's 40th anniversary as an institution.

The current in-house

exhibition presents the story of the evangelization of the Philippines from the perspective of the Filipinos. It explores changes in the "Filipino" psyche as colonization introduced a new religion and culture to the natives.

With the display of religious images belonging to the IA collection, the exhibition is able to highlight Filipino artistry and craftsmanship that developed from the merging of the indigenous and the foreign.

Curated by Dr. Esperanza Gatbonton, Gino Gonzales, Dr. Cecilia dela Paz, Santiago Pilar and Martin Tinio, the exhibition has six components: (1) The Immaculate Conception, (2) The Religious Order, (3) The Patronato Real and the establishment of Parishes, (4) Religious Colonial Paintings, (5) The establishment of a parish and sacred vessels, and (6) The Indio Response.

In her 1981 book Philippine Relihious Imagey, co-curator Dr. Gatbonton wrote, "This

## **Sumitomo-MHI-TESP** takes over MRT-3 rehab

**MANILA** Sumitomo Corporation, its technical partner, Mitsubishi Heavy Industries (MHI), and MHI's fully-owned Philippine subsidiary, TES Philippines (TESP), formally took over on Wednesday the reins of the comprehensive rehabilitation maintenance of the Metro Rail Transit 3 (MRT-3).

This, after the MRT-3 Maintenance Transition Team (MTT) handed over the task to the private contractor in a ceremony on Tuesday at the MRT-3 Depot in Quezon City.

Starting Wednesday, Sumitomo-MHI-TESP handle rehabilitation and maintenance works for MRT-3 to restore the railway system back to its original design condition.

During the ceremony, the MTT formalized the transfer of documents to Sumitomo-MHI-TESP as the new rehabilitation and maintenance service provider for the railway line.

Department Transportation (DOTr) Secretary Arthur P. Tugade congratulated the official turnover to Sumitomo-MHI-TESP, noting that the strong partnership between the Philippines and Japan will result in much-improved operations and services for the passengers of

"As we celebrate today's milestone, let us remember that there is still a lot of work ahead of us. We aim to restore the MRT-3 – currently our main mass transit – to its high-grade design condition, in the hope that we can look to the future and improve on its

infrastructure," Tugade design condition. said.

The hand-over ceremony for the rehabilitation and maintenance works was 1ed by DOTr Undersecretary for Railways Timothy John Batan, together with Japan International Cooperation Agency Chief Representative Yoshio Wada, MRT-3 General Manager Rodolfo Garcia, MRT-3 Director for Operations and Maintenance Transition Team Head Michael Capati, Sumitomo Infrastructure Department Director and General Manager Masanori Honda, MHI Engineering Project Manager Koji Nishiyama, and TESP Chairman Kiyoshi Morita.

#### Japanese railway expertise

Under the MRT-3 Rehabilitation Project. Sumitomo-MHI-TESP will undertake the overhaul of all of MRT-3's 72 Light Rail Vehicles (LRVs), replace all mainline tracks. rehabilitate power and overhead catenary systems, upgrade signaling, communications and CCTV systems, and repair all of MRT-3's escalators and elevators, among other system repairs improvements.

As the original designer, builder, and maintenance provider of the MRT-3 for 12 years, Sumitomo-MHI-TESP brings with it an extensive track record in railway engineering, construction, and maintenance, and is best fit for the challenging task of restoring MRT-3 to its

As early as end-2018, Sumitomo-MHI-TESP has already conducted advance transition works for the rehabilitation project.

In February 2019, ahead of receiving any advance payment, it began procurement of tracks, train parts, and necessary components for the comprehensive rehabilitation and maintenance of MRT-3.

The project will last for 43 months, with rehabilitation works slated for completion within the first 26 months.

## SSS pension loan disbursements jumps by 54% due to policy enhancements

QUEZON CITY, May 1 -- In early March, SSS relaxed its guidelines for more than 1.2 million retiree pensioners so that those who are receiving their monthly pension even for just a month, is already qualified to avail of the SSS pension loan.? In the old rule, a retiree-pensioner must be receiving his monthly pension for at least six months to qualify for the pension loan.

Further, with the new guidelines for PLP other application, government-issued identification cards aside from the Social Security card (SS card) or Unified Multi-Purpose Identification (UMÎD) card may now be used as a form of identification.

The following are acceptable identification cards: Alien Certificate of Registration issued by Bureau of Immigration; Driver's License issued by Land Transportation Office; Firearm Registration, License to Own and Process Firearms, and Permit to Carry Firearms Outside of Residence from the Philippine National Police; National Bureau of Investigation (NBI) Clearance; Passport; Postal Identity Card, Seafarer's Identification Record Book (Seaman's Book); and Voter's ID Card.

In the absence of a primary ID card/ document, applicant shall present and submit any two valid ID cards bearing a signature and a photo of the applicant.

As of end-March, SSS pension loan releases reached P788.664 million to more than 32,872 retiree pensioners. Among the 166 branches receiving PLP applications, Bacolod branch approved the most number of PLP applications at 2,240 and released more than P47.16 million. Diliman branch, on the other, released the highest amount of pension loans amounting to P48.08 million to more than 1,861 pensioners for the said period.

The top three branches with the most number of approved PLP applications were Victorias branch in Bacolod; Cebu branch; and Bago branch.

PLP was launched in September last year in celebration of the 61st anniversary of the pension fund and was intended to be offered to retiree pensioners for a period of one year only. But now, PLP has become a permanent loan facility of SSS under Republic Act

11199 or the Social Security Act of 2019 which took effect last March 2019.

With only 10 percent interest per annum, PLP offers lower interest rate compared with highinterest loan offerings of some financial institutions.?

Meanwhile, Ignacio cautioned pensioners from dealing with fixers.? "Some of our branches received reports that pensioners were asked to pay as much as P2,500 as commission for the processing of their loan application with SSS. This has to stop. SSS does not charge processing fees for its pension loan application. Those who want to avail of the pension loan must personally apply in our branch offices nationwide. Avoid transacting with fixers who promise to hasten your loan application but would take a pay cut from your le proceeds," she said. loan

"In view of the stringent rules of the Data Privacy Law, we would like to stress that SSS employees or officials are precluded from extracting information of pensioners through any social media platform like Facebook and Twitter," Ignacio added. (SSS)
