# Affected families in Mindanao quake now 7,293

MANILA -- The number of families and affected by the magnitude 6.3 earthquake that struck parts of Mindanao last Oct. 16 has reached 7,293, the National Disaster Risk Reduction Management Council (NDRRMC) said in its update are being aided in three Wednesday.

This is equivalent to 35,465 persons.

The report, signed released NDRRMC executive director Ricardo Jalad. said these persons are residents of 127 barangays in Davao and Soccsksargen regions.

Of this number, 936 families or 4,604 persons evacuation centers while 407 families or around 2,035 individuals are being assisted outside of these centers.

The number of the dead and injured remains at seven and 215, respectively, the agency added.

The number of damaged infrastructure in Northern Mindanao, Davao Region and Soccsksargen was placed at 6,947. (PNA)

# Metro Manila malls agree to late opening during weekdays

MANILA—The Metropolitan Manila **Development Authority** (MMDA) on Tuesday agreed with Metro Manila malls reschedule their opening hours to ease the volume of traffic and lower the number of commuters during morning rush hours of the holiday season.

In a briefing, **MMDA** general manager Arturo Garcia said mall owners have agreed to delay their opening not earlier than a.m. during weekdays while closing hours will not be between 7 p.m. to 8

p.m. beginning on Nov. 11 this year to Jan. 10, 2020.

He added that weekend mall schedules remain at the discretion of their owners.

"Dati po kasi, 10 a.m. nagbubukas ang mall (In the past, malls open at 10 a.m.). We're talking about more or less mga (about) 100 malls 'yan eh (there) in Metro Manila," Garcia said.

Based on rough estimates of the MMDA and mall owners, each mall employs 2,000 to 3,000 employeestotaling to about 200,000 to 300,000 within Metro Manila alone.

"Yung 200,000 na 'yan (That 200,000), we're not talking about the clients pa (yet), the customers," Garcia said.

"Meaning yung 8 to 9 a.m. po mababawasan ng more or less 200,000 na tao. Ito po yung nagbu-bus, nage-LRT, MRT, nagji-jeep, motorsiklo, at yung iba may kotse (This means the 8 to 9 a.m. traffic will be lessened by more or less 200,000 people. These people are the ones using buses, the LRT, MRT, motorcycles, and cars)," Garcia added.

# LTFRB issues over 800 special permits to buses for 'Undas'

MANILA -- The Land Transportation Franchising and BoardRegulatory (LTFRB) on Wednesday announced the granting of 855 special permits to buses public supplement public transportation during the expected influx of passengers for "Undas" or All Saints' Day.

The issuance of special permits to these buses ended on the last day of September and will be valid from October 30 to November 3.

**LTFRB** Under Oplan Byaheng Ayos: Undas 2019, for these buses to qualify for the special permit, the make and models of these

vehicles must not be more than 10 years old, insurance papers must be updated, and operators must not have a pending summons or case filed with the LTFRB.



estimated capacity of 4,800 vehicles at 25 to 30 kilometers per hour (km/h)—a far cry from the current actual capacity of 7,000 vehicles which causes severe traffic slowdown.

"Kaya kung makakabawas tayo ng more or less 3,000 cars-yung oras ng 8 to 9 a.m., 9 to 10 a.m.--malaking tulong po yan sa flow ng traffic natin (That's why if we can reduce this by more or less 3,000 cars—in the hours of 8 a.m. to 10 a.m.—this will be a boon to the flow of traffic)," Garcia said.

Delivery schedules for malls remain between 11 p.m. to 5 a.m. with exceptions for perishable goods, he said.

Aside from the adjustment of mall schedules, mall owners have also agreed not to hold sales or reduced pricing during weekdays

within the said period.

Garcia added that a mall made an early announcement for a sale on Nov. 15 which will be given an exception.

To further help the MMDA in addressing vehicular congestion, SM Megamall and Trinoma have agreed to strict traffic enforcement in their areas of jurisdiction and loading bays which will include the refusal of entry to public utility vehicles (PUV) once loading bays are full to avoid these vehicles affecting Edsa traffic.

Other measures mall owners agreed to include helping the MMDA against "colorum" PUVs through the refusal of entry to their passenger loading areas and additional security staff in parking areas to expedite vehicular security measures. (PNA

# Dar sees 2.5% agri growth in 2020

MANILA -- The Department of Agriculture (DA) foresees farm production growth at 2.5 percent in 2020 with the full implementation of the Rice Competitiveness Enhancement Fund (RCEF), a component under Republic Act No. 11203, otherwise known as the Rice Tariffication

"(We will have) full rollout (of the RCEF) next year. (Growth target) should be between 2 to 3 percent-2.5 percent average," Agriculture Secretary William Dar said in a press briefing on Tuesday at the Agricultural Training Institute (ATI) in Quezon City.

Dar said the implementation of the RCEF will be a "big factor" in improving rice production in the country especially during the August 2019 to July 2020 harvest season.

He said the PHP10billion RCEF for this year has been fully allotted and undergoing obligation to relevant activities of the various components.

Out of the PHP10 billion, about 32 percent or PHP3.2 billion is now obligated for the distribution of inbred seeds, farm mechanization, and training of farmers in rice-producing provinces.

Dar said the DA has started distributing certified inbred rice seeds to eligible beneficiaries, which is expected to help farmers achieve five to six tons per hectare yield as compared to four tons per hectare they are producing now.

"We hope to elevate

the yield average (of farmers) to five to six metric tons (MT) (per hectare) so they can compete to our Asean neighbors like Vietnam and Thailand," he said.

Around 2.12 million bags of certified inbred seeds will be distributed in 57 rice-producing provinces covering 1.06 million hectares in 947 municipalities.

"This is the right time of the year (that) such intervention (to) start. We would like to believe that for the next six years, properly implemented RCEF will make the rice farmers more productive, competitive, and more prosperous," Dar added.

Also part of RCEF, aside from the distribution of certified inbred seeds, is the availability of farm machinery and postharvest facilities to farmers' cooperatives and associations (FCA).

Around 1,200 to 1,600 FCAs nationwide will benefit from the program which the Philippine Center for P o s t - h a r v e s t Development and M e c h a n i z a t i o n (PhilMech) aims to start distribution by December.

President Rodrigo Duterte enacted the Rice Tariffication Law in February this year removing quantitative restrictions on rice imports and setting a 40percent tariff for shipments from non-Asean countries if imports are below 350,000 MT; 180 percent if imports are from non-ASEAN countries and above

# NAIA ready for influx of passengers during 'Undas': MIAA

MANILA – Manila International Airport Authority (MIAA) general manager Ed Monreal on Tuesday said the Ninoy Aquino International Airport (NAIA) is ready to accommodate the expected influx of passengers during 'Undas' (All Saint's Day)

Monreal said "Oplan desks" will be set up in airport terminals to address queries and concerns of the passengers.

The desks at the four NAIA terminals will be manned by MIAA, the Civil Aeronautics Board, as well as police and medical teams.

Recently, Monreal met with the airlines' representatives to remind them of some guidelines to ensure the smooth operation of NAIA during the All Saint's Day period.

In a statement, Monreal asked the airlines to close their counters if they only have three or five remaining customers who have not yet checked in "so that others could opt to use that counter".

"Airlines were urged to occupy the counters earlier than their standard schedule of three hours prior to the flight departure time. The move will somehow ease the queuing time in the immigration counters," it added.

The airlines are also advised to have their passengers with bags to go through the check-in counters instead of kiosks, since they would need to physically appear at the counter.

Some local carriers offer bag drop kiosks as well as self-check-in kiosks.

During the meeting, Monreal agreed with airlines' representatives that they could implement a longer lead time for security check-in processes, especially for flights to Australia and America where there are additional security measures required.

The airport chief also reminded the airlines to ensure that their aircraft are in shape and good condition.

He also asked them to tell their handling agents to limit paging announcements to three per flight.

"Let us be considerate of passengers. Too many announcements and announcing with a loud and garbled voice are both irritating," Monreal said. (PNA)

# Leonard lifts Clippers past James' Lakers; Raptors win

Los Angeles— Kawhi Leonard and the Clippers won the opening round of Los Angeles's revitalised battle for basketball supremacy on Tuesday, defeating

LeBron James and the Lakers 112-102 in a pulsating season-opening clash at the Staples Center.

Leonard lifts Clippers past James' Lakers; Raptors win

Leonard, who arrived at the Clippers in the off-season after leading Toronto to the NBA title last season, wasted no time roaring back into action, leading the scoring with 30 points.

"It was great. A lot of emotions, game one," said Leonard, who grew up in Riverside, 50 miles east of Los Angeles.

"I am just happy we came out and got a victory. We had great practices and some carry over from that tonight."

The Clippers attacked the rim, forced easy turnovers, used a stingy defence to keep James and his new sidekick Anthony Davis in check.

Leonard also had six rebounds and five assists, reserve guard Lou Williams finished with 21 points and power forward Montrezl Harrell tallied 17 points and seven rebounds.

James shot seven-of-19 for 18 points and

Davis shot eight-of-21 for 25 points for the Lakers who are hoping their offseason changes will boost the team's fortunes after they finished a disappointing 37-45 and failed to qualify for the postseason for the sixth season in a row.

"It is the first game," said James. "It was a huge test. We have a lot of room to improve. We are a new group with a new system. We did some good things and we did some not so good things.

The one bright spot for the Lakers was newcomer Danny Green who scored 28 points by hitting 10 of his 14 fieldgoal attempts, including seven of nine from beyond the arc.

Davis said he and James will need time to get used to each other on the court. "We are both aggressive so sometimes we miss each other," Davis said. "We are still learning and just trying to figure it out. This is game one of many."


Thanks to the addition of Leonard from Toronto and Paul George from Oklahoma City, the Clippers are one of the early front runners to contend for a title.

34 points and added 18 rebounds before fouling out of the NBA's season-opening contest at Scotiabank Arena which featured the

Raptors' championship banner and ring ceremony.

Both teams were missing some big names as the Raptors began life without Kawhi Leonard and the Pelicans lost Anthony Davis in a trade and were missing injured first pick Zion Williamson.

"We had to reach into our bag of tricks," said Raptors coach Nick Nurse.

The game was one of two opening night contests with the Los Angeles Lakers taking the court later against the Leonard's new team Los Angeles Clippers.

Prior to the tipoff against the Pelicans, the Raptors presented their players and coaches with their rings and unveiled the 2019 championship banner in the rafters of the arena.

The massive ring features over 80 diamonds including 74 in and around the Toronto skyline logo which represents the club's 74 wins last season.

The Pelicans decided to remain on the floor during the pre-game festivities instead of loosening up in their locker room.

"It was great to see the ceremony," said Pelicans coach Alvin Gentry. "That is what we aspire to be."

Kyle Lowry chipped in 22 points and Serge Ibaka added 13 for Toronto, whose championship pedigree shone through by outscoring the Pelicans 13-5 in overtime. The teams were tied 117-all at the end of regulation.

Nurse blamed their slow start against the Pelicans on the ceremony.

"I thought energy was an issue," Nurse said.

"The emotions of the night took its toll.

"I was super happy it was tied at the half. There was noticeable lack of energy just in locker room.

"You just got to take them (wins) in this league when you get them."

Brandon Ingram finished with 22 points to lead the Pelicans.

This marks the end of the Leonard period in Toronto as he left as a free agent to join the Clippers.

That means leadership by committee with the load being distributed amongst Lowry, VanVleet and Siakam, who signed a four-year, \$130-million contract extension Monday.

The Raptors are also without another key player from their championship team in Danny Green, who departed as a free agent for the Lakers.
