MMDA identifies affected areas for 30th SEA Games

MANILA - The Metropolitan Manila Development Authority (MMDA) Wednesday cautioned motorists of heavy traffic in routes affected by the opening ceremony of the 30th Southeast Asian Games (SEA Games) on November 30 and a dry run on Thursday.

In a message sent to reporters, MMDA Spokesperson, Assistant Secretary Celine Pialago said the dry run or traffic simulation aims to practice the movement of SEA Games athletes, visitors, and other

Manila and would occur from 1 p.m. to 4 p.m.

MMDA special operations officer Manny Miro said a bus from Tagaytay would depart towards Manila at 1 p.m., while buses from Metro Manila hotels would depart at 2:15 p.m. to 3:15 p.m. at the latest.

"Buses from Metro Manila, earliest departure from hotel is 2:15 p.m. The latest is 3:15 p.m.—depends on the hotel locations," Miro said.

DSWD polishes guidelines for 4Ps rice allocation

MANILA -- The Department of Social Welfare and Development (DSWD) has been working closely with the Department of Agriculture (DA) and the National Food Authority (NFA) to distribute rice to beneficiaries of the Pantawid Pamilyang Pilipino Program (4Ps) beneficiaries instead of cash for the rice subsidy component of the program, an official said Wednesday.

"We have been conducting a lot of meetings with the NFA and DA to polish the strategy," said DSWD **Undersecretary Camilo** Gudmalin, chair of the Technical Working Group on Rice Subsidy.

He said the distribution of actual rice to 4Ps beneficiaries is one way to help farmers cope with the present drop in rice prices.

The House Committee on Agriculture and Food has approved the House joint resolution on October 25 while the Senate has approved on third and final reading its own version of the measure on November 4.

The House and Senate joint resolutions will be deliberated on during a bicameral session to come up with the final version which will subsequently transmitted to President Rodrigo Duterte for signing.

spokesperson Irene Dumlao said once it is approved, DSWD will be given the authority to transfer the remaining

2019 rice subsidy funds to NFA, which, in turn, will use the funds to buy rice from farmers.

"NFA shall be the only agency authorized to distribute rice to the 4Ps beneficiaries," she added.

In a meeting on October 4, the three agencies discussed strategies on how to distribute the actual rice subsidy to beneficiaries.

In the proposed agreements, beneficiaries will pick-up their rice subsidy from the existing warehouses of NFA.

For those who live far from the warehouses, DSWD and NFA will designate distribution outlets where the beneficiaries could claim their subsidy.

The department, she said, will also tap associations under the Sustainable Livelihood Program (SLP) as designated distribution outlets, especially in areas where there are no **NFA** outlets warehouses.

Dumlao said the DSWD and NFA will ensure that beneficiaries will not incur additional expenses in claiming their rice subsidy.

The DSWD said upon approval of the joint resolution, department, together with NFA, will pilot the distribution of rice subsidy in kind in the Ilocos region, Cagayan Valley, Central Luzon, MIMAROPA, Western Visayas, and Zamboanga until December 2019.

DA urges youth to take up farming

MANILA -- The Department of Agriculture (DA) on Wednesday urged the country's young workforce to pursue farming as a business, as it cited the need to interest the youth on agriculture.

"Young people are attracted to jobs that pay high but without a promise of career growth or skills development. And they often trade this over agriculture or farming that require patience, perseverance. So, there are cases that no one in the family will develop the farm because it is not appealing," DA Undersecretary Natividad Caballero said in a media interview during the Knowledge Learning Marker & Policy Engagement Summit 2019.

Caballero said one of the platforms where the youth could engage in farming is through DA's Digital Farmers program, where old farmers are introduced to market their products online via social media with the help of their millennial kin.

"The average age of farmers is 57, we need to bridge that gap through engaging the younger members of the family to be interested in agriculture. Farming is not just a job for one person in the family, everyone needs to help, especially the youth," Caballero said.

In the forum, farmers and agriculture experts from around the country shared some of their best practices in the field.

Virginia Agcopra, project coordinator of Dynamic Conservation and Sustainable Use of Agrobiodiversity in T r a d i t i o n a l Agroecosystems of the Philippines, said that in Ifugao, Mountain Province, the famed Banaue Rice Terraces has been deteriorating because of e n v i r o n m e n t a l degradation and unregulated development brought about by urbanization.

"One of the reasons for this is that the local residents, those who are supposed to utilize, maintain, and protect this heritage site, are veering away from farming due to changing values and to pursue more lucrative sources of income," she said.

Agcopra added that the youth, in particular, are migrating out of the province to seek other well-paying jobs or businesses, while many of those who remain choose to engage in nonagriculture-related professions.

The Dynamic Conservation and Sustainable Use of Agrobiodiversity in Traditional Agroecosystems of the Philippines project aims to address the challenges being faced by the UNESCO recognized landmark implementing interventions to regain Ifugao youths' interest in agriculture, enhance farming skills, and enrich their knowledge on the value and importance of agrobiodiversity and its indelible ties to their

unique culture'.

One of the key initiatives of the project, said, is its collaboration with the Indigenous Peoples Education Center (IPED) of the Department of Education (DepEd) to develop learning guides and modules for Grades 5 and 8 students, most of whom belong to the Tuwali tribe.

These learning guides and modules integrate both agrobiodiversity and Indigenous Knowledge Systems and Practices (IKSPs).

"The goal of this initiative is to stimulate children's interest in farming and to enhance their knowledge and appreciation of their rich cultural values and traditions, which are slowly disappearing because of modernization, just like the rice terraces," she said.

The Asian Development Bank-enhanced lesson plans and workbooks are intended to create awareness among the students on the importance of fruit trees and the products derived from them and traditional taming equipment and their uses, among others.

The learning modules, she said, were designed to be easily understood by the target students and to encourage active discussions. (PNA)
