DOH extends polio campaign until April

MANILA, -- The Department of Health (DOH) today announced additional rounds of Sabayang Patak Kontra Polio (SPKP) in all regions of Mindanao and the National Capital Region, extending the campaign until April 2020.

For NCR, two (2) additional rounds are scheduled on January 27 to February 7 and March 9 to March 20, 2020. For Mindanao, a limited response round will be conducted in Basilan, Sulu, Tawi-Tawi, Zamboanga City, Isabela City, and Lambayong,

Sultan Kudarat on January 6 to 12, 2020; and additional two (2) rounds for all regions in Mindanao are scheduled on February 17 to March 1 and March 23 to April 4, 2020.

PRRD signs P4.1 trillion 2020 national budget

MANILA, -- President Rodrigo Roa Duterte on Monday signed the 2020 General Appropriations Act (GAA) geared towards sustaining critical infrastructure, human capital development and socio-economic growth

in the country.

In a speech during the signing ceremony in Malacañang, President Duterte said the passage of the P4.1 trillion GAA is proof that with the help of the House of Representatives and the Senate, the government

can effectively work towards the enactment of key legislative measures that will support the country's development agenda in the next two and a half years.

He called on Congress, civil society partners, and civil

servants in the executive branch to remain driven towards the collective goal of providing a more comfortable life for the people.

"Together, let us ensure that every peso in this budget will never be used to support the

selfish greed of the few, but spent exclusively for the benefit and service of Filipino taxpayers," he said.

Representing almost 20 percent of the country's projected GDP for 2020, this year's P4.1 trillion budget will support the administration's vision of a more peaceful and progressive Philippines—an upper middle-income country that has already cut poverty rate to just

14 percent and achieved a 7.5 percent GDP growth by 2022, according to the President.

The 2020 GAA, like in previous years, will continue to allocate a huge portion of the national budget for government projects such as infrastructure, development and social services, which will greatly benefit the lives of Filipinos.

DA eyes higher palay harvest in 2020

QUEZON CITY, -- The Department of Agriculture (DA) targets to produce more palay (unhusked rice) and import less rice this year, as farmers begin to reap the initial benefits of the government's Rice Competitiveness Enhancement Fund (RCEF) program.

"We aim to harvest 19.6 million metric tons (MMT) of palay, net of damage due to adverse weather conditions," said Agriculture Secretary William Dar, during his first media briefing, on January 3, 2020, at the DA main office in Quezon City.

"Our 2020 palay yield forecast would be

three percent more than the estimated 2019 palay output of 19 MMT," added the recently-confirmed DA chief.

"We expect that initial benefits of interventions under the P10-billion RCEF program, particularly on inbred rice seeds given free to farmers, will be realized during the dry and main season crops starting this year," Secretary Dar added.

Inbred certified palay seeds produce an average of 4.54 MT/ha as compared to farmer home-saved seeds' yield of 3.50 MT/ha and traditional seeds' yield of 2.13 MT/ha, according to the DA-Philippine

Rice Research Institute (DA-PhilRice).

"Hence, with RCEF seed intervention, we would generate an incremental yield of at least one MMT, as we will provide farmers nationwide, tilling a total of one million hectares, free certified palay seeds," said Secretary Dar.

The DA-PhilRice started distributing certified palay seeds in October 2019 for the dry-season planting in 947 rice-producing towns and cities in 57 provinces.

Under RCEF, P3 billion is set aside each year for certified seeds up to 2024, where farmers

will receive 40 kilograms (kg) per hectare of certified rice seed

GSIS-PRRD extended until Sept 30

PASAY CITY, -- State pension fund Government Service Insurance System (GSIS) has extended the deadline for application to the GSIS Program for Restructuring and Repayment of Debts (GSIS-PRRD) until September 30, 2020.

GSIS-PRRD is the one-time condonation and restructuring program for members who are already out of government service to settle their outstanding loan balances in full or in part.

"GSIS is intensifying its efforts to recover and collect outstanding and non-moving loan accounts through the program. It likewise addresses the clamor of separated GSIS members and pensioners for a little more time to restructure their loans and pay the remaining balance through instalment," GSIS Chairman and Acting President and General Manager Rolando Ledesma Macasaet said.

GSIS-PRRD avalees may settle their

balance until December 31, 2020.

"We urge inactive GSIS members to apply for PRRD so they can pay their remaining balance free of penalties on an instalment basis at 10% interest per annum only," the pension fund chief said.

GSIS-PRRD covers various service loans, which include Salary Loan, Restructured Salary Loan, Enhanced Salary Loan, Emergency Loan Assistance, Summer One-Month Salary Loan, Member's Cash Advance/eCard Cash Advance, Conso-Loan, Emergency Loan, Home Emergency Loan Program (HELP); Study Now, Pay Later and Fly PAL, Pay Later loans (did not avail of the condonation program in 2014); Education Assistance Loan (did not avail of EAL II), Stock Purchase Loan (did not avail of the condonation program in 2013); Policy Loan; and GSIS Financial Assistance Loan (for DepEd Personnel). BI ready to enforce possible changes in OFW deployment ban

MANILA -- The Bureau of Immigration (BI) on Tuesday said it is ready to implement any changes in foreign policy or overseas Filipino worker (OFW) deployment, should the Department of Foreign Affairs (DFA) or Department of Labor and Employment (DOLE) impose any new ban on deployment to Iraq, Iran, and Libya.

"The government's primary concern is the welfare of our kababayans, hence the BI is ready to implement any directive regarding our foreign policy or OFW deployment should the concerned agencies see a need to

implement any change," said BI Commissioner Jaime Morente in a statement.

This came amid brewing tension between the United States and Iran, following the death of Qassem Soleimani, the head of Iran's elite Quds military force.

Meanwhile, the BI announced that it has started implementing the government ban on the deployment of newly hired household service workers (HSW) to Kuwait.

BI port operations division's chief Grifton Medina said immigration officers in the different international ports have

The government will spend 36 percent of the budget to fund programs on education, healthcare, housing and social welfare.

And to further boost the thriving economy, the Duterte administration will invest 29 percent of the 2020 budget in infrastructure, tourism, trade, job generation, and agriculture.

With the extension of the campaign, the

Department aims to achieve at least 95% coverage in ALL identified areas for EVERY SPKP round to ensure that there will be NO CHILD MISSED.

"We need to provide evidence that the transmission of poliovirus is already contained before we can end the Sabayang Patak Kontra Polio campaign. Therefore, the fight against polio is far from over. For us to effectively and successfully stop the transmission of this disease, we need to sustain our synchronized efforts. We must continue to ensure that no child is left unvaccinated," the Health Secretary concluded. (DOH)

Plastics to worsen waste, health problems

ANKARA -- If the current trend continues and 1 billion tons of plastic are produced annually by 2050, very serious health and waste problem may occur globally, according to an expert on plastic waste.

"We could see more plastic in the sea than fish. Land could be filled with abandoned mountains of plastic garbage," Sedat Gundogdu, an expert on sea waste and microplastics at Turkey's Cukurova University, told Anadolu Agency.

Noting that plastics are divided into macroplastics, microplastics, and nanoplastics, he said nanoplastics, in particular, are extremely difficult to identify and can affect people through contamination of the food chain.

"Macroplastics are also the main source of micro- and nanoplastics. While [entanglement by] macroplastics could lead to amputation among many forms of wildlife, and marine species, for example, can suffocate and die from plastic ingestion, micro- and nanoplastics are threats to all living creatures, including the smallest species," he added.

Classifying plastics by their chemical structure, Gundogdu said polystyrene rigid, polyvinyl chloride (PVC), polyethylene and polyethylene terephthalate (PET) are

serious threats after becoming waste, which is the main reason many countries want to send plastic waste to other countries.

"Despite the fact that plastic makes human life easier, its dangerous properties are ignored. There is no other material that has entered almost the entire sphere of our lives and carries so much risk," he said, adding plastic is a toxic chemical cocktail.

Touching on the dangers of plastics to animal species, Gundogdu said many turtles can suffer serious injuries that lead to amputation of limbs because they become entangled in plastic waste while some can suffocate and die from plastic ingestion.

"For example, 300 endangered sea turtles were found dead off the coast of Mexico [in 2018] because they were caught in an abandoned [plastic] fishing net. Similarly, many large whale species are dying due to plastics in seas," he added.

He went on to say that the fact that plastic contains many other chemicals and pollutants makes it a "Trojan horse."

"In other words, while plastics make human life easier, they can also darken the lives of many living things."

relationship between plastics and climate change, Gundogdu highlighted that from production to recycling, plastic contributes to the climate crisis as it is made from oil, which is one of the main sources of greenhouse gasses.

"The amount of greenhouse gas emitted from plastic production and burning was estimated at over 850 million tons in 2019, equivalent to the emissions from around 189 coal-fired power plants," he said.

He added that the estimated amount of greenhouse gas emissions from plastics will increase to 2.8 billion tons by 2050.

"Plastic pollution may

be having a less direct but ultimately greater role in climate change through its impact on the species that form the foundation of oceanic food chains and provide the biological carbon pump that sequesters carbon in the deep oceans," said a report released last May by the Center for International Environmental Law.

Reiterating the dangers of plastics to public health, the environment and the climate, Gundogdu said the "easy, fast lifestyle" should be given up.

"Apart from the necessary areas, we should stop using plastic intensively and we should turn to product designs suitable for re-use and

need to implement the deposit-refund system and the prohibition of single-use plastics.

"Plastic is everywhere, and I think the question should now be 'Where isn't there plastic?' We are only at the beginning of our understanding of the problems associated with this issue," Rebecca Prince-Ruiz, founder and executive director of the Plastic Free Foundation, told Anadolu Agency.

Mentioning the plastic threat in the seas, Ruiz said 8 million tons of plastic enter oceans each year, more than 270 marine species are affected by marine debris, and it is estimated that 99 percent of seabirds will have

ingested plastic in the next 30 years.

"As a material, plastic has its advantages...Plastics have enabled us to transport food and other goods across the other side of the world and have led to situations whereby people in Europe drink water in plastic bottles that has come from Fiji," she said.

Despite the advantages to daily life, however, she thinks that people should be aiming for a world without plastic waste.

"We need to significantly reduce our use of single-use plastics, and where it is used there have to be systems in place to collect and reuse

Touching on the Plastic Free July campaign, which she founded, she said an estimated 230 million people globally took part in the "challenge" last year and chose to refuse at least one single-use plastic.

Plastic Free July, led by the independent non-profit Plastic Free

Foundation and celebrated annually by communities around the world, is a campaign for a world without plastic waste.

"This record shows that many people worldwide are concerned and want to take action - and lots of small steps add up to make an impact," she added.
