Cavite Provincial Government releases financial assistance to ASF-affected hog raisers

Following the African Swine Fever (ASF) epidemic that hit the province of Cavite late last year, the provincial government has distributed more than eleven million pesos worth of financial assistance to the 530 hog raisers affected. The first batch was released on February 11, 2020 for the 106 beneficiaries in the City of Bacoor in the distribution witnessed by City Mayor Lani Mercado-Revilla, Mr. Richard Quion, City Disaster Risk Reduction and Management Officer and Dr. Ella Mae Gandia of the City Veterinary Services Office.

was hit by the African Swine Fever (ASF) late last year affecting its small hog industries. The PDRRMO and the Provincial Veterinary Office (PVO) conducted Pre-Disaster Risk Assessment and confirmed cases of ASF in the cities of Baccor,

Dasmariñas, Imus and Gen. Trias. To prevent the further spread of the virus, additional Quarantine Checkpoints were stationed in entry and exit points in the province along with other epidemic interventions in the affected swine farms.

Governor Jonvic Remullasought the aid of the legislative body for the passage of Sangguniang Panlalawigan Resolution No. 1352-2019 declaring the province under State of Calamity on November 13, 2019 and authorizing the release of quick response fund to address the ASF and mitigate its impact.

Hogs affected by the virus and those within the one-kilometer radius were culled and buried as a standard protocol enforced by the Department of Agriculture. The financial assistance from the provincial government was intended help small hog raisers recover from the losses brought by the

ASF and is separate from the assistance from the national and local government. The amount of financial assistance which will be given to hog raisers is computed based on the number of pigs affected, each equivalent to Php 2,000.00. The PVO issued a certification which determines how much each beneficiary is entitled to receive.

Leading the distribution of financial assistance were the Provincial Social Welfare and Development Office and Provincial Treasurer's Office in coordination with the local veterinary offices, DRRMs and city social welfare offices.

The second wave of financial assistance distribution was done on February 12, 2020 in the Cities of Imuswith 32 beneficiaries, Dasmarifaswith 273 affected hog raisers and Gen. Trias with 114 recipients.



Hong Kong donates P14.7-M worth of aid to 'Ursula' victims

Typhoon Phanfone, known in the Philippines as Typhoon Ursula, wreaked havoc in the Philippines in December, affecting over 1.7 million villagers in six regions.

A total of 372 schoolhouses, nearly 305 houses, 31 health facilities, and 98 government offices were damaged by heavy rain and fierce winds. (Xinhua)

Filipinos staying in China that the government is prepared to repatriate them anytime they wanted to return home.

"To our kababayans who remain in lockdown areas in China, I assure you that the government is ready to bring you home if you want. Hindi naman kayo papabayaan (We won't leave you behind)," Duterte said.

As for the first batch of Filipino repatriates who are currently staying in the quarantine facility inside the Athletes' Village at the New Clark City in Capas, Tarlac, Duterte assured them that government is taking care of them.

Earlier, Malacañang said the government will shoulder the costs of tests, medicines, confinement, and all hospital-related expenses for those undergoing quarantine in government hospitals and facilities.

Government has also banned the entry of all foreign nationals from mainland China and its administrative regions Hong Kong and Macao as well as Taiwan. However, Filipinos and foreigners with permanent resident visas are allowed in the Philippines but will have to undergo quarantine.

D u t e r t e acknowledged that it is "normal" to feel anxious, concerned, and afraid of the possibility of a local outbreak but reminded them to observe safety precautions to minimize the chances of being infected.



Sen. Go pushes for quarantine facilities in DOHrun hospitals; aids fire victims in Caloocan

preempt possible spread of the 2019 Novel Coronavirus Acute Respiratory Disease (2019-nCoV ARD) and as preparation for similar situations that may occur in the future, Senator Christopher Lawrence "Bong" Go said on Tuesday, February 11, that he will push for the establishment quarantine facilities in all 73 hospitals all over the country that are retained by the Department of Health (DOH).

"I'm planning to file a bill na maglalagay tayo ng separate quarantine facilities sa lahat ng mga DOH-run hospitals or kung kakailanganin po ay hiwalay na lote or structure doon sa may ospital," Go told reporters in an interview in Caloocan City, where he distributed financial and relief assistance to victims of a fire.

"Paghahanda ito hindi lang sa posibleng pagkalat ng nCoV. Kung saka-sakaling meron pang dumating ay handa na po tayo at hindi na po tayo magtuturuan sa ibang lugar na ayaw naman nilang tanggapin, at para magkaroon na rin po ng peace of mind ang bawat isang mamamayan natin sa kanya-kanyang lugar," Go added. referring to the difficulty of the government in finding quarantine facilities for the Filipinos from Hubei province in China who decided to return home.

Go, the chairperson of the Senate Committee on Health, said that he will seek the help of President Rodrigo Duterte to ensure the

The Filipinos from Hubei are currently staying at the Athletes' Village in New Clark City in Capas, Tarlac for a fourteen-day quarantine, "Ngayon nagagamit pa ang Athletes' Village. Para po 'yun sa mga atleta. Ginagamit natin sa quarantine purposes sa ngayon. Kung meron na tayong separate quarantine area at facilities, ang mga ito ay primarily for that purpose only," Go said.

The Senator said he will file the bill as soon as possible and will urge his colleagues in Senate and the concerned agencies to support the measure.

'I will request that the measure be certified as urgent. Huwag na natin antayin pang magkandarapa tayo na maghanap na naman ng pasilidad. What if it will spread in Mindanao? Meron po tayo dapat na handang pasilidad na nandidiyan po ang mga doctor dahil malapit lang po sa mga DOHrun hospitals," he also

In the meantime. the Senator calls for immediate identification of quarantine facilities in DOH-run provincial hospitals. "Kailangan na nating magkaroon



identified quarantine facilities in each region or maybe in each province, especially po 'yung mga sentro dahil unang-una, hindi naman natin malalaman kung sino po 'yung matatamaan," he said, adding that the government should always be proactive in dealing with these kinds of crisis situations.

"Kung kakailanganin, magrenta tayo for the meantime kung sakaling dumami talaga (ang Persons Under Investigation)," he added.

Meanwhile. extended assistance to Caloocan City residents who lost their homes on February 6 in a fire that started at No. 151 on 9th Avenue, Barangay 63, eventually spreading to Barangay 59 and affecting 75 families in both barangays.

Aside from giving the victims financial and relief assistance, Go offered to provide for the fare of those who want to relocate to the provinces and for the uniforms and school supplies of the affected children

He also offered to assist in the medical needs of the residents, even those who are not affected by the "Sa fire. mga nangangailangang magpaopera, magpa-dialysis o may cancer, ako na hong magpapagamot sa invo. Yung mga bill ninyo sa ospital; tutulong po kami," Go said.

He explained that patients can now easily ask for help at the Malasakit Center, a onestop shop for medical and financial assistance from the Philippine Health Insurance Corporation (PhilHealth), Department of Health (DOH), Department of Social Welfare Development (DSWD) and Philippine Charity Sweepstakes Office

(PCSO). He also mentioned that Malasakit Centers had been opened at the Philippine General Hospital in Manila, Philippine Heart Center in Quezon City, and in the cities of Valenzuela and Novaliches.

So far, 62 Malasakit Centers have been opened in different parts of the country, and the Malasakit Center Act of 2019, which was based on the bill that Go filed in the Senate, mandates the establishment of a Malasakit Center in each of the DOH-run hospitals in the country. Local government-run hospitals may also have their own Malasakit Centers provided they meet the minimum standards and set criteria.

Number of PUIs for nCoV rises to 261: DOH

MANILA -- The Department of Health (DOH) on Monday reported that the number of persons under investigation (PUIs) for possible novel coronavirus (2019-nCoV) infection has gone up to 261.

"We are seeing a

rapid increase in the transmission rate of the virus globally. In response, DOH has strengthened its capacity in preparation for the possibility of local transmission. All DOH hospitals are equipped to cater to the influx of patients and are following strict infection control protocols to contain the virus" Health Undersecretary Eric Domingo said in a press

office.

Domingo said the PUIs are admitted in various health facilities. About 48 of them have been discharged under strict monitoring.

Meanwhile, 109 PUIs have tested negative and 3 tested positive for the 2019-nCoV. There are 202 cases pending test results from the Research Institute for Tropical Medicine (RITM).

Domingo said the DOH Epidemiology Bureau and the Philippine National Police-Criminal Investigation and Detection Group have identified 441 contacts of the first and second case of 2019-nCoV on Sunday, February 9.

"Regarding the third confirmed case, a total of 224, that's 56 percent, out of 403 contacts were traced, including copassengers and individual contacts from hotels and hospitals. Currently, 147 or 66 percent contacts have been interviewed and were placed on home quarantine, eight symptomatic contacts

have been categorized as PUIs and are admitted for isolation and monitoring," he said.

DOH, DFA bring home Filipinos from Wuhan, China

Domingo also reported that the Inter-Agency Task Force on Emerging Infectious Diseases led by the DOH and the Department of Foreign Affairs (DFA) on Sunday repatriated a total of 32 Filipinos, including two DFA advance party personnel, from Wuhan City.

The 14 females and 18 males landed at the Clark Airbase in Pampanga and were transferred to the Athletes' Village in New Clark City, Capas, Tarlac for the 14-day quarantine procedure together with eight members of the Philippine repatriation team, six plane crew members, and three ground crew operators.

Domingo said they did not manifest fever or any respiratory symptoms all throughout the journey back to the country.

"The repatriates are considered as Persons Under Monitoring (PUM) and are currently being observed and isolated. Our on-site medical staff from Jose B. Lingad Memorial Regional Hospital will be working 24/7 to conduct daily monitoring of the vital signs and status of the PUMs, and provide appropriate health services to those who are quarantined," he added.

To check any significant changes in their health status, Domingo said their daily monitoring is scheduled every 9:00 a.m. and 4:00 p.m.

The DOH has also declared code blue in all government hospitals, health offices, and other health facilities in the region for swift medical response.

"Those who will develop symptoms, such as fever, cough and colds, and other respiratory symptoms, will be immediately brought to a designated hospital for isolation and proper clinical management. We will be closely monitoring them to ensure their safety, as well as the people within their vicinity," the Health Chief assured the public," Domingo said. (PNA/By Ma. Teresa Montemayor)

Death toll in China's coronavirus outbreak rises to 909

EIJING -- The death toll in China from the novel coronavirus outbreak has risen to 909, the country's National Health Commission (NHC) said Sunday.

Authorities said 40,171 confirmed cases have been reported, while in the last 24 hours, 97 people have died and more than 3,281 new cases have been detected.

The number of people under medical observation has risen to 187,518 while the number of those thought to be infected stands at 23,589.

The number of those detected with the virus outside China's mainland has reached 36 in Hong Kong and 10 in Macau.

3,281 patients recovered

A total of 3,281 patients infected with the nCoV had been discharged from hospital after recovery by the end of Sunday, the NHC announced Monday.

Sunday saw 632 people walk out of the hospital after recovery, including 356 in Hubei Province, it added.

The virus is said to have been transmitted to humans from animals, particularly bats.

The virus has spread to more than 20 other countries, including the US, the UK, Singapore, France, Russia, Spain, and India.

Many countries have evacuated their citizens from the city of Wuhan-the epicenter of the virus -- and other affected areas of China, placing them in isolated medical care.

The World Health Organization (WHO) has declared the outbreak an international emergency. No new country reported nCoV cases

On Sunday, WHO
reported that about 307
confirmed cases and one
death were recorded in

other countries while no new country reported nCoV cases in the past 24 hours.

The WHO also reported that all crew and passengers of the Cruise Ship Diamond Princess, currently harbored in Yokohama, Japan, are being quarantined for a 14-day period on board the vessel.

"All crew and passengers are closely followed-up and are medically examined and tested for 2019-nCoV when displaying any signs or symptoms suggestive of 2019-nCoV disease. The quarantine period will come to an end on 19 February as epidemiological and environmental investigations are ongoing," the WHO said.

As of Feb. 8, the Japanese health authorities reported that 64 individuals -- passengers and crew members -- were found to have been infected with the 2019-nCoV.

"All individuals testing positive were disembarked and admitted for medical care in infectious disease hospitals in the Yokohama area. Close contacts of the infected passengers are asked to remain in quarantine for 14 days from last contact with a confirmed case." It has

WHO said.

It added that the quarantine period would extend beyond February 19 for close contacts of the newly confirmed cases.

Earlier, the WHO started working closely with International Air Transport Association and jointly developed a guidance document to provide advice to cabin crew and airport workers.

The WHO developed protocol for the investigation of early cases which aims to gain an early understanding of key clinical, epidemiological and virological characteristics of the first cases of 2019nCoV infection detected in any individual country, and to inform the development and updating of public health guidance to manage cases and reduce potential spread and impact of infection.

It also advised the practice of frequent hand washing, avoid unprotected contact with farm and wild animals, practice proper cough etiquette, and avoid close contact with people suffering from acute respiratory infections to reduce the risk of transmission of the virus.
