# DOLE, attached agencies to go on 4-day work week

MANILA - The office in Intramuros, Department of Labor and Manila as well as its Employment (DOLE) and its attached agencies will implement a four-day work week as a precaution against the coronavirus disease 2019 (Covid-19) threat.

In Administrative Order (AO) No. 99. series of 2020, dated March 11 released on Thursday, Labor Secretary Silvestre Bello III said the new work schedule covers all employees at the central

regional offices, bureaus and field offices.

Under the AO, the work schedule for all DOLE employees, as well as its attached agencies, will only be from Monday to Thursday starting on March 16

"All offices/agencies shall observe a four-day workweek which shall be from Monday to Thursday instead of working for five days a week and work schedule

from 7 a.m. to 7 p.m.," the order said.

Also covered by the AO are the Philippine Overseas Welfare Administration (POEA), the Overseas Workers Welfare Administration (OWWA), Professional Regulation Commission (PRC), and the National Relations Labor Commission (NLRC).

Included in the order are the following guidelines:

-Friday shall be the day-off of all employees;

-Employees must p.m. and 7 p.m.; render not less than 10 hours of work a day, exclusive of meal

-They may report for work anytime from 7 a.m. to 8 a.m. and end work anytime between 6

-Off-setting tardiness or undertime shall not be allowed:

-The official lunch break shall be maintained at 12 noon to 1 p.m. regardless of the time the employee reports for work.

It added that oneday absence shall be considered as a 10-hour absence and shall be deducted proportionately from the employee's leave credits and employees who are required to report for

### Coronavirus shuts down NBA games

Los Angeles, United States—Sport across the United States and Canada was gripped by coronavirus fears on Wednesday (Thursday Philippine time), with the NBA suspending its season after a Utah Jazz player tested positive for COVID-19:

The NBA's move followed a dramatic lastminute postponement of Utah's scheduled game against the Thunder in Oklahoma City, league officials taking action after deliberating during the day how best to proceed in the face of the outbreak.

"The NBA is suspending game play following the conclusion of tonight's schedule of games until further notice," the league said.

"The NBA will use this hiatus to determine next steps for moving forward in regard to the coronavirus pandemic."

The move came days after the Indian Wells tennis tournament in California became the first high-profile casualty of the crisis

Mounting concern over the possible spread of COVID-19 also prompted Canadian authorities to cancel the World Figure Skating Championships, which were due to take place in Montreal from March

The decision came after escalating anxiety about the potential for unchecked transmission of the virus among fans attending sporting events.

Shortly after the NBA's decision, the NHL said it would update the status of its season on Thursday.

The National Hockey League is aware of the NBA's decision tonight to indefinitely suspend its season due to a player testing positive for the coronavirus," the NHL said in a statement.

"The NHL is continuing to consult with medical experts and is evaluating the options. We expect to have a update further (Thursday).'

Pending league-wide action, the NHL's San Jose Sharks said they would play the three home games remaining this month without fans after a ban on mass gatherings in Santa Clara County in California.

The Santa Clara County edict also forced the postponement of a March 21 Major League Soccer game between the San Jose Earthquakes and Sporting Kansas City.

The NHL's Columbus Blue Jackets said they would host the Pittsburgh Penguins on Thursday behind closed doors after an order

banning mass gatherings in Ohio, set to be the first major professional sports event to be played in an empty arena.

The San Francisco Giants baseball team said a planned pre-season game against the Oakland Athletics on March 24 would be rescheduled.

In Washington state, authorities announced a ban on all gatherings of more than 250 people in three counties until at least the end of March, including the area which covers Seattle.

### 'More aggressive position'

"It is clear that our state needs a more vigorous and more comprehensive and more aggressive position if we are going to slow the spread of this epidemic," Washington governor Jay Inslee said.

The MLS's Seattle Sounders later said a game against FC Dallas on March 21 had been postponed.

The Seattle Mariners baseball team said they would seek to reschedule the club's opening home games of the 2020 season, which had been set for late March.

Meanwhile the wildly popular climax to the US college basketball season -- "March Madness" -- will be

"I have made the decision to conduct our upcoming championship events, including the Division I men's and women's basketball tournaments, with only essential staff and limited family attendance." National Collegiate Athletic Association (NCAA) president Mark Emmert said.

The NCAA took the unprecedented move after consulting public health officials.

Anthony Fauci, head of the National Institute of Allergy and Infectious Diseases, told a US Congressional panel in that the agency believed any large gatherings of played in virtually fan-free people represented a risk

COVID-19 spreading.

"We would recommend that there not be large crowds. If that means not having any people in the audience, as the

NBA plays, so be it," Fauci said. "Anything that has large crowd is something that would give the risk to spread."

Johns Hopkins University's coronavirus tracker put the number of known US cases at around 1,300, with 36 dead.

Golf's US PGA Tour said Wednesday it has no plans to postpone its schedule, but added it has not ruled anything

out either. The Players Championship tournament is set to start on Thursday.

Players "The Championship will continue as scheduled. although we will absolutely continue to review recommendations from the Centers for Disease Control, World Health Organization and local health administrations," the statement said

"Players in the field have been notified to be prepared to play round 1, as scheduled."

The Tour said it would provide a further undate on Thursday.

### WHO declares coronavirus global pandemic

World Health Organization on Wednesday declared coronavirus "a global pandemic."

At conference in Geneva at WHO headquarters, head of the UN health Tedros agency, Adhanom Ghebreyesus, said that over the past two weeks, the number of COVID-19 cases outside China increased 13-fold and tripled in the number of countries where it occurs.

"WHO has been assessing this outbreak around the clock and we are deeply concerned both by the alarming levels of spread and the severity and by the alarming levels of inaction," he said.

"We have therefore made the assessment that COVID-19 can be characterized as a pandemic," Tedros added.

There are now more than 118,000 cases in 114 countries, and 4,291 people have lost their lives while \$1 countries have no cases so far, he

"We have never before seen a pandemic sparked by coronavirus. This is the first pandemic caused by a coronavirus," said Tedros.

He said the world had also never seen a Tedros noted. (Anadolu)

GENEVA — The pandemic that can be controlled at the same time. adding some countries were not taking action to stem the disease.

"Describing the situation as a pandemic does not change WHO's assessment of the threat posed by this virus. It doesn't change what WHO is doing, and it doesn't change what countries should do," said Tedros.

Of the 118,000 cases reported globally in 114 countries, more than 90 percent of cases are in just four countries, he said and that two of those -- China and South Korea have significantly declining epidemics.

"If countries detect, test, treat, isolate, trace, and mobilize their people in the response, those with a handful of cases can prevent those cases becoming clusters, and those clusters becoming community transmission." said Tedros.

All countries needed to strike a fine balance between protecting health, minimizing economic and social disruption, and respecting human rights.

"This is not just a public health crisis; it is a crisis that will touch every sector -- so every sector and every individual must be involved in the fight,"

Jose Angelito Palma, WWF-PH Executive Director said the way how people eat their food has an impact on our climate, adding that it is important to address how to change our behaviors.

He also said eating exotic cuisines can affect the environment and eventually harm the people as "how the coronavirus is threatening the entire world now, citing reports that the sweeping disease came from consuming wild animals.

### Precaut measures

Meanwhile, Ibay said along with the observance of the Earth Hour, WWF-Philippines also precautionary measures amid the Covid-19 threats.

"For those who are doing events on their own related to the earth hour. we are coordinating with them and we do have guidelines for them -- to ensure the health and safety of the participants are not at risk," she said.

The welfare and the health of the public, she added, are the utmost priority of the WWF-PH.

benefit of all family households, particularly depressed in communities," the DA chief added.

"For our basic staple. rice, the current inventory various NFA warehouses nationwide is good for at least 80 days, and it will be further augmented by the incoming palay harvest this current dry season. providing additional stocks for another two to three months," Dar said.

"Together with the rice stocks held by the private sector and households, we will have a 35-week rice supply, which means this is good for at least nine months," he said.

"Further, to ensure readily available and affordable supply of other basic food commodities, we have gathered initial commitments from the private sector and DA regional offices to sufficiently supply the needs of Metro Manila residents, under our Food Resiliency Action Plan," he added.

He said the plan includes the strategic positioning and efficient distribution of basic food commodities, including the monitoring of suggested retail prices of the same in public markets in Metro Manila.

Other than rice, the other basic food items include pork, chicken, eggs, other poultry products, fish. vegetables, fruits, sugar, cooking oil, and other coconut by-products.

The food resiliency action plan will be further expanded and updated in partnership with the private industry, local government units, and farmers' and fishers'

The agri chief said this is also an opportune time for Metro Manilans to consider engaging in food production via urban gardening or aquaculture in their respective backyards, verandas, roof tops, and designated areas in the barangay, school or community.



## CSC adopts 4-day workweek, shift work amid Covid-19 scare

MANILA – The Civil Service Commission (CSC) on Wednesday issued a memorandum circular (MC), adopting the interim guidelines for alternative work schemes in government amid the threat posed by coronavirus disease 2019 (Covid-19).

A copy of MC 7 released by CSC on Monday directs all heads of constitutional bodies and offices in local and national governments to adopt "either or both" the four-day workweek and shift work.

The order covers all government agencies, including constitutional bodies, departments, bureaus, and agencies of the national government, government-owned and controlled corporations with original charters, local government units, and state universities and colleges.

Under the four-day workweek arrangement, public employees' workweek is reduced to four days, but the number of work hours per day is increased to 10 hours so the total number of required work hours per week would not be less than 40 hours.

"The agency shall ensure that its normal workweek is maintained," MC 7 read.

The work shift scheme, meantime, allows the shifting of government employees, as long as they are able to meet the required 40 hours per week.

MC 7 takes effect immediately.

The agency head should ensure that health workers. first responders. and frontline service providers are provided support mechanisms like health interventions. stress debriefing, and appropriate technologies to minimize face-to-face contact, according to the CSC order.

The CSC adopted the guidelines after President Rodrigo Duterte on Sunday declared a state of public health emergency nationwide amid the rise in the confirmed cases of Covid-19 in the

country

MC 7 notes that the alternative work arrangements should be adopted for the duration of the state of public health emergency.

"Agencies may

formulate their internal rules and regulations governing the implementation of the alternative work arrangements in accordance with these guidelines, which shall be submitted to the Civil Service Commission through the CSC Regional Offices for records purposes," it

"Agencies shall adopt a monitoring mechanism during the implementation of the alternative work arrangements to ensure that public service delivery is not prejudiced," the order added.

The number of people infected with Covid-19 in the country has risen to 49, the Department of Health confirmed earlier Wednesday. (By Ruth Abbey Gita-Carlos/PNA)

## Commentary: To fight pandemic, world must avoid pan-panic

BEIJING — The World Health Organization (WHO) on Wednesder as day characterized the Covid-19 outbreak as a pandemic.

As the world is striving to push back the pandemic, it must be fully aware of the lurking danger of pan-panic.

danger of pan-panic.
Already, the daily
update of the fastgrowing number of new
infections and deaths has
had many in different
parts of the world on
tenterhooks. Masks,
disinfector, and even
toilet papers were sold
out; Asian-looking
people were attacked in
Europe and America;
stock markets worldwide
are on roller-coaster
rides.

The very reason the WHO finally called the spread of Covid-19 a pandemic is certainly not to fuel fear and panic but to rally even greater consensus among countries worldwide for urgent and stronger actions against the disease.

"All countries can still change the course of this pandemic if countries detect, test, treat, isolate, trace and mobilize their people in the response."

WHO Director-General Tedros Adhanom Ghebreyesus said on Wednesday in Geneva.

In this battle against a previously unknown infectious disease, it is understandable to harbor concerns.

However, if left unchecked, those concerns could spark unwarranted fear, and unwarranted fear could foster racism, nationalism, and isolationism, thus turning one against another at a time when solidarity and trust should be valued and ardently encouraged.

Therefore, for the world to beat the disease, it should also find ways to contain panic at the same time.

To do that, governments across the globe should use every tool at their disposal to inform the general public about the best possible way to stay healthy, come out loud and clear against any misinformation with truth, and rid racism and xenophobia of any chance to swell and swing people's minds.

Of course, the most powerful weapon to counter panic now is to have full confidence in the human race's ability to end the outbreak only if all countries come together.

The international community can draw that confidence from China's own experience as the country has been making steady progress in containing the spread of the virus within its borders. If China can turn the tide against the disease, so can others.

Over the past few days, countries like Italy, France, and South Korea have all taken rigorous measures like locking down cities, suspending schools and tightening port controls.

Also, more and more leaders, academics and medical professionals have spoken up for the importance of global solidarity and cooperation. It seems that the international community is racing to catch up with the curve.

With the latest reminder from the WHO, countries worldwide should do everything they can to make sure that panic will not stand between them and the final victory. (Xinhua)

## Italy widens restrictions as Covid-19 death toll jumps to 827

ROME – Italy will close all its shops, bars, restaurants and main commercial activities except essential services in its latest effort to contain the spread of the novel coronavirus.

Prime Minister Giuseppe Conte made the key announcement late Wednesday in a speech to the nation after the death toll from the virus jumped by 196 in only 24 hours to



827 with a total of 10,590 confirmed cases in the country – the most hard-hit in

Europe.

Conte said the new restrictions will be imposed nationally for at least two weeks, after which the main effects of the new measures will be assessed

"We will only be able to see the effects of this great effort in a couple of weeks," he said, adding this sacrifice by all Italians was key for the future of the country.

"This is the time to take a further step," Conte added, without ruling out future restrictions.

The Italian premier specified that all shops will be shut down with the exception of supermarkets, grocery stores and pharmacies. All bars and restaurants will also be closed, while firms will be able to continue their activities only if they apply specific security

protocols to protect their employees.

Conte said, however, that essential services including transportation, banking and insurance and agricultural activities will continue.

### UP-NIH to do 1K tests per week with coronavirus detection kit

MANILA - With the allow it to be sold to the use of the SARS CoV-2 PCR Detection Kit, the University of the Philippines-National Institute of Health (UP-NIH) can perform 1,000 tests per week, providing immediate diagnosis and monitoring of the coronavirus disease 2019 (Covid-19), Department of Health (DOH) said Wednesday.

D 0 Undersecretary and Food and Drug Administration Director-General Eric Domingo said the locallyproduced kits could improve but not drastically change the pace of testing of specimens from potential Covid-19 cases

"Even when the test kits are available ang maximum na magagawa ng UP-NIH is 1,000 tests per week at 'yun din ang enough na mapo-produce nila na (only 1,000 tests per week maximum the UP-NIH can create and they can produce enough) reagents for 1,000 patients per week," Domingo said during a press briefing in Manila.

Domingo said the local test kit "will not be widely available to the public since its Certificate of Exemption does not

public.

"May selection pa rin kung sino ang dapat matest (There's still a selection of who must be tested). This is going to be done within the UP-NIH...there subnational laboratories listed to use the local test kits, and we're also listing private hospitals," he said.

The UP-NIH has committed to start with the testing on Monday (March 16), a week after the kit was approved.

The kit has a shorter turnaround time with 45 minutes to two hours processing to extend the capacity of the DOH laboratories

Meanwhile, DOH Assistant Secretary Maria Rosario Vergeire said the Research Institute for Tropical Medicine still has enough supply test kits for possible Covid-19 cases.

"The RITM, 300 tests per day, kaya pang tugunan ang mga (it can still accommodate) requests for tests. We're mobilizing our partnership with UP-NIH in case the cases continue to go up.' she added. (By Ma. Teresa Montemavor/ PNA)
