## 8 Filipinos wounded, 12 missing in Lebanon blast

MANILA -- Twelve Filipinos are missing after a deadly blast followed by shock waves rippled through the Lebanese capital Beirut on Tuesday, the Department of Foreign Affairs (DFA) confirmed.

One of the missing

nationals is a household service worker while the remaining 11 are seafarers who were onboard the ship MV Orient Queen docked about 400 meters away from the blast site.

Foreign Affairs Undersecretary Sarah Lou Arriola said the 11

were part of a group of 13 Filipino seafarers who all jumped into the sea as the massive blast tore through the city and sent plumes of smoke billowing into the sky. Two of the 13 are currently seeking shelter at the Embassy.

# OneHospitalCommand Center to centralize Covid-19 beds

MANILA - To maximize the availability of hospital beds reserved for those infected with the coronavirus disease (Covid-19), the government Thursday launched the One Hospital Center Command (OHCC).

The center, located at the Metropolitan Manila Development Authority (MMDA) Gymnasium in its headquarters Guadalupe, Makati City, will provide coordinated care for Covid-19 patients, allowing for transfers, referrals, and to provide "medical direction" between hospitals, Department of Health (DOH) Undersecretary Leopoldo Vega said.

He said the OHCC will work in tandem with the DOH's Covid-19 hotline, where calls that require "transfer,

coordinated care, or medical direction" will can also be dispatched be transferred to from the MMDA responders at hospital, the OHCC.

"And the MMDA responders will connect with the different incident commanders of different hospitals whether they can that would need intensive care treatment or if they are full," Vega

"We are also here for strengthening capacity. And strengthening capacity would mean we need to identify ready hospitals that can accommodate intensive care or rooms for moderate cases," Vega

He cited the new building at the East Avenue Medical Center, set to be inaugurated as the "main integrated facility for Covid-19" on August 17, as an example of the government's plan to expand the capacity of existing hospitals.

"We are strengthening capacity by putting up modular hospitals. And one of the identified modular hospitals that can serve moderate and severe cases is at [Quezon Institute]. But this is going to be an extension facility of Jose Reyes Memorial hospital because it can never be standalone," Vega said.

Secretary Carlito Galvez Jr., Presidential Adviser on the Peace Process and chief implementer of the National Task Force (NTF) Against Covid-19, said the government originally had two coordinating centers for Covid-19—one located at Camp Aguinaldo and another managed by the DOH.

"Meron na tayo talagang nabuo na command center and also yung DOH meron din sila. Ang ginawa lang natin, instead na meron magkahiwalay command center ang DOH at saka yung NTF, binuo na lang natin na isang command (We had a command center and DOH had their own. What we did is, instead of having separate command centers, we merged them into one)," Galvez said.

Aside from unifying the two separate coordinating centers, he said the space provided by the MMDA will allow for further expansion of the OHCC.

"They jumped from the ship and only two are accounted for, so we're trying to find out if they were able to swim to the shore. We'll be giving more details once we have concrete information on the ground," she told reporters in a virtual briefing.

The Philippine government is in coordination with the Lebanese authorities for efforts to locate the 12.

Arriola added that two Filipinos also died while eight were injured when the explosion took place in Beirut's port. Of the wounded, one sustained serious injuries while the seven had minor ones.

"As of now, everything is very fluid because it hasn't been 24 hours since the incident took place and if you've seen, the explosion was really massive. We are trying to tell all our Filipino overseas workers in Lebanon and all the next of kin that we are doing the best we can to assist all our nationals," she said.

who need it, test more, and isolate those infected.

He also urged the government's economic team to present during budget hearings a "second half" battle plan.

"We lost PHP1.4 trillion during the first half. About PHP 10.8 billion daily from April to June alone. The economy is gasping in the ER and a more robust stimulus package is the ventilator that it needs," Recto said.

Senate Minority Leader Franklin Drilon, meanwhile, emphasized the need to revive the demand side of the economy by restoring the people's confidence in the ability of the government to handle the pandemic.

"The key is to revive demand, but that will only happen when people feel safe to go out. People will feel confident when they see that the government is doing the right thing, effective measures are in place and the healthcare system is not collapsing," he said.

"Thus, it all boils down to our ability to control the pandemic," Drilon said.

He said there is a need to increase the stimulus fund under the Bayanihan to Recover as One Act (Bayanihan2).

On Wednesday, the House of Representatives passed the measure on second reading, containing a PHP 162 billion-stimulus fund.

Drilon said the second round of social amelioration program (SAP) is in order for those who were badly hit by the pandemic.

"Their lives did not become better after receiving the first tranche. They are the ones who continue to experience hunger every day. The government should provide for them until the pandemic is over," he said.

His call for a second round of SAP was echoed by Senator Sherwin Gatchalian who pointed out that the economic contraction created by the coronavirus pandemic will push numerous families back into poverty that will eventually worsen hunger and malnutrition in our country.

"At this point, it is important for the government to guarantee that there is food on the table for every Filipino family. I implore the government to expedite the distribution of the second tranche of the SAP to the 18 million low-income beneficiaries since most areas have again been placed under stricter auarantine protocols," Gatchalian said in a separate statement.

"Given that many of our constituents may not be able to go back to their respective work under a modified enhanced community quarantine (MECQ), the government should continue to give out the SAP even if we revert to the general community quarantine (GCQ). This is to ensure that no family will go hungry with the economy in tailspin under the pandemic," he added.

Meanwhile, Senator Sonny Angara assured that the Senate is willing to work with economic managers to hammer out the needed economic recovery strategy.

"All economies of the world are in a recession. What is important is the recovery strategy which a country pursues," the chair of the Senate Committee on Finance said.

"Bayanihan 2 will help initially but many are commenting it should be followed by other economic actions. Kami naman sa Senado (As for us in the Senate), we have shown our willingness to work with our economic managers to pursue a successful recovery strategy," Angara said. (PNA)

## **Infected people face big fines in Australia**

Melbourne— Hundreds of coronavirus-infected people in Australia's worst-hit state have been caught flouting stay-at-home orders, authorities said Tuesday, prompting tougher fines.

The southern state of Victoria has endured a second wave of infections over recent weeks that the government has partly blamed on people breaking rules that restrict travel.

Residents of Melbourne, Australia's second biggest city and the capital of Victoria, are now enduring an overnight curfew, closure of non-essential businesses and mandatory mask-wearing as hundreds of new cases are recorded daily.

But 800 infected

people—or more than 25 percent of those doorknocked aross Victoria—were not at home when authorities condcted recent checks, which state Premier Daniel Andrews called "completely unacceptable".

Andrews said people infected people in Victoria can now be slapped with on-the-spot fines of almost Aus\$5,000 (\$3,558)—up from Aus\$1,652—if they are caught leaving home a second time.

The only exception will be to seek emergency medical care. Previously, outdoor exercise was allowed.

An additional 500 troops will also be deployed in Melbourne to help health officials go door-to-door checking on people who should be staying at home, Andrews said.

Victoria police commissioner Shane Patton said hundreds of officers were also on the streets to enforce the curfew, mask-wearing and stay-at-home orders.

Patton said police had observed a small but emerging trend of socalled "sovereign citizens", who believe the laws do not apply to them and were consistently flouting the rules.

"We've seen them at checkpoints baiting police, not providing a name and address," Patton said.

"On at least four occasions in the last week, we've had to smash the windows of cars and pull people out to provide details."

Just over 160 fines were handed out in Victoria in the past 24 hours, including to a woman who was charged over allegedly smashing a police officer's head into concrete after being questioned for not wearing a mask.

Victoria has recorded more than 12,000 of almost 19,000 total coronavirus cases across Australia, as well as 147 fatalities of the country's total of 232.

## Ensure equal education Distribution of Financial opportunity to poor students: Go

MANILA – With a little more than three weeks to go before classes officially open, Senator Christopher "Bong" Go Thursday urged the education sector to ensure that the burden that may result from the transition to flexible modes of learning amid the coronavirus disease (Covid-19) pandemic will not be passed on to students, especially the

"Schools and education officials must guide students in order for them to adjust to new modes of learning. Siguraduhin natin na lahat ng mga estudyante mabibigyan ng pantay na oportunidad sa ilalim ng ating (Let us ensure that all students will be given equal opportunities under the) learning continuity plan in all levels of education," Go said.

"Despite current health crisis, our aim is to ease the burden for our students and also their families," he added.

In urging for equal opportunity education, the chair of the Senate Committee on Health noted that the consequences of the current health crisis on education make it imperative to look not in the g o v e r n m e n t ' s capability to adjust to these challenges but also the students'

capability to respond to the new norm of education - the online platform.

Go said even if the government offers free education in many state colleges and other vocational schools, many students are facing issues other than that tuition intensified further due to the adverse socioeconomic impact of the pandemic.

The prospects are especially grim for the majority of college and vocational students who come from poor families, he said.

"Marami pa rin sa ating mga mag-aaral ang mahihirap at naghahanap ng paraan para maitawid ang kanilang mga nagugutom na sikmura habang nag-aaral. Ano pa ngayong may pandemya na? He noted that the situation of poor students is confounded by their lack of access to digital equipment and internet connection.

## and Burial Assistance

Amidst the Covid 19 pandemic, the provincial government led by Governor Jonvic Remulla never cease to find ways to deliver its services to the people of Cavite, particularly the distribution of financial assistance which was temporarily suspended due to the outbreak. Prioritizing the safety of its constituents, mass distribution which will gather a huge crowd disallowed was prompting the Office of Governor to spearhead the house-tohouse distribution of aid to beneficiaries.

Aside from the Botika on wheels which caters to the medical needs of the locals, the team from the Office of the Governor and the Provincial Social Welfare Development Office went down barangays to dispense financial and burial assistance which were already processed in the previous months and awaiting release.

On July 21-23, a of 116 total beneficiaries were given assistance including those from

## Face shields required in public transport by Aug. 15: DOTr


MANILA-The use of face shields will soon be mandatory for passengers and drivers of public transportation to curb the transmission of the coronavirus disease (Covid-19).

In a media bulletin on Wednesday, the Department Transportation (DOTr) said the new policy would start on August 15 (Saturday), on top of the current mandatory wearing of face masks.

"The initiative aims to further reduce the risk of transmitting the coronavirus disease (Covid-19) in public transport facilities as health authorities have pointed out that the use of face shields and reduces masks exposure to and emission of respiratory droplets considerably," the DOTr said.

The directive is applicable to all public transportation in the country including the aviation sector, airports, railway transport, road transport, and the maritime sector, it said.

In a message, DOTr Assistant Secretary Goddes Hope Libiran said the policy was earlier circulated internally among executives of the DOTr

attached and its agencies through the issuance memorandum circular 2020-014 signed by DOTr Undersecretary Artemio Tuazon Jr. on August 3.

In the bulletin, shield worn inside public transport should "sufficiently cover the nose and mouth."

"We advise that our passengers use the ones that cover the whole face," Tuazon said.

While the new requirement will incur some cost for public transport commuters, DOTr Secretary Arthur Tugade said the face shield would add an extra layer of protection against Covid-19.

"Huwag sana nating isipin na panibagong gastusin o

dagdag abala ang pagrequire natin sa paggamit ng (Let us not think of this as an additional expense or inconvenience when using a) face shield. Let us remember that no amount of protection is Tuazon said the face too much when it comes to health and safety," Tugade said.

Aside from mandatory wearing of face shields, the DOTr said other preventive measures against Covid-19 remain such as mandatory wearing of face masks, safe physical distancing measures, and hand washing or sanitizing.

It added that talking or using mobile phones inside all public transportation is also discouraged. Raymond Carl Dela Cruz/PNA)
