the health safety of both the drivers and the passengers," Eleazar said.

Eleazar made his call after health experts said smokers and those who would inhale the secondhand smoke coming from cigarettes are susceptible to Covid-19 infection as their immune system is already compromised.

The JTF COVID Shield has been receiving complaints that there are some drivers and passengers who are smoking in **PUV** terminals, especially in the provinces.

Eleazar said police commanders were also tasked to account and regularly monitor the existence of smoking areas in their respective Areas of Responsibility (AORs).

He said police commanders should coordinate with the **Local Government Units** (LGUs) for utilization of barangay tanods and the city and municipal Public Order and Safety personnel for the enforcement of the nationwide smoking ban.

Earlier, the Manila International Airport Authority temporarily closed all the smoking areas in all terminals of the Ninov Aquino International Airport due to the threat of coronavirus infection among smokers. (By Christopher Lloyd Caliwan/PNA)

In 2017, Duterte signed the Paris Agreement, which aims to reduce the emission of gases that contribute to global warming.

### Gov't sends more than 200K OFWs to home provinces

MANILA - Over 200,000 returning overseas Filipino workers (OFWs) had been transported back to their home provinces, the Department of Labor and Employment (DOLE) said on Thursday.

Citing report of Overseas Workers Welfare Administration (OWWA), **DOLE** Silvestre Secretary Bello III said the government has assisted 218,205 OFWs since May.

The OFWs were repatriated after losing jobs due to the impact of the coronavirus disease 2019 (Covid-19) pandemic.

According OWWA, the latest batch of 1,440 OFWs was transported to their respective provinces after testing negative for



Covid-19.

Aside from Covid-19 test, the government provided accommodation, food, and transportation going back to their home provinces upon their arrival in the country.

The DOLE has also been extending a one-USD200 time (PHP10,000) cash aid

program to OFWs whose incomes were affected by the pandemic, both on-site and those stranded in the country.

Bello said more OFWs will benefit from the AKAP program following President Rodrigo Duterte's signing of Bayanihan to Recover as One or Bayanihan 2 law.

Meanwhile, Bello said there alternative overseas job markets for displaced OFWs particularly in the Middle East.

"In the Kingdom of

Saudi Arabia, which has resumed accepting and processing work visas; Qatar, which has abolished the 'kafala' system that requires migrant workers to get permission from their employers should they decide to change jobs; and the Kingdom of Bahrain, which has renewed the recruitment household service workers," he said in a statement.

He added that job markets available for Filipino workers are China, Japan, Czech Republic, and Taiwan. (DOLE PR)

# **BOC** intensifies audit on rice imports vs smuggling

protect to government revenue as well as the local producers agricultural products, the Bureau of Customs (BOC), through the Post Clearance Audit Group (PCAG), heightened its campaign against undervaluation and misclassification of importations through continuous checking of compliance of rice importers with Customs laws and regulations.

The transaction-based audit of importers is a continuing effort of the BOC to determine the correctness of the valuation of the goods and determine the liability of the importer for duties, taxes, and other charges, including fine or penalty for rice importations.

According to PCAG, a total of 245 entities falling under Tariff Heading 1006 have imported rice from March 5 to June 20, 2019. Of which, 60 entities with the greatest number of incidents of deviation and the highest percentage discrepancies in duties paid were selected for transaction-based audits.

Based on the audit results, auditees were found liable for the payment of Php 1,417,167,368.10 customs duties, penalties, surcharges, and interest due to undervaluation, misclassification, and/ or understatement of freight and insurance charges. Moreover, it found that undervaluation declared customs value remains the primary risk in revenue collection

In terms of the level of compliance, the audit findings show a low level of compliance among the audited importers, as 47 auditees or 85.45% were found to have violated customs laws regulations. Meanwhile, 8 auditees were found to have properly declared their goods and provided pertinent documentary requirements stipulated in the CMTA.

On the other hand, audit examination and investigation of the five (5) auditees were deferred due to its pending dispute settlement proceedings with the respective ports of entry.

Under Customs Administrative Order No. 01-2019, the BOC may conduct an audit e x a m i n a t i o n, inspection, verification, and investigation of records of any goods declaration within three years from the date of final payment of duties and taxes or from customs clearance.

The Bureau of Customs assures that the agency will remain steadfast in protecting government revenue through compliance audits of imported goods, especially during this critical time. The Bureau also forewarned that legal measures and penalties will be imposed on those importers that will be found involved in the smuggling of agricultural products and other commodities into the country. ### 20 private colleges, universities still have no billing submissions for the release of TES stipends-CHED, UniFAST

QUEZON CITY, --From the list of 264 noncompliant private education higher institutions (HEIs) previously released by the Commission on Higher Education (CHED) and the Unified Student Financial Assistance System on Tertiary Education (UniFAST) in June, 20 schools remain to be noncompliant in their billing requirements to the Private Education Assistance Committee (PEAC) thus delaying the processing and disbursing of the Tertiary Education Subsidy (TES) stipends to 500 TES grantees for Academic Year 2019-2020.

PEAC processes the TES billings of private HEIs and endorses these billing claims to CHED and UniFAST for payment, and those private schools that have already received the TES stipends are those TES billings that have been endorsed by PEAC to the UniFAST Secretariat and CHED.

A total of 253,585 continuing and new TES beneficiaries from 1,247 private HEIs nationwide were validated for AY 2019-2020 to receive the TES grant.

To date, UniFAST has processed 91% of the billing claims endorsed by PEAC for 234,436 grantees in 943 private HEIs. The 20 schools are part of the remaining 9% that consists mostly of billing claims yet to be endorsed by PEAC to UniFAST from 304 private HEIs with a total of more than 15,000 grantees.

"The CHED and UniFAST staff have been reminding these HEIs to immediately comply with their billing submission requirements so their student-grantees can immediately receive the subsidy due in their last academic year especially now that classes for AY 2020-2021 have started," said CHED and UniFAST Board Chairman J. Prospero E. De Vera III.

PEAC has reached out to these private schools to follow-up on their submissions. While some of the schools are in a rush to comply, most of them were unavailable to answer calls.

**CHED** While recognizes that the quarantine imposed during the COVID-19 pandemic may have delayed the submission by these private HEIs, nine months have passed and these HEIs still have not complied. The TES Management System Portal was opened in January for these HEIs to submit their TES billing documents. Their students continue to suffer from their inaction. The Commission will now look into how these HEIs can be penalized for not following their responsibilities in the Memorandum of Agreement they signed with CHED.

Students enrolled in private HEIs who are eligible in the TES Program will receive PhP 60,000.00 per academic year if they belong to the Department of Social Welfare Development - National Household Targeting Office (DSWD-NHTO) Listahanan 2.0 or they reside and study in private HEIs in cities and municipalities where there is no existing public university or college. The TES benefit covers payment for their tuition and education-related expenses. (CHED)

# NTA consults tobacco private sector for stronger cooperation

QUEZON CITY, -Gearing up for the upcoming tobacco season, the National T o b a c c o Administration (NTA) got commitment for stronger cooperation from cigarette manufacturers, leaf buyers and traders to boost the industry for the benefit of the local tobacco growers.

In a consultative conference at the NTA Central Office in Quezon City on September 10, NTA Administrator Robert Victor G. Seares Jr. said the cigarette manufacturers, through their representatives, have pledged to increase their purchase commitment for locally produced tobacco.

At present, the local manufacturers are buying 25% of the local production and the agency pushes for a higher rate or at least 45% to sustain growth for the tobacco industry.

"This support is crucial as we enter a tobacco season under the current pandemic which have impacted a lot of sectors, especially a g r i c u l t u r a l production," said Seares.

"Our partners from the private sector also agreed to our proposals to come up with their own five-year purchasing plan in line with our medium-term roadmap for sustainable tobacco production, and to submit quarterly reports with respect to their local purchases and import data to enhance our data cropping season under gathering," he added. a difficult situation

The industry development roadmap, Sustainable Tobacco Enhancement Program (STEP), is expected to accelerate the modernization and industrialization of the tobacco industry towards increased production and higher income for the farmers for the next five years.

"We always aim to give better opportunities of our growers to earn more for their tobacco venture as this is our major thrust under our administration, and with the support of our key industry players," said Seares.

Present in the meeting were representatives from Japan Tobacco International (JTI), Atty. Jose Paolo Patajo and Robert Eugenio; and Philip Morris and Fortune Tobacco Corporation (PMFTC), Atty. Anicka Zaragoza and Atty. Archie Gonzales. The representative from La Suerte Cigar and Cigarette Factory, Walter Barrios, joined the discussion through video conference app JioMeet.

According to Deputy Administrator for Operations Roberto R. Bonoan, the meeting provided a more focused discussion on the issues and challenges affecting the industry.

"We need this cooperation as we prepare the next cropping season under a difficult situation brought about by the pandemic," said Bonoan.

Directors Rodolfo F. Salanga and Nestor C. Casela, both members of the NTA Governing Board, and NTA Regulation Manager Atty. Rohbert A. Ambros also joined the meeting facilitated by Bonoan.

In a separate meeting on September 14, leaf buyers and traders also gave their commitment to buy more locally produced tobacco for the export market.

Local production last year reached 46.6 M kg, a 7.7% increase from the 43.2 M kg production in 2018. According to Winston Uy, president of Universal Leaf Philippines, Inc., 75% of the local production goes to the export market.

Seares said that the leaf buyers, true to their commitment before the trading season in March, bought all leaf produced by the tobacco growers despite the difficulty of trading activities due to lockdown.

Uy, joined by Matthew Diong of TransManila Inc. (TMI) in the said meeting, assured NTA that they continue making their contract growers to be more efficient with better technology and sufficient production and financial assistance in producing quality tobacco that can

## PhilMech, DA-7 distribute P75-M farm machineries

The Department of Agriculture (DA-7) and the Philippine Center for Postharvest Development and Mechanization (PhilMech) turned over P75 million worth of farm machineries to Negros Oriental farmers on Sept. 17, 2020.

In a turnover ceremony held in Bayawan City, the farmer's group in the town received four units Hand Tractor, five Floating Tillers, one Rice Precision Seeder, one unit Walk-behind Rice Transplanter, one Riding-type Transplanter, and five units mini Rice Thresher.

Regional DA-7 Executive Director Salvador Atty. Diputado and PhilMech Director Baldwin Jallorina personally handed-in the machineries to the farmer's recipient group - the Bayawan United Farmer Irrigators' Association,

compete with the world market. Kingsley Pua of Pentaleaf Corp joined the meeting via JioMeet.

The leaf buyers and the NTA agreed to adopt the policy of market-driven tobacco production. In particular, the leaf buyers encouraged the production of Virginia Topped and Burley Topped this year in response to the current

Funded under the Rice Competitiveness Enhancement Fund (RCEF), other recipient farmers' group of these machineries in Negros Oriental are from the cities of Bais, Canlaon, and Tanjay; and the municipalities of Sta. Catalina and Siaton.

PhilMech Director Jallorina who attended the turnover ceremony explained the benefits of farm mechanization to optimize farm yield.

The event was the first in a series of distribution activities in Central Visayas.

Per guidelines, only the provinces of Bohol and Negros Oriental are covered under the RCEF program in Central Visayas, being the major riceproducing provinces in the region.

The team will also conduct a distribution activity of these machineries to Bohol farmer beneficiaries.

"This project is part of the Rice Mechanization Program implemented by Agriculture Secretary William Dar to increase farm production and income," Diputado said.

He went on saying that the rice mechanization program would reduce the amount of physical labor required from the farmer and improve their planting efficiency.

Diputado also shared the challenge of Secretary Dar to the Local Government Units to increase their farm production to at least 10 percent, which was positively accepted by the local officials present.

Data of PhilMech reveals that about two to three percent of postharvest losses can be saved with the use of mechanized rice mills, mechanical dryers, and combined harvesters, among others.

Director Jallorina shared in the official PhilMech webpage that using rice machines is very applicable amid the COVID-19 pandemic, since only two to three people are needed to get things done.

Negros Oriental Vice Gov. Mark Macias, Tanjay City Mayor Reynaldo Concepcion, and 1st District Representative Jocelyn Limkaichong attended the turnover ceremony with the farmer beneficiaries. (PR/DA-RFO-7, RAFIS)

Sign na rin siguro yun na ito na yung tamang time para magretiro (I had to fly back to Davao when my father got sick and eventually died, and I had a difficult time returning due to the pandemic. It may be a sign that it is the right time to retire)," Simon said.

### From 'overlooked' to legend

He said he was surprised by what his career has gone through all these years.

"Hindi ko inakala na pagkatapos hindi mapansin nung 2001 PBA (Philippine Basketball Association) Rookie Draft na posible pa pala mag-iwan ng sarili kong marka sa liga (I never thought that after I was

overlooked in the 2001 PBA Rookie Draft, it would still be possible for me to leave a mark in the league)," Simon said.

He was selected in the fifth round of the 2001 Draft but Sta. Lucia, the team that selected him, did not sign him to a contract, leaving him as a free agent.

Simon eventually found himself joining the Davao Eagles in the 2001 MBA season, where he became their focal point of offense.

His stint with Davao ended right when the MBA met its demise in 2002 but Hapee, then a powerhouse team in the Philippine Basketball League (PBL), recruited him afterward.

Simon instantly became a key player in Hapee's offense and he developed an individual mini-rivalry with Welcoat's star, James Yap.

However, in 2004, Magnolia acquired both Simon and Yap through free agency and the draft, respectively, and they became the team's 1-2 punch in the offense.

Behind Simon, Yap, and defensive ace Marc Pingris, the Purefoods franchise won seven championships from 2006 to 2014, capped by a grand slam.

Even after Yap was essentially shipped back to the Welcoat franchise, now known in the PBA as Rain Or Shine in a trade for Paul Lee, Simon would still win a title for Magnolia, ruling the 2018 Governors' Cup.


"Binigay ko yung 17 years ng buhay ko sa PBA, sa Magnolia Hotshots, at sa lahat ng fans (I gave 17 years of my life to the PBA, the Magnolia Hotshots, and all the fans)," added Simon, who played with the Purefoods franchise throughout his illustrious career that is also highlighted by eight All-Star Game appearances, the 2008 All-Star Game Most Valuable Player award, and being a member of the 2014 Mythical Second Team.

He thanked San Miguel big boss, Ramon S. Ang, for giving him the opportunity in sports and business, and his coaches, teammates, and fans in the 17 years he played basketball.

### Jersey retirement up

Before the start of the season, the Hotshots' management said Simon's number eight jersey would be retired, becoming the fourth Purefoods player to have his jersey lifted to the rafters.

With his jersey set to be retired, he will join an elite list that includes Alvin Patrimonio, who is currently the club's team manager, Jerry Codiñera, and Rey Evangelista.

They were key players in the Hotshots'

dominance during the '90s.

Except for Codiñera, who still got to play for the TNT franchise, then known as Mobiline, and FedEx later on, Patrimonio and Evangelista, like Simon, played their entire careers with the Purefoods franchise.

"Nakakatuwa kasi isang team lang kami (I was very happy because we only played with one team)," Simon said about joining Patrimonio and Evangelista in the retired jerseys list.

Simon still got to play

in the season opener, making four points in 11-and-a-half minutes off the bench but the Hotshots fell to the Beermen, 78-94.

The Magnolia management initially set jersev Simon's retirement on May 10, when the team was to take on Ginebra in the latest chapter of the "Manila Clasico", but the pandemic forced the postponement of the season and, in effect, the retirement ceremony. (By Ivan Stewart Saldajeno/PNA)
