## Over 100K tablets distributed in Manila ahead of school opening

MANILA – The Division of City Schools (DCS) of Manila has ramped up its preparations for the school opening after it distributed some 100,398 tablets to students of public schools in the city.

This comprises 73.3 percent of the 136,950 total number of tablets procured by Manila city parents of public school students who may be incapable of buying gadgets for their children for the blended learning.

Meanwhile, some 11,000 laptops with pocket Wi-Fi were also school teachers.

#### DOH consults WHO after SoKor test failed RITM validation

MANILA – The Department of Health (DOH) on Wednesday said it is coordinating with the World Health Organization (WHO) about an antigen test kit included in the WHO emergency use listing but failed the local validation sensitivity.

"The SD Bio Sensor is the first antigen test kit that has been validated by

Research Institute for Tropical Medicine (RITM), and, yes, it's true it didn't meet the diagnostic performance we have set based on the recommendation of the WHO which should be all antigen test kits must have 80 percent sensitivity and 90 percent specificity," said DOH Undersecretary Maria Vergeire Rosario during a virtual media

Apart from the pilot test on antigen test kits, Vergeire said the RITM is also studying saliva testing for Covid-19.

"There are two things about saliva. One is saliva is used as specimen instead of the nasopharyngeal and the oropharyngeal specimens, meron namang isa na itinutuloy na nila sa pagte-test (there's another one where they continue on with the test), so, you call it saliva testing," she said.

She said Philippine Red Cross is already conducting a trial using saliva as specimen.

"So dalawang institutions gumagawa ngayon ng pag-aaral dito sa (So two institutions are now already conducting studies on this) saliva testing as a possible specimen for testing for Covid-19," she said. "Aside from that we still don't have other studies." (By Ma. Teresa Montemayor/ PNA)

and his family met in Malacañang Wednesday night.

It was also the same day House members voted to reject the offer of Cayetano to resign from his post amid the speakership stemming from a 15-21 term-sharing deal with Marinduque Rep. Lord Allan Velasco. Duterte brokered the agreement in July last year.

During the meeting, Roque said Duterte simply asked Cayetano to make sure that the 2021 budget, which will be used for coronavirus disease (Covid-19) response, is passed on time.

Roque said Duterte will no longer interfere the House speakership between his two allies because he recognizes the vote of its members.

"Well, uulitin ko po ang paninindigan ng ating Presidente, iyong pagpili po ng liderato ng Kamara ay isang internal matter para sa Kamara Representante nirirespeto naman po ng Presidente ang naging desisyon ng Kamara na ibinasura po iyong pagri-resign ni Speaker Alan Cayetano (I will just repeat the stand of the President, selecting a leader in Congress is an internal matter of the House of Representatives and he respects the decision of the House to reject the resignation of Speaker Alan Cayetano)," he said.

Tuesday, On Duterte met Cayetano and Velasco to settle the House leadership row between the two.

Velasco would supposedly assume the position from October 14 until the 18th Congress ends in 2022.

Villanueva scheduled his meeting with Duterte two weeks ago, he added.



## DICT, Zambales to boost province-wide Internet with Free Wi-Fi and Broadband Network

ZAMBALES, -- The Department of Information Communications Technology (DICT) and the Local Government of Zambales are strengthening their partnership in providing Internet connectivity in the province through the signing of a Memorandum of Agreement (MOA) for the continuous deployment of free public Wi-Fi through the DICT's Free Wi-Fi for All Program and establishment of the Provincial Zambales Broadband Network.

The ceremonial signing took place during the launching of 64 Free Wi-Fi live sites in 16 locations in Zambales on 29 September 2020. The said Free Wi-Fi sites were the result of the cooperation between the DICT and the Province of Zambales formalized through a previous MOA signed last January. These sites have been accessible to the public since August this year.

"Wala naman sa ating nakaisip na the COVID-19 pandemic would set in so we never anticipated or foresaw the events that followed after the singing of the MOA – the heightened clamor for Internet connectivity after the onset of the community quarantine in the Philippines took the telecommunications sector by surprise... So today, thanks to the initiative of the Zambales Local Government and, of course, with the help from the DICT, we are a step ahead in strengthening Internet in Zambales during these uncertain times when digital access has become one of the most valuable resources," DICT Secretary Gregorio B. Honasan II said.

At present, government offices, hospitals, state universities and local colleges, among others, benefit from existing Free Wi-

Fi sites in the province. These include the President Ramon Magsaysay State University and the Philippine Merchant Marine Academy. It is expected that with the new MOA, more public institutions will be provided with free Internet.

"We take part and participate in the program of the government in its efforts enhance Internet accessibility and bolster economic, social and educational undertakings as a way to minimize the digital divided present in our society today. At ako ay natutuwa na tayo ay isa sa mapapalad na lalawigan na tatanggap ng tulong mula sa pamahalaan bilang bahagi ng Republic Act 10929 sa pangunguna ng Department of Information Communications Technology," Zambales Governor Hermogenes Ebdane, Jr. said.

[...And I am elated that we are among the provinces that will receive help from the government as part of Republic Act 10929 led by the Department of Information and C o m m u n i c a t i o n s Technology.]

Meanwhile, the to-be established Provincial Broadband Network is to be linked to the national broadband backbone. Phase 1 of the government-owned network will be completed by the end of 2020.

"We aim in this joint partnership to be a catalyst in furthering inclusive and comprehensive broadband penetration in the province by supporting the provincial government's initiative for the establishment of the Provincial Broadband Network and by ensuring that the provincial LGU is provided with adequate bandwidth at reasonable, competitive rates as allowed by law, if not free," Secretary Honasan explained.

"Looking forward, this partnership between the DICT and the Provincial Government of Zambales and its people is the best opportunity that will create a positive impact in the lives of people," Governor Ebdane added. (DICT)

On Friday, the city government distributed free helmets along Quezon Avenue to bicycle riders.

In a Facebook post, QC personnel prioritized senior citizens as well as indigent residents who use the bicycle as their mode of transportation in going to and from their workplaces and in doing their errands.

"Pinapaalalahanan lahat magsisimula nang magmulta ang lungsod sa mga walang helmet na siklista simula October 15, alinsunod sa Ordinance No. SP-2942 na nagnanais gawing ligtas ang bikers ng Quezon City (we would like to remind everyone that starting October 15, the city government will start to fine bicycle riders who will be caught not wearing their helmets, in accordance with Ordinance No. SP-2942 that aims to make bikers in Quezon City safe)," Mayor Joy Belmonte said in a Facebook post.

Under City Ordinance No. SP-2942, violators will be penalized with fines of PHP1,000, PHP3,000 and PHP5,000 for the first, second and third offense, respectively. (By Marita Moaje/ PNA)

# Netizens ask QC gov't to prioritize needy in giving bike helmets

MANILA – Netizens urged the Quezon City government on Friday to prioritize the needy in the distribution of free helmets for bicycle riders in the city.

This came as the city approved an ordinance requiring the use of helmets for bikers and imposing fines for violators.

"Sana mabigyan po ako may tatlong anak, sa lahat ng ayuda minalas ako, kahit helmet man lang mabigyan ako (I wish that I be given one. I work as a janitor and I have three children. I did not receive any cash assistance in the past, I hope to receive at least a helmet)," Ronnie Sanchez Alo said in his post.

M a a y o n Sheryllene, meanwhile, wished in her post written in a mix of English and Filipino that her husband be given a helmet because his meager salary is barely enough to buy a helmet and they have more important expenses to prioritize.

Vinz Matthew Fugaban, in his post, asked that he also be given a helmet as he only borrows the bicycle that he is using.

I can't even buy a bicycle of my own)," Fugaban said.

Meanwhile, Roberto Jr David said that aside from giving free helmets, the city government should come up with other measures to ensure the safety of bikers. This includes the strict enforcement of speed limit in the city's roads for motorists and the minimum distance between motorists and cyclists.

He also suggested that city government officials should try biking going to work for a month to be able to fully assess the safety of bikers.

Another netizen, Ignacio Sabas Mamposte called for the establishment of more bicycle lanes especially in major

## Water rationing likely as Angat dam posts below normal level

MANILA Residents of Metro Manila may likely experience water rationing until the coming months, as the Angat Dam's current water level is below normal, and the projected rainfall is not enough to normalize it until December, said Philippine Atmospheric, Geophysical and Astronomical Services Administration (PAGASA)administrator Vicente Malano on Friday.

In an interview with the Philippine News Agency, Malano said that of the three main sources of water supply in Metro Manila --Angat, Ipo, and La Mesa dams -- only Angat is currently below normal level.

"The problem is that the main source of water for La Mesa is Angat. Based on current data, the projected rainfall is not enough to normalize the water level in Angat even until December. requires (This) reduction of water allocation. Our climate and hydromet divisions closely are coordinating with the NWRB (National Resources Water Board)," he said.

The current allocation, he said, is 46 cubic meters per second (cms).

"It (allocation) can be reduced if people would conserve water. It is also a way to force people to conserve water," he added.

Malano, however, clarified, that he sees water is too essential this time in Metro Manila, considering several ongoing

constructions.

He added that he does not see water shortage to the point that residents would not have the water, but reducing allocation is essential.

"We (PAGASA) could only suggest. The NWRB has the final say regarding allocation," he pointed

La Mesa dam as of 6 a.m. Friday is at 79.10 meters at its rule curve level, while Angat Dam is at 178.37 meters above mean sea level (AMSL).

"The 178.37 m. is below 8.7 m. from rule curve (today), but still at full operational level," Malano said, adding that a rule curve changes every day.

A rule curve divides the storage volume of a reservoir in zones different where strategies for demandsupply will be applied.

Malano said there is no "normal water level" for La Mesa since its water comes from Angat. Angat Dam's normal water level, on the other hand, is 212 m. during dry season, and 210 m. during wet

Based PAGASA's rainfall reservoir will be at:

\* 187 m. AMSL by the end of October 2020 (with forecast rainfall of 386 mm.)

\* 190 m. AMSL by the end of November 2020 (with forecast rainfall of 294 mm.)

\* 188 m. AMSL by the end of December 2020 (with forecast rainfall of 129 mm.)

"Angat's water level will improve by reducing allocation to MWSS (Metropolitan Waterworks Sewerage System)," Malano said.

"What the public should look at is the (status) of Angat, since this is the water source of La Mesa," he said.

Malano also clarified that even if PAGASA has just announced the onset of La Niña, the amount of projected rainfall for dams is not enough as La Niña would mostly affect the eastern section of Luzon, Mimaropa, and Visayas and Mindanao.

The NWRB on Friday announced it is reducing the water allocation to the Metropolitan Waterworks and System Sewerage (MWSS) and National Irrigation Administration (NIA) for the month of October.

MWSS receives 44 forecast, the Angat cubic meters per second (cms) while NIA receives 25 cms.

## 49K Pinoy seafarers deployed in September

MANILA - Some 49,000 Filipino seafarers were deployed in September as the seafaring industry gradually reopens amid the coronavirus disease 2019 (Covid-19), the Philippine Overseas Employment Administration (POEA) said Friday.

"Last month, a number of seafarers not below 49,000 were able to board their ships. This is the normal number of seamen we send abroad. It only means, slowly the industry started to pick up. Slowly, we are getting back our deployment because of the easing up by some countries destination." POEA administrator Bernard Olalia in a Laging Handa briefing.

Olalia also advised them to coordinate with POEA to obtain valid information on job vacancies recruitment.

"Just like what they say, if it's too good to be true, you are probably talking to an illegal recruiter," he said. (By Ferdinand Patinio/PNA)


