Lawmaker pushes for bigger SAP in 2021 budget

MANILA - The chairman of the House Ways and Means Committee on Tuesday said the country's economic contraction in the third quarter is a "sign" to include more direct transfers to the poor in the 2021 national budget.

Albay Rep. Joey Salceda made the statement after the government reported that the Philippine economy shrank at a slower pace in the third quarter of 11.5 percent still due to the impact of the coronavirus disease pandemic.

"Two weeks ago, I told members of the economic team that if the Q3 GDP (gross domestic product) figures are deeper than expected, we should have a bigger SAP (social amelioration program) 3 in the 2021 budget. It is now clear

MANILA – There These new routes are as will be more traditional public utility jeepneys (TPUJ) plying the roads of Metro Manila after the Land Transportation Franchising and Regulatory Board (LTFRB) announced that it is opening 16 routes more Wednesday.

that it should be the case," Salceda said.

Salceda noted that the fourth quarter figures will also have some complications because of the typhoons.

"Before this pandemic, Bicol was one of the fastest-growing regions in the country. With one of our growth drivers diminished, we will see some of our pains continue to the fourth quarter," Salceda said.

In a message to economic managers, Salceda said the government has to watch out for depletion in disposable income and household savings in analyzing the country's own third-quarter figures.

"If the disposable income goes down below deeply, expectations, we should be open to a direct, universal cash transfer. There should be some fiscal space left since we outperformed revised revenue targets this year," he said. "We can also borrow a bit from future revenues, provided we enact the tax proposals my committee has already passed on to the House plenary and the Senate."

Salceda said there is fiscal space for SAP 3 in the 2021 budget, but the government should be prepared to increase it to a more universal level if the third-quarter figures are dire.

He said he is not afraid of increased deficit spending in 2021, noting that there are measures lined up to raise a total of at least PHP300 billion annually.

"In 2021, stimulus measures will work because mobility restrictions will be less than that of 2020, so we should not be afraid to spend more. I estimate that we have at least PHP150 billion more in fiscal space for the 2021 budget. I'll confer with the DOF (Department of Finance) and DBM (Department of Budget and Management) to see

what we can work out," Salceda added.

The government reported Tuesday the country's gross domestic product (GDP) slide eased in the July to September period from a contraction of 16.9 percent in the second quarter.

"(This) indicates that the economy is on the mend. The path is clearer to a strong bounce-back in 2021," acting Socioeconomic Planning Secretary Karl Kendrick Chua said during a virtual press conference. "The economic team is optimistic that the worst is over for the country."

Chua is bullish about economic growth in the fourth quarter, citing easing restrictions on businesses and transportation while enhancing the implementation of the minimum health standards.

Chua said the still double-digit contraction in the third quarter did not come as a surprise given the return of stringent quarantine measures in the National Capital Region, adjacent provinces, and Cebu City, which account for around 60 percent of the Philippine economy.

On the supply side, agriculture growth slowed to 1.2 percent, as the sector faced several plant and animal diseases. These headwinds, however, had minimal effects on the overall food supply as evidenced by falling food inflation in the same period.

Both industry and services also showed a smaller contraction, consistent with the initial recovery of employment, where some 7.5 million workers returned in the third quarter.

On the expenditure side, smaller contractions were recorded in household consumption, firm investment, exports, and imports. This signals that households and firms are recovering. (By Filane Mikee Cervantes/PNA)

Andanar lauds Laguna report as province with highest Covid-19 recovery rate

STA. CRUZ, Laguna – The province of Laguna, which used to be one of the COVID-19 hotspots in earlier months, is now among areas with the lowest COVID-19 active cases and rising as the LGU with the highest COVID-19 recovery rate at 91%.

During the Pagdalaw sa Laguna: "Explain, Explain, Explain, Explain, Explain, Explain" conference on Wednesd ay, Presidential Communications Operations Office Secretary Martin Andanar lauded the development of the COVID-19 situation in Laguna.

The said conference aims to present and bring closer to the people the programs and services of the national government amid the pandemic, and provide an avenue for stakeholders to acquire and share updates on the COVID-19 situation of the locality.

"Kailangan natin maipakita sa buong Pilipinas kung gaano po kagaling ang Laguna na maresolba ang kaso ng COVID-19. In previous months, high numbers of COVID-19 infections were reported in Metro Manila, Bulacan, Cavite, Laguna, and Rizal, prompting the National Task Force Against COVID-19 (NTF COVID-19) to designate Cabinet members to oversee said areas.

Secretary Andanar is the designated "Big Brother" of the anti-COVID coordination for Laguna, linking gaps among LGUs and state agencies and ensuring synchronized COVID-19 responses.

As of November 3, 2020, Laguna recorded 15,300 coronavirus infections, of which 1,063 are active cases

Aside from these new routes, a total of 387 routes plied by 33,979 TPUJs are already active in Metro Manila.

Since June 1, the LTFRB has allowed the resumption of service of 865 modern jeepneys in 48 routes, 4,499 public utility buses in 35 routes, 387 point-to-point buses in 34 routes, 6,755 UV Express units in 118 routes, 21,436 taxis, 25,068 transport network vehicle services, 459 provincial buses in 20 routes, and 40 modern

UV Express units in two routes.

The LTFRB also reminded passengers, drivers, conductors, and operators to always wear face masks and shields, refrain from talking, eating in public transport, maintain proper ventilation of the vehicle, regular disinfection, bar anyone with Covid-19 symptoms, and to always follow the "one-seatapart" physical distancing rule. RA No. 11466, signed by President Rodrigo Duterte in January, contains the newest four-year salary upgrading program in the bureaucracy.

Under the law, the lowest-paid worker gets an adjusted monthly salary of PHP11,551 up to PHP12,244, depending on length of service, this year. The pay increases to PHP13,000-P13,780 in the fourth year (2023).

On the other hand, the

highest-paid official, the President, receives PHP407,734 this year. His salary goes up to PHP431,718 in 2023.

Defensor said the law, however, does not apply to President Duterte and incumbent members of the House of Representatives and the Senate. The Constitution prohibits them from being beneficiaries of their official acts. (By Filane Mikee Cervantes/PNA)

Palace suspends gov't work, classes in 8 regions Nov. 13

MANILA – Upon the discretion," he said. recommendation of the National Disaster Risk Reduction and Management Council (NĎRRMC), Malacañang suspended work in government offices and classes in public schools in Metro Manila and seven other regions on Friday.

In a statement on Thursday, Presidential Spokesperson Harry Roque said government work and classes will also be suspended in Regions 1, 2, 3, Calabarzon, Mimaropa, Bicol and Cordillera Administrative Region (CAR).

However, he said government agencies whose functions involve the delivery of basic and health services, preparedness/response to disasters and calamities, and/or the performance of other vital services "shall continue with their operations and render the necessary services."

"We leave the suspension of work for private companies, offices and schools to their respective heads'

He also urged the public to continue their regular monitoring of weather advisories and g o v e r n m e n t announcements, try to stay indoors, and keep safe and dry.

On Wednesday,

Malacañang has suspended work in government offices and classes in all public schools in Metro Manila and the regions of Cagayan Valley, Central Luzon, Calabarzon, Mimaropa, Bicol, and the Cordillera Administrative Region due to Typhoon Ulysses.

Suspended work and classes started at 3 p.m. Wednesday until Thursday, also upon the N D R R M C recommendation.

Heavy rains brought "Ulysses" left many flooded areas, prompting Rodrigo President Duterte to conduct aerial inspection in Marikina City and Rizal province on Thursday afternoon.

In his televised address to the nation, Duterte assured that the

national government will provide relief, rescue, and assistance to families severely affected by typhoon, adding that no one will be left behind.

He added that local and national government agencies have been mobilized to respond to the situation on the ground as heavy rains and strong winds brought by the typhoon triggered massive floods and power interruptions.

"From the beginning, various government agencies have already been mobilized to respond to the situation on the ground. I renew my call on all local government units and concerned agencies to ensure that the well-being and the safety of our people remain the top priority," he said.

Concerned agencies, he said, will exert all its efforts to attend to people's needs.

"As President, I guarantee you that your government will do its best to provide assistance in the form of shelters, relief goods, financial aid and post disaster counseling. Rest assured the government will not leave anybody behind. We will get through this crisis, I assure you," he added.

Duterte also rejected criticisms that the government has been sleeping on the job, saying local and government have been addressing challenges brought by the typhoon since it received an advisory.

He had in fact temporarily left the ongoing video conference of the 37th Asean Summit on Thursday to monitor the disaster situation.

"We are suffering in the midst of the storm of Typhoon Ulysses. There is a great damage and I may not be around to attend further in this regard for I have to go around and see what I can do for my people," Duterte said in his speech during the virtual Asean Summit. (By Jelly Musico/PNA)

DSWD still has more than P800-M for typhoon victims

MANILA - The Department of Social Welfare and Development (DSWD) on Thursday said it has more than PHP800million budget still available for the victims of calamities, including Typhoon Ulysses which left many flooded areas in Marikina City and provinces of Rizal and Bulacan.

D W spokesperson Irene Dumlao told Philippine News Agency that the agency has over PHP226-million standby fund and PHP184million quick response fund (ORF).

Undersecretary Rene Glen Paje earlier said the DSWD field or regional offices use the department's ORFs in crisis situations.

Dumlao said DSWD has stockpiles of 282,000 family food packs worth PHP130 million, food items worth PHP177 million, non-food items worth PHP271 million that are ready for distribution.

"As part of our mandate to provide technical assistance and resource augmentation to local government units and being the lead in Camp Coordination and Camp Management, DSWD also ensures efficient and effective delivery of protective services to affected families as well as management evacuation centers," she said.

She said the DSWD always makes sure that evacuation centers are comfortable particularly for children and women.

"We also practice minimum health PNA)

standards in coordination with the Health Department. Psychosocial supports are also extended to internally displaced persons," she added.

DSWD personnel are doing fieldworks to assess the extent of caused by the typhoon to determine appropriate assistance. For the recovery phase, they are offering programs such as cashfor-work, emergency shelter assistance, among

As of 12 p.m. on Thursday, the DSWD-NCR has recorded 8,154 families or 33,158 individuals taking shelter in 187 evacuation camps in Metro Manila due to "Ulvsses".

GENEVA — The World Health Organization chief on Monday congratulated US President-elect Joe Biden and Vice President-elect Kamala Harris, saying the WHO looks forward to working with their administration "very closely."

"We need to reimagine leadership, built on mutual trust and mutual accountability -- to end the pandemic and address the fundamental inequalities that lie at the root of so many of the world's problems," WHO Director-General Tedros Ghebreyesus said in a 40-minute speech at the opening day of the World Health Assembly.

Tedros hopes to see a reversal of the May 30 announcement by President Donald Trump that the US is ending its relationship with the WHO.

Biden had said during his election campaign, he would reverse the decision made by Trump when he tweeted on July 8, "On my first day as President, I will rejoin the @WHO and restore our leadership on the world stage."

That followed a months-long review

Trump had ordered after saying "they have failed to make the requested and greatly needed reforms" and halting Washington's funding over concerns the global health body mishandled the novel coronavirus outbreak.

He continued to insist China has "total control" over the WHO, claiming "Chinese officials ignored their reporting obligations" to the health body during the coronavirus pandemic and "pressured" it to "mislead the world."

The assembly, which will sit through Nov. 14, is being held due to the coronavirus disease 2019 (Covid-19) pandemic and follows the reduced meeting of May 18-19.

"It's time for the world to heal -- from the ravages of this pandemic, and the geopolitical divisions that only drive us further into the chasm of an unhealthier, unsafer and unfairer future," said Tedros in his address. "It's time to forge a new era of cooperation that puts health and wellbeing at the center of our common future."

after making contact with a person who tested positive for the Covid-19, but he had noted that he has no virus symptoms.

The WHO said it will hold no news conferences this week.

Turning to the reform that the US and other nations have demanded at the WHO, Tedros said, "This is an organization that has changed and is changing.

"We have prepared a detailed transformation update, which the Member States will receive during the Assembly," he said.

The WHO chief insists he supports transparency for the organization.

He said that among other developments, there is a new division for Data, Analytics, and Delivery for Impact, "making WHO a modern, data-driven organization that supports with timely, reliable, and actionable data to drive impact."

"The ACT Accelerator is a unique mechanism with two aims: to develop vaccines, diagnostics, and therapeutics fast; and to allocate them fairly," the WHO chief added.

In September, WHO reached an agreement to make 120 million new rapid tests available to low- and middle-income countries.

"We have secured courses of dexamethasone -- the only medicine shown to reduce the risk of death so far -- for up to 4.5 million patients in lower-income countries," Tedros said. (Anadolu)
