President Rodrigo Duterte has approved the recommendation to advance make payments to suppliers of potential vaccines for coronavirus disease 2019 (Covid-19), Malacañang said Thursday.

"Papasok po tayo ng advance market commitments kasama ng private vaccine developers at pagbigay ng advance payments sa kanila (We will enter into advanced market commitments with private vaccine developers and will advanced give payments to them)," Presidential

Roque said in a Palace press briefing.

Roque said Duterte agreed to enter into advance market commitments (AMCs) to avoid being among the last countries to acquire a vaccine. The President was initially against having to pay pharmaceutical companies to reserve Development vaccines in advance.

Relief ops for 'Rolly', Ulysses' reach P169-B

MANILA - The Department of Social Welfare and (DSWD) said it is scaling up relief operations for individuals affected by the super typhoon Rolly and typhoon Ulysses.

The assistance provided by the DSWD reached PHP169,134,599 for

both "Rolly" and "Ulysses," based on the data of the DSWD-Disaster Response **Operations Monitoring** and Information Center (DSWD-Dromic) on Wednesday morning.

"Though there are regions that were affected by both typhoons, Dromic records separate monitoring including the amount of

Roque said Duterte also approved various modes of financing for including vaccines private-public tripartite agreements without cost to government and the emergency use authorization to be issued to the Food and Drug Administration (FDA) via proposed executive order.

Once the President issues an executive order, Roque said it would speed up the process of allowing the use of vaccines with FDA approval from countries they were developed in.

In a taped meeting with Cabinet members aired Tuesday, Duterte said the government must get the "best bargain" for the country's supply of vaccines once available.

Duterte said he will rely on vaccine czar Carlito Galvez Jr. to manage the acquisition of a vaccine by December or January 2021.

Galvez, in the same meeting, said the government can enter into a multilateral arrangement with the World Bank and Asian Development Bank to facilitate the country's vaccine procurement.

He endorsed the Department of Health's proposal on the emergency use authorization for the coronavirus vaccines, saying it will guarantee 30 million to 50 million doses in the country by next year. (By Azer Parrocha/PNA)

DSWD said the assistance comes in the form of family food packs, non-food items such as hygiene kits and kitchen kits.

Financial assistance is also provided for typhoon victims to help them rebuild their homes.

Typhoon Ulysses has affected residents in parts of the National Capital Region (NCR), Ilocos Region, Cagayan Valley, Central Luzon, Calabarzon, Mimaropa, Bicol, and the Cordillera Administrative Region (CAR).

DSWD said some 824,035 families or 3,473,757 persons were affected by the weather disturbance.

Of this figure, 55,921 families or 223,378 persons are staying in 1,570 evacuation centers.

The total amount of assistance provided to the victims climbed to PHP75,460,593 on Wednesday.

Typhoon Super Rolly, on the other hand, ravaged parts of NCR, Cagayan Valley, Central Luzon, Calabarzon, Mimaropa, Bicol, Eastern Visayas, and CAR.

According to its latest report, DSWD said it has rolled out PHP93,674,005 for its relief assistance efforts.

There are 547,121 families or 2,130,778 persons affected by the onslaught of "Rolly."

Of the figure, 8,246 families or 34,007 persons are staying in 437 evacuation centers as of posting.

Meanwhile, DSWD assured that its personnel will continue to provide technical assistance to local government units (LGUs) in the proper management of evacuation centers amid the pandemic.

The agency said it leads the camp coordination and camp management cluster of the National Disaster Risk Reduction and Management Council (NDRRMC).

"DSWD aims to ensure that minimum health and safetv protocols are followed in evacuation centers by observing the Camp Coordination and Camp Management and Protection Covid-19 **Operational Guidance** that the Department issued in May 2020," the agency said.

The DSWD Operational Guidance states that it is necessary to preposition personal protective equipment for camp management personnel and volunteers. and strictly limit the number of internally displaced persons (IDPs) per camp.

Environment and Natural Resources (DENR), in coordination with relevant non-government organizations and civil society groups, will lead the observance and celebration of National Bicycle Day.

All other agencies and instrumentalities of the national government, including government owned or -controlled corporations and state universities and colleges, are enjoined and all local government units, as well

as the private sector, are encouraged to actively participate and render support and assistance to the DENR for the effective implementation of the proclamation.

More people have started riding bicycles when lockdowns were implemented across the country due to the prevailing coronavirus (Covid-19) disease pandemic.

Last May, the Department of the Interior and Local Government (DILG) urged local government units (LGUs) to establish bicycle lanes in all local roads to

support those who will bike to their work destinations due to the reduced capacity of public transportation under community quarantine.

Interior Secretary Eduardo Año said LGUs must also ensure that all bicycle lanes are free from any obstruction to prevent any untoward road accidents.

LGUs must also enact ordinances to impose reasonable penalties on violations in the use of the bicycle lanes to ensure that both motorists and cyclists follow the

regulations along the said lanes, he added.

The Department of Works and Public Highways (DPWH), last June, also created a Working Technical Group to directly coordinate with the Department of Transportation and Metropolitan Manila Development Authority for the preparation of a conceptual design and construction of a Metro Manila-wide bicycle lane for national and local roads. Philippine Jin Jiang Shen Fu Zhen Association, Inc., and World Fujian Youth Federation of the Philippines, Inc.

During the Covid-19 pandemic lockdown, these organizations likewise raised PHP300 million to provide rice sacks, surgical and N95 face masks, personal protective equipment, medical supplies, hygiene kits, and vitamins to more than 600 barangays, 300 hospitals, provinces, cities and municipalities across the Philippines.

An earlier batch of food relief packs was dispatched to typhoon of victims Albay province.

Successive strong typhoons have battered different regions in the Philippines in less than a month, affecting millions

of Filipino people and displacing thousands of families.

Super Typhoon Rolly, which was dubbed as the world's strongest typhoon in 2020, has killed 25, injured 399, with six persons still missing. It also left more than PHP5 billion worth of damage to crops, livestock, fish and agricultural facilities in several regions.

Typhoon Ulysses, on the other hand, brought massive flooding in Northern Luzon and has so far affected 3.4 million individuals in 5,951 barangays across the country.

The recent typhoon killed 73, including rescuers, and left 19 missing persons and 24 wounded. (By Joyce Ann L. Rocamora/PNA)

Paete Wood Carving Industry gradually recovering from Covid-19 impact

MANILA - With lesser number of people going to the town of Paete due to the threat of COVID-19, Vice Mayor Aurelio Paraiso said that wood carvers there have gone online to market their products as means to cushion impacts of the pandemic.

In an interview on Monday, he said that selling their products and services online have helped revive the livelihood of their constituents, especially now that Christmas season is already approaching and many are patronizing their decorative products.

"Medyo nakakabangon na nang paunti-unti ang ekonomiya ng bayan ng Paete [The economy of Paete is gradually recovering]," he said during the Network Briefing News with host Presidential CommunicationsOperations Office Secretary (PCOO) Martin Andanar.

He also noted that they are monitoring the situation of their seabased and overseas Filipino workers, who were affected by the travel restrictions back to their jobs abroad.

Paete is known as the wood carving capital of the Philippines and its industry is gradually returning to its feet amid the pandemic, while the local government continues to aid them.

"Nagbigay po ng ayuda ang pamahalaang bayan dun sa mga small and medium entrepreneurs ng puhunan na walang tubo unti-unting para makabangon yung ating maliliit mga na nagnenegosyo [The municipal government has provided loan without interest to small and medium entrepreneurs so they can recover]," Vice Mayor

Aurelio added.

Typhoon-hit farmers in Visayas receive assistance from DA

In the same episode, the Office of the Presidential Adviser for the Visayas (OPAV) Assistant Secretary Jonji Gonzales reported initiatives of the Department of Agriculture (DA) across the islands of Visayas.

He said that the regional counterpart of the DA continues to implement its programs for its farmerbeneficiaries, especially in typhoon-hit areas such as Iloilo, as part of the Typhoon Ursula rehabilitation Program of DA - Western Visayas.

"The program aims to distribute 2, 695 heads of native chicken. I n a a s a h a n g makukumpleto ng DA ang distribusyon ng mga ito under the DA quick response fund for Typhoon Ursula before the end of the year," Asec. Gonzales said.

Livestock were distributed in the towns of Batad, Concepcion, and Estancia.

Meanwhile in Central Visayas, the DA turned over farm machineries and hybrid rice seeds to farmers in Jagna, Bohol.

DA-7 distributed 4 units of Pump Irrigation System Open Source (PISOS) complete with pump and engine sets and pipes. Along with these is a unit of hand tractor.

According to Asec. Gonzales, the municipality of Jagna is one of the LGUs that responded to the challenge of DA Secretary William Dar of increasing farm production by at least 10%.
