Nearly 6M Filipinos register for nat'l ID

MANILA - The Philippine Statistics Authority (PSA) on Wednesday said 5,788,615 low-income Filipinos have taken the first step of the registration phase for Philippine identification system (PhilSys) amid some delays posed by the recent typhoons.

"We partnered with the Department of

National Defense to transport registration kits to the 32 provinces, but due to the recent typhoons and the resulting relief we efforts, encountering minor delays," Assistant Secretary Rosalinda Bautista, Deputy National Statistician of the PhilSys Registry Office (PRO), said in a statement.

Bautista asked the public to understand the situation "as the delivery of assistance to those affected by the typhoon is of utmost importance."

She said the PSA has notified the registrants about the changes in schedules due to the unforeseen calamities.

"We have notified, via text message, the

registrants who were set to undergo Step 2 registration November 25 to 30 about the change in schedule. Barangay officials in registration areas were requested to inform their constituents," Bautista said. "Personnel from the Provincial Statistics Offices were also instructed to man the registration centers to

Meanwhile, Romulo Quimbo Jr., chief communication officer of the Metro Tollways Pacific Corporation (MPTC), said about 66.4 percent of motorists who passed through MPTC/EasyTrip expressways have used RFIDs as of November 17 compared to 31.9 percent in July this year.

"In terms of cash payers that we have to accommodate by December 1, we have a significant minority. We have gone beyond the tipping point in terms of RFID use," Quimbo said.

As of Monday, he said the MPTC has installed a total of 1,523,991 EasyTrip RFID stickers, noting that almost a million stickers were installed since August 13, the day the Department ofTransportation (DOTr)

released its Department Order 2020-12 that required mandatory cashless transactions in all tollways.

Manuel Bonoan, president and chief executive officer of O&M Skyway Corporation, Manila Expressway System, and Tollway Corporation, said the San Miguel Corporation (SMC) has given away about 1.7 million free AutoSweep **RFID** stickers since 2015, noting that RFID use in its tollways has climbed to about 77 percent from 46 percent before the Covid-19 pandemic.

DOTr Assistant Secretary Goddes Hope Libiran said motorists who fail to have an RFID installed in their vehicle beyond the December 1 deadline will be able to do so in all toll lanes at all times from December 1 to January 11. (By Raymond Carl Dela Cruz/PNA)

signified that they currently do not have bank accounts.

"This emphasizes the importance of ensuring the rollout of the country's national ID program, as one of the main hindrances to financial inclusion is the lack of formal identification," the PSA said.

The mass rollout of the PhilSys project allows more Filipinos to access basic banking services and make them less vulnerable to informal lending practices that charge heavy interest rates, the PSA added.

The national identification will also help Filipinos access government and financial services.

The PSA said it will start the second phase the PhilSys registration, which involves the capturing biometric information such as fingerprints and iris scans, "once the required systems are fully functional and secured."

Among the major preparatory activities for Step 2 is the deployment of more than 4,000 registration kits to the target provinces, according to the PSA.

The third step of the registration is the issuance of a physical ID card stored with a PhilSys 12-digit number or personal serial number (PSN) and a 16-digit PhilSys card number (PCN).

DepEd's 2021 budget ready for bicam deliberations

MANILA – The Department of Education's (DepEd) 2021 budget for benefit of teachers and learners amid the changing times in education is now ready for bicameral deliberations.

"DepEd ensures that these funds are for the benefit of our teachers, learners, and personnel as we continue to adapt to the changing times in education. We thank Senator Pia (Cayetano) for graciously defending our budget, and we welcome our senators' inputs to efficiently utilize our funds," Secretary Leonor Magtolis-Briones said in a news release on Wednesday.

Cayetano successfully defended DepEd's proposed budget, including the funds of the National Museum, National Council for Children's Television, Early Childhood Care and Development Council, National Book Development Board, Philippine High School for the Arts, and the newlyestablished National Sports Academy as it hurdled the Senate plenary November 19.

Included in the 2021 budget is the increase of teaching supplies allowance from PHP3,500 to PHP5,000 next year.

DepEd also appealed for the inclusion of annual medical exam and World Teachers' Day incentive bonus to the FY 2021 Budget.

Meanwhile, the budget

also includes restoration of funding level for the Senior High School Voucher program, flexible learning options, Indigenous People's education, Special Education, disaster preparedness, and response.

Other changes and appeals of the Department for next year's budget include:

- Move the PHP25 billion unprogrammed fund to the programmed fund of DepEd.
- Increase in funding for learning resources Self-learning Modules, DepEd TV/Radio.
- Special provision for extended validity of funding for specific education programs.
- Additional Maintenance and Other Operating Expenses (MOOE) for school operations.

Undersecretary for Finance Annalyn Sevilla said hearings for DepEd's 2021 budget is now terminated and now awaits bicameral deliberations.

"Thank you, DepEd Secretary Leonor Magtolis Briones for your untiring and committed leadership. Salamat, salamat at Salamat (Thank you) to all DepEd Executive and Management committee members, the Budget-hearings TWG, Finance and Planning Service, all support staff and our whole DepEd family for the teamwork, hard work, [and] for giving all efforts and your best," Sevilla said.
