Marcos vows justice for student killed in hazing

MANILA - President Ferdinand R. Marcos Jr. on Wednesday vowed to deliver justice for Matthew Salilig, the 24year-old chemical engineering student from Adamson University who allegedly died of hazing.

Marcos gave the assurance, as he sympathized with Salilig's family.

"I extend my sympathies to John Matthew Salilig's family during this extremely difficult time and assure them that justice will be served," he said in a Facebook post.

Marcos lamented that hazing rites continue in pursuit of brotherhood. He said hazing is

never an option, as it only incites violence. "John was a child, a brother, a friend, a

classmate and a son of this nation, with a bright future ahead of him. It is not through violence that we can measure the Law passed in 1995

"There should be no room for violence in our which our children consider family, and in our schools which they consider their second home," he added.

Salilig was recently found dead in the city of Imus in Cavite province. Salilig, who had been reported missing since Feb. 18, was found buried


