PBBM urges Filipino Christians to become better agents of change

MANILA President Ferdinand R. Marcos Jr. has called on Filipinos to "know Jesus Christ more" to become better agents of change as Christians around the world observe the Holy Week.

"I urge all of us now to make this promise personal: Let it stir in

each of us the desire to know Jesus Christ more so that we may become better agents of change and conveyors of truth wherever we go," he said in his Palm Sunday message.

"With the hope for a brighter future by the grace of God, I wish everyone a meaningful

celebration," he added. Marcos recognized

how Filipinos take the time to commemorate the blessed occasion in "varying degrees and traditions."

"Ultimately, no matter how constant or diverse this occasion is in the Filipino psyche, one thing emerged true

The Holy Week, which is observed from Palm Sunday until Easter Sunday, is the most sacred period in the liturgical year of Christianity, marked by prayers, penance, and reflections.

On Friday, Malacañang announced the suspension of work in government offices starting noon on Holy Wednesday, to give workers ample time to prepare for the observance of the Holy Week, like those going home to the provinces.

The Palace made the announcement through Memorandum Circular 16 signed by Executive Secretary Lucas Bersamin.

Malacañang earlier declared Maundy Thursday and Good Friday (April 6 and 7) as regular holidays.

The day after Easter Sunday, April 10, is also a non-working holiday in observance of Araw ng Kagitingan (Day of Valor).

Security measures for 'exodus'

Meanwhile, all security plans are in place following the inspection of major bus terminals and ports ahead of the expected influx of travelers during the Holy Week, National Capital Region Police Office (NCRPO) chief Maj. Gen. Edgar Alan Okubo said in a statement over the weekend.

Okubo inspected Terminal 3 of the Ninoy

Aquino International Airport and bus terminals in Pasay City, Parañaque Integrated Terminal Exchange, Asian Terminals Inc. and North Port in Manila, and a bus terminal along EDSA in Cubao, Quezon City.

He also assured the public of police visibility, assistance desks, and 4,600 security officers from April 2 to 9.

The Metro Manila Development Authority, Philippine Coast Guard, Bureau of Fire Protection, Special Action Force, Regional Highway Patrol Unit, Regional Maritime Unit, and Aviation Security Group will account for about 3,000 of the personnel.

In Bulacan, police provincial director, Col. Relly Arnedo, directed the deployment of 200 more officers to maintain peace and order at strategic locations and all points of convergence across the province under "Ligtas SUMVAC" (Summer Vacation).

"The Bulacan Police has taken the initiative to conduct frequent inspections and increase police presence at tourist attractions and areas expected to have a high volume of tourists to ensure the safety and security of infrastructure such as passenger terminals, resorts, and pools,' Arnedo added. PCUP, Mercury Drug ink deal to help urban poor

MANILA - The Presidentia1 Commission for the Urban Poor (PCUP) signed a memorandum understanding (MOU) with Mercury Drug Foundation, Inc. (MDFI) at the latter's office head Bagumbayan, Quezon City on March 29 to help uplift the lives of marginalized the sectors.

The MOU highlights the foundation's pledge to provide free medicines under Oplan Bigay Lunas for the commission's Service Caravans, which are set to continue this year.

From 2019 to 2022, the commission's service caravans aided about

120,000 Filipinos across the country.

P \mathbf{C} Undersecretary Elpidio R. Jordan Jr. said with this alongside the commission's four banner programs, they would be able to deliver their mandate in support of President Ferdinand R. this is the highlight of our role as immigration officers where many people leave and return," BI spokesperson Dana Sandoval said at the Laging Handa briefing.

To efficiently serve arriving and departing passengers, the BI deployed 155 more officers and 36 others who recently finished their course at the Philippine immigration Academy.

Airport authorities said they expect over a million passengers this week and until Araw ng Kagitingan (Day of Valor) holiday on April 10, the day after Easter.

Sandoval advised travelers to monitor the immigration counters' situation at airports through social media.

"We have been very active also on social media to post immigration traffic updates," she said.

For the first time in three years since the pandemic struck, Filipinos are expected to travel to their hometowns to spend the long Holy Week weekend as travel restrictions have been relaxed.

M e a n w h i l e, Sandoval supported Senator JV Ejercito's push to amend the Philippine Immigration Act to be at par with the current situation.

"It's a 1940s law. Imagine, that was 83 years ago. It was written during the time that there were still no international flights in the country. The law is really outdated, truth be told. And there are a lot of provisions in it that are no longer applicable in modern times. So we fully support this observation," Sandoval said. (PNA)

Job Far in Alfonso

As part of the recovery efforts on the after effects of the COVID-19 pandemic to the livelihood and employment of the younger workforce, the Sangguniang Kabataan Provincial Federation headed by its President, Board Member Tom Carlo M. Ardemer spearheaded a Mega Job Fair Caravan with the theme, "Trabaho sa Kabataang Kabitenyo" in Alfonso, Cavite on March 24, 2023 thru the Provincial Public Employment Service Office (PPESO). The event was in partnership with the SK Federation Presidents from the LGUs of Alfonso, Magallanes and General Emilio Aguinaldo, and in collaboration with DOLE Cavite and the Department of Migrant Workers (DMW).

Krystel Faye Alcazar, SK Federation President of Alfonso welcomed the guests and applicants in the said activity and encouraged the youth take advantage of the opportunity offered in the mega job fair. BM Ardemer and PPESO Head, Ms. Rizalie Pinpin-Enero also delivered messages recognizing the partners who have been instrumental in bringing the job caravan to the LGUs

Also present in the event were SK Federation Presidents, John Allen Cabahug of General Emilio Aguinaldo, Glydel Ann Crisostomo of Magallanes, Councilor Joseph Lopez and Mr. Eddie Panganiban, representatives from General Emilio Aguinaldo and Mr. EJ Fontanilla, who co-hosted the job fair.

Awarding of certificates to partner agencies was also done during the event.

Participating employers include Caishen Marketing Services, Inc., Enomoto Philippine Manufacturing, Inc., Euro-Med Laboratories, H.R.D Singapore, Synergy Expert Labor Service Cooperative, Sanford Marketing (SM Savemore), Powerlane Resources and Hopewell Overseas Manpower Network, Inc., W&W Human Resource, Specialists Corporation, WalterMart Supermarket, Inc., and Lazurite Titanium & Life Insurance Agency (Pru-Life IJK)

Among the local job positions offered were production operators, quality control, molding inspector, assembly technician, stamping operator, and facility technician. Overseas jobs offered were caregiver, staff nurse, nursing aide, general crop farmer, livestock farmer, hotel maintenance, technician officer, waitress, engineers, building electrician, furniture carpenter, fork lift operator and foreman.

A total of 3,718 vacancies for local employment and around 80 for overseas employment were offered. Some 64 applicants were interviewed and 22 were hired on the spot.--- PICAD

The caravan aimed to provide career prospects for Cavite youth.

Mr. Noah M. Caasi, the Municipal Administrator of Maragondon, began the job fair caravan with a message of support for the event and emphasized the importance of employment creation for the youth. Ms. Rizalie P. Enero, PPESO head and Mr. Rodel Vincent T. Bae, head of the Provincial Youth and Sports Development Office (PSYDO), also gave brief statements encouraging participants to take advantage of the job fair and underscoring the government's commitment to assisting young people in obtaining work.

In total, 3524 job vacancies for local employment were offered.

APEC tracks progress in cervical cancer elimination

JAKARTA – Asia-Pacific Economic Cooperation (APEC), through its Health Working Group, announced comprehensive report that measures the progress in cervical cancer elimination and the status intervention programs to prevent and control the condition across the region.

Cervical cancer is one of the most common cancers affecting women worldwide, with over 600,000 new cases and more than 340,000 deaths estimated in 2020, according to the report issued by the APEC Health Working Group and received on Monday.

APEC economies accounted for an estimated 38 percent of new cases and 35 percent of deaths globally.

The report builds on the 2021 roadmap that sets policy targets for member economies to bolster health capacity and enable women and girls to lead healthy and productive lives.

It outlines how member economies can achieve key objectives for cervical cancer elimination programs, such as implementing comprehensive, interoperable registries and establishing definitive strategies for referrals to secondary and tertiary care.

"There is no doubt that healthy women bring palpable benefits to our economy," chair of the APEC Health Working Group Narong Aphikulvanich affirmed.

"Most illnesses and deaths occur in women at an age when they are leading productive lives and contributing to society and the economy while attaining leadership positions and caring for their family members," Aphikulvanich said. "As such, cervical cancer has reverberating effect on social and the economic welfare of families and society alike."

The World Health Organization's global strategy for cancer elimination aims to achieve three targets: fully vaccinating 90 percent of girls with the HPV vaccine by the age of 15, screening 70 percent of women between the ages of 35 and 45, and providing treatment to 90 percent of women diagnosed with cervical disease.

These targets will help avert more than 74 million new cases of cervical cancer and over 62 million deaths by 2120.

"As the only cancer that is both curable and preventable, cervical cancer presents an opportunity," Dr. Suleeporn Sangrajrang from the Thailand National Cancer Institute that oversees the project said.

"Strengthening interventions across the prevention and control continuum improves the health, well-being,

and economic participation of women and girls. Tracking progress through a dashboard underscores the compelling case for i n v e s t m e n t, "Sangrajrang said.

While most economies have implemented a strategy for cervical cancer elimination, whether through comprehensive elimination program, ongoing development plan, intervention strategies included in a broader cancer plan, there remain gaps implementation.

"The data from the report indicates that most APEC economies are furthest along in meeting targets for cervical cancer treatment," Dr. Ted Trimble of the United States Department of Health and Human Services, who co-led the project, said.

"This reflects a traditional focus of health systems, but in order to reduce the disease incidence, increasing investment and uptake of vaccination and screening are an urgent imperative," Trimble added.

Recognizing the need for multi stakeholder collaboration to build technical capacity and strengthen health equity, the report also spotlights best practices from economies that promote partnerships between government, the private sector and civil society as well as

PhilHealth warns of dangers of heat stroke

MANILA – With the onset of the dry season, the Philippine Health Insurance C o r p o r a t i o n (PhilHealth) advised the public to take necessary precautions to avoid heat stroke.

"Hindi po biro ang heat stroke dahil maaari po itong magdulot ng permanent damage sa utak at iba pang vital organs tulad ng puso at kidneys, kaya iwasan sana nating magbababad sa init (Heat stroke is no joke because it can cause permanent damage to the brain and other vital organs such as the heart and kidneys, so let's avoid soaking in the heat)," PhilHealth acting president and chief executive officer Emmanuel Ledesma Jr. said in a news release on Sunday.

He advised the public to avoid drinking hot beverages like coffee and tea when the weather is too hot.

"Ugaliin din po nating uminom ng tubig para hindi tayo madehydrate (Let's make

it a habit to drink water so we don't get dehydrated)," he added.

According to the US Centers for Disease Control and Prevention, heat stroke is the most serious heat-related illness and can cause permanent disability or death if the person does not receive emergency treatment.

Heat stroke occurs when core body temperature rises to 41°C or higher and the body is unable to cool down.

Symptoms may include confusion, altered mental status and slurred speech; loss of consciousness; hot, dry skin or profuse sweating; seizures; and very high body temperature.

"Those with the highest risk for heat stroke are the elderly, the very young, and people with chronic diseases. Dalhin po agad sa ospital ang sinumang nagpapakita ng sintomas ng heat stroke (Take anyone showing symptoms of heat stroke to the hospital immediately)," Ledesma said.

Ledesma reminded the public that the state insurer covers confinement for heat stroke, sunstroke and heat exhaustion at PHP6,500, including PHP4,550 for hospital fees, and PHP1,950 for professional fees.

"Bilang paunang lunas ay maaari po tayong mag-apply ng bimpo basang tuwalya sa ulo, leeg, kili-kili at singit. Kung maaari ay bigyan din po ng cold water o ice bath ang pasyente upang mapababa ang kanyang body temperature (As a first aid we can apply a wet towel to the head, neck, armpits and groin. If possible, give the patient a cold water or ice bath to lower his body temperature)," he said. (PNA)
