# Riceimportation remains an option for emergency, relief ops

MANILA President Ferdinand R. Jr. Marcos Wednesday said the government is looking at the option of importing rice to beef up the country's supply in the event of natural calamities, such as typhoons and the El Niño weather phenomenon.

assured that the country has ample supply of the staple grain to keep the prices stable in the market.

He also dismissed the possibility of a repeat of the rice crisis in 2018.

"So, we are watching and waiting to see what the production levels are Marcos, however, going to be after the last

## **NWRB** approves hike in water supply allocation for MWSS

MANILA - The National Board Resources (NWRB) has increased the allocation for the Metropolitan Waterworks and Sewerage System for the (MWSS) remaining days of April to help address water interruptions.

During the Laging Water Handa Public Briefing aired over PTV4 on Wednesday, NWRB Executive Director Dr. Sevillo David Jr. said they recognize measures being undertaken by the MWSS to immediately address water supply issues ahead of the El

government is trying to figure out how to boost its buffer stock without causing the rice prices to rise during harvest season, considering that the NFA is only allowed to buy from local farmers.

Under the Department of Agriculture's (DA) 2023 supply outlook, the country's total supply is at 16.98 million metric tons (MMT), which is sufficient to cover this year's demand estimated at 15.29 MMT.

"This would leave the country with an ending balance of 1.69 MMT, which is equivalent to 45 days of buffer stock, instead of the 90-day ideal buffer stock to stabilize the price of rice," a DA briefer said.

# Providing affordable food items to the grassroots

Marcos launched another outlet of the Kadiwa ng Pangulo Program in San Jose del Monte City, Bulacan to provide affordable agrifishery commodities to consumers and a ready market for farmers and fisherfolk.

Marcos is envisioning the program as a platform to bring affordable food items to the grassroot level to manage food inflation, as well as provide more income opportunities for farmers, fisherfolk and micro, small and medium enterprises (MSMEs).

"Ginagawa namin ang lahat upang paramihin ang ating mga Kadiwa hanggang umabot na kahit sa malalayong lupalop at lahat ng ating mga

kababayan ay makaramdam ng kaunting ginhawa dahil nga sa pagbaba ng mga presyo ng bilihin (We are trying our best to open more Kadiwa stores so that it could reach even the farthest areas and every Filipino could at least experience a bit of relief as the prices of basic goods go down)," he said.

The President also awarded interventions amounting to PHP15.793 million for several farmers' cooperatives and associations (FCAs) in Bulacan province.

The Dulong Bayan Farmers Association based in San Jose Del Monte City received PHP5 million from the Department of Agriculture (DA)-National Rice Program for the construction of warehouse with mechanical grain dryer. It also received PHP5.5 million from the DA-National Livestock Program for the Integrated National Swine Production Initiatives for Recovery Expansion and (INSPIRE) implementation.

On the other hand, Biyaya the Matangtubig Irrigators Association, Inc. of Baliuag town, the Sta. Catalina Matanda Bata **Irrigators Association** of San Ildefonso, and the Magmarale Farmers Field School Marketing Cooperative of San Miguel each received PHP1.764 million worth of rice combine harvester from the DA-Philippine Center for Postharvest Development and Mechanization. fellow Indonesians.

"Sadly, right under our very noses, the Philippines is hosting its very own scam hubs," Hontiveros said as she opened the hearing of the Senate Committee on Women, Children, Family Relations and Gender Equality.

She said large c o n d o m i n i u m buildings are being repurposed as living and working facilities for those trafficked persons forced to perform scams on hapless victims.

Hontiveros said these trafficked persons, who are now by the thousands, came from Vietnam, Cambodia, Myanmar, Indonesia, countries in Africa and countries in South Asia.

Last year, Hontiveros exposed a large-scale human trafficking operation that targeted Filipinos looking for jobs abroad. The OFWs were then forced to work as scammers in Myanmar and Cambodia.

"A humanitarian crisis is taking shape. A mass of desperate humanity. Human beings of the world are being hurt, abused and used in order to perpetrate fraud. Nananakit ng kapwa para manloko ng kapwa," (Hurting others to fool others) Hontiveros said in a statement.

statement.

At the hearing, Ridwan (not his real name), an Indonesian national, said he applied to work in the Philippines as a digital marketer and discovered later that the job was to scam fellow Indonesians to invest in fraudulent cryptocurrency investments.

He arrived in the

country on March 7. He said he was greeted by an escort who helped him and two other Indonesians seamlessly pass through the Bureau of Quarantine and the Philippine immigration counters. They were later brought to Bayport West NAIA Garden Residence.

"We instructed to steal the identities of other people to scam targets. Our targets are our fellow Indonesians. We find them on Tinder, Facebook, Instagram. After our targets fall in love with us, we make them invest cryptocurrency. When we do not get victims, we will get punished," Ridwan told committee.

He said fellow workers were electrocuted and punished severely when they failed to do their jobs.

Ridwan said he wanted to leave immediately, but he was asked to pay the PHP100,000 that the company spent to bring him to the Philippines. He left the premises on March 13.

"It is frightening that these criminal activities have been made easy by social media platforms. But it even more frightening to hear how effortless foreigners can get into the country, with the aid of unscrupulous airport or immigration officials. This is a serious national security concern that we must urgently address. We cannot allow these syndicates to turn our country into outlaw territory," Hontiveros said. Geophysical **Astronomical Services** Administration (PAGASA) shows near normal rainfall in Angat area Norzagay, Bulacan from May to September 2023. David also appealed to water consumers to use practical water conservation measures to ensure water supply sustainability in homes, offices, businesses and communities.

## PBBM vows continuous delivery of basic goods, aid amid inflation

MANILA President Ferdinand R. Marcos Jr. on Wednesday vowed to provide Filipino consumers continuous supply of quality and safe food items being sold at the Kadiwa ng Pangulo outlets to cushion the effects of inflation.

During the Kadiwa ng Pangulo launching in San Jose del Monte, Bulacan, Marcos said the initiative will be replicated in various parts of the country, noting that these food outlets would provide consumers with fresh and affordable products, as well as provide ready market to farmers and producers.

"Kaya't tinitiyak namin na magkaroon ng magandang supply sa susunod. Hindi na natin kailangan alalahanin na mauubos (We assure you that there will be more supply next time. There's no need to worry thar products will run out)," Marcos said.

Marcos said the Kadiwa program aided micro, small and medium enterprises (MSMEs) in regaining their footing following the economic impact of the coronavirus pandemic their on businesses.

"Kaya't binibigyan natin ng pagkakataon ang ating mga MSMEs, binibigyan natin sila ng isang lugar, isang palengke, isang merkado kung saan sila makapunta para naman maibenta nila ang kanilang mga produkto (We are giving MSMEs the opportunity -- a single place or market where they could sell their products)," he said.

Kadiwa is a market linkage facilitation program of the Department of Agriculture (DA) that aims at making products

Marcos said the administration will also be focusing on generating not just jobs, but decent and quality work for Filipinos.

Upon his arrival at the convention center, Marcos personally turned over three combine harvesters to the Biyaya Matangtubig Irrigators, Sta. Catalina

Matanda Bata Irrigators, and Magmarale Farmers' Field School.

Marcos also handed over 10 Negokarts, worth PHP30,000 each, and three sari-sari store packages worth PHP20,000 each to identified beneficiaries during the event.

Various government agencies, such as the Department of Labor and Employment (DOLE), gave livelihood assistance worth PHP1 million to 50 members of a local coffee farmers' group in the area.

The DOLE through its Integrated Livelihood Program also extended PHP4.7 million worth of assistance to beneficiaries under its Tulong Panghanapbuhay sa Ating Disadvantaged Workers Program (TUPAD).

Meanwhile, the DA also awarded certificates for the construction of a warehouse with

mechanical grain dryer worth PHP5 million and Integrated Swine **Production Initiatives for** Recovery and Expansion worth PHP5.5 million to the Dulong Bayan Farmers' Association.

The Department of Social Welfare and Development likewise distributed food packs worth PHP5,000 each to the residents under its Assistance to Individuals in Crisis Situation program while the Department of Trade and Industry provided loan assistance worth PHP3.4 million under its RISE UP Loan Program to selected beneficiaries.

### **PSWDO** holds consultation dialogue on programs and services for older persons

The Provincial Social Welfare and Development Office (PSWDO) partnership with the National Commission of Senior Citizens (NCSC) conducted a one-day Consultation Dialogue on Programs and Services for Older Persons recently at the Cavite Collaboration Center for Public Health Auditorium, Trece Martires City. Heads representatives from the Office of Senior Citizens Affairs, senior citizen officers from all the 23 local government units of Cavite as well as the City and Municipal Social Welfare and **Development Officers** were present in the event.

The consultation dialogue formally started through the acknowledgement of participants done by Mr. Ciriaco S. Angeles, Regional and Provincial Federation of Senior Citizen President, immediately followed by messages of Provincial Administration for Community Affairs Alvin S. Mojica and Board Member Romel R. Enriquez, Chair-Committee on Social Services, Family, Women, Children and Elderly. They both stressed that the consultation dialogue will be a great help to formulate programs for the elderly and assured that the provincial government will support the undertakings.



Mr. Jarryd Bello represented Vice Governor Athena Bryana D. Tolentino NCSC under the Office and relayed message emphasizing the importance of providing programs and services that cater to the needs of older persons, as they are essential part of society.

S Commissioner Ricardo Rainier S. Cruz III's discussion focused on the transition, gaps and challenges in the implementation of programs and services for older persons which were all previously undertaken by the Department of Social Welfare and Development (DSWD). Among the programs mentioned are the distribution of social pension and registration of senior citizens (online and offline) and emphasized proposal to rationalize the selection of indigent senior citizens.

Republic Act 11350 the National Commission for Senior Citizens Act highlighted in the presentation of Commissioner Reymar R. Mansilungan along with other legislations implemented to ensure

the welfare of senior citizens. This law which created the her of the President mandates commission to ensure the full implementation of laws, policies, and programs of the government on senior citizens, review and conduct related studies, and recommend policy to Congress and the President. It abolishes National Coordinating and Monitoring Board created under RA 9994 and transfers related functions from the DSWD to NCSC.

> On the other hand, Ms. Jhoana M. Nodora of DSWD-Region IVA discussed the updates of the programs and services for senior citizens offered by their agency. Services include social pension for indigent senior citizens, centenarians and assistance to older persons.
