### Rise dengue cases possible despite drought-DOH

MANILA, (PIA) -There is a high possibility that dengue cases will still increase in the country even though El Niño has been officially declared due to the increase in public water storage that is infested with mosquitoes, according to the Department of Health.

### Solon recommends safety net for farmers amid El Niño

MANILA – A House leader on Tuesday recommended setting up a financial safety net to support farmers affected by the El Niño phenomenon.

In a statement, Deputy Speaker Camille Villar said the government should create a fund that farmers may tap for assistance to cushion the possible impacts of the weather phenomenon, particularly on agricultural production.

"It is important to discuss this now and prepare for contingency measures especially for our small-scale farmers," Villar said.

Villar cited a previous El Niño episode in the country in 2019, which cost the agriculture sector an estimated PHP8 billion in damage.

"In previous El Nino episodes in the Philippines, there were severe dry conditions that affected the agricultural sector and wrought damage to other essential sectors in billions of pesos. It was also during El Nino that powerful typhoons struck the country," she said.

The Philippine Atmospheric, Geophysical, and Astronomical Services Administration (PAGASA) last week announced the onset of the El Niño phenomenon, which is currently "weak" but likely to show "signs"



of strengthening in the coming months."

### DepEd to get rid of 'remedial class' stigma through NLC

MANILA – The Department of Education (DepEd) is planning to dismiss the "remedial class" or "summer class" stigma, which is required for students who got low or failing grades during the past school year.

During a press briefing by the Presidental Communications Office on Tuesday, DepEd spokesperson Undersecretary Michael Poa said they are planning to do this

through the National Learning Camp (NLC) that is set to be rolled out during the 2022-2023 End-of-School Year (EOSY) break.

"Dati kapag nag-summer class ka o nag-remedial class ka, ibig sabihin noon ay bumagsak ka or mababa iyong grades po (In the past, going to summer or remedial classes means you obtained failing or low grades). That is stigma that we want to get rid of. That

is why, kasi nga ang priority natin ngayon (our priority now) is learning recovery after the pandemic," Poa told reporters.

The NLC will be implemented under the DepEd's National Learning Recovery Program, which is aimed at addressing learning loss and in support of the MATATAG Basic Education Agenda.

Under NLC, Poa said there are three differ-

ent camps – Enhancement Camp, Consolidation Camp, and Intervention Camp.

Experts warned that the El Niño would most likely lead to a new spike in temperatures and trigger more extreme weather and climate events, with crops feeling mostly the impact that could affect food security in the regions.

Villar pointed out that more than 30 provinces may experience dry spells or below normal rainfall conditions in the coming months up to next year.

"We need to be bet-

ter prepared and ready to extend assistance to farmers whose livelihoods are at risk so that they can have some sort of safety net or social protection either in the form of loans, direct cash assistance or cash-forwork," she said.

Villar earlier filed House Resolution 1024 to look into possible government interventions for the different sectors in the light of the return of El Niño. (PNA)

gue cases?)" asked DOH spokesperson Undersecretary Enrique Tayag.

When there is a dry spell or drought, people tend to save water in containers or vessels which tend to have the possibility of becoming breeding places for mosquitoes.

To avoid this, Tayag advised the public to ensure placing a lid or cover on these containers.

Tayag said that during the 1998 El Nino, there was a dengue fever outbreak in the country despite the fact that people lacked water, attributing it to improper storage of water.

Based on the DOH's latest epidemic-prone disease case surveillance report, 72,333 dengue

cases were recorded from January to June 17, 2023, which is 14 percent higher than the 63,526 in 2022.

There were also 249 deaths due to dengue this year.

Health Secretary Ted Herbosa, for his part, emphasized that the public should be careful against mosquito-borne diseases such as dengue, and water-borne diseases such as cholera.

Last week, PAGASA declared the onset of El Niño—a phenomenon characterized by abnormal warming of sea surface temperatures in the central and eastern equatorial Pacific Ocean and below normal rainfall. (PIA-NCR)

Mr. Lester Zafra, the representative for the Rescue MARCH Philippines, revealed that the activity was initiated in 2015 as part of the proactive preparation of the country for "The Big One" disaster.

Meanwhile, Ms. Eloisa Rozul, head of OPDRR-MO, imparted that the event served as a way to assess the capabilities, interoperability, and endurance of the responders in various scenarios. With this, strengths and weaknesses of every participant would be evaluated.

The march route began at Barangay Asis III, Mendez, and ended at the track oval of Tagaytay City. The exercise consisted of 3 stations that were designed to evaluate the participants' responses to crises, such as when an individual sustained an injury, and when a person suddenly collapsed. The final station was the static display, presenting the available protective and rescue tools and equipment of various local government units (LGUs).
