MANILA - President Ferdinand R. Marcos Jr. has approved the National Tourism Development Plan (NTDP) 2023-2028 which will serve as his administration's blueprint and development framework for the tourism industry.

## DA eyes 'regulated' importation amid rising onion prices

MANILA— The Department of Agriculture (DA) on Tuesday said it might consider "regulated" importation amid renewed spike in the prices of onions.

In a media interview, DA Deputy Spokesperson Rex Estoperez said the import volume might be at 22,000 metric tons for red and white onions or equivalent to a month-long consumption volume.

"Other alternatives that we have considered also is that, will we import? Kung ganoon patuloy 'yung presyo

(If the price continues that the DA wanted to to be this [high]), we might import... but on a regulated or calculated basis," he said.

Based on the DA's latest price monitoring, the prevailing price of local red onion in Metro Manila ranges from PHP160 to PHP200 per kilogram, while local white onion is pegged from PHP150 to PHP200 a kilo.

Estoperez noted that the farmgate price of onions is now at PHP120 per kilo as the country approached the off-season.

PH daily average of new Covid cases up by 31% from May 8-14

MANILA – The country's daily average of new coronavirus disease 2019 (Covid-19) cases increased by 31 percent from May 8 to 14, the Department of Health (DOH) reported Monday.

In its latest case bulletin, the agency recorded 1,773 daily infections which is a 421-case increase

from the 1,352 recorded between May 1 to 7

Additionally, there were 12,414 new cases in the recent week.

The tally of severe and critical infections increased to 437 from the previous week's 410.

Only 18.8 percent or 394 out of the 2,093 intensive care unit (ICU) beds are in use,

while 21.7 percent or 3,791 of 17,454 non-ICU beds are utilized.

At least 78,443,972 or 100.4 percent of the country's target population (78,100,578) have been vaccinated against Covid-19, including 82.16 percent of 8,721,357 senior citizens, as of March 19

A total of 23,811,248 have received booster



shots out of the fully vaccinated population. To date, the coun-

try has logged over 4.1 million coronavirus cases and 66,453 deaths since January 2020.

sco said in a Palace press briefing.

"This NTDP is the result of consultation among tourism coordinating council as well as our various tourism stakeholders from our regions all over the PH," Frasco said.

"As a whole, the NTDP shall provide a guide for our regions as well [as] in the effort of President to spread countrywide development through tourism," she added.

The NTDP 2023-2028, Frasco said, lays down the Department of Tourism's (DOT) seven objectives which focus on the essential pillars of development that would give the Philippines a "fighting chance at becoming a tourism powerhouse."

Frasco said the NTDP aims to promote the Philippines domestically and internationally, as well as address several issues on tourism development, including challenges on infrastructure, connectivity, and digitalization.

She added that the national development plan seeks tourism equalization, enhancement of overall tourism experience, and strengthening of tourism governance.

"We are very grateful to our President for articulating very early in his administration his priority for tourism development. And this has resulted in a convergence among government agencies as far as giving full support to the development of the industry, recognizing the losses

that have ensued as a result of the pandemic and various calamities," Frasco said.

Frasco said the NTDP would give Filipinos an opportunity to enjoy gainful employment and livelihood and the Philippines a better position in its primary role in the Southeast Asia and the world.

"This is just one of the many programs under the Marcos administration that aims to maximize domestic tourism, recognizing its strength to support our economy as well as to usher in more international tourists," she said.

Marcos had already been informed of the overall proposed financial consideration for the NTDP 2023-2028, according to Frasco.

### 'Enhanced' tourism slogan

Quizzed about the change in the DOT's marketing strategy, Frasco said the Marcos administration's focus is to "highlight the heart and soul of the Filipinos."

She said there would be consultations with tourism stakeholders before the government launches its new enhanced tourism slogan promoting the Philippine experience in the coming weeks.

"The main change first of all is that the focus of the DOT will be to highlight the heart and soul of the Filipino that is evident in our culture, our festivals, our food, the local products of our small and medium enterprises are living cultur-

MANILA - The Marcos administration has earmarked about PHP138.77 billion for higher education programs and initiatives, the Department of Budget and Management (DBM) announced Tuesday.

The appropriated budget is part of the line items under the 2023 General Appropriations Act (GAA), the DBM said in a statement.

It said about PHP107.04 billion of the PHP138.77 billion budget would go to state universities and colleges (SUCs), while the remaining PHP31.73 billion will be given to the Commission on Higher Education (CHED).



### DBM: Gov't personnel to get midyear bonus starting May 15

MANILA - State riod. workers will receive their midyear bonus starting May 15, confirmed Department of Budget and Management (DBM) Secretary Amenah Pangandaman on Sunday.

"I am happy to announce that our civil servants will be receiving their midyear bonus this year, as provided in the agency-specific allocation under the 2023 Gen-Appropriations eral Act or GAA. Alam naman po natin na isa ito sa mga inaabangan ng ating mga kapwa kawani ng gobyerno na talagang makatutulong sa kanilang arawaraw na pangangailangan (We know that fellow government employees look forward to receiving this bonus which can really help in their everyday needs)," she said in a news release Sunday.

"So, we are reminding all government agencies and offices to ensure the timely release of bonuses to their employees or as stipulated in our existing rules and regulations, simula (starting) May 15 po 'yan."

The midyear bonus is equivalent to one month basic pay as of May 15 and shall be given to entitled personnel who have rendered at least a total or aggregate of four months of service from July 1 of the immediately preceding year to May 15 of the current year.

The employee shall also remain in the government service as of May 15 of the current year and have obtained at least a satisfactory performance rating in the immediately preceding rating period or the applicable performance appraisal pe-

will be given to all positions for civilian personnel, whether regular, casual, or contractual, appointive or elective, full-time or part-time, now existing or hereafter created in the Executive, Legislative, and Judicial branches, Constitutional Commissions and other Constitutional offices, state universities and colleges, and government-owned or -controlled corporations (GOCCs) covered by the Compensation and Position Classification System, and in local government units.

Entitled personnel to receive the mid-year bonus also include the military personnel of the Armed Forces of the Philippines under the Department of National Defense; personuniformed nel of the Philippine National Police, Philippine Public Safety College, Bureau of Fire Protection, and Bureau of Jail Man-agement and Penology of the Department of the Interior and Local Government; Bureau of Corrections of the Department of Justice; Philippine Coast Guard of the Department of Transpor-tation; and National Mapping and Resource Information Authority of the Department of Environment and Natural Resources.

The grant of midyear bonuses for personnel of covered GOCCs shall be determined by their respective governing boards while those of provinces, cities, municipalities, and barangays shall be determined by their sanggunian (council). (PNA)

### House bill seeks monthly fuel subsidy for municipal fisherfolk

MANILA – Municipal fisherfolk will receive a monthly fuel subsidy of not less than PHP1,000 under House Bill No. 8007 or the "Pantawid Pambangka Act of 2023".

The Department of Agriculture (DA) will administer the monthly subsidy program, with the amount subject to revision yearly to account for inflation.

"Despite the fishing sector's major contribution, our fishermen continue to be among the fundamental sectors' poorest people. Hindi po makatarungan na kung sino pa ang producer ng pagkain, sila pa ang napapabayaan at pinaka-naghihirap (It is not fair that they produce food but they are neglected and suffering the most," AGRI Partylist Rep. Wilbert Lee, the bill author, said in a news release on Sunday.

The beneficiaries of the bill shall be municipal fisherfolk within municipal waters, whether coastal or inland, and who use motorized fishing ves-

sels of three gross tons or less provided they are registered under BFAR's National Program for Municipal Fisherfolk Registration.

If passed into law, beneficiaries of the program will be automatically covered by the Philippine Health Insurance Corporation.

The Social Security System shall also provide microinsurance mechanisms to beneficiaries.

The equivalent of 10 percent of any increase in the collections in the excise tax on fuel shall be earmarked for the implementation for this Act, which shall be indicated as a separate line item under the annual appropriations of the DA under the General Appropriations Act.

According to the Bureau of Fisheries and Aquatic Resources (BFAR), the municipal and aquaculture sub-sectors contributed 73 percent to the total production of the fisheries sector from 2011 to 2020.

Based on the preliminary estimates of the Philippine Statistics Authority's 2021 poverty data, fisherfolk registered the highest poverty incidence rate of 30.6 percent, higher than the 26.2 percent recorded in 2018.

"We are not only showing the importance of their valuable contribution, this (subsidy) could also enhance their production which is beneficial also to the consumers," Lee said. (PNA)
