## Bills to address climate change threats gain traction in House

House of Representatives has approved two measures that will address the ill effects of climate change through the rehabilitation and conservation of key resources.

During Monday's plenary session, a total of 268 lawmakers voted to approve on fi-

MANILA - The nal reading House Bill 8204, which seeks to enhance the conservation and restoration of peatlands to allow the country to manage it sustainably given their value as natural solutions to address climate change.

Speaker Martin Romualdez said peatlands, which are wetland ecosystems with accumulation of decomposed plant materials, have peat and permanent water logging and vegetation in the form of trees, shrubs, grasses, and mosses.

# PBBM urges parents to vaccinate kids vs. measles, rubella, polio

MANILA - President Ferdinand R. Marcos Jr. urged parents to have their children immunized against measles, rubella and polio.

In a video uploaded on his official Facebook page, Marcos said parents should take advantage of the Department of Health's month-long (DOH) "Chikiting Ligtas" program aimed at protecting their children from the vaccine-preventable diseases.

"Bilang mga ma-

gulang, nasa atin ang responsibilidad na proteksyunan ang ating mga anak laban sa sakit. Hangad po nating magkaroon ng ligtas na kapaligiran at malusog na pangangatawan ng bawat batang Pilipino (As parents, it is our responsibility to protect our children from any disease. Our goal is to provide a safe environment and good health for every Filipino child)," Marcos

"Kaya ngayong buwan ng Mayo, makiisa po tayo sa kampanya ng Kagawaran ng Kalusugan laban sa tigdas, rubella at polio (That's why on this month of May, let us join the Department of Health's immunization campaign against measles, rubella, and polio)," he added.

The nationwide Chikiting Ligtas 2023 aims to vaccinate at least 95 percent of the total population of children aged 0 to 59 months old against polio and nine to 59 months old against

measles and rubella.

Marcos assured the parents that the vaccines against the contagious diseases are "free, safe and effective."

## DOH warns public vs. illnesses due to El Niño

MANILA - The Department of Health (DOH) on Tuesday warned the public against certain illnesses that may arise due to the El Niño season.

In a message to reporters on Tuesday, the DOH reminded the public to take precautionary measures, saying that extreme weather heat, scarcity of clean water, and frequent rains could cause diseases like asthma, cholera, dengue, diarrhea, fatigue,

food poisoning, heat cramp, heat stroke, nausea, sunburn, typhoid fever, and other diseases due to consumption of food affected by red tide.

"To avoid heat stroke and exhaustion, hydrate yourself and drink water always, and refrain from going out during 10 a.m. to 3 p.m.," the DOH said.

"Wear sunglasses, sunscreen, and light clothes. Bring an umbrella whenever you have to get exposed to

the sun."

To prevent dengue, the DOH reminded the school administrations and the public to observe the 5S strategy of search and destroy mosquito breeding sites; uphold self-protection like using insect repellents; seek early consultation at the nearest health care facility; support fogging, spraying, and misting in hot spot areas; and sustain hydra-

tion for climate change mitigation considering that they function as carbon sinks because they take in and store more carbon than they release.

"Hence, this measure will provide opportunities for the country to achieve multiple benefits for biodiversity and climate resiliency, including financing through market-based instruments and mechanisms," he said

The bill tasks the Department of Environment and Natural Resources (DENR), through the Biodiversity Management Bureau (BMB), to lead the monitoring and overall implementation of the proposed legislation.

Under the measure, the DENR shall develop a National Peatland Conservation and Restoration Program to provide direction, support and guidance to the local government units (LGUs) and stakeholders in the development and implementation of their local peatland conservation and restoration programs.

The program will include a mapping of peatlands in the country, and assessment of vulnerability to climate change and disaster risk management, among others.

The proposed law requires that peatlands classified as agricultural lands will be reclassified to either forest lands or national parks, upon DENR's recommendation

The bill also prohibits the drainage, deforestation, clearing, dumping of waste and introduction of invasive alien species in peatlands.

The chamber also overwhelmingly approved with 284 votes House Bill 7754, which seeks to reforest and re-

### WHO report warns of accelerating food insecurity worldwide

NEW YORK – The World Health Organization (WHO) new report, "Grow food, not tobacco", has recalled that around 349 million people are facing acute food insecurity, many of them in some 30 countries on the African continent, where tobacco cultivation has increased by 15 percent in the last decade.

Ahead of World No Tobacco Day on May 31, WHO deplored that 3.2 million hectares of fertile land across 124 countries are being used to grow deadly tobacco -- even in places where people are starving.

With hunger spreading worldwide and tobacco responsible for eight million deaths each year, countries should stop subsidizing tobacco crops and help farmers grow food.

According to WHO, nine of the 10 larg-

The bill proposes to amend Section 43 of Presidential Decree 705 or the "Revised Forestry Code of the Philippines" and reduce from five years to three years the period needed to reforest unutilized or abandoned fishponds.

Romualdez said instead of remaining an idle asset, these abandoned or unutilized fishponds can be used to help in efforts to safeguard and protect the environment.

"This measure also aims to address the ill effects of climate change by actively promoting reforestation in areas that can be planted with trees," he said.

The main objective of HB 7754 is to expedite

est tobacco cultivators are low and middle-income countries. Tobacco farming compounds these countries' food security challenges by taking up arable land. The environment and the communities which rely on it also suffer, as the crop's expansion drives deforestation, contamination of water sources and soil degradation.

The report also exposes the tobacco industry for trapping farmers in a vicious cycle of dependence and exaggerating the economic benefits of tobacco as a cash crop.

Dr. Rüdiger Krech, WHO Director for Health Promotion, said the crop contributes less than 1 percent of gross domestic product (GDP) in most tobacco-growing countries and that the profit go to the world's major cigarette-mak-

the reversion of unutilized or abandoned fishponds to forest lands so that these can be "immediately rehabilitated and reforested".

It also mandates the Department of Agriculture and the Department of Environment and Natural Resources to jointly set guidelines in the determination and rehabilitation of abandoned, undeveloped or underutilized fishponds covered by Fishpond Lease Agreements.

The measure was introduced by Agusan del Sur Representatives Alfelito Bascug and Eddiebong Plaza, together with Bulacan Rep. Linabelle Ruth Villarica, and was approved in the House Committee on Natural Resources chaired by Cavite Rep. Elpidio Barzaga. (PNA)

# House passes salt industry dev't, agri info system bills

MANILA – The House of Representatives on Monday approved on the third and final reading a bill seeking to revitalize the Philippine salt industry and another measure establishing an online agriculture information system (AIS) throughout the country.

With 287 affirmative votes, the House passed House Bill (HB) 8278, or the proposed Philippine Salt Industry Development Act, that is listed by the Legislative Executive Development Advisory Council (LEDAC) as one of the priority legislations of President Ferdinand R. Marcos Jr.

'The significance of the salt industry hasn't been lost on our President and concurrent Department of Agriculture (DA) chief Ferdinand Marcos Jr. He knows that we need to correct the sad irony that the country imports nearly 550,000 metric tons (MT) or 93 percent of its requirement for salt. This is indeed a sin," Speaker Ferdinand Martin G. Romualdez said in a statement.

The bill has been described by its authors as a whole-of-nation, whole-of-society and whole-of-government approach as it seeks to revitalize the salt industry.

Under the measure, the government shall provide support through appropriate technology and research, as well as adequate financial, production, marketing and other support services, in order to revitalize the salt industry, attain increased income for salt farmers and salt producers, achieve salt self-sufficiency, and become a net exporter of salt.

HB 7828 provides

that salt -- whether unprocessed or processed -- is hereby classified as a basic agricultural product with all its necessary legal and regulatory implications.

The DA shall also ensure that salt is a priority commodity to be produced locally in areas or regions identified in proposed law, as well as in the development plan for the salt industry.

The measure establishes the Philippine Salt Industry Devel-Roadmap opment (PSIDR) which shall include programs, projects, interventions and incentives for the development and management, research, processing, utilization, modernization business development and commercialization of Philippine salt.

HB 7828 also creates the Philippine Salt Industry Development Council (PSIDC) to ensure the unified and integrated implementation of the PSIDR and accelerate the modernization and industrialization of the Philippine salt industry.

The PSIDC is tasked to formulate the PSIDR containing the short-term, medium-term, and long-term development plan; identify specific and priority programs and projects in support of, and in line with the Roadmap; provide development funds, technical assis-

tance, and equipment to salt farmers and the industry; and identify sources of financing and facilitate credit windows with government banks and the Agricultural Credit Policy Council to expand the salt industry development.

Through the DA-Bureau of Fisheries and Resources Aquatic (BFAR), the PSIDC will put up new small scale artisanal salt farms; increase production of local salt by increasing land area devoted to salt and improving farm productivity; institutionalize capacity building for salt farmers through the Agricultural Training Institute; strengthen market linkage and promotion of Philippine salt; and conduct continuing research and development (R&D) on innovation and modernization of the salt industry; among others.

The measure also mandates the utilization of public lands previously intended for fishpond development and those with existing fishpond lease agreements.

It also requires that all salt produced or manufactured in the Philippines for export shall be labeled as "Made in the Philippines" in a prominent and conspicuous manner on the product, its packaging and accompanying documentation.

# Maynilad earmarks over P10B for pipe replacements

MANILA – Maynilad Water Services Inc. (Maynilad) has allotted more than PHP10 billion for pipe replacement projects from 2023 to 2027, to be done in various portions of its concession areas.

Maynilad, in a press release on Tuesday, said it is replacing a total of 477.2 kilometers of old, leaky pipes over the next five years, in line with its program to upgrade the distribution system and reduce water losses.

"When we took over Maynilad in 2007, the pipe network we inherited included the oldest water system in Asia. We are committed to upgrading our network for the benefit of our customers," Maynilad chief operating officer Randolph Estrellado said.

Once completed, this will bring the total length of pipes replaced within the West Zone to 3,643 kilometers, which is 78 percent of the distribution system that the water firm inherited from the government upon re-privatization in 2007.

From January to April 2023, pipe replacements completed were in the cities of Caloocan, Quezon, Malabon, Navotas, Valenzuela, Manila, Pasay, Paranaque, Imus and Muntinlupa.

These activities are being fasttracked so the water firm can recover more water supply in preparation for the El Niño weather phenomenon.

For 2023 alone, Maynilad earmarked almost PHP4 billion for its Non-Revenue Water (NRW) Management Program, which is a 25 percent increase from its NRW capital expenditure of PHP3.2 billion in 2022. (PNA)

mandates that no person shall import salt without securing the appropriate authorizations from the Department of Health's Food and Drug Administration and the DA-BFAR for food grade salt; and from the DA-BFAR for industrial salt.

#### House Bill 7942

Voting 280-0 with no abstentions, HB 7942, or the Agriculture Information System Act also hurdled the plenary with an end view of creating a wider range of market linkages among farmers and agricultural buyers.

It mandates all cities and municipalities to establish an AIS which shall serve as a dynamic online computer database where information on then demand for specific agricultural and fisheries commodities is gathered and uploaded simultaneously with the production data from farmers in every barangay.

The AIS shall merge and synchronize ag-

ricultural data from different sources into a cohesive database designed to facilitate linkages from place of origin to local and, ultimately, global markets.

The AIS shall be integrated with the existing systems of the Department of Agriculture.

All cities and municipalities shall encourage and facilitate the free registration of farmers, fisherfolk, as well as buyers transacting within their respective areas in the AIS.

Romualdez said once enacted into law, HB 7942 could pave the way for the full development of the agriculture sector and the attainment of national food security through data-driven science and technology, planning and distribution of resources.

"Improving, developing and modernizing the farming and fisheries sector is important to us because this area of the economy is one of the country's largest employers. Millions of our kababayan (countrymen) and their families depend on it. Farming and fishing are their sources of livelihood and income," he said. (PNA)

## LOCAL FARMERS IN CALABARZON TO RECEIVE TRAINING ON MODERN FARMING TECHNIQUES

## Romualdez vows long-term solution for Batangas sugar farmers

MANILA – House of Representatives Speaker Ferdinand Martin G. Romualdez on Tuesday pledged to help find a long-term solution to the plight of all sectors affected by the closure of the Central Azucarera de Don Pedro, Inc. (CADPI) in Nasugbu, Batangas.

Romualdez made the pledge after leading the distribution of PHP10,000 cash aid each to 800 sugar farmers who lost their livelihood after the shutdown of the largest sugar mill in the province.

"I have requested all government agencies now here with us to pool their resources together and come up with a long-term and comprehensive solution to the displacement issue affecting the farm workers and their families. Inaasahan ko po ang report nila sa office ko sa lalong madaling panahon (I am expecting them to submit their reports to my office at the soonest possible time)," he said in his brief message.

He said the financial assistance, which his office secured through the Assistance to Individuals in Crisis Situ-

ation (AICS) program of the Department of Social Welfare and Development (DSWD), is just the beginning of collaboration to help the sugar farmers.

Meanwhile, DSWD officials assured that similar payouts would be held in the coming days to help those adversely affected by the sugar mill closure. (PNA)
