DFA sees PH forging ahead beyond pre-pandemic situation

MANILA – The Department of Foreign Affairs (DFA) is looking to go beyond the restoration of the Philippines' national condition before the Covid-19 pandemic to attain middle power status in the next few decades.

In his message celebrating the 125th Phil-

ippine Independence Day on Monday, DFA Secretary Enrique Manalo said the theme "Kalayaan. Kinabukasan. Kasaysayan." (Independence. Future. History.)" meant not only shaping the country's past but also the future.

"DFA pays tribute to our rich and proud his-

tory by drawing wisdom from its lessons, guiding our steadfast commitment to an independent foreign policy that navigates the complexities of our time," Manalo said.

The Philippines, he said, "stands on the cusp of attaining middle power status" and

Gov't eyes cash aid distribution to Mayon evacuees in Albay

MANILA – The government is considering granting financial assistance to thousands of families affected by Mayon Volcano's ongoing restiveness, Social Welfare Secretary Rex Gatchalian said on Tuesday.

In a Palace press briefing, Gatchalian said the Department of Social Welfare and Development (DSWD), upon the instruction of President Ferdinand R. Marcos Jr., is coordinating with the local government units in Albay province for the possible distribution of cash aid to families who have been displaced due to Mayon's volcanic activity.

This, as Gatchalian acknowledged that food packs would not suffice the needs of those who were forced to leave their resi-

dences, given the risks posed by the possible hazardous eruption of Mayon Volcano.

"Nag-uusap na rin kami ng (We are talking to the) local government, upon the instruction of the President, na baka kailangan sustentuhan o ayudahan natin ng (to discuss the possibility of distributing) financial assistance,"

PBBM eyes 'large' water impounding areas to avoid flooding in NCR

MANILA – President Ferdinand R. Marcos Jr. on Tuesday bared his administration's plan to build "large" water impounding facilities in areas outside of Metro Manila in an effort to control flooding in the country's metropolis.

Marcos made the

pronouncement in a video message after his sectoral meeting with the Department of Public Works and Highways (DPWH) at Malacañan Palace in Manila to discuss the flood control programs.

Marcos stressed the importance of pursu-

ing more water impounding projects in the country, saying the proposal will not just focus on flood mitigation.

He said the impounded water could also be used for agricultural purposes.

"Huwag natin naman sana tinatapon 'yung tubig dahil kailangan na natin iyang
tubig na iyan. So, gumagawa rin kami ng
paraan para maipon
ang tubig. Naghahanap ngayon kami ng
mga lugar sa labas ng
Maynila kung saan
puwedeng maglagay
ng mga malaking large
na impounding areas
(Let us not waste the
water because we will
need that. That's why

we are also looking for a way to impound the water. We are now looking for areas outside Metro Manila where we can build large impounding areas)," Marcos said.

"Para doon natin kokontrolin, hindi na papasok dito sa Maynila. At mayroon pa tayong naipon na tubig para sa agrikultura, para sa iba't ibang

gamit (We will control the flow of water and stop that from submerging Metro Manila. We would also be able to collect the water and use that for other purposes such as agricultural purposes)," he added.

Gatchalian said.

Gatchalian said he is in constant communication with Albay Gov. Edcel Greco Lagman, the affected LGUs, and the lawmakers from the province to determine the amount of money that would be given to each household.

"Alam naman natin ang pagpapatakbo ng (We all know that running the) evacuation centers [is the responsibility] of the local government units. But the DSWD, upon instruction of the President, will give them the necessary logistical support," Gatchalian said.

As of June 12, some 9,338 families or 36,814 persons from 26 villages in Albay have been affected by Mayon Volcano's unrest, according to the DSWD data.

For now, the evacuees would receive family food packs for the next 45 days, Gatchalian said.

Gatchalian also noted that the Office of Civil Defense had sent filtration machines to Albay to address the concern of potable water in the province.

He ensured that Marcos is "carefully and constantly" monitoring the situation and developments in Albay province to make sure that the affected families are getting the necessary

assistance from the government.

"The President is monitoring the situation carefully. We've been in constant communication since last week, on a daily or hourly basis, about his directives on making sure that lahat ng mga na-evacuate ay may pagkain (all evacuees have food to eat)," he said.

Department of Health (DOH) Secretary Ted Herbosa, who also joined the press conference, said the department's Water, Sanitation and Hygiene (WASH) team has been deployed to overcrowded evacuation areas.

"I will send another team, para ma-augment sila kagaya noong (to augment more personnel) alternating with waves. So, we need to send more health teams to the area and, sabi sa akin, mga 90 days pa daw. So, it looks like this (will be) a long-drawnout activity," he said.

Mayon's restiveness started to escalate on June 8, prompting the Philippine Institute of Volcanology and Seismology to place it under Alert Level 3.

The entire Albay province was also placed under a state of calamity. (PNA)

is looking to become the world's 16th largest economy by 2040.

"Our international engagements and partnerships play a vital role in realizing these ambitions while ensuring concrete benefits for our people," he said.

He noted that the DFA was one of the first agencies established following the country's independence 125 years ago and had the original objective of attaining international recognition for the Philippines as the first Asian republic.

Since then, he said the country has upheld the principles of decolonization, human rights and equality.

"These fundamental principles have shaped

directed the Water Resources Management Office (WRMO) of the Department of Environment and Natural Resources (DENR) to come up with a "comprehensive" plan to protect coastal communities and Metro Manila from flooding, Communications Secretary Cheloy Garafil said in a statement.

This, as Marcos noted that the DPWH's flood control projects in Metro Manila and its surrounding areas have an estimated cost of PHP351 billion, Garafil said.

"Marcos underscored the need for a comprehensive plan to control where the floodwaters should go and what should be done," she said.

Garafil noted that the briefing also focused on other ongoing flood control projects in the provinces of Pampanga, Cavite and Leyte, as well as in Cagayan de Oro City.

She said there was also a discussion on the construction of access roads leading to irrigation areas identified by the National Irrigation Authority under the Katubigan Program implemented jointly with the DPWH.

acquire more donations and considering procurement of additional jabs.

However, there are "snags and issues," which may slow down the procurement process, he said.

"So, the issue of the vaccine is in terms of the EUA (emergency use authorization). So, to procure it, kailangan ma-i-rehistro sa ating (they have to be registered with the) FDA (Food and Drug Administration). But, we are trying hard to get all these bivalent (vaccines)," he said.

Earlier, the DOH reported that 1.002 million doses of Pfizer's bivalent jabs from the COVAX Facility would arrive in March.

Since the declaration of a state of calamity due to Covid-19 lapsed, clauses on indemnification and immunity from liability found in the agreements with the donating countries and/or manufacturers remain key impediments to the delivery of the donated bivalent vaccines. (PNA)

DOH distributes bivalent Covid jabs, negotiates to acquire more

MANILA – The Department of Health (DOH) has begun distributing the 390,000 bivalent coronavirus disease 2019 (Covid-19) vaccines donated by the Lithuanian government.

"As we speak, I think they have already been

redistributed to the different region(al offices) of the Department of Health," Health Secretary Teodoro Herbosa said in a Palace press briefing on Tuesday.

Herbosa noted that most of the jabs went to the National Capital Re-

gion while the rest were distributed to the other regions.

The elderly, individuals with co-morbidity, and health care workers will be prioritized in the administration of the bivalent vaccines as booster shots.

The prioritized population must be vaccinated immediately as the bivalent doses only have a six-month shelf-life upon delivery.

"So, kapag binili mo iyan (if you buy them) out of the shelf, like this one, this donation, they end on November 23, that's the expiry date," he

Although the World Health Organization has already declared an end to Covid-19 as a public health emergency, Her-bosa emphasized that the public must not be complacent in its fight against the virus and get

vaccinated or receive booster shots.

He explained that getting infected could still lead to death, especially among individuals with co-morbidity.

Acknowledging that the donated doses are not enough, he said the DOH is negotiating to
