Marcos wants gov't to develop semiconductor industry

MANILA – President Ferdinand R. Marcos Jr. has called on the government and key stakeholders to prioritize the growth of the semiconductor and electronics industry, highlighting its substantial potential to boost the economy.

In a meeting with the Private Sector Advisory Council-Education and Jobs Sector Group (PSAC-EJSG) in Malacañang Tues-

day, the President discussed updates on previous recommendations and new proposals concerning the semiconductor industry.

“Actually, we really need to push on the semiconductor industry. It’s because, again, it’s not something that we had in mind but the situation — considering how much money we make as the income we get from exports al-

ready,” Marcos said.

He emphasized the need for a stronger focus on the sector to enhance its contribu-

tions to the country’s economy.

“We really should be focusing on it more. So, let’s do that now.

Cavite students learn disaster preparedness via video game



KAWIT, Cavite (PIA) — Over 800 students from Emilio Tria Tirona Memorial National Integrated High School in Kawit, Cavite get immersed in an innovative disaster management lecture, learning about flood preparedness through

the interactive online video game Minecraft.

This initiative is part of the ongoing efforts of the Department of Public Works and Highways (DPWH) and the Japan International Cooperation Agency (JICA) to strengthen disaster

and flood preparedness among the youth under the Cavite Industrial Area-Flood Risk Management Project (CIA-FRIMP).

Mr. Keisuke Ono, a lecturer at the Tohoku Institute of Technology in Japan, led the session on flood education using a 3D city model within Minecraft.

Ono emphasized the benefits of Minecraft’s three-dimensional features in helping students and the younger generation better understand disaster management and identify flood-prone areas, compared to tradition-

PHA urges Pinoys to observe heart healthy resolutions in 2025

MANILA — The Philippine Heart Association (PHA) on Wednesday said New Year's resolutions are key to healthy living, so these have to be

specific and measurable at the same time.

PHA Director and Advocacy Chair Avenilo Aventura Jr. noted that heart disease is still

one of the top health concerns nationwide.

Data from the Philippine Statistics Authority showed that 30,848 Filipinos died from ischemic heart disease (IHD) which accounted for 20.2 percent of all deaths from January to April 2024.

Aventura emphasized that cardiovascular risks can be significantly reduced through mindful eating, regular physical activity, and quitting harmful habits like smoking and excessive alcohol consumption.

"Healthy eating is not about the fancy diets or expensive meals. It is about making smart choices," he said in an *Usapang Puso sa Puso* episode.

The PHA promotes the observance of *Pinggang Pinoy* in everyone's daily diet. This recommends a plate that has fruits (17 percent), vegetables (33 percent), foods rich in carbohydrates (33 percent), and foods rich in protein (17 percent).

The PSAC-EJSG had earlier recommended reviewing the implementing rules and regulations of the CREATE MORE Law to include provisions for the semiconductor sector.

They presented a comprehensive road-map for the country's semiconductor and electronics industry.

Another key recommendation was the creation of a National Education and Workforce Development Plan (NatPlan), which Marcos supported. (PNA)

Apart from healthy food, the group encourages everyone to avoid processed foods and salty foods such as soy sauce, fish sauce, and bagoong because they cause hypertension.

Aventura said individuals with hypertension, diabetes, or high cholesterol must take maintenance medication on time to prevent life-threatening complications.

Keeping an active life, exercising at least 30 minutes every day, avoiding chronic stress, sleeping at least eight hours, and not drinking alcohol also help lower blood pressure and keep diseases related to it at bay.

He also cited that smoking and vaping are not good for the heart because they increase the risk for cardiovascular risks by almost 34 percent as cigarettes and e-cigarettes result in cholesterol build-ups in the arteries.

"Vaping is not a good alternative for smok-

activities by groups aligned with communist-terrorist groups (CTGs) happening in schools and universities. He said cooperation with other government agencies and school administrators was needed to protect students from extremist ideologies.

He added: "National security awareness among the youth will inform them about the ills caused by those recruited by CTGs while letting them know that the government is there to support and guide them."

instill disaster resilience among the youth by immersing them in a hands-on, visual learning experience. Through the 3D city model, students were able to simulate real-life flood scenarios, identify flood-prone areas, and explore evacuation routes and risk reduction strategies.

Using the gamified approach, Ono guided students through discussions on the causes of flooding, structural and non-structural mitigation measures, and community-based strategies for disaster risk reduction.

For the teachers of Emiliano Tria Tirona Memorial National Integrated High School, the Minecraft online video game enabled students to better appreciate disaster management lessons.

"The interactive application captured the students' attention, making the learning experience both enjoyable and informative. By incorporating engaging elements, the app facilitated

a deeper comprehension, allowing the students to connect with the material in an exciting way," the school stated.

The Provincial Government of Cavite supported the initiative, recognizing it as a step toward building a disaster-resilient community.

"This activity underscores the commitment of CIA-FRIMP, the Provincial Government of Cavite, and the local government of Kawit. By empowering the younger generation with knowledge and practical tools, this initiative will enable them to create safer communities ready to face the challenges of natural disasters," the provincial government said.

Ice cream brand expands to fresh milk production to boost supply

MANILA – A Filipino ice cream brand has expanded its product line to include locally-sourced fresh milk to increase livelihood opportunities for dairy farmers and boost supply by the end of 2025.

In his message during a press conference to launch the Carmen's Best fresh milk in Makati City on Wednesday, Jovy Hernandez, president and chief executive officer of Metro Pacific Agro Ventures (MPAV), the wholly owned agriculture unit of Metro Pacific Investments Corp. (MPIC), said with the new product line, they aim to uplift the country's dairy industry by working alongside various stakeholders such as farmers, the academe, and the local and national government.

MPIC invested in the Carmen's Best Group to develop and expand its dairy farm and dairy products manufacturing in 2022. "Real fresh milk keeps all the most important things... Of any developed country, agriculture is always there. The North Star of [MPAV] is really get into agricultural sub-sectors, apply the latest technologies, and the most modern

Meanwhile, Toby Gatchalian, MPAV chief commercial officer, noted that they have supported 39 dairy and corn farmer families to help augment their supply.

According to him, Filipinos lack access to local fresh milk products because 99 percent of dairy products are imported, and 70 percent is in powdered form.

He shared that only one percent of the country's dairy requirements is sourced locally, making the

vices Administration (PAGASA) recently confirmed the presence of La Niña in the Tropical Pacific. This condition, which began with the cooling of sea surface temperatures in September 2024 and intensified into a La Niña phenomenon by December 2024, is projected to persist until March 2025.

"With this development, higher chances of above normal rainfall in January – February – March 2025 season is expected, which may cause floods, flashfloods and rain-induced landslides," said PAGASA.

"Furthermore, increased chance of tropical cyclone activity within the Philippine Area of Responsibility during the period is likely," it added.

CALAMBA CITY, Laguna (PIA) — The Regional Disaster Risk Reduction and Management Council (RDRRMC) Calabarzon has urged local government units (LGUs) to sustain preparedness efforts as the La Niña phenomenon continues to affect the region.

In a memorandum issued by RDRRMC Chairperson and Office of Civil Defense (OCD) IV-A Regional Director Carlos Eduardo Alvarez III, LGUs were urged to implement essential preparedness measures in response to the expected persistence of the La Niña phenomenon until March 2025.

These include conducting pre-disaster

risk assessments, preparing evacuation centers and other critical facilities, and maximizing the use of local DRRM funds for disaster response initiatives.

Alvarez also emphasized the need for LGUs to enhance logistical capabilities and adhere to the Department of the Interior and Local Government's (DILG) LISTO preparedness protocols.

Member agencies and response clusters of the RDRRMC are also urged to maintain readiness to respond swiftly to the potential effects of La Niña.

the Department of Public Works and Highways (DPWH), in coordination with the Municipal Government of Kawit through its Disaster Risk Reduction and Management Office, spearheaded an Information, Education, and Communication (IEC) activity on disaster management for flood preparedness using an innovative 3D city model on January 15 to 16, 2025, at Emiliano Tria Tirona Memorial National Integrated High School in Kawit, Cavite.

A lecture on Flood Education using a 3D city Model with Minecraft was led by Mr. Keisuke Ono, Lecturer at Tohoku Institute of Technology in Japan, engaging 400 Grade 7 student attendees as part of the mission to instill disaster resilience among the youth.

The two-day initiative aimed to educate students about flood risks, preparedness measures, and the significance of community involvement in mitigating disaster impacts. The interactive 3D city model and Minecraft served as a powerful visual tool, allowing students to better understand flood scenarios and how these can affect their locality. By simulating real-life situations, students were able to visualize flood-prone areas, learn evacuation routes, and explore strategies to minimize risks.

Facilitators from CIA-FRIMP and Tohoku Institute of Technology guided the students through discussions on the causes of flooding, its structural and non-structural measures, and disaster education for flood management using 3D City Model with the popular video game Minecraft. The engaging nature of the activity encouraged active participation and fostered a deeper understanding of disaster risk reduction.

The IEC activity underscores the commitment of CIA-FRIMP, Provincial Government of Cavite and the local government of Kawit to building a safer and more resilient community by educating the younger generation on disaster preparedness.
