Survey: DSWD programs improve indigent Filipinos' financial stability'

MANILA – The results of the latest surveys conducted by Pulse Asia and Social Weather Station (SWS) showed that four Department of Social Welfare and Development (DSWD) programs have "improved the financial stability of Filipinos belonging to the lower social class."

The surveys, com-

missioned by Stratbase Group, gauged public opinion on various government social welfare programs, including the Pantawid Pamilyang Pilipino Program (4Ps), Ayuda sa Kapos ang Kita Program (AKAP), Walang Gutom Program (WGP) and Assistance to Individuals in Crisis Situation (AICS).

The SWS survey, conducted Jan. 17 to 20, interviewed 1,800 respondents with a ±2% margin of error, while the Pulse Asia survey, conducted Jan. 18 to 25, interviewed 2,400 respondents with the same margin of error.

Among the most impactful programs is the 4Ps, which 90 percent of Filipinos found

helpful, according to the SWS.

Pulse Asia supported this, with 82 percent of respondents saying 4Ps improved the financial stability of lower-income families.

Other social protection programs also gained strong approval ratings.

The AKAP program was considered bene-

NFA rice stock up 485% in Jan, to surge further in Feb

MANILA – The rice stock inventory of the National Food Authority (NFA) rose by 485.1 percent in January compared to the same period last year, recent Philippine Statistics Authority (PSA) data show.

The NFA depositories logged 284,810 metric tons (MT), significantly higher than 48,680 MT rice stocks in January 2024.

In a phone interview Monday, NFA Admin-

istrator Larry Lacson said the surge in national rice buffer stock was due to the higher buying price scheme for local palay (unhusked rice), which is set at PHP23/kg. to PHP30/kg. for dry palay, and PHP17/kg. to PHP23/kg. for fresh or wet palay.

"That allowed us a good chance of buying palay from the farmers kasi dati, hindi tayo nakakapamili sa mga farmers dahil ang

presyo ng trader ay let's say PHP25, tayo nakapako sa PHP19 hanggang (because before, we cannot buy from farmers because the trader's price is, let's say PHP25, we are locked from PHP19 to) PHP23," he said.

He said the NFA rice stocks may further increase with the "flexible" buying scheme in place.

The Walang Gutom Program, formerly the Food Stamp Program, also gained approval from 81 percent of respondents, while the AICS program registered an 80 percent approval rating.

"This validation from the people strengthens our resolve to further improve our social welfare programs and services and ensure that no Filipino is left behind," DSWD spokesperson Assistant Secretary Irene Dumla said in a statement Tuesday.

"We reaffirm our commitment to strengthen and expand these initiatives, as well as explore additional measures, to ensure that more Filipinos in need can access necessary assistance," she added.

Launched in 2008 and institutionalized by Republic Act (RA) 11310 in 2019, the 4Ps is the national poverty reduction strategy and human capital investment program that provides conditional cash transfer to poor households for a maximum period of seven years to improve their children's health, nutrition, and education.

As part of its enhancements, the DSWD is adding the First 1,000 Days (F1KD) of Life conditional cash grant under 4Ps starting 2025 to cover essential health and nutrition expenses of pregnant mothers or parents during the critical period of a child's life.

Under the F1KD, a monthly health grant worth PHP350 will be granted to female 4Ps beneficiaries who are pregnant and households that have children aged 0 to 2 years.

The AKAP is a program intended to provide targeted social assistance and safety nets for low-income earners whose purchasing power eroded due to

inflation.

The AKAP program is set for conditional implementation in 2025, subject to the issuance of new and stricter guidelines as conveyed in the veto message of President Ferdinand R. Marcos Jr. when he signed the General Appropriations Act 2025 on Dec. 30, 2024.

The Walang Gutom Program aims to bring down the incidence of involuntary hunger experienced by Filipinos from low-income households. It also promotes social and behavioral change among food-poor families by teaching them how to prepare nutritious, delicious, and affordable meals.

The AICS program is part of the DSWD's protective services for the poor, marginalized, vulnerable, and disadvantaged individuals through the provision of medical assistance, burial, transportation, education, food or financial assistance for other support services or needs of a person or family.

Vindication

Meanwhile, Assistant Majority Leader Pammy Zamora said the survey results are proof that the House of Representatives was right in introducing the AKAP.

"Well, personally, masaya ang masaya ako sa survey na 'yan kasi (I am very happy because) it vindicates what we've always said na itong mga issues patungkol sa ayuda ay pawang ingay lamang at talaga namang hinahanap ito ng taong bayan (that the issues over the assistance were mere noise and the people really wanted it)," Zamora said in a press briefing.

At least 13.2 million birds were said to be affected in confirmed infected premises in Maryland and Missouri, following the outbreak reported last Jan. 23, with 89 flocks testing positive for bird flu, the Deputy Administrator and Chief Veterinary Officer of the Animal and Plant Health Inspection Service said.

The first case in Maryland was detected on Jan. 14.

Besides increment in NFA stocks, rice inventory from households also incurred a 5.4 percent annual increase equivalent to 1.1 million MT, higher than last year's 1 million.

The commercial sector, however, logged a 16.5 percent annual decrease, equivalent to 816,510 MT, lower than January 2024's 978,000 MT.

For corn, the PSA reported a 45 percent annual decrease in inventory at 328,400 MT in January, down from 597,620 MT for the same period last year.

Gatchalian backs NFA's rollout of cheaper rice, calls for transparency

Meanwhile, Senator Sherwin Gatchalian said the rollout of cheaper NFA rice must be transparent and

strictly monitored to prevent price manipulation.

"The commencement of the National Food Authority's sale of cheaper rice is a welcome development as this would largely benefit underprivileged households," he said in a news release Tuesday.

The senator urged the NFA to collaborate with local government units to ensure accountability in the distribution process, ensuring that the intended beneficiaries receive the rice.

Gatchalian also stressed the need for law enforcement agencies to monitor rice supplies closely to prevent hoarding that could drive prices up. (With a report from Wilnard Becelonia/ PNA)

DA to lower Kadiwa ng Pangulo's Rice for All prices by up to P3/kg

MANILA – The price of Rice for All (RFA) options under the Marcos administration's Kadiwa ng Pangulo (KNP) is set to drop by PHP2 to PHP3/kg. starting Wednesday, the Department of Agriculture (DA) said Tuesday.

The DA's move comes amid the continuous downward trend of rice prices in the global market and the upcoming peak of palay (unhusked rice) harvest season.

"Starting tomorrow (Feb. 12), RFA5 rice will be priced at PHP43 per kilogram, RFA25 at PHP35/kg., and RFA100 at PHP33/kg.," Agriculture Secretary Francisco Tiu Laurel Jr. said in a statement.

The RFA5 or the 5 percent broken rice is currently priced at PHP45/kg.; while the RFA25 or the 25 percent broken rice is at PHP38/kg.; and PHP36/kg. for RFA100 or Sulit rice, which is 100 percent broken but white.

The National Food Authority (NFA), likewise, will continue its P29 program or the sale of PHP29/kg. aging but good quality rice stocks in KNP Centers for the vulnerable sector including members of the Pantawid Pamilyang Pilipino Program (4Ps), senior citizens, persons with disabilities (PWDs), and solo parents.

The RFA options, meanwhile, will be lower than the retail prices monitored in Metro Manila as of Monday, which include imported premium rice ranging from PHP48 to PHP58/kg.; imported well-milled

rice, PHP44 to PHP45/kg. and imported regular-milled rice at PHP38 to PHP46/kg., according to the DA Bantay Presyo (price watch).

Local premium rice, meanwhile, ranges from PHP46 to PHP58/kg.; local well-milled at PHP42 to PHP52/kg.; and PHP38 to PHP45/kg. for local regular-milled rice.

On Feb. 5, the DA lowered its maximum suggested retail price (MSRP) for imported 5 percent broken rice to PHP55/kg., which is PHP3 lower than the first PHP58/kg. MSRP set last Jan. 20.

The MSRP was earlier implemented to help tame spiking retail prices alongside other

government interventions like lower tariffs on imported rice and availability of RFA options and P29 in KNP Centers and kiosks.

The DA, likewise, declared a food security emergency for rice to help influence markets in bringing down rice retail prices; release rice stocks at PHP33/kg. from the NFA to the local government units (LGUs), government agencies, and government-owned and controlled corporations (GOCCs) which can sell it at a PHP35/kg.-level to consumers; and free up NFA warehouses to give space for local palay procurement from farmers. DepEd commits to deploy over 15K principals this year

MANILA – The Department of Education (DepEd) on Tuesday said it will deploy over 15,000 qualified passers of the National Qualifying Examination for School Heads (NQESH) as principals in the country.

The decision aims to address the shortage of school heads, with around 55 percent of public schools operating without principals, according to the Second Congressional Commission on Education (EDCOM II).

The EDCOM II cited several factors, including historically low passing rates for NQESH, high personnel turnover, insufficient pipeline of candidates, burdensome qualification processes, and the absence of structured mentoring, coaching and formal induction programs.

"This pressing issue is an eye-opener. So many of our schools operate without brains —because that's what our principals are, the brains of our schools. Rest assured, DepEd is taking swift action to address this problem," DepEd Secretary Sonny Angara said in a statement.

At least 7,916 NQESH passers in 2024 can help fill va-
