DOLE gives aid to child laborers, families in Batangas

BATANGAS CITY (PIA) — At least 100 child laborers and their families benefited from the Information and Service Caravan organized by the Department of Labor and Employment (DOLE)-Calabarzon on February 20 at the Rosario Cultural and Sports Center in Batangas.

The event gathered various government agencies to provide essential services, including PhilSys reg-



istration, health insurance enrollment, medical and dental checkups, livelihood assistance, and skills training.

Laguna forms team to strengthen farm-to-market road network plan



SANTA CRUZ, Laguna (PIA) — A technical working Group (TWG) has been created to oversee Laguna's agricultural infrastructure development under the Farm-to-Market Road Network Plan (FMRNP) of the

provincial government.

Citing its positive impact on the agri-fisheries sector, the Laguna Provincial Planning and Development Office (PPDO) said that the newly formed TWG aligns with

President Ferdinand Marcos Jr.'s goal of revitalizing the country's agricultural economy.

"This initiative ensures the thorough and strategic formulation of the FMRNP and its corresponding investment plan, fostering well-planned infrastructure development that enhances market access, rural connectivity, and economic growth," said Maria Rowena Beatriz Inzon, Laguna's Provincial Planning and

Remote Laguna community soon to access potable water

CALAMBA CITY, Laguna (PIA) — Residents of eight upland villages in Majayjay, Laguna will soon have access to safe and adequate water, upon the expected completion of the P90-million potable water system project in January

2026.

Funded by the Department of Agriculture-Philippine Rural Development Project (DA-PRDP) and the Majayjay local government, the project will also rehabilitate and expand the town's existing water system

through the installation of water tanks, transmission and distribution lines, valves, communal tap stands, and the construction of a 40-meter hanging bridge.

CALAMBA CITY, Laguna (PIA) — Domestic workers in Calabarzon are set to receive higher take-home pay beginning March, following the approval of a wage increase by the Regional Tripartite Wages and Productivity Board IV-A (RTWPB IV-A).

Under the new wage order, domestic work-

for child labor elimination continues so that we can fully eradicate it in the country," said Regional Director Erwin Aquino.

Aquino added that the caravan coincided with the first anniversary of International Labor Organization (ILO) Convention No. 190, which seeks to eliminate all forms of violence in the workplace.

Citing the importance of child labor prevention and elimination efforts, Aquino expressed gratitude to partner agencies for their active participation in the program.

"We sincerely thank all the agencies that supported and joined the Child Labor Prevention and Elimination Program. Your collaboration demonstrates strong unity and cooperation in improving the lives of children," he added.

The child laborers also participated in a skills demonstration conducted by the Technical Education and Skills Development Authority (TES-

DA) Batangas, featuring bread and pastry production as well as hydroponic farming techniques.

As part of the caravan, DOLE Batangas also conducted an orientation on the Child Labor Prevention and Elimination Program (CLPEP).

The discussion covered how work involving children aged 17 and below can be classified as child labor, the worst forms of child labor, and exceptions that allow minors to work, such as in modeling and acting.

John Kevin, one of the profiled child laborers, expressed his gratitude to DOLE Calabarzon for the services and livelihood assistance provided to him and his family, emphasizing that it would be a significant help in improving their lives.

A pledge of commitment to implement ILO Convention No. 190 was also signed by partner agencies, followed by a recognition ceremony for program collaborators. (BDC, PIA Batangas)

DA: MSRP on 5% broken imported rice set at P49 starting March 1

MANILA – The Department of Agriculture (DA) on Wednesday announced the lowering of the maximum suggested retail price (MSRP) of 5 percent broken imported rice to PHP49/kg. starting March 1.

This came as the MSRP dropped to PHP52/kg. from PHP55/kg. on Feb. 15, with the original MSRP set at PHP58/kg. on Jan. 20, much lower than the PHP62/kg. to PHP64/kg. retail

ties, unlock economic opportunities, and promote undiscovered tourist destinations.

tainous villages of Bakkia, Bitaoy, Botocan, Gagalot, Isabang, Piit, Rizal, and Taytay have been relying on either tap or mineral water for their drinking needs.

During the project's groundbreaking ceremony, Project Director Engr. Redelliza Gruero of the DA's Regional Project Coordination Office in Calabarzon cited the local government's aspirations to improve the lives and well-being of residents.

"I hope [this] project

will help beneficiaries improve their living and socio-economic conditions," she said.

Gruero said the DA-PRDP will extend its partnership with the Majayjay LGU for agri-fishery projects.

Meanwhile, Majayjay Mayor Romeo Amorando thanked the DA-PRDP for its support to the project, expecting that the water facility will curb water-borne diseases, aside from bringing convenient access to adequate and safe water to the people.

The event commenced with a warm welcome by Dr. Melinda Villanueva, Amadeo Municipal Health Officer, to the guests and attendees, urging their full engagement in the program. It was followed by a message from Dr. Melnita Bayot, PDA - Cavite Chapter President, reminding the parents of their vital role in maintaining their children's healthy teeth, as good dental health should start at home. On February 22, 2025, a total of 454 residents of Barangay Munting Mapino received free healthcare services during the medical and dental mission organized by the Provincial Government of Cavite.

Spearheaded by the Office of the Provincial Governor in collaboration with the Office of the Provincial Health Officer and Tagaytay City Health

₱5,000 per month will now receive a minimum of ₱6,750. The wage increase will take effect on March 7, 2025.

The Wage Board Calabarzon stated that the increase was determined after a series of consultations and a review of socioeconomic factors.

"After a thorough review and evaluation of the results of the consultation and public hearing, existing socio-economic conditions in the region, the needs of the domestic workers and their families, as well as the employers' capacity to pay, the Board deemed

it necessary to increase the prevailing minimum wage rates for domestic workers in the region," the board stated.

The new wage order applies to all domestic workers, whether in live-in or live-out arrangements, including but not limited to house helpers, nannies (yaya), cooks, gardeners, laundry personnel, and any worker regularly performing domestic duties in a household.

The RTWPB IV-A emphasized that wages must be paid in cash at least once a month, with no deductions except

those mandated by law.

Additionally, to further improve productivity, household employers and their domestic workers may voluntarily and mutually agree to implement a competency-based pay scheme, allowing for salary adjustments above the applicable minimum wage.

The wage board encourages household employers to comply with the newly prescribed minimum wage, citing implications enumerated under the Republic Act 10361 or the Domestic Workers Act. (FC, PIA4A)

efforts to help drive down market prices.

"Kaunti na lang (Just a little more), we would reach the ideal price of PHP40 to PHP45/kg/ of imported rice," SINAG executive director Jayson Cainglet said in a separate statement. "At the current price of USD380 per metric ton (MT) of 5 percent broken Vietnam rice, imported rice should further go below PHP40/kg."

Tiu Laurel, however, said the PHP49/kg. MSRP will be implemented only in select areas in Metro Manila

and other urban centers.

"In many provincial areas, we've seen prices of imported rice already lower than the MSRP. So we will apply it more selectively," he said.

As of Feb. 25, the price range of premium imported rice in Metro Manila is set at PHP49 to PHP57/kg.; PHP43 to PHP46/kg. for imported well-milled; and PHP36 to PHP46/kg. for imported regular-milled, according to the DA Bantay Presyo (price watch). (PNA)

CALAX Governor's Drive Interchange Nears 40% Completion, Set to Open in 2025

Construction of the Cavite-Laguna (CALAX) Governor's Drive Interchange is now nearing 40% completion, keeping it on track for target opening in the second half of 2025. This 8.64-kilometer segment will connect Silang (Aguinaldo) Interchange to Governor's Drive in General Trias, Cavite, further enhancing mobility and reducing congestion in the region. Once operational, this new segment will further enhance CALAX's connectivity providing faster, seamless travel to General Trias and nearby areas. It will also ease traffic congestion on Governor's Drive and Aguinaldo Highway.

"We are committed to completing the entire stretch of CALAX by 2025. Its full opening will not only ease traffic and improve connectivity but also support economic growth by enhancing access to key areas in Cavite and Laguna," said Ms. Elvina D. Rumawak, Officer-in-Charge of MPCALA Holdings Inc.

Meanwhile, construction continues on its remaining sections, with Subsection 1 (Kawit Interchange) now over 31% complete, and Sub-section 2 (Open Canal Interchange) at 21.9% completion.

Once completed, CALAX will stretch 45 ki-



lometers from Mamplasan Rotunda in Laguna to Kawit, Cavite, integrating with major expressways to provide a seamless connection between Cavite, Laguna, and Metro Manila. The expressway will feature a total of eight interchanges: Laguna Technopark, Laguna Boulevard, Santa Rosa-Tagaytay Road, Silang East, Silang (Aguinaldo), Governor's Drive, Open Canal, and Kawit Interchange.

CALAX will connect with the Manila-Cavite Expressway (CAVITEX) in Kawit, providing a more efficient route for motorists traveling between Cavite, Laguna, and Metro Manila. Once the entire expressway is

fully operational, it is expected to serve up to 95,000 vehicles daily, significantly improving travel times and boosting economic activity in the region.

MPCALA Holdings Inc., concessionaire of the Cavite-Laguna Expressway, is a subsidiary of Metro Pacific Tollways Corporation. Aside from CALAX, MPTC's domestic portfolio also includes the Manila-Cavite Expressway (CAVITEX), North Luzon Expressway (NLEX), the NLEX Connector Road, the Subic-Clark-Tarlac Expressway (SCTEX), and the Cebu-Cordova Link Expressway (CCLEX) in Cebu.



DOH brings PuroKalusugan program to Taytay community

TAYTAY, Rizal (PIA)

— Residents of Barangay Dolores in Taytay, Rizal now have access to free medical and health services as the Department of Health (DOH) in Calabarzon launched PuroKalusugan—a grassroots healthcare program designed to bring essential services to small communities.

DOH Calabarzon Assistant Regional Director Voltaire Guadalupe said that PuroKalusugan aligns with the health department's 8-Point Action Agenda, which includes Immunization, Nutrition, Water Supply, Sanitation and Hygiene (WASH), Maternal Health, Tuberculosis and HIV, Road Safety, Hypertension and Diabetes, and Cancer.

"Through PuroKalusugan, health promotion, preventive, and curative care will be accessible in every purok, particularly in underserved and unserved areas. The delivery of health services will not only be within reach for every Filipino but will also be tailored to the unique needs of each community," Guadalupe said.



Implemented in partnership with local government units, PuroKalusugan focuses on delivering essential health services to smaller community governance structures called 'puroks.'

Among the services provided during the health initiative launch on Feb. 21, include free medical consultations, free medicines, laboratory testing, oral health services, maternal health services, chest X-ray screenings, pneumococcal vaccinations, and nutrition counseling.

As part of its health promotion initiatives, lectures and activities were also conducted to educate children and youth on proper healthcare and disease prevention, particularly against dengue and measles. Topics covered in the lectures

included hands-on CPR, road safety, handwashing, and adolescent health.

The Barangay Dolores local government expressed gratitude for the PuroKalusugan initiative, emphasizing the benefits it offers to their citizens.

The DOH aims to expand and bring PuroKalusugan to more communities to ensure that quality healthcare services are accessible to all. Guadalupe also thanked partner agencies for their support in the health initiative.

Matanguihan.


Gio Gorpido and Kent Altarejos also delivered in the final inning to complete the win.
